OFFICE OF JUSTICE PROGRAMS AWARDS MORE THAN \$212 MILLION TO SUPPORT JUVENILE JUSTICE

WASHINGTON –The Office of Justice Programs today announced awards of more than \$212 million in grant funding to enhance state and local juvenile justice systems, provide gang prevention and intervention services, support mentoring and reentry services for youth and families, and help states comply with the Juvenile Justice and Delinquency Prevention Act. Unless otherwise noted, all awards were made by OJP's Office of Juvenile Justice and Delinquency Prevention.

Mentoring Programs and Services (\$83.1 million)

More than \$81 million was awarded to 29 organizations in 18 states and the District of Columbia via OJJDP's *Mentoring Opportunities for Youth Initiative*. This program supports the implementation and delivery of mentoring services to youth populations that are at high risk for juvenile delinquency and juvenile justice system involvement. Another \$2 million supplemental award was provided to the National Mentoring Partnership, Inc., under OJJDP's *National Mentoring Resource Center* program, to support mentoring strategies primarily targeted to youth under 18. OJJDP's mentoring approaches have grown in recent years to include one-to-one, group, and peer mentoring across school, community, and institutional settings. With this FY 2019 funding, the Resource Center will build upon past efforts, continue to support mentoring services in innovative contexts, and develop training and technical assistance to improve the capacity of organizations and communities to develop and deliver mentoring programs for youth.

Assistance to States (\$42.7 million)

More than \$42.7 million was awarded to help states, territories, and the District of Columbia improve their juvenile justice systems. Of that amount, nearly 37 million will be awarded through the Formula Grants Program under Title II of the Juvenile Justice and

Delinquency Prevention Act. The funds will help state and local governments prevent juvenile crime and delinquency and assist states in meeting the four core requirements of the Act, which include: deinstitutionalization of status offenders, separation of juveniles from adults in secure facilities, sight and sound separation between juveniles and adults in jails and lockups and addressing reduction in racial and ethnic disparities within the juvenile justice system. Funds are provided to those who submit an approved state plan to address the Act's program requirements and are determined to be in compliance with the four core requirements.

Nearly \$6 million was awarded to the American Institutes for Research via OJJDP's *Center for Coordinated Assistance to States.* This grantee will provide states with resources and training to plan, operate, and assess delinquency prevention, intervention and juvenile justice system improvement projects to ensure they comply with the four core requirements.

Drug Courts and the Opioid Crisis (\$38.3 million)

OJP awarded over \$38.3 million to provide services to youth impacted by the opioid crisis, and fund family and juvenile drug courts.

Just over \$12.3 million across 18 awards were made under the Office for Victims of Crime's *Enhancing Community Responses to the Opioid Crisis: Serving our Youngest Crime Victims Program.* Recipients include:

Another \$1 million was awarded to the Institute for Intergovernmental Research to provide training and technical assistance to states, local governments and tribal jurisdictions in developing data-driven responses to opioid abuse.

OJJDP awarded just over \$7 million across 11 awards under its *Family Drug Court Program*. This program seeks to build the capacity of state and local courts, units of local government, and federally recognized tribal governments to sustain existing drug courts or establish new ones. Family drug courts serve parents who require treatment for a substance abuse disorder and who are involved with the child welfare system as a result of child abuse, neglect or other parenting issues. OJJDP awarded another \$8 million to the Center for Children and Family Futures, Inc. (\$4.5 million), and the National Association of Drug Court Professionals (\$3.5 million) to provide training and technical support of the *Juvenile Drug Treatment Court Program* and the *Family Drug Court Program*. The Center will provide training and technical assistance services under the *Family Drug Court Program*, while the Association will provide such services under the *Juvenile Drug Treatment Court Program*.

Reentry Services for Youth and Families (\$11.2 million)

More than \$11.2 million was awarded to help jurisdictions supplement reentry services for detained juveniles and incarcerated parents with children under the age of 18. OJJDP's *Second Chance Act Addressing the Needs of Incarcerated Parents with Minor Children* program supports the successful and safe transition of fathers and mothers from detention, out-of-home placement, or incarceration to their families and communities. More than \$4.5 million was awarded to seven jurisdictions. Recipients include:

More than \$6.7 million was awarded to nine jurisdictions under OJJDP's *Second Chance Act Youth Offender Reentry Program*. This program encourages collaboration between state agencies, local government, and community and faith-based organizations to address the challenges youth face when returning to their communities from juvenile residential or correctional facilities. Court Appointed Special Advocates Membership, Accreditation, and Subgrants (\$10.7 million)

Nearly \$10.7 million was awarded to the National Court Appointed Special Advocate Association. This program provides advocacy for abused and neglected children – including foster care youth – in dependency hearings and supports other child welfare system stakeholders at all levels of government.

Gang Prevention, Intervention, Education and Victim Support (\$7.4 million)

Nearly \$7.4 million was awarded under four separate gang prevention, intervention and education programs. OJJDP made four awards in the amount of \$2 million under its *Youth Gang Desistance/Diversion Grant Program* to jurisdictions struggling with high levels of youth gang violence. The program funds implementation of the OJJDP Comprehensive Gang Model to reduce violent crime, gangs and youth victimization, while enhancing public safety through desistance and diversion opportunities for youth at risk of becoming or continuing life as gang members. Nearly \$1.34 million was awarded to six sites under OJJDP's *Youth Gang* Suppression Implementation Grants Program. The goal of the funding is to reduce or prevent gang violence by implementing suppression strategies outlined in OJJDP's Comprehensive Gang Model. Recipients include:

Finally, supplemental funding of \$830,531 was awarded to the Institute for Intergovernmental Research to continue operating the National Gang Center. The Center provides leadership, information and training and technical assistance on comprehensive, community-based anti-gang initiatives, including gang prevention, intervention, enforcement, and reentry.

Youth with Sexual Behavioral Problems (\$3.4 million)

More than \$1.9 million was awarded to four organizations under OJJDP's Supporting Effective Interventions for Adolescent Sex Offenders and Youth with Sexual Behavioral Problems Program. Three project sites were awarded to develop a community-based, comprehensive approach to respond to youth with sexual behavior problems, their child victims and their families. The funding also provides for a training and technical assistance provider to support the project sites in developing intervention models. Recipients include:

An additional \$1.5 million was awarded to the University of Oklahoma Health Sciences Center to provide enhanced training and technical assistance to the Department of Defense Family Advocacy Program. This program trains and provides resources to those military professionals who respond to problematic sexual behavior in military children and youth residing both stateside and overseas.

Child Abuse Training for Judicial and Court Personnel (\$2.7 million)

OJJDP's *Child Abuse Training for Judicial and Court Personnel Program* provided nearly \$2.7 million (actual amount \$2,686,460) to the National Council of Juvenile and Family Court Judges to improve juvenile justice and dependency systems' response to child abuse and neglect, as well as child sexual exploitation and sex trafficking. This program provides judicial, legal, and social service professionals with training and technical assistance to improve their understanding of child abuse issues; their ability to prevent placement in foster care, when possible and to reunify families after foster care placement. This funding also supports strategies to coordinate information and services across systems, as well as systematic efforts to reduce the length of time children spend in the system.

Juvenile Indigent Defense (\$1.8 million)

OJJDP made three awards totaling nearly \$1.8 million under its *Enhancements for Juvenile Indigent Defense Program*. These awards help states and localities develop and implement specialized training for public and appointed defenders who provide services to juvenile defendants from arrest through post-disposition and reentry. The awards also help improve data collection and reporting capacity of the juvenile court system while also analyzing the juvenile defense delivery system to identify critical program, practice and policy needs. Finally, these awards help provide juvenile offenders with access to high-quality, specialized juvenile defense services. Recipients include:

Training for Juvenile Prosecutors (\$1.5 million)

Another \$1.5 million was awarded to three project sites and one training and technical assistance provider under OJJDP's *Addressing the Training Needs of Juvenile Prosecutors Program*. This funding allows states to develop or supplement existing training and professional development tailored to the unique needs and challenges related to juvenile prosecution. Recipients include:

Supporting Tribal Youth (\$1.4 million)

Additionally, OJJDP awarded nearly \$1.4 million in continuation funding to the Tribal Law and Policy Institute under the Supporting Tribal Youth TTA and Youth Leadership Development Program. This award will help the Institute continue preventing crime and delinquency and provide culturally appropriate training, resources and other related technical assistance to Native American tribes and indigenous youth. This includes support for courts, probation, prosecutors, and other key stakeholders charged with responding to juvenile crime as well as an intentional focus on prevention programs.

Juvenile Justice Facility Leadership (\$450,000)

OJJDP awarded \$450,000 to the Council of Juvenile Correctional Administrators to support the Juvenile Justice Facility Leadership Certificate Program. Designed for juvenile correctional directors and staff, this training aims to improve facility operations, ensure proper conditions of confinement, protect facility staff, and enhance outcomes for confined juveniles.

Juvenile Justice Emergency Planning Demonstration Program (\$433,454)

Three awards totaling \$433,454 were made under OJJDP's *Juvenile Justice Emergency Planning Demonstration Program*. This program supports the development, improvement, and implementation of emergency planning activities for state, tribal, county and local juvenile justice residential facilities. Juvenile Justice Programs Research and Evaluation (\$5.3 million)

OJJDP also transferred \$5.3 million to OJP's National Institute of Justice as part of an interagency agreement to fund a variety of juvenile justice and public safety-related research and evaluation projects. These funds will be awarded in Fiscal Year 2020 by NIJ.

Census of Juveniles in Residential Placement (\$1.2 million)

OJJDP also transferred \$1.2 million to the U.S. Census Bureau to continue data collection activities under the biannual Census of Juveniles in Residential Placement and the Juvenile Residential Facility Census. These data collections provide valuable information about juveniles in residential placement and the facilities that hold them.

Archival of OJJDP data (\$400,000)

Another \$400,000 was provided to the Bureau of Justice Statistics to archive and disseminate OJJDP's data at the National Archive of Criminal Justice Data, the nation's leading resource for secondary analysis of research data on crime and the juvenile and criminal justice system.
