# OPIOID FACT SHEET JUSTICE DEPARTMENT IS AWARDING MORE THAN \$333 MILLION TO COMBAT OPIOID CRISIS

Comprehensive Opioid Abuse Site-based and Training and Technical Assistance Programs (\$163 Million)

BJA is awarding 95 grants totaling almost \$163 million to jurisdictions under the BJA's *Comprehensive Opioid Abuse Site-based Program*, which provides financial and technical assistance to state, local and tribal jurisdictions to reduce opioid abuse and fatalities, and mitigate impacts on crime victims.

Authorized by the 2016 Comprehensive Addiction and Recovery Act, this program offers grant awards across three focus areas.

Category 1 is designed to encourage and support the development of comprehensive, locally driven responses to the opioid epidemic that expand access to supervision, treatment and recovery support services across the criminal justice system; support law enforcement and other first responder diversion programs for non-violent drug offenders; promote education and prevention activities; and address the needs of children impacted by the opioid epidemic. All projects are expected to involve multiple agencies and partners. These awards include:

Category 3 awards may be used to establish or enhance a prescription drug monitoring system; facilitate the exchange of information and collection of data on prescriptions and other scheduled chemical products among states; develop a training program for system users; produce and disseminate educational materials; support collaborations between law enforcement, prosecutors, public health officials, treatment providers and drug courts; facilitate electronic information sharing among states in compliance with the Prescription Monitoring Information Exchange National Architecture; expand monitoring to Schedules II, III, IV and V; improve the quality and accuracy of Prescription Drug Monitoring Program data; develop or enhance the capacity to provide unsolicited reports of controlled substance prescribing to authorized individuals or entities; and assess the efficiency and effectiveness of the PDMP program or specific PDMP initiatives. In addition, BJA awarded approximately \$17.6 million to the Institute for Intergovernmental Research<sup>1</sup>, including:

- \$10.2 million for Rural Responses to the Opioid Epidemic;
- \$2.5 million for Tribal Responses to the Opioid Epidemic;
- \$3.7 for support and monitoring of subawardees;
- \$1 million for an overdose fatality review and the development of a set of products to support criminal justice and public partnerships; and
- \$250,000 to integrate the E-Health exchange with the RxCheck hub.

BJA announced it is awarding nearly \$8.3 million under the *Comprehensive Opioid Abuse Program* to four training and technical assistance providers. This amount includes nearly \$800,000 to expand peer recovery programs, develop a virtual training program and conduct yearly visits to mentor recovery sites. Another \$2.5 million will help to establish a partnership between law enforcement and first responders and public health and behavioral health agencies that respond to the opioid epidemic. Funding will also provide \$2.5 million to establish a jail treatment-based mentor program and create a publication focusing on evidence-based research associated with jail-based medication-assisted treatment programs. Another \$2.5 million will provide direct support to state agencies to address implementation and training issues associated with state deployment of local opioid initiatives.

Finally, \$5 million will fund a resource center, develop a legislative update to be disseminated online and support the RXCheck Hub and the Prescription Monitoring Information Exchange Working Groups.

#### Justice and Mental Health Collaboration Program (\$23.8 Million)

More than \$23.8 million via 49 awards will be awarded to jurisdictions under BJA's *Justice and Mental Health Collaboration Program*, which provides financial and technical assistance to facilitate collaborations between criminal justice, mental health and substance abuse treatment systems to serve individuals with mental illness or co-occurring mental illness and substance abuse issues. While not all awards made under the JMHCP program are focused

explicitly on addressing the opioids epidemic, the following 49 awards were made in FY 2019

#### Adult Drug Courts (\$65.5 Million)

More than \$44 million (90 awards) is being awarded to jurisdictions, academic institutions and training and technical assistance providers to establish, expand, assist and research the effectiveness of adult drug courts, including veterans treatment courts.

Drug courts have been demonstrated to reduce recidivism and substance abuse among high-risk, high-need participants and increase their likelihood of successful rehabilitation. These courts integrate evidence-based substance abuse treatment, mandatory drug testing, sanctions and incentives, and transitional services in judicially supervised court settings. OJP will fund several FY 2019 drug court programs, including BJA's *Adult Drug Court and Veterans Treatment Court Discretionary Grant Program*, which provides financial and technical assistance to states, state courts, local courts, units of local government and tribal governments to develop, implement and enhance drug courts and Veterans Treatment Courts.

BJA is awarding more than \$44 million in three categories: implementation of new drug courts (Category 1); enhancement of fully operational drug courts that incorporate the evidence-based principles included in the National Association of Drug Court Professionals' Adult Drug Courts Best Practice Standards (Category 2); and improvement, enhancement or expansion of drug court services statewide (Category 3).

More than \$21.4 million will be awarded to seven organizations in support of the BJA FY 2019 Adult Drug Court and Veterans Treatment Court Planning, Training, Technical Assistance, and Resource Center Initiative, which aims to reduce opioid abuse and the number of overdose fatalities, as well as to mitigate impacts on crime victims. It supports the implementation and enhancement of drug court programs and systems for nonviolent offenders with addictions, and to veterans treatment court programs and systems for offenders with both addiction and a history of violence related to post-traumatic stress disorder.

The six categories of funding include planning training for new drug courts (Category 1); enhancement training for fully operational drug courts (Category 2); improvement, enhancement or expansion of drug courts (Category 3); planning, operations, evaluation and data collection for drug courts statewide (Category 4); coordination of an annual Veterans Treatment Court conference and training and technical assistance consistent with the National Association of Drug Court Professionals' Best Practice Standards (Category 5); and training and technical assistance for Tribal Healing to Wellness Courts and Coordinated Tribal Assistance Solicitation grantees, along with support services (Category 6).

#### Family Drug Court Program (\$7 million)

The Office of Juvenile Justice and Delinquency Prevention funded the *Family Drug Court Program* in the amount of just over \$7 million via 11 awards to build the capacity of states, state and local courts, units of local government and federally recognized tribal governments to sustain existing family drug courts or establish new ones. These courts serve parents who require treatment for a substance abuse disorder and who are involved with the child welfare system as a result of child abuse, neglect or other parenting issues.

#### Drug Treatment Courts Training and Technical Assistance (\$8 Million)

#### Child Abuse Training for Judicial Personnel (\$1 Million)

OJJDP awarded \$1 million to the National Council of Juvenile and Family Court Judges to provide specialized training for juvenile and family court judges on serving families affected by opioids.

#### Mentoring Opportunities for Youth Initiative (\$15 Million)<sup>2</sup>

OJJDP awarded \$15 million under the *Mentoring Opportunities for Youth Initiative* to address opioids and substance abuse. Of this amount, \$5 million is allocated to four national mentoring organizations to support youth affected by opioids—Big Brothers Big Sisters of America, Boys & Girls Clubs of America, the National 4-H Council and the National Court Appointed Special Advocate Association. This funding is part of a group of larger awards made under Category I of this program, "National Mentoring Awards," and is dedicated to opioid-related activities. Another \$10 million will go to regional, state, local and tribal agencies and organizations specifically to address the opioid crisis (Categories IV and V below).

In addition, RTI International was awarded \$1.5 million to support forensic activities that will address the opioid crisis through the NIJ Forensic Technology Center of Excellence program.

#### Paul Coverdell Forensic Science Improvement Grant Program (\$17.0 Million)

OJP is making up to \$17 million available to support forensic activities related to opioids under the Paul Coverdell Forensic Science Improvement Grant Program. NIJ expects Coverdell grant funds to be used, in part, by medical examiners/coroners and forensic laboratories to address the dramatic increase in deaths and the backlogs of seized drugs as a result of the opioid crisis. Laboratories are overwhelmed with drug seizures and requests for toxicological analysis in opioid-related crimes and deaths, which in turn puts pressure on other laboratory sections. Also, medical examiners and coroners are required to conduct unprecedented numbers of autopsies and expend other resources in dealing with opioid deaths. Most of the funding is being provided to states on a formula basis. Awards made under the Coverdell Competitive program include the following<sup>3</sup>:
