JUSTICE DEPARTMENT AWARDS OVER \$62 MILLION TO SUPPORT HEALTH AND SAFETY OF LAW ENFORCEMENT OFFICERS

Bulletproof Vest Partnership Program (\$21.1 million)

More than million \$21 million was allocated to 5,280 jurisdictions across 49 states and Puerto Rico under OJP's Bulletproof Vest Partnership Program, which reimburses states, counties, federally recognized tribes, cities and local jurisdictions for up to 50 percent of the cost of body armor vests purchased for law enforcement officers. Since 1999, over 13,000 jurisdictions have participated in the BVP Program, with a total of \$467 million in federal funds for the purchase of over one million vests (1,349,813 as of January 2019). Law Enforcement Safety and Wellness Programs (\$14.8 million)

OJP's Bureau of Justice Assistance is providing more than \$14.8 million to support the National Officer Safety and VALOR initiatives. Of this funding, under the *Officer Robert Wilson III Preventing Violence Against Law Enforcement Officers and Ensuring Officer Resilience and Survivability (VALOR) Initiative*, \$7.2 million will be awarded to two organizations to provide education, training and other resources to enhance law enforcement officer safety:

- The Institute for Intergovernmental Research will receive \$6,649,651 to enhance the VALOR Program's portfolio of innovative on-site and online officer safety and wellness training, resources and services. This organization will receive an additional \$2 million to focus on developing and delivering a national program focused on preventing officer suicide.
- The Board of Trustees of St. Petersburg College will receive \$550,349 to educate law enforcement on promising officer safety, resilience and wellness programs.

Additionally, \$3.4 million of VALOR supplemental funding was awarded to two organizations: the International Association of Chiefs of Police (\$2 million) and the Police Foundation (\$1.4 million).

Under the 2018 National Officer Safety Initiatives Program, BJA is providing more than

\$4.2 million to four recipients to address officer safety and survival through a multifaceted approach, including national research, analysis and development of recommendations on law enforcement suicide prevention. Recipients include:

- The International Association of Chiefs of Police will receive \$1.5 million to develop health and wellness resources and deliver them to law enforcement agencies.
- Virginia Center for Policing Innovation will receive \$1 million and Polis Solutions, Inc., will receive \$750,000 to evaluate and improve defensive tactics trainings for law enforcement agencies and training academies.
- The National Crime Prevention Council will receive \$1 million to design and implement a messaging, education and community engagement program around the theme that driving down violent crime is a shared responsibility between communities and law enforcement.

Body-Worn Camera Program (\$23 million)

BJA awarded nearly \$20.53 million to 82 law enforcement agencies under its *Body-Worn Camera Policy and Implementation Program*. Funding will enable grantees to improve their capacity to gather evidence and protect the safety of law enforcement officers and citizens. Recipients include:
