



Ohio Arrest-Related Deaths, 2008-2010

The Office of Criminal Justice Services submits arrest-related deaths data for the state of Ohio annually to the Bureau of Justice Statistics to be included in the federal Arrest-Related Deaths Program. This report is a summary of Ohio arrest-related deaths from 2008 to 2010.

Background

An arrest-related (ARD) death is defined as a death that occurs anytime a person's freedom to leave is restricted by state or local law enforcement. Arrest-related death incidents include:

- ❖ A death that occurs before law enforcement personnel establish physical custody or before a formal arrest process is initiated.
- ❖ A death that occurs while attempting to elude law enforcement personnel during the course of apprehension (e.g., police chases involving action by law enforcement personnel such as deploying tire deflation devices, and standoffs).
- ❖ A death caused by any use of force by state or local law enforcement personnel, as well as those not directly related to actions of law enforcement, such as deaths attributed to suicide, accidental injury, and illness or natural causes.
- ❖ A death that involves law enforcement assistance in restraining and transporting individuals in need of medical or mental health care.

Deaths that occur in a jail or other long-term holding facility and deaths that occur in the custody of federal law enforcement officers are outside the scope of the ARD program and are not collected by OCJS¹.

Methodology

The data collection cycle begins January 1 and ends December 31. OCJS researchers rely on multiple sources to collect ARD data; but media reports are often used for initial identification. Official autopsy reports are then requested via fax from the appropriate county coroner. Once these reports are received four weeks to six months following the death, final incident reports are completed.²

In some cases, coroner's offices are proactive and submit reports to OCJS of deaths they believe to qualify under the ARD program. Some of these reports have been excluded from this summary because they do not meet the parameters of an ARD.

HIGHLIGHTS

Manner of death (Figure 1)

- ❖ From 2008 – 2010 there were 88 arrest-related deaths in Ohio. Homicide by law enforcement personnel accounted for 61 (69%) of reported arrest-related deaths.
- ❖ Suicide accounted for approximately 24% of reported arrest-related deaths.
- ❖ Accidental injury caused by the decedent³ or others⁴ on the crime/arrest scene accounted for approximately 5% (4) of all reported arrest-related deaths.

Decedent characteristics (Tables 1 and 2)

- ❖ Eighty-four, or 96% of all arrest-related deaths were males.
- ❖ Whites accounted for 58% of arrest-related deaths while blacks made up approximately 40%.
- ❖ Persons between the ages of 25 and 34 accounted for 33% of arrest-related deaths. Persons in the age range of 35 – 44 accounted for the second largest amount with 24% of all arrest-related deaths.

Manner of death and decedent characteristics (Tables 3 and 4)

- ❖ Decedents between the ages of 25 – 44 accounted for 36 (59%) of reported arrest-related homicides by law enforcement and 13 (62%) of reported arrest-related suicides.
- ❖ Approximately 76% of reported arrest-related suicides were white decedents; 24% were black.
- ❖ 85 out of 88 decedents died of injuries only.

Ohio counties (Tables 5 and 6)

- ❖ Between the years 2008 and 2010, Cuyahoga County accounted for 24% of all arrest-related deaths. Nineteen percent occurred in Franklin County and approximately 11.5% took place in Lucas County.
- ❖ At least one arrest-related death occurred in 26 Ohio counties.

Incident circumstances (Tables 7 and 8)

- ❖ In 69% of arrest-related deaths, charges were intended to be filed against the decedent.
- ❖ Among arrest-related deaths, approximately 57% of decedents allegedly engaged in violent offenses.
- ❖ In approximately 19% of the arrest-related incidents, no devices were used by law enforcement personnel.
- ❖ The most commonly used device by law enforcement during arrest-related incidents was a firearm.
- ❖ Of persons who died from injuries only, 24% were self-inflicted by suicide. Seventy-three percent were inflicted by law enforcement at the crime/arrest scene.
- ❖ Approximately 55% of decedents expired at the crime/arrest scene while 42% died at a medical facility.

Law enforcement agency characteristics (Tables 9-12)

- ❖ Nine reported arrest-related death incidents involved law enforcement personnel from multiple agencies.
- ❖ Local police departments were involved in approximately 90% of reported arrest-related death incidents.
- ❖ Law enforcement personnel from sheriff's offices were involved in approximately 24% of reported arrest-related suicide deaths.
- ❖ Of the 58 law enforcement agencies involved in reported arrest-related death incidents, 34 employed between 25 – 99 full-time sworn personnel.

Figure 1 – Percent of arrest-related deaths, by manner of death, 2008-2010

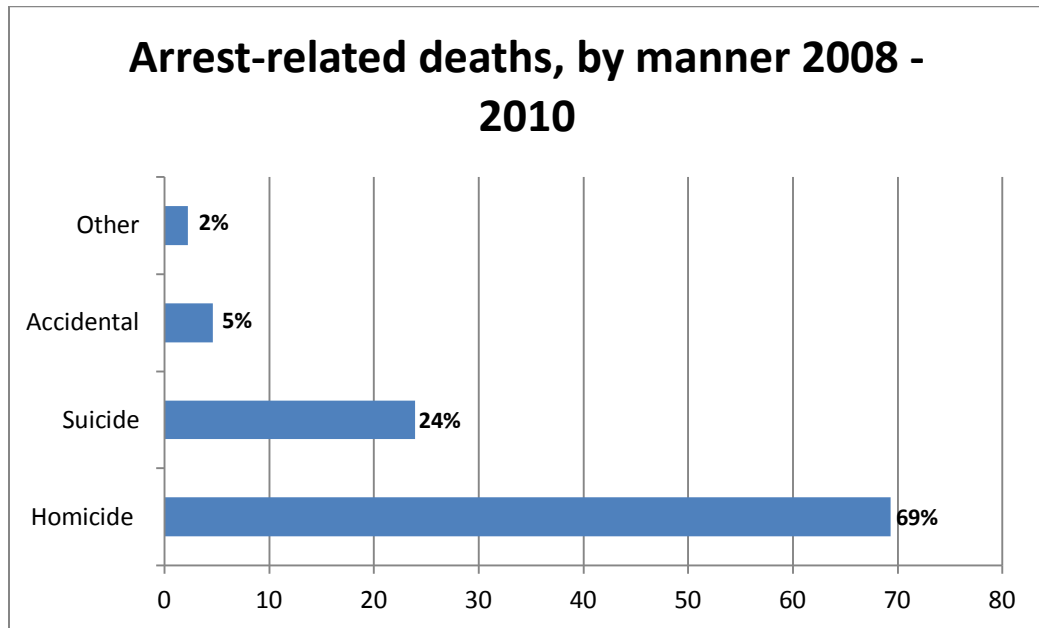
