## INTRODUCTION

This is the third edition of the Directory of New York State Criminal Justice Agencies, a product of the Office of Policy Analysis, Research and Statistical Services of the New York State Division of Criminal Justice Services. The Directory and the companion Directory of New York State Criminal Justice Information Sources is produced by the Bureau of Criminal Justice Statistical Services under a cooperative agreement with the United States Department of Justice's Bureau of Justice Statistics. The purpose of the agreement is to improve the transfer and communication of criminal justice information between federal, state, local, and private criminal justice organizations.

This Directory is intended to provide concise and useable address listings of major criminal justice agencies in the State. In addition to addresses, telephone numbers and the names of the agency Director (with the exception of judges under the court listings) are provided for each organization.

This edition provides listings in two new areas. They are; regional parole offices and county youth bureaus. The listings are divided into eight major categories: Law Enforcement, Prosecution and Defense, Courts, Corrections, Parole, Probation, Youth, and State Level Criminal Justice Agencies. These are further subdivided where appropriate. Note that Sheriff Departments are listed in the Law Enforcement category even though most operate correctional facilities at the county level. Within sub-categories, agencies are listed alphabetically; State Police Troop Headquarters are listed alphabetically by the troop letter designation (with the exception of Manhattan, which is located at the end of the list).
