

This report covers the four month period beginning September 15, 1986. During this period about 2,400 citizens contacted the office. Information and referral assistance satisfactorily addressed the citizens' needs in all but one hundred and sixty-five of the contacts. In those instances the citizens' problems were documented as complaints. The complaints and resolutions are briefly described in this report.

This report also marks the end of the 1986 reporting period. Therefore, included in this report is a summary and brief over-view of issues that surfaced during the 1986 complaint investigation process and which merit bringing to your attention.

### 1986 OVER-VIEW

Approximately 8,000 citizens contacted this office in 1986. The majority of the citizens simply needed information on how or where to obtain a service. Information and referral assistance was provided and the citizens went happily on their way. About 1,000 citizens had problems that were not so easily resolved. In those instances Ombudsman inquiry was initiated and the citizens' problems were documented as complaints. The complaints requiring the most extensive investigation and that were the most difficult to resolve were land use related.

### RAVINES AND EROSION

Severe erosion problems are appearing related primarily to drainage from subdivision construction. This problem is occurring in seven of the nine Council districts; districts not affected are two and five. Parks, Planning, and Resources is in the process of identifying those sub-basins having a high risk of very severe stream channel erosion as a result of development.\*

Unfortunately, several of those basins have already been impacted by development. Mini "canyons" thirty to sixty feet deep have been created as the increased run-off resulting from development is concentrated into the ravines. Truckloads of sand and gravel have been washed onto downstream properties in the process. In one instance as much as 800 yards of gravel was washed onto the property below in a month's time.

The County's Surface Water Runoff Policy requires that "The drainage course for a minimum distance of one-fourth mile downstream from the development must be evaluated for its capacity to pass the Design storm flow after completion of development." A ravine obviously has the capacity to accommodate an increased flow. Therefore, problems associated with using the ravines to accommodate the storm drainage from new development was not perceived as a problem until recently. It is now recognized that the ability of the highly erodible soils in the identified basins is severely limited in its ability to accommodate increased drainage flows.

In the undeveloped state, drainage seeps through the soil layers of the drainage basins and is carried in many separate, natural drainage channels. Clearing and grading alters the topography and compacts the soils. Impervious surfaces such as houses, patios, and streets replace the trees and cover the soils. Evaporation and transpiration that occur in a naturally forested area is eliminated. Development thus increases the amount of drainage and also concentrates it through drainpipes and culverts.

<sup>\*</sup> The identification is complete in the Bear Creek and Snoqualmie Community Planning areas. It is estimated that approximately 10% of these areas have the potential for severe erosion. Farther west, the percentage of land so affected appears to be somewhat less than in the Bear Creek and Snoqualmie areas.

Retention/detention systems in the new developments control the rate of release of the drainage, but significantly more water is discharged into the basins over shorter periods of time as development occurs. As a result, the sandy soils in these basins erode swiftly and dramatically. Deep incising of drainage channels, slumping or sliding of banks, and build-up of silt and gravel on downstream properties then occurs.

The Surface Water Runoff Policy also provides that where the Department has determined the "existing flooding, drainage and/or erosion conditions present an eminent likelihood of harm to the welfare and safety of the surrounding community," developments shall meet special drainage conditions set by the department. Many of the basins having erosion problems have now been identified and staff has recognized the problem. However, no formal designation of these sub-basins has yet been made and application of necessary controls authorized by the ordinance will be controversial in that any remedy will be costly.

### IMPACTS OF DEVELOPMENT DRAINAGE ON DOWNSTREAM PROPERTIES AND ROAD SYSTEMS

Complaints also indicate that road culverts, ditches and road drainage systems are frequently non-existent, or inadequate to handle the increased runoff from new development. When the increased flows are not accommodated, the downstream road system and downstream properties are impacted. This can include the areas identified as having highly erodible soils.

The Surface Water Runoff Policy requires consideration of impacts for a minimum distance of one-quarter mile downstream. The requirements placed on developers typically do not consider the impact outside the one-quarter mile distance, although the road drainage system beyond that point may be inadequate or non-existent. The cost of providing off-site accommodation for development drainage can be of significant cost. It is therefore difficult for staff to impose this cost whether the impact occurs within or without the one-quarter mile distance.

The road system and downstream properties are then impacted in several ways. Increased, concentrated flows through culverts can cause severe erosion on private properties. Drainage that once meandered slowly around a bend and into a culvert may now reach the culvert traveling at such velocity that the water cannot make the turn into the culvert. In such cases there is erosion or scouring of the property upstream of the culvert and back up of the water onto adjacent properties. The downstream property may also have erosion damage and flooding from the concentrated flow through the culvert. Where no drainage system is in place, the runoff may travel along the road shoulder for a distance then take the path of least resistance over private property. Property damage typically results.

The affected property owners perceive their drainage problems as originating from the County road system and demand that Public Works fix the problem.

However, County road funds are used to do such work only when the direct cause of the impact is the road system, or if the road system is impacted by the drainage. Drainage problems caused by development usually do not meet the interpretation of that criteria.

In the cases we have investigated, the problems of erosion or inadequate downstream drainage facilites did not become apparent until individual lot construction began. The plat had received final approval and the plat bonds had been released. County control at that point is limited to building permits.

Who Should Pay? Some think the Surface Water Management utility should be directed to spend a percentage of annual revenues on mitigating the erosion and road drainage problems.\* Others suggest that developers pay a downstream impact fee that would be used to upgrade County road drainage systems and provide control and conveyance in the erosion problem areas in the basins they are developing. Still others think it should be up to the downstream property owners to deal with the problems any way they can.

Given the magnitude of the problems, policy direction from elected officials is needed to determine how the costs of solutions should be borne and whether present policy, criteria and ordinance language is being correctly interpreted and applied. Additionally, it appears that it would be helpful to strengthen the Critical Basin and the Sensitive Areas mapping ordinances to reflect the current knowledge of erosion likely to occur as the identified erodible drainage basins are developed.

#### LOT DRAINAGE

The effectiveness of plat drainage controls can be significantly diminished by inadequate control of individual lot development. Recontouring and grading of the lots by builders or owners can block drainage causing water to pond in yards. Failure to provide footing drains or to tie downspouts and footing drains into drainage systems can also cause ponding, soggy lawns, and drowning of landscape plants. On steep terrain uncontrolled lot drainage can sheet-flow over streets causing hazardous driving conditions, particularly in freezing weather.

Efforts are underway in Building and Land Development to educate building permit and inspection staff to the problems that can result from individual lot drainage. This seems a good time then for consideration of legislation in support of the individual lot drainage inspection process.

<sup>\*</sup> Most of the Bear Creek and Snoqualmie problem sites lie outside of the present boundaries of the Surface Water Management utility area. Though serious erosion problems presently exist there, SWM utility monies cannot be used to address the problems in those areas at this time.

#### JAILHOUSE BLUES


We received over 3,000 calls from inmates in the Jail in 1986. We have attempted to reduce the calls by restricting the Jail Speed Dial incoming calls to one line. Calls are, however, continuing to come in at the rate of approximately twelve calls a day. The problems are related primarily to over-crowding. The over-crowded conditions affect staff's ability to provide for visiting, recreation, uniforms or to organize for more efficient operation. There are simply too many demands on staff and not always enough staff, supplies or facility space to meet the demands.

The length of time prisoners are held in the booking area continues to be of particular concern. Twenty or more persons may be held in a ten person cell for twelve or more hours. Seating capacity is for ten persons. Half or more of the prisoners must sit or lie on the concrete floor. Meals served are "brown bag." DAD staff has tried several strategies to deal with the backlog; including rotating staff. None of the strategies made a significant difference. The backlog appears primarily related to staff ratio to incoming prisoners, rather than to competence or process. The performance audit presently being conducted by the County Auditor's staff will be helpful in identifying the exact causes and cures for this on-going problem.

Visiting continues to be a source of complaint. Because the Jail is over-crowded, there are not enough visiting booths to provide the required three hours of visitation per prisoner each week. Visits are regularly cut short. Some visitors are denied opportunity to visit; particularly those who do not arrive half an hour before the scheduled visiting time. This situation creates stress and conflict for staff, inmates and visitors. Efforts have been made to staff the Reception area with persons who can handle the stress and still be pleasant with the public. This has reduced the number of complaints, but the problem of shortened or denied visits is still there.

Complaints indicate there is a problem controlling contraband coming into the Work Release facility. Drugs and weapons have been found in the facility. Random urinalyses and searches are being conducted. However, to stop the contraband problem all Work Release prisoners should be searched when they return to the facility. Jail staff says they are not able to search each person because they do not have enough staff to do so. This problem needs to be addressed.

County staff in all departments were cooperative and helpful in addressing citizen complaints in 1986. Their continuing cooperation and assistance is appreciated.



#### EXPLANATORY NOTE

### Complaints

Complaints (allegations) are listed by agency. In those cases when more than one agency was involved in the same complaint, the complaint will be listed under each agency. The County Council District in which the complainant resides is listed with the exception of those complainants who do not wish to give their address or who reside out of the County.

### Assists

An assist designation indicates that a complaint was resolved with a quick phone call, letter, or research by Ombudsman staff resulting in fairly immediate resolution of a complaint. No paperwork is routed to the director of the agency involved. The assist category was developed in response to suggestions from members of the Council's Operations, Police, and Judiciary Committee and from Executive departments that paperwork be reduced for the relatively minor and repetitive complaints.

### "Discontinued" Designation

A discontinued designation typically is assigned when at some point during our inquiry into a complainant's allegation, the complainant decides to drop the complaint, or fails to respond to our request for additional information, or we discover that the complaint is already being appropriately addressed by another agency.

### "Open" Designation

When a complaint has been concluded, the disposition is stated in the report. Complaints that were not concluded by the end of the reporting period are shown as "open."

#### Numbering System

Complaint numbers contain a key to the year and the month we received the complaint. The first two digits indicate the year (86 equals 1986). The second two digits indicate the month (11 equals November). The last three digits indicate the chronological order of the complaint within each month. Thus, 8611-009 refers to the ninth complaint received in November, 1986.
