A COMPARISON OF THE YOUTH AUTHORITY'S
INSTITUTION AND PAROLE POPULATIONS

June 30, 1977 through June 30, 1986

INTRODUCTION

Special Note

In this report the terms "CDC cases" and "CYA cases" are used extensively. "CDC cases" are offenders who have been committed to the Department of Corrections, but who are ordered by the criminal court to be housed in Youth Authority facilities pursuant to Section 1731.5(c) of the Welfare and Institutions Code. "CYA cases" are offenders who have been committed directly to the Youth Authority by either the criminal court or the juvenile court.

The following narrative and accompanying tables provide information on the characteristics of the Youth Authority's institution, camp and parole populations as of June 30 of each year, 1977 through 1986. Unless otherwise stated, only the 1985 and 1986 institution and camp populations reflect both CYA cases and CDC cases. CDC cases are included in the tables only where specified, and only for 1985 and 1986. Because of incomplete data, the following types of cases have been excluded from the populations:

- o Cases housed in Department of Mental Health facilities
- o Parole revocations being held in county jails
- o Incoming commitments awaiting delivery to a Youth Authority facility
- o Absentees from the institutional setting (i.e., out-to-court, furlough, escape, etc.)
- o Out-of-state parolees residing in California
- o Institutional contract cases (federal or out of state)
- o Parole cases on temporary detention are excluded from institutional figures, but are counted in the parole tables.

The characteristics compared include committing court, county of commitment, admission status, ethnicity, Youthful Offender Parole Board (YOPB) status, average age, and the following categories of commitment offenses:

Violent Offenses: Homicide, robbery, all types of assaults, forcible rape, and kidnapping.

Property Offenses: Burglary, theft (including auto), and arson.

Narcotic and Drug Offenses: All offenses related to narcotics and dangerous drugs.

Other Offenses: All offenses not specified above.

The area of commitment format has been changed from previous years' reports to reflect county of commitment by potential Youth Authority parole region.

Tables are provided for the total populations in the camps and in the institutions. Due to the small populations in Silverlake, El Centro, northern county facilities, SPACE, Federal and Department of Corrections institutions, separate tables were not tabulated. However, these data are included in the overall total tables (1 through 3).

HIGHLIGHTS

To reduce the pressures of increasing population, the Youth Authority implemented a policy in 1981 of rejecting many of the more serious commitments from the criminal courts. This policy continued through late 1982 when it was discontinued due to the passage of Proposition 8, which barred a majority of these cases from commitment to the Youth Authority.

In January 1984, Senate Bill 821 became effective as Welfare and Institutions Code Section 1731.5(c). Under this section, commitments to the Department of Corrections (CDC) are ordered by the sentencing courts to be placed in Youth Authority facilities to serve their sentences. These cases remain in the Youth Authority institutions until they are ordered returned to CDC facilities (usually for disciplinary reasons), their sentence is completed, or they reach the age of 25. Since these cases are not under the jurisdiction of the Youthful Offender Parole Board (YOPB) or Youth Authority parole, they are not included in the parole population.

Until excluded from admission in March 1986, some of the CDC cases may have had a prior Youth Authority commitment. However, for the purposes of this report, they are treated as first commitments. Consequently, any changes in characteristics from 1981 through 1986 must be interpreted in light of these developments.

- The 1986 fiscal year-end population of 7,536 is the largest number of offenders housed in Youth Authority facilities in its history. This increase is primarily due to the CDC cases, which comprised 19 percent (1,410) of the Youth Authority's total institutional population.
- The proportion of minorities in the institutional population increased from 64 percent in 1977 to 71 percent in 1986.
- During the period 1977-1981, the proportion of criminal court CYA cases in the institutional population fluctuated between a low of 43 percent and a high of 48 percent. In 1982, it dropped to 40 percent as a result of the Department's rejection policy, and has continued to drop to the current 14 percent, as a result of Proposition 8 and Welfare and Institutions Code Section 1731.5(c).

SUMMARY

This ten-year summary includes the fiscal year ending figures for the period June 30, 1977 through June 30, 1986. The distinct changes which have occurred in the Youth Authority's population over these years are as follows:

POPULATION

The institutional population has nearly doubled during the ten years shown, from 3,818 in 1977 to 7,536 in 1986. The largest increase of 16 percent occurred during the last fiscal year, from 6,474 on June 30, 1985 to 7,536 on June 30, 1986. In contrast, the parole population has decreased by approximately 33 percent since 1977, from 7,548 to 5,029 in 1986. The largest decrease of 19 percent occurred during the last fiscal year, from 6,188 on June 30, 1985 to 5,029 on June 30, 1986.

SEX

Over the ten-year period, female offenders comprised four to five percent of the institutional population. The female parole population was about six percent in 1977 and has since decreased to four percent.

COURT OF COMMITMENT

During the period 1977-1981, the proportion of institutionalized criminal court commitments has fluctuated between a low of 43 percent and a high of 48 percent. Since 1982, the number of CYA case criminal court commitments dropped significantly as a result of the Department's rejection policy, Proposition 8, and Welfare and Institutions Code Section 1731.5(c). Although the overall criminal court institutional population, including CDC cases, rose to 33 percent in 1986, only 14 percent were direct Youth Authority commitments. Sixty-seven percent of the 1986 population were committed from the juvenile courts.

From 1977 to 1986, the percentage of juvenile court commitments on parole increased steadily from 49 percent in 1977 to almost 66 percent in 1986. Conversely, the percentage of criminal court commitments on parole has steadily decreased from 51 percent in 1977 to 34 percent in 1986, primarily as a result of the decrease in the number of commitments.

COUNTY OF COMMITMENT

The largest proportion of the Youth Authority's population has always been from Los Angeles County. The percentage of the institutional population from Los Angeles County ranged from a low of 38 percent in 1977 to a high of 49 percent in 1984. The percentage of the parole population from Los Angeles County ranged from a low of 32 percent in 1977 to a high of 41 percent in 1985.

Commitments from other counties in the Southern California area has dropped in recent years; from 19 percent of the institutional population in 1977 to 14 percent in 1986. The parole population from Southern California also declined from 25 percent in 1977 to 14 percent in 1985, although there was a slight rise to 15 percent in 1986.

San Francisco Bay Area commitments have comprised between 18 and 24 percent of the institutional population and between 22 and 26 percent of the parole population.

The other Northern California area commitments ranged from 16 to 20 percent of the institutional population and 18 to 22 percent of the parole population.

COMMITMENT OFFENSE

The commitment offense perhaps best illustrates the fluctuations in the composition of the Youth Authority's population during the ten-year period.

The proportion of offenders institutionalized for violent offenses increased from 55 percent in 1977 to 61 percent in 1982, then decreased to 49 percent in 1986. The proportion of offenders on parole for violent offenses increased from 43 percent in 1977 to almost 50 percent in 1983, but gradually declined to 47 percent by 1986.

Those offenders institutionalized for property offenses have fluctuated between a high of 41 percent in 1979 and a low of 34 percent in 1982. By 1986, the proportion of those committed for property offenses increased to 39 percent. The proportion of property offenders on parole increased from 41 percent in 1977 to 48 percent in 1980, then declined steadily to less than 43 percent of the parole population by 1986.

Commitments for narcotic and drug offenses declined in the early 80's (to approximately two percent), but has steadily increased to about seven percent by 1986. Those on parole for narcotic and drug offenses declined from five percent in 1977 to two percent in 1983, then rose back up to five percent by 1986.

ADMISSION STATUS

The proportion of first commitments in the institutional population gradually increased from 80 percent in 1977 to 86 percent in 1981. This percentage began falling after 1981 (78 percent in 1984) because of the considerable increase in parole revocations and a decrease in direct criminal court commitments. The percentage of first commitments rose to 80 percent in 1985 and 1986 due to the inclusion of CDC cases as first commitments.

The proportion of offenders on parole for the first time remained fairly constant for the first five years (79 to 80 percent), rose to 82 percent in 1982 and 1983, then declined to 77 percent by 1986.

Those on parole for the second time increased from 15 percent in 1977 to almost 20 percent in 1986, while those on parole for the third time or more decreased from seven percent in 1977 to four percent in 1986.

ETHNIC GROUP

The percentage of institutionalized Whites has dropped from a high of 36 in 1977 to a little over 28 percent of the 1986 population. In contrast, there has been an upward trend in the proportion of institutionalized minorities,

from 63 percent in 1977 to 71 percent in 1986. The Hispanic population rose gradually over the years, from 26 percent in 1977 to 33 percent in 1984. Hispanics comprised approximately 31 percent of the 1986 population. The Black population proportion has remained relatively constant at about 38 percent.

The parole population has followed a trend similar to that of the institutional population with the proportion of Whites dropping from 41 percent in 1977 to 31 percent in 1986. The proportion of Hispanics increased from 21 percent in 1977 to 31 percent in 1986. The Black population has remained relatively constant at about 35 percent.

YOUTHFUL OFFENDER PAROLE BOARD (YOPB) STATUS

The percentage of the institutional population with Full Board designations increased significantly over eight years, from 44 percent in 1977 to 54 percent in 1984. This is consistent with the increase in the proportion of offenders committed for violent offenses. However, in 1986 only 12 percent of the institutional population was on Full Board status. This significant decrease is due to a change in YOPB's board designation policy begun in 1985, which classifies offenders into categories by their committing offenses with only the most serious being placed on Full Board status. Since the YOPB does not have jurisdiction over CDC cases, this data is for CYA cases only.

AVERAGE AGE

Over the past ten years, the average age of the institutionalized population has increased from 18.6 in 1977 to 19.0 years in 1986. This change is primarily due to a larger proportion of the older aged CDC cases in the population.

The average age of the parole population has increased only slightly, from 20.2 in 1977 to 20.7 in 1986.
