## ABSTRACT

AB 144 (Naylor, 1985) requires that the court consider a blood alcohol concentration (BAC) of .20% or more as a special factor to consider in enhancing penalties when sentencing drunk drivers. This interim report (due six months following enactment of AB 144) summarizes the tabulations of sanction severity by BAC level for first DUI offenders, both prior and subsequent to the enactment of AB 144 and by the offender's license status at the time of the DUI arrest (valid vs suspended license). Due to apparent data discrepancies in the sanction dispositions of second DUI offenders, the results of the second offender analysis are not included in the interim report. The source of the errors will be identified and corrected for the final report.

Only DUI offenders with reported BAC levels were selected for analysis. (Because of court omissions and/or unavailability of BAC information, only 41% of all DUI convictions contained the offender's blood alcohol concentration level.) While the data for first offenders indicate a trend for high BAC drivers to receive enhanced penalties and while this trend tended to increase following the enactment of AB 144, additional data and longer-term analyses are needed before drawing firm conclusions and interpretations. These conclusions will be made in the final report, which will also present an analysis of variations in sanctions across county.

AB 144 (Naylor, 1985), enacted on September 30, 1985, requires that the court consider a blood alcohol concentration (BAC) of .20% or more or a refusal to take a chemical test as a special factor to consider in enhancing penalties when sentencing DUI offenders. This bill also required the Department of Motor Vehicles to compile statistics on the disposition of cases by reported BAC levels and to produce an interim and final report, at the end of six and twelve months, respectively, following the enactment of AB 144. The complete bill is shown in Appendix A.

The purpose of this interim report is to summarize the data collected to date. Tabulations of sanction severity by BAC level are provided for first offenders prior and subsequent to enactment of AB 144. As requested by the bill, the report also tabulates the sanction and BAC distributions by license status (invalid vs. valid). Results for the second offender analysis were not included in the interim report due to apparent discrepancies in the second offender disposition information contained on the Department's DUI offender data base.

Because of the interim nature of the report and the short post-AB 144 follow-up period, no attempt is made to interpret the results or draw conclusions regarding the impact of AB 144 on DUI sanction severity. Formal "tests of significance" have not been applied to the data nor has any attempt been made to evaluate variations across county. These analyses will be made in the final report.

#### Subject Selection

DUI subjects were identified by their recorded DUI convictions on the monthly DMV BAC and Suspension and Revocation tapes of December 1984 and January 1985 for the pre-AB 144 subjects and of the same months one year later for the post-AB 144 subjects. These DUI conviction tapes represent all DUI convictions reported to DMV by the courts. Subjects for this report were selected only if they had a reported BAC level and if their conviction dates occurred after September 30th in both time periods.

Since DUI offenders with a felony conviction receive a narrower and more stringent range of sanctions, they have been excluded from these analyses.

Felony DUI convictions are also relatively infrequent, representing only less than 1% of all DUI adjudications.

### Reporting of BAC Levels

Although the courts are required by law to report BAC levels to DMV "when it (the information) is readily available to the clerk of the court," (CVC 1804) the data notably indicate that court reporting of BAC levels is not very complete. Table 1 shows that the percentage of subjects with reported BAC levels in the pre-AB 144 period was 41.5 while it was 40.7 in the post-AB 144 period. Since only 9 to 10% (Sadler, 1985) of all persons arrested for DUI refuse to submit to chemical testing, the majority of the non-reporting represent court procedural problems or the court's decision not to report the information. This low level of reporting limits the validity of these statistics, particularly if reporting were selective (e.g., higher BAC levels might be reported more often than low BAC levels or vice-versa). The results, therefore, may not be applicable to the entire population of offenders with BAC levels of .20 or more.

### Disposition Code Combinations

When an offender is convicted of a DUI offense, the court determines the sanctions to be imposed upon the DUI offender, and these sanctions are indicated by the disposition codes on the abstract of convictions. Typical patterns of disposition combinations are shown on the attached tables. The codes listed here comprise the sanctions of primary interest, although additional disposition codes are reported on each conviction abstract. For example, most DUI offenders pay a fine, but the code indicating 'fine' is not shown here. It should be noted that the license suspension disposition categories (D, X or Y) do not represent all suspended offenders since DMV suspends the license of offenders in certain cases regardless of the court's recommendation. Specifically, the vehicle code requires that all second offenders in the GJ, J and "all other" sanction categories be suspended by DMV. First offenders who show any codes without probation (G) also must be suspended by DMV, whereas DMV would not suspend those given probation (G) unless a D, X or Y is shown. In 1982, a change in the law (CVC.13201.5) repealed the court's authority to suspend licenses (D), but some D's continue to appear on driver records.

### First DUI Offenders

Table 2 shows the frequency counts and percentages of first DUI offenders with valid licenses(1) who received various 'court-ordered' sanctions. The upper table represents drivers whose DUI convictions occurred before AB 144 while the lower table displays the corresponding numbers and percentages for drivers whose DUI convictions occurred after the enactment of AB 144. It is evident from Table 2 that 70% of first DUI offenders from both time periods, where BAC levels were reported, have BAC levels below .20% while about 30% have reported BAC levels above .20%. The largest proportion of first offenders in both time periods received the sanction of license restriction (90 days) plus program (GSTVQ). However, when comparing the two time periods, the percentage of post-AB 144 subjects receiving the restriction plus program sanction was lower (44.4%) than those (49%) in the prior time

period. Since significance testing is being deferred to the final report, the reader is cautioned not to interpret this and other variations as necessarily representing a true or reliable difference. In both time periods, a greater proportion of those with high BAC levels received the jail sanctions (GQJ,GJ) compared to those with low BAC levels. This difference was more marked in the Post-AB 144 time period. Slightly fewer offenders received court-ordered suspensions (D, X, or Y) in the post-AB 144 time period than in the earlier time period, for both BAC levels.

Table 3 shows frequency counts and percentages of first offenders receiving the various sanctions for drivers convicted of CVC 14601 (driving with a suspended or revoked license) at the same time that they were convicted of the DUI offense. Such offenders are termed "invalid" licensees for the purpose of this report. It is important to note, however, that the procedure used to identify suspended licensees would not include suspended drivers who were not convicted of a 14601 offense by the court. It is known from other research (Helander, 1986) that the majority of offenders who are under suspension at the time of a DUI arrest are not convicted of a CVC 14601 charge. As a result, some offenders in the "valid license" category were actually suspended at the time of arrest.

Looking at both the upper (pre-AB 144) and lower (Post AB 144) tables, it is evident that the largest percentage of these drivers, regardless of BAC level, received the program plus jail sanction (GQJ). In the post-AB 144 period, 66% of those with high BAC levels received this sanction as compared to 52.3% of those with low BAC levels. In contrast, the pre-AB 144 period showed an opposite trend with lower BAC subjects more often given a jail sanction. As might be expected, a comparison of Tables 2 and 3 shows that the license suspension recommendation was more often applied to offenders with invalid licenses than to those with valid licenses. There was a corresponding reduction in the use of the license restriction plus program sanction (GSTVQ) for offenders with suspended licenses.

#### Comparison of Jail Days

Table 4 shows the average number of jail days among first offenders (both valid and invalid licensed drivers) by reported BAC levels and pre-and post-AB 144 time periods. Conclusions from these findings should be guarded

since courts are not required to report to DMV the number of jail days imposed on DUI offenders and many courts use community service in lieu of actual jail time. The mean for jail days is calculated without cases where jail was not used or where the term was not shown. (33.3% of cases in the prior group showed the number of jail days reported while 39.5% of the post-AB 144 group had jail days reported.) It should be noted that the imposition of jail time is an option for first offenders whereas it is mandated for all second offenders.

From Table 4, it is evident that, for valid licensed first offenders, the average number of jail days was greater in the post-AB 144 period as compared to the earlier time period for both BAC groups. For invalid licensed drivers, the two time periods showed no change but that those with high BAC's were given longer jail terms. Since the number of invalid licensees is very small, little confidence can be placed in the pre-post difference by BAC level.

### Dispositions by County

Although tables of sanction codes by county are included in Appendix B for first offenders, the small sample size does not permit adequate interpretation of the findings. These tables were included primarily to indicate the structure and scope of the information to be provided in the final report. The final report will also include county tabulations for second offenders.

### Conclusions and Scope of Final Report

For the reasons cited, it was not the intent of the interim report to offer conclusions and interpretations. There is some evidence, however, to show that among first offenders high BAC drivers tend to receive enhanced sanctions and that this trend increased following AB 144. Nevertheless, the trends are not very dramatic and require additional data and analysis before conclusions can be drawn. The final report will include about six months of additional data for both pre- and post- AB 144 periods. It will also analyze the trends within counties and will employ formal tests of significance in evaluating the reliability of the relationship and the magnitude of the impact of AB 144 on the sanction patterns.

Assembly Bill No. 144

CHAPTER 1256

An act to add Section 23206.5 to the Vehicle Code, relating to driving offenses, and declaring the urgency thereof, to take effect immediately.

[Approved by Governor September 29, 1985. Filed with Secretary of State September 30, 1985.]

LEGISLATIVE COUNSEL'S DIGEST

AB 144, Naylor. Driving offenses: blood-alcohol concentration.

(1) Under existing law, a person convicted of driving under the influence of an alcoholic beverage or drugs, or both, with an excessive blood-alcohol concentration, or when addicted, is required to be sentenced, as specified, and may be granted probation by the court. If granted probation, the time of probation is required to be 3 years, and the terms and conditions of probation are required to include at least specified incarceration periods, minimum fines, and, for some 1st and 2nd offenders, specified drivers' license restriction instead of suspension, which minimum terms vary with the number of convictions of prior offenses occurring within 5 years of the offense.

This bill would require the court to consider a blood-alcohol concentration of 0.20% or, or a refusal to take a chemical test by, a person convicted of any of those offenses as a special factor which may justify enhancing the penalties, or determining whether probation is granted, and, if granted, in determining the terms and conditions of probation.

(2) The bill would also require the Department of Motor Vehicles to compile and provide an interim report regarding specified statistics to the Legislature on December 31, 1985, or within 6 months after the effective date of the bill, whichever is later, and provide a final report regarding specified statistics to the Legislature on June 30, 1986, or within 12 months after the effective date of the bill, whichever is later.

(3) The bill would take effect immediately as an urgency statute.

*The people of the State of California do enact as follows:*

SECTION 1. Section 23206.5 is added to the Vehicle Code, to read:

23206.5. In addition to any other provision of this code, if any person is convicted of a violation of Section 23152 or 23153, the court shall consider a concentration of alcohol in the person's blood of 0.20 percent or more, by weight, or the refusal of the person to take a chemical test as a special factor which may justify enhancing the

penalties in sentencing, in determining whether to grant probation, and, if probation is granted, in determining additional or enhanced terms and conditions of probation.

SEC. 2. The Department of Motor Vehicles shall compile statistics on the reported disposition of cases in which the reported concentration of alcohol in the blood of a driver is 0.20 percent or more by weight and shall provide the Legislature an interim report on the results of the compilation on December 31, 1985, or within six months after the effective date of this act, whichever is later, and provide the Legislature a final report on the results of the compilation on June 30, 1986, or within 12 months after the effective date of this act, whichever is later.

The reports shall contain, to the extent practicable, a comparison of dispositions during the year prior to the effective date of this act with dispositions after that date. The reports shall also distinguish between dispositions of cases involving:

- (a) Blood-alcohol concentrations below 0.20 percent with those above that level.
- (b) First and second offenders.
- (c) Persons who drive without a valid license and those who drive with a valid license.

This section shall become inoperative 12 months after the effective date of this act and, as of January 1, 1987, is repealed, unless a later enacted statute, which becomes effective on or before January 1, 1987, deletes or extends the dates on which it becomes inoperative and is repealed.

SEC. 3. This act is an urgency statute necessary for the immediate preservation of the public peace, health, or safety within the meaning of Article IV of the Constitution and shall go into immediate effect. The facts constituting the necessity are:

In order for the requirements of this act, which require the court to consider greater alcohol consumption before driving as a more serious crime, to become effective as soon as possible, and to permit the Department of Motor Vehicles to complete the statistical study required by this act in the time required, it is necessary that this act take effect immediately.
