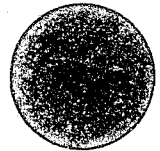

Abstract

This report presents a statistical description of the 3,022 offenders released to the street from a Massachusetts correctional facility during 1986. This report also presents some information on trends among releases over the last six years.

Some highlights of the information included in this report are:

- The 3,022 releases in 1986 represent an increase of 691 (30 percent) over 1985 releases and an increase of 1904 (170 percent) over 1981 releases.
- The number of males released during 1986 increased by 38 percent from last year, while the number of females released during 1986 increased by 10 percent.
- Fifty-nine percent were released by parole, 30 percent were discharged and 11 percent were released by expiration of sentence.
- Fifty-two percent were released from secure facilities and 48 percent were released from lower security facilities. Many of those released from secure facilities were females serving county sentences or male parole violators.
- The average time served was 55.3 months for individuals serving Cedar Junction sentences, 23.7 months for individuals serving Concord sentences, and 5.7 months for individuals serving Framingham sentences.

Introduction

This report is a statistical description of individuals released to the street from facilities of the Massachusetts Department of Correction during 1986. The tables which follow contain information on the nature of the present offense, personal background characteristics, criminal history, furlough program participation and release characteristics for these individuals. The information contained in these tables was derived from the computerized inmate data base and was produced by the Operations Research Unit on the Regent's Computer Network (RCN). Some information is also reported on trends in the release population over the last six years, 1981 to 1986.

Only those individuals who were released to the street by the authority of the Parole Board, by expiration of sentence, or by a certificate of discharge are included in the report. Individuals who were released to another correctional authority or to another sentence are not included. Individuals who were released by means other than parole, discharge or expiration are not included in the report. This includes releases by court order, death and escape. Individuals transferred to other correctional authorities to serve their sentences who were subsequently released are not included in the report; individuals transferred from other authorities who were subsequently released from a DOC facility are included in the report. Individuals who were released more than once during 1986 are counted as multiple cases in the report.

In reading the tables in this report, the reader should note the following: (1) the release population is divided according to the institution of release; (2) the top number in each cell represents the number of individuals who fall in the corresponding category in the table; (3) the bottom number in each cell represents the percentage of the number of individuals in a particular category to the total number of releases from that institution (column percents).

For example, upon referring to the table on page 34, committing institution is presented and the following types of information can be obtained:

- (1) the number of releases from each facility in 1986; and,
- (2) the number and percentage of releases from each institution who were originally committed to each of the committing institutions.

The reader should note that the rate of unknowns is relatively high for certain variables, especially certain social history variables. Caution should be used in interpreting these variables.

Releases From the DOC, 1981 to 1986

During the last six years the number of releases from the DOC rose dramatically, from 1,118 in 1981 to 3,022 in 1986. This represents an increase of 170 percent over this period. Table 1 (on pages 8 through 10) shows selected characteristics of releases for each year in this period. The increase occurred for both male and female releases. Male releases increased from 849 in 1981 to 2238 in 1986 (164 percent). Female releases increased from 269 in 1981 to 784 in 1986 (191 percent).

In 1986, 44 percent of all males were released from secure facilities and 56 percent were released from lower security facilities. This is similar to the pattern of releases over the previous five years. In contrast, 76 percent of the females were released from secure facilities and 24 percent from lower security facilities. This is similar to the pattern of prior years.

Most males released from the DOC were serving state prison or reformatory sentences, most females released from the DOC were serving county sentences. The type of sentence that individuals were serving prior to release is shown in Table 1.

Type of release is related to the type of sentence served. Most males are released by parole and most females are released by expiration of sentence. There appears to be a steady increase in males and females released by discharge for each year. The pattern of types of release is shown in Table 1.

The average time served varies by the type of sentence served. For 1986 releases the average time served for a Cedar Junction sentence was 55.3 months, the average time served for a Concord sentence was 23.7 months and the average time served for a Framingham sentence was 5.7 months. From the data presented in Table 1 there appears to be a slight increase in time served for Concord sentences, from 17.9 months in 1982 to 23.7 months in 1986. Time served for Cedar Junction or Framingham sentences do not exhibit any clear trends.

Thus, over the past six years releases from the Department increased dramatically. The percentage increase has been more marked for females than for males. Overall patterns of release, including institution released from, type of release and type of sentence show little change. There seems to be some increase in time served for Concord releases.

A Profile of 1986 Releases

Release Characteristics

Tables 2, 3 and 4 (on pages 14 through 16) present selected characteristics of the offender and the release for 1986 releases. All the other tables that follow show the released population by the institution from which the offender was released. In order to maintain the privacy of the individual offenders, no information is presented for institutions from which fewer than five individuals were released. This affects the presentation of all remaining data for two institutions (Lemuel Shattuck and Medfield). In the case of the four releases from Lemuel Shattuck they are included in the following tables as released from the institution they were in prior to placement at the hospital (in one case Cedar Junction, in two cases Concord and in one case Framingham). The two releases from Medfield are included in the total column but do not appear elsewhere in the tables.

Institution Released From. Table 2 presents information on the specific institution and security level from which individuals were released by the sex of the offender. For male releases, 44 percent were released from secure facilities and 56 percent were released from lower security facilities. In contrast, 76 percent of all females were released from secure facilities and 24 percent were released from lower security facilities.

Type of Sentence. The second variable examined in Table 2 is type of sentence served for 1986 releases. For females, 88 percent of those released from the DOC during 1986 were serving county sentences which typically are very short. In contrast, 14 percent of the males released from the DOC were serving county sentences.

Type of Release. For males, the most common type of release is parole, accounting for 68 percent of all releases in 1986. In contrast, 36 percent of the females were paroled. For females, the most common type of release is expiration of sentence or discharge, accounting for 64 percent of all releases. In contrast, 32 percent of males were discharged or released by expiration of sentence.

The information presented in Table 2 show that 1575 (52%) of the 3022 releases were from secure facilities. A further analysis of releases from secure facilities show that 597 (38%) of these releases are females. For female releases, the security level released from is related to type of sentence served, i.e., the majority of the females released were serving county sentences. Table 3 presents select information on the 2238 males released during 1986 by the security level of the institution from which released.

Parole Violator Status. For male releases, the security level released from is often related to parole violator status, that is, many of the releases are actually parole violators being re-released on a sentence. Of the 978 releases from secure facilities, 405 (41%) were parole violators, while 573 (59%) were first releases. Parole violators tend to serve a short amount of time from their return until their re-release, which may explain why so many are released from secure facilities.

Split Sentences. Some of the first releases from secure facilities are individuals who received split sentences. A split sentence is divided into a term of incarceration followed by community supervision by the court. There were 86 males with split sentences who were released from secure facilities as first releases. This makes up 15 percent of the 573 individuals who were first releases from secure facilities. Since the time served in prison for persons receiving split sentences is usually short, this hinders transfers to lower security.

Another variable that may explain some of the releases from secure facilities is whether or not the inmate had received lower security placements during his period of incarceration. Past DOC research has shown that the majority of males released from secure facilities had received one or more placements in lower security settings during their incarceration.

Time Served. Table 4 shows time served until first release by committing institution and offense. Time served varies by committing institution (55.3 months for Cedar Junction, 23.7 months for Concord and 5.7 months for Framingham). Time served also varies by offense. For example, individuals committed to Cedar Junction served an average of 89.3 months for rape and 19.3 months for larceny; and individuals committed to Framingham served an average of 40.7 months for manslaughter and 2.3 months for disturbing the peace.

1. Individuals who were parole violators, were originally committed to another authority or were serving complex sentences (forthwith, split, fines or from & after sentences) were excluded from the analysis.
2. Offenses were selected based on the frequency with which they appear among the releasee group.

Nature of Present Offense

Sentencing Courts. Originally 64 percent of the releases were sentenced in Superior Courts including 19 percent from Suffolk Superior Court, 10 percent from Worcester Superior Court and 10 percent from Middlesex Superior Court. Twenty-four percent of the releases were sentenced in District or Municipal Courts. Eleven percent were transfers from other jurisdictions (out-of-state, federal or county inmates).

Jail Credits. Fifty-five percent of the releases spent time in jail prior to their commitment; 45 percent had spent no time in jail prior to their commitment.

Commitment Institution. Cedar-Junction commitments represented 30 percent of all releases; Concord commitments represented 33 percent of all releases and Framingham commitments represented 26 percent of all releases. There were 335 (11 percent) individuals released who were originally committed to another jurisdiction (most of which were Longwood releases).

Sentence. Most releases (68 percent) were serving either indeterminate sentences or county sentences. Sixteen individuals who were serving life sentences were released in 1986. Fifteen lifers released during 1986 had second-degree life sentences. Thirteen of these individuals had been committed for murder 2, one for armed robbery and one for masked armed robbery. One individual had an out of state life sentence for first-degree murder and was released from a DOC facility during the year.

Present Offense. Forty-four percent of the releases were serving sentences for violent offenses (37 percent for person offenses and 7 percent for sex offenses), 23 percent were serving sentences for property offenses, 11 percent for drug offenses and 22 percent for "other" offenses. There were two individuals who were serving sentences for murder 1 who were released.

One of these individuals was an out of state inmate and the other had received a commutation in his sentence from a term of life to a sentence of years.

Age at Incarceration. The median age at incarceration for the releases during 1986 was 26 years old.

Personal Background Characteristics

Sex. Seventy-four percent of the releases were male and 26 percent were female. The number of males released in 1986 increased by 38 percent over 1985 and the number of females released increased by 10 percent.

Race. Twenty-seven percent of the releases were black and 67 percent were white. There were 3 Native Americans, 2 Asians and 2 cases where race was unknown in the release group. Ten percent of all releases were Hispanic.

Marital Status. The majority of releases (65 percent) were single.

Military Discharge. Of the 2895 releases for whom information was known, 87 percent had never served in the military.

Prior Address. The largest group of releases (47 percent) came from the Boston MSA.

Occupation. Most releases whose occupations were known had worked in the areas of manual labor (49 percent) or services (30 percent).

Education. The median educational level for the 1986 releases was eleventh grade; 45 percent had achieved at least a high school level of education.

Criminal History

The rate of unknowns for the Criminal History variables is 9 percent, the percentages below are based on those cases where criminal history information is known.

Prior Court Appearances. The median age at first court appearance was seventeen years. The median number of court appearances prior to their current commitment was 10. A majority of the releases had previously appeared in court for person offenses (72 percent) and property offenses (80 percent). A minority had appeared in court for sex offenses (13 percent), alcohol offenses (33 percent) and escapes (8 percent). Almost half of the releases had court appearances for drug offenses (49 percent).

Prior Incarcerations. Forty percent of the releases during 1986 had prior incarcerations in a house of correction and 19 percent had prior incarcerations in a state or federal correctional institution. Overall, 51 percent of the releasees had served some time as an adult for another offense.

Prior Paroles. Five percent had been paroled while a juvenile and 50 percent of those had received a parole violation while a juvenile. Twelve percent of the releases during 1986 had been paroled as an adult and 62 percent of those had previous parole violations. Overall, 15 percent had been paroled at least once prior to their current release and 61 percent of those had previous parole violations.

Furlough Program Participation

Twenty-seven percent of the releases had one or more furloughs during their present incarceration; 73 percent had no participation in the furlough program. Only sixteen individuals had one or more furlough escapes. Six percent of the 1986 female releasees and 34 percent of the male releasees had one or more furloughs during their present incarceration. This difference is due, in large measure, to the fact that such a large number of females received relatively short county sentences.

Glossary

Age at First Drug and Alcohol Court Appearances

Not applicable means never charged with such offenses.

Complex Sentence (Time Served)

Forthwith sentences, split sentences, from & after sentences or fines are categorized as complex sentences and are not included in the calculation of time served.

Contract (Security Level Released From)

The contract pre-release facilities are: Brooke House, Coolidge House II, Coolidge House, McGrath House, Temporary Housing Program, Hillside Pre-Release Center, Charlotte House, and Drug Houses.

Court From Which Committed

Municipal Courts are lower courts of Suffolk County.

District Courts are lower courts of all other counties.

Drug Offenses

Class A includes heroin and morphine

Class B includes cocaine, opium, amphetamines and barbiturates.

Class C includes hallucinogens.

Class D includes marijuana.

Class E includes other prescription drugs.

Furlough Outcomes

Successful: returned to DOC facility within the designated number of hours.

Late Under: returned to DOC facility within two hours after designated time of return.

Furlough Outcomes (Cont.)

Late Over: declared escape, returned to DOC facility voluntarily within 24 hours of the designated time of return.

Escape: declared escape, did not return voluntarily within 24 hours of designated time of return.

Institution

SECC is Southeastern Correctional Center.

NCC is Northeastern Correctional Center.

MHHI refers to Massachusetts Halfway Houses, Inc. facilities. This includes Brooke House, Coolidge House, Coolidge II, McGrath House and the Temporary Housing Program.

Drug Rehab refers to pre-release facilities with a substance abuse program component. This includes Meridian House and Boston VA.

Known Drug Use

This information is obtained from the Probation Department report prepared on each individual. Persons are described as drug users if they: (a) describe themselves as one or, (b) have a history of court appearances for narcotics offenses.

Minimum Sentence

Indeterminate Sentences are sentences without a minimum term; parole eligibility is determined by the Parole Board Regulations.

Number of Charges for Various Offenses

The variables listed as "Charges for Person, Sex, Property, Escape, Alcohol and Drug offenses" includes the present charges as well as all prior charges.

Number of Prior House of Correction Incarcerations

Present Offense

Type of Sentence

County incarcerations have a maximum sentence length of 2½ years.

The most serious charge is listed if an individual is committed for more than one offense.

One Sentence Only: simple sentence for one offense.

Concurrent: Sentences for multiple offenses are served at the same time.

Aggregate: Sentences for multiple offenses are served consecutively.

Fine: Offender was given a fine, but because of being unwilling or unable to pay, served time in prison.

Forthwith: Offender was previously incarcerated for another offense; present sentence superseded previous sentence.

From and After: Offender was previously incarcerated for another offense, present sentence began after termination of previous sentence.

Split: Sentence was divided into a term of incarceration followed by community supervision by the court.
