I. Executive Summary

County detention facilities housed a daily average of 27,704 inmates during the month of March, 1988. This represents the highest daily average since the Department of Corrections has been involved in the process of collecting data on inmates held in county detention facilities.

Overall, the data reported for March of 1988 reflects that the daily average for inmates housed in county detention facilities increased by 3,912 inmates over the average reported for March, 1987. This is a growth rate of 16 percent.

The average number of inmates housed awaiting felony trial remains the largest segment of the inmate population in the county system. Of the 27,704 inmates housed on a daily average during March of this year, 53 percent were inmates held for felony trial. This is an increase of 13 percent over March of last year and strongly suggests that the state prison system will continue to see an increase in the pattern of new admissions in the months to come.

In spite of court action, the addition of 4,200 new beds, pretrial intervention programs, and other attempts to abate the influx of inmates, overcrowded conditions in many county detention facilities continue to prevail. This situation is now more critical since March of 1987. The data would also suggest that inmates are now receiving longer sentences for felony crimes and counties appear to be incarcerating at a greater rate compared to March of 1987. However, current construction and planning activities now in process should have considerable impact on reducing overcrowding during the next two years.

Previous data indicated that a daily average of 23,792 inmates were incarcerated in county detention facilities during March of 1987. In March of this year, 27,704 inmates, on a daily average, were detained by counties, representing an increase of 16 percent over March of 1987.

In the adult male category, the felony subcategories sentenced (365 days or more), sentenced (364 days or less) and awaiting trial were significantly higher than the figures reported for March of 1987. The daily average for individuals sentenced to one year or more increased at almost twice the rate as compared to those sentenced to less than one year (+51% vs. +28%), suggesting a trend toward the imposition of longer sentences for felony crime.

In the misdemeanor subcategories for adult males, the daily average for individuals sentenced or awaiting trial increased significantly over March of last year (+20% and +16%), even with an increasing reliance on alternatives to incarceration such as probation, house arrest and pretrial diversion programs.

Other areas involving adult male offenders which reveal significant increases over March of 1987 are the probation violators (+18%) and holdings for other jurisdictions (+29%) subcategories. There was considerable decrease in the daily average for state inmates (-20%). Overall, the adult male category increased 15 percent over March of 1987.

In the adult female category, the daily average for individuals sentenced or awaiting trial for felony crimes increased significantly over March of last year. Like the adult male category for felonies, the data indicates that females are receiving considerably longer sentences, increasing at almost three times the rate as those sentenced to less than one year (+77% vs. +27%).

In the misdemeanor subcategories for adult females, the daily average for individuals awaiting trial increased significantly (+21%) over March of 1987, while those sentenced or awaiting sentencing remained relatively constant.

Other areas that reveal significant increases in the daily average for adult female offenders include probation violators (+32%) and holdings for other jurisdictions (+73%). Overall, the adult female category increased 27 percent, almost twice the rate as the adult male category.

In the juvenile male category, the daily average of individuals held pretrial increased significantly over March of 1987, indicating an increasing use of county detention facilities for juveniles charged with felony crimes. The juvenile female category indicated that the daily average for individuals held for felony trial doubled the daily average for March of last year. Overall, the juvenile male category increased 33 percent, while the juvenile female category increased 50 percent over March of 1987.

Note: County population figures are projections for FY87-88 by the Florida Census Estimating Conference (Official January 25, 1988), Executive Office of the Governor, Office of Planning and Budgeting, Revenue and Economic Analysis Unit.

In March of 1987, the state-wide county detention facility incarceration rate was 2.00 per/1,000 based on the population estimate for 1987. Based on the 1988 population estimate, on a state-wide basis, counties incarcerated at a rate of 2.19 per/1,000 general population in March of this year. This represents a rate increase of 10 percent. According to estimates, the general population for Florida in 1988 will increase by three percent over 1987, indicating that counties, on the average, are housing inmates at a greater rate than the rate of growth in the general population.

It should be noted that the preceding table presents an extremely high incarceration rate of 10.06 per/1,000 general population for Hamilton County. This is caused by the practice of holding a large number of inmates under contract with the Department of Corrections and the U.S. Marshals Service. This is also the case with Baker County, where the rate is approximately three inmates per/1,000 because of housing inmates for the U.S. Marshals Service. Escambia and Collier Counties are also under contract with the Department of Corrections causing a higher incarceration rate for these two counties.

IV Individual County Detention Facility Inmate Daily Averages and Authorized Facility Inmate Capacities

Attachment C provides the daily average and the authorized capacity for each county detention facility for March of this year.

As of March 31, 1988, 26 counties housed an average of 4,285 inmates in facilities beyond their rated authorized capacity, eight counties operated facilities at or near capacity and 32 were holding inmates in facilities below capacity. Figure 2, Attachment D offers an overview of the county inmate capacity status throughout the state.

Currently there are 105 detention facilities housing county inmates throughout the state. This represents the addition of one county facility over March of 1986 and one facility less than March of last year.

The following table presents a comparison of county inmate capacity data for March, 1986, March, 1987 and March, 1988.

The above table reflects the addition of 6,611 new beds in the county detention system since March, 1986. However, these additional beds have failed to keep pace with the accelerated growth in inmate populations in those counties where serious overcrowding exists. A number of counties experiencing high inmate populations are now involved in various stages of detention facility construction and many are in the process of planning new facilities, renovations or additions to their existing facilities. Unless the inmate populations increase more dynamically than they have since March of 1986, current construction and planning activities now in process should produce significant gains in reducing the problem of acute overcrowding during the next two years.
