Residents in Wisconsin  
Juvenile Correctional Institutions  
on June 30, 1983  
With Five-Year Trends for 1979-1983

Ethan Allen School, which houses boys, and Lincoln Hills School, a coeducational facility, are Wisconsin's state-operated (Department of Health and Social Services, Division of Corrections) institutions for juvenile offenders. Children are placed in these institutions under statutory provisions of the Wisconsin Children's Code (revised November, 1978). The Code permits courts to commit juveniles to the custody of the Division of Corrections only if they have been adjudged delinquent because of the commission of an act that would have been punishable by a sentence of six months or more if committed by an adult and only if found to be a danger to society or to themselves and in need of restrictive custodial care and treatment.

A total of 489 juveniles, 452 boys and 37 girls were in residence on June 30, 1983; an increase of 6.5 percent over 1982 levels when 429 boys and 30 girls were in residence. This is the first increase recorded for June 30 resident populations since the Children's Code revision alluded to previously. Tables 1 through 11 contain descriptive information about juveniles in residence on June 30, 1983 including data relating to race and ethnicity, current disabilities, age, etc. Trend data for the period 1979-1983 can be found in Appendix Tables A and B.

Four hundred and fifty-two boys, 304 at Ethan Allen and 148 at Lincoln Hills, were in residence on June 30, 1983. Boys committed from five counties: i.e., Milwaukee (199), Racine (23), Waukesha (20), Dane (19), and Rock (15) made up slightly more than three-fifths (61.1 percent) of the resident population. The majority of boys at both facilities (82.9 percent at Ethan Allen; 89.2 percent at Lincoln Hills) were received as new admissions to juvenile correctional institutions. Four boys who were not committed under Wisconsin Statutes were in residence at Lincoln Hills. The average age of residents was reported to be 16.2 years. Boys from white or white-hispanic background made up somewhat over one-half (55.3 percent) of the resident population. Twenty-one of the 24 boys from Native American backgrounds were in residence at Lincoln Hills School; 163 of the 167 boys from Black family backgrounds were in residence at Ethan Allen

School. Burglary, theft, battery, and auto theft were the delinquent acts which most often led to institutionalization.

One of the major goals of juvenile institution programming is to determine what problems a child has and then provide he or she with the opportunity to over-come or cope with the problems. Table 5, appearing for the first time in this publication, presents minimal information on the various problems and combinations of problems faced by juveniles in residence on June 30, 1983. Boys that had problems unrelated to drugs, sexual behavior, or assaultive behavior made up slightly more than one-tenth (11.7 percent) of the resident population while only five boys were reported as having problems that related only to drugs. Over one-half (53.7 percent) of the boys were reported as having problems with assaultiveness either to themselves or toward others while problems relating to drugs were recorded for slightly over two-fifths (44.0 percent) of the residents. Table 7, also appearing in this publication for the first time, provides minimal information on various types of disabilities which may or may not affect juveniles in residence. Somewhat less than one-fourth (23.0 percent) of the boys were reported as having no current disabilities, while three boys were noted to be suffering from physical disabilities. It is interesting to note that two-thirds (66.6 percent) of the boys were reported to have some type of developmental and/or emotional disability.

Thirty-seven girls were in residence at Lincoln Hills School on June 30, 1983; an increase of 23.3 percent over the preceding fiscal year when 30 girls were in residence. Girls committed from Milwaukee (10), Racine (4), Rock (4), and Dane (3) counties accounted for over one-half (56.8 percent) of the resident population. The majority (83.8 percent) of the girls were new commitments while the remainder were those who had been returned to the institution from state aftercare supervision. Seven-tenths (70.3 percent) were from white family backgrounds; none were reported to have come from a Hispanic background. The average age was found to be 15.9 years. Theft, battery, burglary, and aggravated battery were the most common delinquent acts committed by girls prior to admission.

Slightly less than one-third (32.4 percent) of the girls in residence were reported to have problems with assaultive behavior while slightly over one-half (51.4 percent) had difficulties in relation to drugs and/or alcohol. Over

three-fifths (64.9 percent) were affected by developmental and/or emotional disabilities while four girls were affected with physical disabilities as well as those characterized as developmental and/or emotional in nature.
