Between 1978 and 1987, over two million adult felony arrests receiving a final disposition were reported to the Bureau of Criminal Statistics' Offender-Based Transaction Statistics (OBTS) system. Approximately 15 percent were dispositions for female defendants. Over half of those female offenders were convicted and sentenced by California courts. "WOMEN IN CRIME: The Sentencing of Female Defendants" examines the sentencing trends of female adults sentenced from 1978



From 1978 to 1987 the proportion of females receiving incarcerative type sentences increased from 53.8 to 79.2 percent (up 25.4 percentage points).

Conversely, the proportion of females receiving nonincarcerative type sentences decreased from 46.2 to 20.8 percent (down 25.4 percentage points).

Without considering any contributing factors such as prior record, criminal status, or severity of the crime, more punitive or institutional-oriented sentences are being given to female defendants as the decade of the eighties progresses.

In spite of this underreporting, these final dispositions generally describe statewide processing of adult felony arrestees through California's criminal justice system.

From 1978 to 1987 the proportion of adult females given the sentence of:

- Prison increased from 3.4 to 7.5 percent, an increase of 4.1 percentage points.
- from 40.5 to 62.6 percent, an increase of 22.1 percentage points.
- Jail remained fairly constant, but decreased slightly from 8.6 to 8.4 percent.
- Probation decreased from
 39.6 to 19.4 percent, a decrease of 20.2 percentage points.

Fine - decreased from 6.5 to 1.2 percent, a decrease of 5.3 percentage points.

From 1978 to 1987 the proportion of females sentenced to prison more than doubled. During the same period, probation with jail sentences increased by 22.1 percentage points while the proportion of straight probation sentences were cut in half. These changes reflect a more punitive shift in the criminal justice system's sentencing of female defendants.

An examination of the sentences for convictions of violent crimes, property crimes, and drug law violations from 1978 to 1987 shows that:

- the same general sentencing trends occurred.
- In each offense category, the largest proportion of females convicted are sentenced to probation with jail.
- For each offense category, probation with jail sentences increased the most. Conversely, the greatest decrease was found in straight probation sentences.
- The greatest increase in prison sentences was found in the violent crime category (up 5.9 percentage points).
- The largest increase in incarcerative sentences was found in the drug law violations category (up 34.8 percentage points).
