INTRODUCTION

This document is the third Directory of Local Criminal Justice Computer Systems. The Directory contains descriptions of the automated information systems which provide support to Virginia's local criminal justice agencies. The principal purpose of the Directory is the provision of a reliable single reference for criminal justice practitioners and data processing specialists to use in developing or enhancing locality-operated criminal justice computer systems. Use of the Directory can facilitate the transfer of local systems by providing information that reduces duplication of effort. The Directory describes criminal justice information systems, software and host hardware, operated by each locality in Virginia and identifies an appropriate contact person for each agency. Ninety agencies are included in this edition of the Directory.

The Directory consists of five sections: Agency, Application, Hardware, VCIN and CAIS Listings. The Agency Listing contains local agencies in alphabetical order and descriptions of their automated criminal justice information systems in operation or under development. The Directory user who wishes to identify those agencies having a system which performs a specific function of interest should refer to the Applications Listing. This section identifies all agencies using computers for specific applications in alphabetical order of the application. The third section is the Hardware Listing. This index contains listings, by equipment manufacturer and model, of

types of computers used by each agency. The VCIN Listing and the CAIS Listing identifies all agencies accessing the Virginia Criminal Information Network and the Courts Automation Information System respectively.

The listings in this directory represent the updating of a survey conducted in 1988 by Virginia's Department of Criminal Justice Services. Forms requesting system descriptions and names of responsible contacts were mailed to all chiefs of police, sheriffs, and commonwealth's attorneys in Virginia. Follow-up contact for clarification purposes was accomplished by telephone.

Since it was not possible to validate all the data submitted for inclusion in the Directory, information was accepted and used as reported by the respondents. Therefore, before acting on any of the Directory's content, the Directory user should assure by communication with the cited contact person that there is a common understanding of a system's purpose and capabilities.
