INTRODUCTION

Historical Statistics on Prisoners in State and Federal Institutions, Yearend 1925-1986 provides annual data on size of prison population and size of general population for the period 1925 to 1986. The dataset consists of 54 records: 1 record for all prisoners in the U.S. (state and federal prisoners combined); 1 record for federal prisoners; 1 record for state prisoners (state prisoners and District of Columbia prisoners combined) and; 51 records altogether for the individual states (prisoners in the 50 states plus District of Columbia prisoners).

Background

In 1926 the federal government, in a statistical series called "National Prisoner Statistics," began keeping annual records of state and federal prison populations. The series has been in continuous operation ever since. Published reports from the series are the source of national statistical information on prison populations in the United States.

Among the several continuously published measures of the prison population, one from the annual report is intended to provide a measure of the overall size of the prison population. It is the number of prisoners present in state and federal prisons at the end of the year. These prison population yearend counts from the annual reports were compiled in a single publication titled "Historical Statistics on Prisoners in State and Federal Institutions, Yearend 1925-1986" (Appendix C). The dataset for that publication is described herein.

Methodology

National Prisoner Statistics is a voluntary reporting program initiated by the federal government in 1926. The Federal agency responsible for administering the program was the Bureau of the Census from 1926 to 1949, the Federal Bureau of Prisons from 1950 to 1970, the Law Enforcement Assistance Administration from 1971 to 1978, and the Bureau of Justice Statistics from 1979 to the present.

Yearend prison population counts are the product of a yearly national census in which the responsible federal agency asks each state correctional institution (or its central reporting agency), the District of Columbia, and the federal Bureau of Prisons to report summary statistics. The census is one among many other censuses and surveys that together make up the series called National Prisoner Statistics.

The census of yearend prison population uses a mail questionnaire. Results of the census are reported in an annual publication. Revisions to published results are reported in subsequent publications.

For some years, the same publication reported more than one set of yearend figures, reflecting different ways of defining the yearend population. The yearend figures that were chosen for inclusion in this dataset are based on the most comparable data published. The most comparable data are: 1) those that define the prison population as the total number of sentenced adult felons in the physical custody of state and federal institutions at yearend; and 2) those that reflect any revisions to originally published figures.

Three specific identified exceptions to this definition are:

1. The prison population on January 1, 1926 is identified in this dataset as December 31, 1925. For certain other years as well, yearend population figures in this dataset are actually figures for January 1 of the subsequent year. January 1 counts are used because they reflect revisions to previously published December 31 figures.

2. Figures for 1925 through 1970 include a small number of misdemeanants (defined as inmates with a maximum sentence less than 1 year). Data for felons alone were not published during these years. Figures for 1971 through 1986 refer solely to felons (defined as inmates with a maximum sentence over 1 year).

3. Figures for 1986 are subject to revision. Final revised figures were not available at the time this dataset was prepared.

Other exceptions are noted in the published reports from which the data were taken.

In most cases yearend figures in the dataset are not from the original publication. The source is typically a later publication presenting revised yearend figures. A list of sources is contained in Appendix C.

Further details of the methodology used in the annual census of yearend prison population are provided in the publication State and Federal Prisoners, 1925-85 (BJS Bulletin NCJ-102494, October 1986). Total prison populations in the dataset supercede those reported in that publication.

United States General Population Data

In addition to prison populations, the dataset also contains general population counts and estimates. The "Current Population Reports," Series P-25, which are based on the decennial census conducted by the Bureau of Census, are the source of United States population figures contained in this dataset. The individual state and United States totals include only the resident population and have been rounded off to the nearest thousand. A list of sources is contained in Appendix A.

Rates of Imprisonment

The presence of general population figures in the dataset enables the users to calculate imprisonment rates (traditionally defined as the number of prisoners per 100,000 general population). Rates computed from the dataset differ from previously published rates for one particular reason: previously published rates are based on preliminary (not final) prison population counts and preliminary general population estimates whereas rates computed from this dataset are based on final prison population counts and final general population estimates. The only exception to this is that dataset figures for the 1986 prison population are subject to revision as are general population estimates after 1980.

A comparison of previously published rates and rates based on this dataset is presented in Appendix B. As can be seen, the two sets of rates correspond closely to one another. Appendix B also presents sources of general population figures and sources of published rates. Note that sources of general population figures in Appendix B differ from those in Appendix A. The reason, alluded to earlier, is that Appendix A sources are for final general population estimates whereas Appendix B sources refer to preliminary general population estimates.

Limitations

The dataset preserves what was reported in the historical record. No attempts were made to correct any errors that may have existed in the record. All data recorded are the actual figures taken from the published reports that make up the historical record. In some cases the historical record was based on an estimate. Such estimates have been preserved.

Also, some states are missing data for particular years. These states either failed to report their prison population or, in the case of Hawaii and Alaska before becoming states, were not asked to participate in the statistical series. Missing data codes alert the user to such instances.

Additional Information

Additional information about the dataset is in the Bureau of Justice Statistics publication titled HISTORICAL STATISTICS ON PRISONERS IN STATE AND FEDERAL INSTITUTIONS, YEarend 1925-86. See Appendix C for a copy.

Related information can be found in the Bureau of Justice Statistics publication titled HISTORICAL CORRECTIONS STATISTICS IN THE UNITED STATES, 1850-1984 (NCJ-102529, December 1986).

FILE STRUCTURE

HISTORICAL STATISTICS ON PRISONERS IN STATE AND FEDERAL INSTITUTIONS, YEAREND 1925-1986 is available from the ICPSR in two formats: card image and OSIRIS. The card image file contains several decks per case in a format based on 80 column punched cards. The data are sorted by case with all decks for a case together in ascending order.

The OSIRIS dictionary gives the format and other information for each variable in the OSIRIS data file. The dictionary or dictionary-codebook file is used in conjunction with the OSIRIS software package. The OSIRIS data file is constructed with a single logical record for each case. There are 126 variables on 54 cases.

The OSIRIS data file can be accessed directly through software packages or programs which do not use the OSIRIS dictionary by specifying the tape locations of the desired variables. These tape locations are given in the OSIRIS dictionary-codebook.

CODEBOOK INFORMATION

The example below is a reproduction of information appearing in the machine-readable codebook for a typical variable. The numbers in brackets do not appear but are references to the descriptions which follow this example.

- {1} Indicates the variable and reference numbers. A variable number and a reference number are assigned to each variable in the data collection. In the present codebook which documents the archived data collection these numbers are identical. Should the data be subsetted or rearranged by an OSIRIS program (e.g., MMP to intersperse data from another source, or TCOT to produce an analysis deck), the variable numbers would change to reflect the order of the new data collection, while the reference number would remain unchanged to reflect the variable number in the codebook describing the archived data collection.
- {2} Indicates the abbreviated variable name (maximum of 24 characters) used in the OSIRIS system to identify the variable for the user. An expanded version of the variable name can be found in the variable description list.

- {3} Indicates the code values of missing data. In this example, code values equal to 0 are missing data (MD=0). Possible alternative statements for other variables are "MD=9", "MD GE 9," or "NO MISSING DATA CODES," (although only the last statement and "MD=0" appear in this codebook). Some analysis software packages (including the OSIRIS software package) require that certain types of data which the user desires to be excluded from analysis be designated as "MISSING DATA," e.g., inappropriate, unascertained, unascertainable, or ambiguous data categories. Although these codes are defined as missing data categories, this does not mean that the user should not or cannot use them in a substantive role if so desired.
- {4} Indicates the starting location and width of this variable when the data are stored on a magnetic tape in the OSIRIS format. If the variable is of a multiple-response type, the width referenced is that of a single response. In this example the variable named "1946 STATE POPULATI0 SUM" is 9 column(s) wide and is located in the 345th column within the record.
- {5} Indicates the location by deck and column(s) of this variable when the data are stored on cards or in card-image format (80-column format)
- {6} This is the full text (question) supplied by the investigator to describe the variable. The question text and the numbers and letters that may appear at the beginning reflect the original wording of the questionnaire item.
- {7} "Actual number is coded" appears in the codebook to indicate that the variable has been declared continuous. (All variables in this codebook are, in fact, continuous).

ICPSR PROCESSING INFORMATION

The data collection was processed according to the standard ICPSR processing procedures. The data were checked for illegal or inconsistent code values which, when found, were recoded to OSIRIS missing data values. No consistency checks were performed. Statements bracketed in "<" and ">" signs in the body of the codebook were added by the processors for explanatory purposes.

Introduction

In 1926 the Federal Government, in a statistical series called "National Prisoner Statistics," began keeping annual records of State and Federal prison populations. The series has been in continuous operation ever since. Published reports from the series are the source of national statistical information on prison populations in the United States.

Among the several continuously published measures of the prison population, one from the annual report is intended to provide a measure of the overall size of the prison population. This measure is the number of prisoners present in State and Federal prisons at the end of each year. Changes from one year to the next in the number of prisoners present at yearend reveal whether prison populations are increasing, decreasing, or staying the same in the United States.

This report combines yearend population counts from the annual published reports into a single table (table 1). Table 1 shows the prison population of each State, the District of Columbia, and the Federal Government on December 31 of each year from 1925 to 1986.

Over the more than 60 years in which prisoner counts have been reported, definitions of included populations have occasionally changed, and published figures have been revised (see Methodology). Annual counts reported here are based on final revised figures and represent the most comparable data published.

National trends, 1925-86

Record high number of prisoners. From 1925 to 1974 the record high prison population was in 1981, when 220,149 persons were in prison. The record was broken in 1975, when the prison population reached 240,593. Every year since 1975 a new record high was set. To date, the 1986 prison population of 503,794 is the highest number ever recorded. It nearly equals the 1986 population of Alaska (534,000), Vermont (541,000), or Wyoming (507,000).

Record year-to-year numerical increase. The largest numerical increase in the prison population ever recorded was from 1981 to 1982, when the prison population grew by 41,060 prisoners. At that rate, the equivalent of a new 1,000-bed prison would have to be built nearly every week just to keep up with prison population growth.

Record year-to-year percentage increase. Over the past 62 years prison populations have typically increased from one year to the next. The average year-to-year change has been a 2.8% increase (table 2). The largest year-to-year percentage increases ever recorded have all occurred in the past 12 years. The largest year-to-year increase ever recorded was from 1980 to 1981, when the prison population increased 12.9%; the second largest, 11.9%, was from 1981 to 1982; the third largest, 10%, was from 1974 to 1975. From 1980 to 1986 the average year-to-year change in the prison population was an increase of 8.8%.

Record year-to-year percentage decrease. The largest year-to-year percentage decrease ever recorded was from 1941 to 1942, when the prison population declined 9.1%; the second largest decline, from 1942 to 1943, was 8.8%; the third largest decline, from 1965 to 1966, was 5.3%.

Regional trends, 1925-86

Record year-to-year percentage increase. Over the past 62 years average year-to-year changes have been 2.7% increases in the Northeast; 2.1% increases in the Midwest; 3.4% increases in the South; and 3.9% increases in the West. Year-to-year changes from 1980 to 1986 have averaged much higher: 10.8% average yearly increases in the Northeast; 7.9% average yearly increases in the Midwest; 6.4% average yearly increases in the South; and 14.1% average yearly increases in the West.

Individual State trends, 1925-86

Record year-to-year percentage increase. Over the historical period 1925-86, the average annual change has been a 2.8% increase. The States with the historically largest average annual increases (5% or more) are:

Trends in the size of the Federal prison population as a percentage of the total prison population

Record high percentage of Federal prisoners. The prison population has two components: a State prison population (including the District of Columbia) and a Federal prison population. The Federal prison population as a percentage of the total population has fluctuated over time. From 1925 to 1945 the prevalence of Federal prisoners increased, reaching its all-time high level of 13.9% in 1945 (table 3).

Record low percentage of Federal prisoners. From 1945 to 1982 the prevalence of Federal prisoners steadily declined, reaching its all-time low level of 5.6% in 1982 (table 3). Since 1982 the prevalence of Federal prisoners has been growing.

Methodology

National Prisoner Statistics is a voluntary reporting program initiated by the Federal Government in 1926. The Federal agency responsible for administering the program was the Bureau of the Census from 1926 to 1949, the Federal Bureau of Prisons from 1950 to 1970, the Law Enforcement Assistance Administration from 1971 to 1978, and the Bureau of Justice Statistics from 1979 to the present.

Yearend prison population counts are the product of a yearly national census in which the responsible Federal agency asks each State correctional institution (or its central reporting agency), the District of Columbia, and the Federal Bureau of Prisons to report summary statistics. The census is one among many other censuses and surveys that together make up the series called National Prisoner Statistics.

The census of yearend prison population uses a mail questionnaire. Results of the census are reported in an annual publication. Revisions to published results are reported in subsequent publications.

For some years the same publication reported more than one set of year-end figures, reflecting different ways of defining the yearend population. The yearend figures that were chosen for inclusion in this publication are based on the most comparable data published. The most comparable data are: 1) those that define the prison population as the total number of sentenced adult felons in the physical custody of State and Federal institutions at yearend and 2) those that reflect any revisions to originally published figures. Three specific exceptions to this definition are:

- The prison population on January 1, 1926, is reported here as December 31, 1925. For other years as well, yearend population figures reported here are actually figures for January 1 of the subsequent year. January 1 counts are used because they provide an acceptable measure of the

yearend population and because they reflect revisions to previously published December 31 figures.

- Figures for 1925 through 1970 include a small number of misdemeanants (defined as inmates with a maximum sentence less than 1 year). Data for felons alone were not published during these years. Figures for 1971 through 1986 refer solely to felons (defined as inmates with a maximum sentence greater than 1 year).

- Figures for 1986 are subject to revision. Final revised figures were not available at the time of this publication.

Other exceptions are noted in the published reports from which the data were taken.

In most cases yearend figures reported here are not from the original publication. The source is typically a later publication presenting revised yearend figures.

Further details of the methodology used in the annual census of yearend prison population are provided in the publication **State and Federal Prisoners, 1925-85** (BJS Bulletin, NCJ-102494, October 1986). Total prison populations reported here supersede those reported in that publication.

How to obtain the data

The dataset for "Historical statistics on prisoners in State and Federal institutions, yearend 1925-86" is available in a variety of machine-readable formats (floppy disk, nine-track tape, and so forth) from the National Criminal Justice Data Archive at the University of Michigan. Contact the archive at P.O. Box 1248, Ann Arbor, MI 48106 (313-763-5010). In addition to the counts of prisoners by year and by jurisdiction, the dataset also includes general population estimates by year and by jurisdiction. These general population estimates were supplied by the U.S. Bureau of the Census to this project and incorporate any revisions to previously published estimates. As a result, calculated rates of imprisonment (prisoners per 100,000 population) from the dataset may differ from previously published rates.
