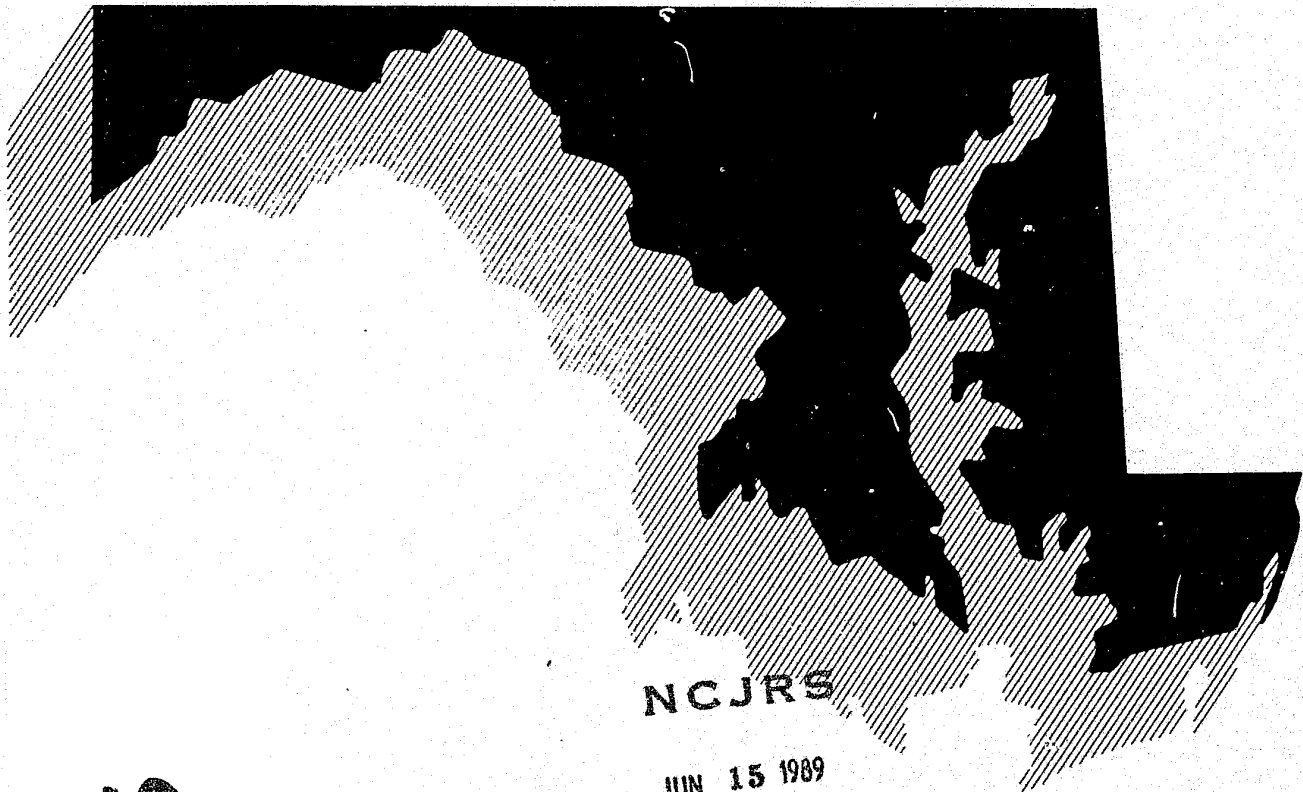

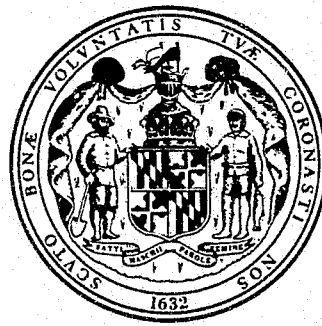

INTRODUCTION

The Office of Research and Statistics has prepared this report annually to provide descriptive data on sentencing dispositions to the state correctional system and on the length of stay within state correctional facilities for inmates released on parole or by mandatory release. The information presented does not represent a comprehensive picture of sentencing and release practices in Maryland since it does not include data on local jail intakes and releases, or dispositions unsupervised by the agencies of the Department of Public Safety and Correctional Services (i.e. fines only, probation to the court, etc.).

This report does not attempt to analyze the data presented or compare jurisdictional differences. Such an analysis would be of questionable value due to the lack of comparable local jail statistics and the limitations within the state correctional information system. It does, however, provide a broad overview of intakes and releases in a format that allows criminal justice practitioners to examine data on jurisdictions of interest.

SENTENCING DISPOSITIONS

Background

Within the range of criminal sanctions available to judges at the time of sentencing, there are primarily two dispositions that require by law the correctional services provided by agencies within the Department of Public Safety and Correctional Services. These sanctions are terms of incarceration at the Division of Correction or Patuxent Institution and terms of probation under the supervision of the Division of Parole and Probation.

Article 27, Section 690(c) of the Annotated Code of Maryland provided in 1988 that no sentence to the Division of Correction could be for less than one year. Intakes to the Division of Correction could therefore range from a sentence of one year to life. These terms of incarceration are served in the custody of the Division of Correction or, in some cases, Patuxent Institution.

Article 27, Section 639(a) provides that a judge can suspend a criminal sentence and impose appropriate conditions of probation. If ordered by the Court, the Division of Parole and Probation will supervise the conduct of individuals placed under its supervision and will report to the judge if the conditions of probation are violated. Probation dispositions are usually granted after a finding of guilt but in some situations probation without verdict can be granted (see Art. 27, Sections 292 & 641).

Sentencing Data

This report provides tables displaying sentences by jurisdiction, offense and sentence range for inmates received at the Division of Correction during Calendar Year 1988. For the purpose of this report, the tables were compiled using the most serious offense resulting in a criminal conviction, the total sentence imposed in months for all convictions, and the jurisdiction where the conviction for the most serious offense occurred. Both circuit court and district court dispositions are included in these tables.

The Offense Groups used in this report contain a variety of individual offenses. The specific offenses that make up each offense group are displayed in the Appendix. In addition, the Appendix shows the frequency of incarceration and probation dispositions by specific offense. It should be noted that the specific offense designations used in this report are based upon the Department's computer information system offense codes, which do not coincide exactly with criminal offense designations within the Annotated Code of Maryland. The source of offense data is the commitment order for inmates received at the Division of Correction and probation orders for intakes to the Division of Parole and Probation. When an inmate or probationer has been convicted for more than one offense, the most serious offense is

determined by using an offense severity ranking system developed by the Division of Correction.

During Calendar Year 1988, a total of 6,230 inmates were sentenced to the Division of Correction and 43,354 probation cases were opened by the Division of Parole and Probation. Of these 49,584 dispositions requiring the Department's supervision, 87.4% were for probation supervision services and 12.6% were for incarceration services. In comparing the use of incarceration versus probation supervision for specific offenses, caution should be used due to the lack of data on local jail incarceration. Certain offenses, such as Driving While Intoxicated, tend to receive sentences to local jails, rather than the Division of Correction, when a term of incarceration is imposed. In addition, comparisons of the use of incarceration versus probation in specific jurisdictions can be misleading depending on the jurisdiction's use of its local jail and the severity of the specific offenses included in the Offense Groups displayed in the tables.

Data Sources and Limitations

Sentencing dispositions on inmates received at the Division of Correction were derived from the Offender Based State Correctional Information System (OBSCIS I) maintained by the Division of Correction and Patuxent Institution. Probation disposition data was derived from OBSCIS II, the Division of Parole and Probation's computer information system. Although these information systems are sufficiently accurate to provide general descriptive statistics on sentencing dispositions, they do contain certain limitations that affect the validity of the data. Of particular concern are the systems' abilities in identifying specific crimes for which an individual has been convicted. As previously stated, the sources of offense data for the correctional information system are commitment orders and probation orders. On occasion, these orders describe the defendant's offense in general terms such as murder, rape or robbery without identifying the offense degree (i.e. 1st degree Murder vs. 2nd degree Murder) or nature (i.e. attempted robbery vs. robbery). This lack of specificity can result in the improper identification of certain offenses in the correctional information systems. For example, probation orders citing the offense simply as "Murder" can be mistakenly identified as first degree murder cases when in actuality the conviction was for second degree murder.

Another possible misinterpretation results from the need to use total sentence length for those inmates receiving more than one sentence in the same or separate trials. If a number of sentences for minor offenses are imposed consecutively, the total sentence may appear inconsistent with the statutory maximum penalty for that offense.

Caution should be exercised in using this data for other than general descriptive statistics on these types of sentencing dispositions.

RELEASE STATISTICS

Background

Inmates sentenced to the Division of Correction or Patuxent Institution can be released from incarceration for a variety of reasons. The primary types of release from incarceration are parole, mandatory release, court-ordered release, death and escape. During Calendar Year 1988, approximately 556 inmates were court released, 21 inmates died in custody and 82 inmates escaped. This report concentrates on parole and mandatory release data since it is expected that most inmates will be released in this manner barring subsequent court intervention.

Under Article 41, Sections 4-501 through 4-512 and Article 31B of the Annotated Code of Maryland, the paroling powers of the Parole Commission and the Patuxent Institution Board of Review are described. Except for individuals sentenced with mandatory "no-parole" sentences, life sentences or death sentences, most inmates are eligible for parole upon entering the custody of the Division of Correction or Patuxent Institution and receive their first parole consideration hearing by the time they have served 25% of their sentence. In practice, inmates must usually serve a significant portion of their sentence before they will be given serious parole consideration. In recent years, the majority of those inmates leaving correctional facilities were not granted parole but were mandatorily released.

Under Article 27, Section 700, an inmate's sentence can be diminished by five days per month for good behavior, 5 days per month for industrial credit, and 5 days per month for participation in certain special programs. An inmate denied parole must, therefore, be released from custody prior to the end of his sentence if his behavior while incarcerated has resulted in the earning of days credited to the reduction of his sentence under Section 700. Inmates released under this provision of the law are referred to as mandatory releases.

Release Data

This report provides tables displaying the percentage of sentences served by sentence length, jurisdiction, type of release and general type of offense. All inmates were released from the Division of Correction or Patuxent Institution during Calendar Year 1988. For the purpose of this report, the tables were compiled using the most serious offense the inmates were serving, the total sentence imposed in months for all convictions, the jurisdiction where the conviction for the most serious offense occurred, and the percentage of time served from the start of the sentence to the actual date of release as compared to the total sentence imposed. Efforts were made to exclude all inmates who had been previously released on parole or mandatorily released and had been returned to custody for violating the conditions of their release. By only including data on inmates

being released for the first time, a more realistic picture of how much time inmates might be expected to serve on a sentence prior to their release is presented.

The release data in this report has been put in two separate tables for each jurisdiction based upon whether or not the inmate had been convicted for a crime of violence as defined under Article 27, Section 643B(a). Article 27, Section 643B(a) defines a crime of violence as:

"abduction; arson, burglary; daytime housebreaking under Section 30(b) of this article; kidnapping; manslaughter, except involuntary manslaughter; mayhem and maiming under Sections 384, 385, and 386 of this article; murder; rape; robbery; robbery with a deadly weapon; sexual offense in the first degree; sexual offense in the second degree; use of a handgun in the commission of a felony or other crime of violence; an attempt to commit any of the aforesaid offenses; assault with intent to murder; assault with intent to rape; assault with intent to rob; assault with intent to commit a sexual offense in the first degree; and assault with intent to commit a sexual offense in the second degree."

All other offenses have been aggregated as non-643B offenses.

The percentage of sentence served prior to release has been calculated based upon the inmate's sentence start date rather than the date the inmate was admitted to the custody of the Division of Correction. Under Article 27, Section 638C, many inmates are eligible for credit towards their sentence as the result of time spent in custody awaiting trial. The amount of pretrial custody credit granted an inmate can range from nothing to over one year depending on various factors but usually averages approximately one to three months per inmate. Since the percentage of sentence served for an inmate serving a life sentence can not be calculated, they have been excluded from this section of the report.

The statewide tables for this report provides data on 4,365 inmates released from the Division of Correction and Patuxent Institution during Calendar Year 1988. Of the 1,348 offenders released with convictions for crimes of violence, 792 or 59% were released on parole and 556 or 41% were mandatorily released. Of the 3,017 inmates released with convictions for non-643B offenses, 1,361 or 45% were released on parole and 1,656 or 55% were mandatorily released. Most inmates serving sentences between three and six months are mandatorily released since the Parole Commission is not required under Article 41, Section 4-607(a) to provide parole hearings for inmates with sentences of less than six months.

Data Sources and Limitations

Length of stay data in state correctional facilities was derived from the Offender Based State Correctional Information System (OBSCIS I) maintained by the Division of Correction and Patuxent Institution. Although these information systems are sufficiently accurate to provide general descriptive statistics on releases from custody, they do contain certain errors that limit the validity of the data.

Of particular concern is the information system's ability to measure the portion of the sentence that was served prior to an inmate's release as a proportion of the total sentence imposed. To accurately calculate the percentage of a sentence served, the computer information system must contain accurate sentence data and accurate release data. Prior audits of the correctional computer information system have indicated that sentence data and type of release data suffer from data entry and interpretation problems. In addition, the system was not originally designed to capture statistical data of the nature presented in this report. As a result, certain release data was excluded from this report since it was clearly inaccurate. The remaining data presented in this report may also suffer from errors to a limited extent but hopefully is sufficiently accurate to provide a general overview of current release activity.

Caution should be exercised in using this data for other than general descriptive statistics on the percentage of their sentence that is served by inmates released mandatorily or on parole.
