This **NIJ Publications Catalog** is a centralized list of publications and videotapes produced by the National Institute of Justice between 1983 and 1989. It is prepared to help criminal justice policymakers, practitioners, and researchers locate and obtain important Institute materials to keep them abreast of the latest research findings and the implications for their work.

Organized in an easy-to-use format, listings are divided by subject so you can locate publications on specific areas of interest. Within each subject you will find the title of each document, and its author, publication date, number of pages, NCJ number, and availability. Most of the publications included in the catalog are free; others are available for a nominal fee.

The National Institute of Justice produces several publication series, including:

Research Reports—present comprehensive reviews of the results of NIJ-sponsored research projects, and may include research methodology and literature reviews in addition to findings and recommendations. These are intended for criminal justice professionals and researchers closely involved with the issues addressed by the research project. Research findings are often presented as **Executive Summaries** to enable interested criminal justice professionals to keep informed of issues addressed by a research project without the investment of time required to read the full report.

Issues and Practices—explore present program options and management issues in a topic area, based on a review of research and evaluation findings, operational experience, and expert opinion on the subject. The intent is to provide criminal justice managers and administrators with the information to make informed choices in planning, implementing, and improving programs and practices.

Research in Brief (RIB)—synthesizes recent research results and summarizes the key findings in 6- to 12-page documents. RIBs are produced primarily for quick reading by policymakers, practitioners, and researchers.

Research in Action (RIA)—summarizes noteworthy findings and programs on such topics as drug screening of arrestees and electronic monitoring of offenders. Many of the titles available are reprints of feature articles from *NIJ Reports*. RIAs are designed for practitioners who want current research information in a succinct format.

Perspectives on Policing—present reports from the Executive Session on Policing, whose meetings are cosponsored by the National Institute of Justice and Harvard University's John F. Kennedy School of Government, and held with some of the leading figures in American policing. Targeted for law enforcement and policymakers, these 8- to 16-page bulletins highlight issues of importance to Americans interested in the improvement and future of policing.

AIDS Bulletins—present short, nontechnical summaries of important information on AIDS and related justice policies. These bulletins provide helpful, relevant information to criminal justice agencies and professionals concerned about AIDS and its impact on the criminal justice system.

Construction Bulletins—summarize case studies of progressive techniques for constructing correctional facilities. The bulletins are developed to help State and local jurisdictions seeking to increase corrections capacity in a cost-efficient manner.

Crime File Videotapes and Study Guides—present unrehearsed panel discussions by criminal justice experts on 32 critical issues facing the public, such as drug trafficking, sentencing, and prison crowding. The Study Guides, which supplement each videotape, provide background information and offer an in-depth study of the topic and the issues surrounding it. The videotapes and study guides are designed for a diverse audience including educators, policymakers, practitioners, and the public.

You will find other NIJ resources in this catalog, such as research abstracts, videotapes, resource packages and directories, and information on how to obtain publications from the Technology Assessment Program.




