## PREFACE

The Adjudication Technical Assistance Project of The American University is conducted under a Cooperative Agreement with the Bureau of Justice Assistance, U.S. Department of Justice. The primary objective of the project is to provide technical assistance to state and local jurisdictions planning or implementing programs under both the Anti-Drug Abuse Act (ADAA) and Justice Assistance Act (JAA). The project also is designed to support locally-funded efforts in court delay reduction, jail crowding reduction, career criminal/selective prosecution, and general adjudication system improvement programs to accommodate the direct and indirect impact of state and local anti-drug abuse activities on state judicial systems. The project also has a mandate to keep BJA program planning staff informed about issues and developments of importance to state and local justice system practitioners.
