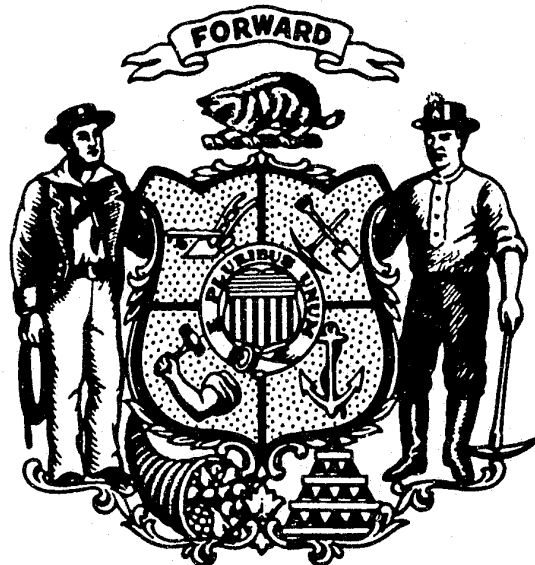

Offenders Released From  
Wisconsin Adult Correctional Institutions  
Calendar Year 1989

HIGHLIGHTS

- A total of 3,016 persons, 2,841 males and 175 females, were released from Wisconsin's correctional institutions for adult offenders during calendar year 1989. The majority (71.8 percent) of those leaving the institutions were classified as first releases, almost one-fourth (22.4 percent) as re-releases, with those released after completion of an alternative to revocation placement (5.4 percent) or after completion of a revocation hearing (0.4 percent) making up the remainder of the group.

- The bulk of the releases (88.0 percent) left the institution for supervision in the community on parole (27.5 percent), mandatory release (55.3 percent), or special action early release (5.2 percent) status. The remainder of the releases were discharged at completion of sentence (5.1 percent), discharged by court order (0.9 percent), or for other reasons (6.0 percent).

- Males first and re-released during 1989 had most often been sentenced for unarmed burglary (27.0 percent), theft (7.5 percent), and other drug violations (7.4 percent). Forgery (19.4 percent), theft (17.1 percent), and other drug violations (10.9 percent) were the offenses for which females first and re-released during 1989 had most often been sentenced.

- Males released during 1989 were serving average (mean) sentences of 63.9 months; females, 50.9 months. The average (mean) sentence for all offenders released in 1989 was 63.1 months. Six males serving life sentences were excluded from these computations.

- Over one-third of the males (35.9 percent) and females (34.3 percent) had been committed to the institutions from Milwaukee County. An additional one-fourth (23.7 percent) of the males and one-third (33.7 percent) of the females had been committed from Dane, Kenosha, Racine, and Rock Counties.

- The average (mean) length of stay since most recent admission for all offenders released in 1989 was 24.0 months. Males had an average (mean) length of stay of 24.4 months; females, 19.1 months.

- Offenders re-released in 1989 had spent, since last new admission, an average (mean) of 54.2 months in the institution. Males spent an average of 55.0 months; females, 33.9 months.

- One-fifth (21.8 percent) of the males and over one-tenth (12.0 percent) of the females re-released during 1989 had a record of at least two prior releases to the community.

- More than one-half of the males (55.8 percent) and females (51.4 percent) released in 1989 were from White racial and ethnic backgrounds.

- One-half (49.7 percent) of the males released were classified as property offenders, another one-fourth (25.7 percent) as assaultive offenders, and one-tenth (10.2 percent) as drug offenders.

- Females categorized as property offenders made up approximately three-fifths (58.9 percent) of the releases, assaultive offenders one-fourth (21.7 percent), and drug offenders less than one-fifth (15.4 percent).

- Less than one-tenth of the males (5.5 percent) and females (3.4 percent) were released on outstanding detainers to authorities from other states.  
(See Table 11.)
- Less than one-fifth (16.8 percent) of the males and one-fourth (25.7 percent) of the females took part in some type of Adult Basic Education program prior to release.  
(See Table 12.)
- Records indicate that over one-tenth (13.0 percent) of the males and over one-fourth (26.9 percent) of the females participated in programs leading to GED or HED certificates.

- The majority of the males (71.3 percent) and females (81.7 percent) did not take part in high school education programs prior to release. However, twenty-one males and five females earned high school diplomas prior to being released.

- Over one-fourth (27.4 percent) of the males and almost one-half (45.7 percent) of the females took part in programs for offenders with problems relating to the use of alcohol and/or other drugs.

- One-fifth (21.9 percent) of the males and less than one-tenth (7.4 percent) of the females had work release experience during this period of incarceration.

- Thirty-seven males (1.3 percent) took part in some type of study release placement prior to leaving the institution. None of the females released during 1989 had participated in a study release program while incarcerated.

- Nearly one-fourth (23.1 percent) of the males and over one-tenth (13.1 percent) of the females were enrolled in some type of vocational or apprenticeship training program prior to release.

- Ninety-two males (3.4 percent) and fourteen females (8.0 percent) were enrolled in college courses while institutionalized.

- Males serving sentences for unarmed burglary, other drug violations, and theft, which were the crimes for which males first-released in 1989 had most often been sentenced, spent an average (mean) of 23.3, 18.0, and 19.4 months respectively in the institution.

- First-released females, who were most often sentenced for forgery, theft, and other drug violations spent an average (mean) of 16.8, 17.6, and 14.8 months in the institution.

- Males serving sentences for the most common offenses among those re-released in 1989 (unarmed burglary, armed robbery, theft) served an average (mean) of 18.0, 33.6, and 15.2 months between the time of reinstitutionalization and release.

(See Table 21.)
- Females serving sentences for forgery, unarmed burglary, and theft spent an average (mean) of 9.7, 12.2, and 19.3 months in the institution prior to re-release.

(See Table 21.)
- First-released males who were serving five year sentences spent an average (mean) of 27.9 months in the institution; first-released females with five year sentences, an average (mean) of 22.9 months.

- Males and females with five year sentences who were previously released and returned to the institution following revocation of field supervision spent an average (mean) of 14.9 and 12.0 months in the institution prior to re-release in 1989.

(See Table 23.)

- Eight out of 10 males (83.3 percent) and six out of 10 females (59.4 percent) released during 1989 planned to live in Wisconsin, while over one-tenth (12.1 percent) of the males and almost two-fifths (37.7 percent) of the females intended to live elsewhere in the United States.
