After eight years in existence, the West Virginia Crime Victims Compensation Fund continues to provide financial assistance to innocent victims who suffer the effects of violent crime in our state.

The staff of the Fund, under the supervision of the Clerk of the Court of Claims, consists of a deputy clerk, two investigators, one secretary, and a part-time typist. There are approximately 300 claims filed each year.

FEDERAL GRANTS

Under the Federal Victims of Crime Act (V.O.C.A.) of 1984, federal monies became available to state compensation programs and victim assistance programs.

The U.S. Department of Justice, Office of Justice Programs, has allocated these funds to state compensation programs based on a formula of 35%-40% of the previous fiscal year claims awarded by each program.

West Virginia has received a total of \$1,133,000.00 in federal funds for its compensation program.

AWARDED CLAIMS FOR NONECONOMIC LOSS

CV-88-33 Angalich

Claimant's 45-year-old husband was the victim of an assault and battery in Ohio County. He died from his injuries two months later. An award of \$2,500.59 was made for funeral expenses and dependent's economic loss, and awards of \$5,000.00 each were granted to the claimant and her minor child for sorrow, mental anguish, and solace.

CV-88-119 Argabright

The 66-year-old claimant was beaten and robbed in Nicholas County. He suffered a loss of sight in the left eye. An award of \$4,778.92 was made for medical expenses, and \$15,000.00 was granted for emotional distress and pain and suffering.

CV-88-114 <u>Cazad</u>

The 24-year-old claimant was the victim of a shooting in Cabell County. He suffered amputation of a finger on the right hand. An award of \$24,119.83 was made for medical expenses and lost income, and \$5,000.00 was granted for emotional distress and pain and suffering.

CV-89-21 Ellis

Claimant's 28-year-old ex-husband was shot and killed in Wyoming County. Awards of \$5,000.00 each for sorrow, mental anguish, and solace were granted to the claimant on behalf of two minor children.

CV-88-183 Escue

The 32-year-old claimant was the victim of a shooting in Summers County. He suffered an eye injury and brain damage. An award of \$35,000.00 was made for medical expenses and lost income, and \$15,000.00 was granted for emotional distress and pain and suffering.

CV-88-192 Freeland

The 26-year-old claimant was injured in a motor vehicle accident in Calhoun County involving reckless driving. The claimant is confined to a wheelchair with permanent injuries. An award of \$35,000.00 was made for her medical expenses, and \$15,000.00 was granted for emotional distress and pain and suffering.

CV-88-178 Fulmer

The 39-year-old claimant was the victim of a sexual assault in Lewis County. An award of \$436.00 was made for medical expenses, and \$3,500.00 was granted for emotional distress and pain and suffering.

CV-87-294b Galati

The 59-year-old claimant was the victim of a sexual assault during a robbery at her home in Kanawha County. An award of \$283.00 was made for medical expenses, and \$5,000.00 was granted for emotional distress and pain and suffering.

CV-88-74 McCauley

The 37-year-old claimant was the victim of a shooting in Barbour County. An award of \$477.80 was made for medical treatment, and \$5,000.00 was granted for emotional distress and pain and suffering.

CV-88-198 Oldham

The claimant's 23-year-old daughter was strangled to death in Kanawha County. An award of \$1,250.00 was made for funeral and burial expenses, and \$5,000.00 was granted to the claimant as guardian of the victim's minor child for sorrow, mental anguish, and solace.

CV-86-39 Price

Claimants are the guardians of two minor children whose 24-year-old mother was found strangled to death in Greenbrier County. An award of \$1,156.25 was made to the victim's father for funeral and burial expenses, and \$20,000.00 was granted to the claimants as guardians of the victim's two minor children for sorrow, mental anguish, and solace.

CV-88-184 Rakes

Claimant's 29-year-old sister was killed in Logan County. An award of \$3,000.00 was made to the claimant and her spouse for funeral and burial expenses, and \$5,000.00 was granted to the claimant as guardian of the victim's minor child for sorrow, mental anguish, and solace.

CV-89-28 Riffle

The 31-year-old claimant was the victim of an assault and battery in Mason County. An award of \$3,145.93 was made for medical epenses, and \$2,500.00 was granted for emotional distress and pain and suffering.

CV-87-25 Riggall

The 35-year-old claimant was attacked and severely beaten in Kanawha County. An award of \$4,070.65 was made for medical expenses, and \$5,000.00 was granted for emotional distress and pain and suffering.

CV-88-182 Shawver

The 19-year-old claimant was the victim of a shooting in Fayette County. An award of \$26,077.43 was made for medical expenses and lost wages, and \$15,000.00 was granted for emotional distress and pain and suffering.

CV-87-70 <u>Tice</u>

Claimant's 54-year-old father was shot and killed in Pleasants County. An award of \$5,000.00 was granted to the guardian on behalf of the claimant for sorrow, mental anguish, and solace.

CV-88-186 Williams

The 18-year-old claimant was injured in a motor vehicle accident involving a drunk driver in Jefferson County. An award

of \$2,500.00 was granted for emotional distress and pain and suffering.
