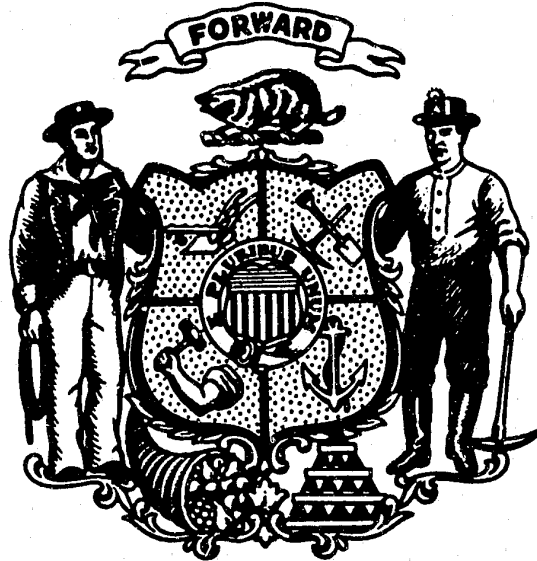

Residents in Wisconsin Adult Correctional Facilities
on December 31, 1989

- Offenders classified as new admissions accounted for the majority of the males (80.8 percent) and females (89.2 percent) in residence in Wisconsin's correctional institutions for adults on December 31, 1989. This category includes those admitted as new sentences and those admitted as probation violators with or without new sentences.
(See Table 1, pps. 1-2, pps. 29-30.)
- Over one-half (53.1 percent) of the males were from White racial and ethnic backgrounds while approximately two-fifths (38.4 percent) were Black. The female resident population was nearly evenly divided between Whites (49.1 percent) and Blacks (47.7 percent).
(See Table 2, p.3, p.31.)
- Unarmed burglary (19.3 percent), armed robbery (9.1 percent), and first degree sexual assault (8.5 percent) were the major offenses for which males had most often been convicted and sentenced. Females were most frequently sentenced for forgery (16.4 percent), other drug offenses (13.2 percent), and theft (10.0 percent).
(See Table 3, pps. 4-7, pps. 32-34.)
- Slightly less than three-fifths (57.1 percent) of the males in residence were classified either as assaultive offenders or as assaultive, sex and/or drug offenders. Males categorized as sex offenders or also as drug and/or assaultive offenders made up one-fifth (20.6 percent) of the resident population while over one-tenth (12.2 percent) were classified as drug offenders either alone or in conjunction with assaultive and/or sex offenses. One-third (32.1 percent) of the males were property offenders.

Two-fifths (40.2 percent) of the females in residence were property offenders. Those classified either as drug offenders or additionally as assaultive offenders made up somewhat less than one-fifth (16.4 percent) of the population while those considered to be sex offenders made up only 1.8 percent of the group. Over two-fifths (42.3 percent) were classified, either solely or in combination with sex and/or drug offenders, as assaultive offenders.

- Males in residence had an average (mean) sentence of 10.8 years while the average (mean) sentence for females was 6.6 years. Three hundred eighty-nine males and 19 females serving life sentences were excluded from these computations.
(See Table 5, p.9, p.36.)
- Over one-third of the males (36.9 percent) and females (34.2 percent) had been committed to the institutions from Milwaukee County. Four counties, Dane, Kenosha, Racine, and Rock, accounted for the commitment of one-fourth (26.8 percent) of the males and over one-third (35.2 percent) of the females.

- Males, with an average (mean) age of 30.7 years, were approximately one year younger than females who had an average (mean) age of 31.6 years.

- Wisconsin was the place of birth for over one-half of the males (54.8 percent) and females (54.1 percent) in residence.
(See Table 8, p.16, p.41.)
- Three-fourths (75.5 percent) of the males and two-thirds (65.1 percent) of the females were without any type of physical, emotional, or developmental disability.
(See Table 9, p.17, p.42.)
- Approximately one-fifth (17.3 percent) of the males and three females (1.1 percent) had a record of previous service in the military.
(See Table 10, p.18, p.43.)
- About one-third of the males (33.4 percent) and females (35.2 percent) had some degree of high school education but had not earned diplomas. GED certificates or high school diplomas had been received by over two-fifths (43.7 percent) of the males and three-tenths (31.3 percent) of the females.
(See Table 11, p.19, p.44.)
- A tested grade level of sixth grade or less was reported for somewhat less than two-fifths of the males (37.4 percent) and females (35.2 percent). Less than one-fourth of the males (22.8 percent) and females (23.1 percent) tested at or over the twelfth grade level.

- Males had been in residence for an average (mean) of 26.5 months; females for 18.5 months.
(See Table 13, p.21, p.46.)
- Over one-third of the males were classified as close or maximum custody (34.5 percent) or as medium or medium out custody (35.8 percent). Slightly less than one-fourth (23.8 percent) were classified as minimum custody while the remainder (5.9 percent) were unclassified. One-fourth (24.6 percent) of the females were classified as maximum, one-fifth (21.4 percent) as medium or medium out, and almost one-half (45.2 percent) as minimum. Less than one-tenth (8.8 percent) were unclassified. The presence of individuals with maximum and medium security ratings in minimum security facilities is due to a time lag in reporting changes to the data system.

- Three-fifths (60.7 percent) of the males and two-fifths (41.3 percent) of the females were found to have at least a moderate need for treatment for problems with the use of alcohol. Information was obtained from the inmate needs assessment system.
(See Table 15, p.23, p.48.)

- Involvement in some type of program for those with problems relating to the use of drugs was at least a moderate need for approximately two-thirds of the males (63.1 percent) and females (65.5 percent) in residence. Information was obtained from the inmate needs assessment system.
(See Table 16, p.24, p.49.)
- Four-fifths (81.7 percent) of the males and three-fourths (75.4 percent) of the females were found to have alcohol and/or drug problems. Information was obtained from the inmate needs assessment system.
(See Table 17, p.25, p.50.)
- At least a moderate need for treatment of some type of mental health problem was indicated for about one-fifth of the males (18.2 percent) and females (19.6 percent) in residence. Information was obtained from the inmate needs assessment system.
(See Table-18, p.26, p.51.)
- Enrollment in some type of educational program was found to be at least a moderate need for over one-half (53.3 percent) of the males and over three-fifths (62.3 percent) of the females. Information was obtained from inmate needs assessment system.
(See Table 19, p.27, p.52.)
- Test results indicated that over three-fourths of the males (76.5 percent) and females (76.9 percent) had moderate or serious needs for some type of vocational training program. Information was obtained from inmate needs assessment system.
(See Table 20, p.28, p.53.)
