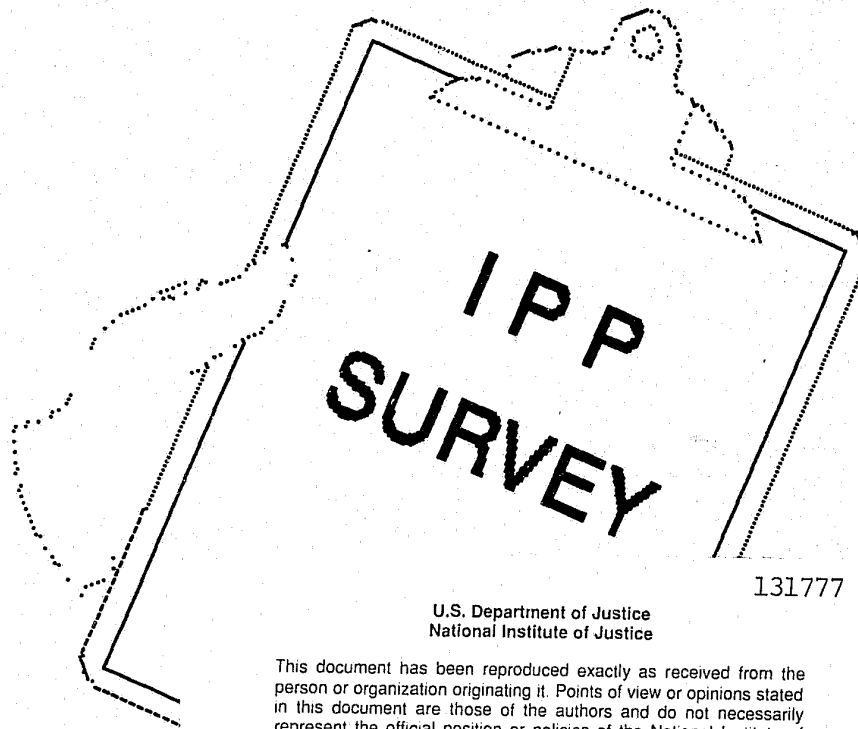

## EXECUTIVE SUMMARY

A survey conducted by the Pennsylvania Commission on Crime & Delinquency, Bureau of Statistics and Policy Research set to measure utilization of county intermediate type punishment programs (IPP). Passage of Acts 193 & 201, allowing for the implementation of IPPs, sparked the necessity of the survey. The survey, conducted via mail, ended in April 1991. The results reveal:

- o Counties currently spend approximately \$34.2 million annually for IPPs.
- o Based on the responses of 65 counties, 459 different IPPs are presently operating.
- o More than 40,000 offenders are currently supervised (or seeking treatment) in IPPs.
- o The IPP type utilized most by counties is partial/intensive outpatient drug & alcohol treatment.
- o The IPP type utilized least by counties is house arrest without electronic monitoring.
- o Thirty-six percent of the IPPs targeting DUI offenders exclusively were created after 1987, the year DUI offenders peaked as the single largest sentenced offender-type received in county jails.
- o Total average annual costs for IPPs is \$800 per individual.
- o IPPs are utilized by 63 of the 65 responding counties. There is no discernable pattern between program type and county size or geographical location.

## OVERVIEW

In 1990, the Pennsylvania General Assembly passed two acts commonly referred to as the County Intermediate Punishments Acts (Act 193 & 201). In part, the Acts reflect the Commonwealth's concerted efforts to encourage counties to develop and implement intermediate punishment programs which simultaneously ensure public safety and promote the efficiency and economy in the delivery of corrections services.

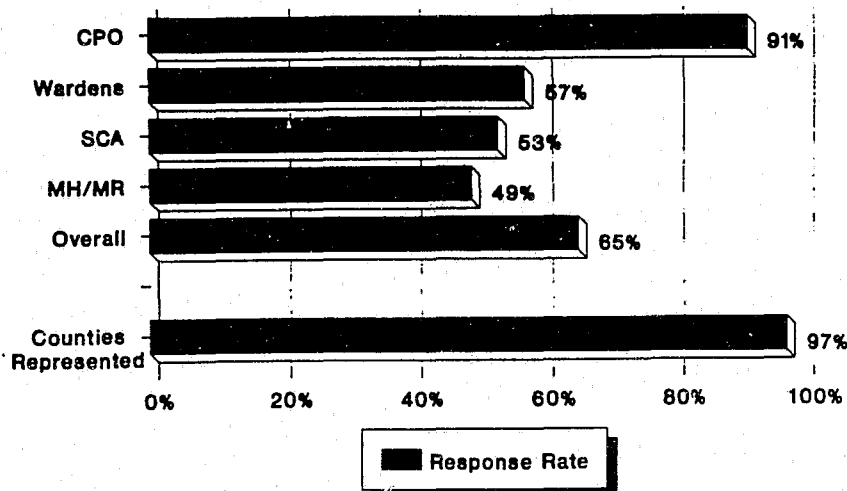
Intermediate punishment programs (IPP) cannot and do not officially exist unless and until counties submit an IPP plan to the Pennsylvania Commission on Crime & Delinquency (PCCD) for approval and certification. However, the PCCD recognizes that intermediate punishment type programs are presently utilized by most counties. As such, the PCCD Bureau of Statistics and Policy Research conducted a state-wide county level survey in the Spring of 1991 to determine the pervasiveness of intermediate punishment type programs. For simplicity, this report refers to such programs as IPPs.

## SURVEY PARAMETERS

The four principal survey respondents were county prison wardens, chief probation officers (CPO), single county authorities (SCA), and county MH/MR administrators. The decision to limit the survey to only these four principals reflects the PCCD's confidence in obtaining the most pertinent and accurate data with the greatest efficiency. Because 27 counties lacked one or more of the four principals, the PCCD mailed a total of 223 surveys.

The overall response rate reached 65% (145/223). The greatest response rate belongs to the CPOs with 91% (60/66), followed by the county prison wardens (57% or 38/67), the SCAs (53% or 26/47) and MH/MR administrators (49% or 21/43). Except for Montour and Potter counties, at least one principal from each county responded to the survey (See Figure 1).

The survey encouraged principals to list known IPPs operating in their county even when the IPP lay beyond their sphere of supervision. When two or more principals from the same county responded with slightly varying information on an identical IPP, the PCCD deferred to the expertise of the principal working most intimately with the IPP and used that information when compiling survey results.

In order to keep the survey data accurate, follow-up phone calls were made to several principals to ensure that the programs they listed were, indeed, IPPs; that is, programs to which a county judge could sentence offenders. Respondents often cited GED, literacy and woodshop programs as IPPs, but these were excluded from the final data because such programs are not sentencing options.

The survey consisted of nine columns. Column titles and definitions used in the actual survey supplement are as follows:

**1. PROGRAM NAME:** Identify the name of the intermediate punishment type program presently operating in your county. Identify only those programs guided by established rules and regulations. List each program separately. For example, your county has an electronic monitoring program and it is administered via two separate programs, one called Program A and the other called Program B. Enter both programs on separate rows.

**2. PROGRAM CLASS:** Classify the program according to the corresponding letter codes below. **USE ONLY ONE CLASSIFICATION FOR EACH PROGRAM.**

3. **TARGET POPULATION:** What is the target population the program is intended to serve? Please use the code for the primary group served by the program.

4. **PROGRAM CAPACITY:** Identify the maximum number of offenders the program is designed for or limited to.

5. **CURRENT PROGRAM POPULATION:** Identify the number of offenders actively involved in the program.

6. **YEAR IMPLEMENTED:** List the year the program became operational.

7. **ANNUAL COST:** Provide the best cost estimate of the program. Include the costs of any equipment as well as personnel.

8. **SUPERVISING PROGRAM AGENCY:** Identify the agency (public, private or non-profit) that is charged with administering the program.

9. **PROGRAM CONTACT PERSON & PHONE NUMBER:** Identify the contact at the agency directly responsible for administering the program and their phone number.

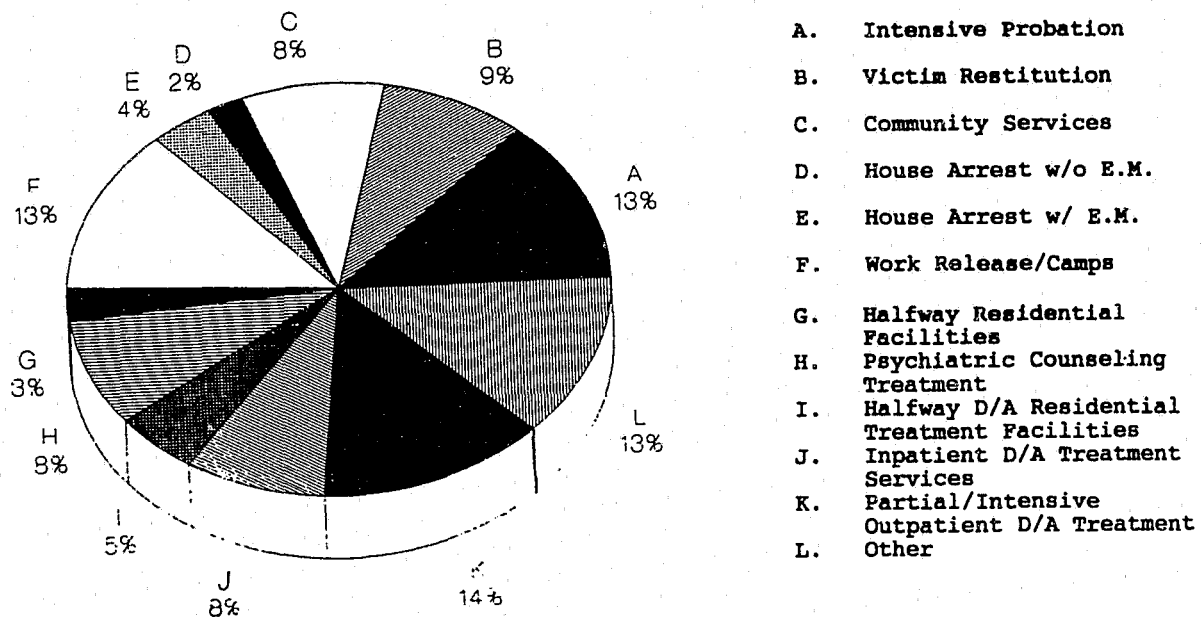
## SURVEY RESULTS

According to the survey results, sixty-five responding counties operate 459 IPPs at an annual cost of over \$34.2 million. Collectively, program capacity totaled 34,170 with total offender enrollment at 40,793. These figures are estimates since many respondents could not provide the capacity and present population for IPPs because such figures were contingent on extenuating circumstances (i.e., number of parole officers, funding levels, unlimited capacity, etc.) or respondents simply did not know. Therefore, both figures could be higher in actuality.

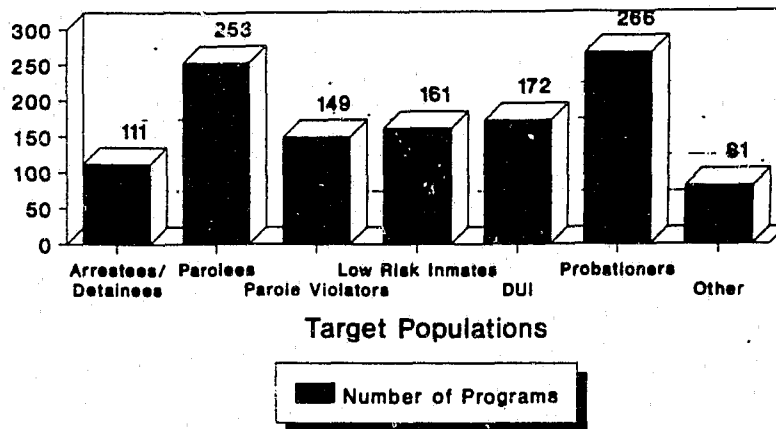
One in five programs <sup>was</sup> implemented between 1989 and 1991 with 25 implemented during the first three months of 1991 alone.

Respondents were instructed to classify each program they listed on the survey according to how best the IPP could be defined. A program could be classified only as one type (intensive probation, community service, or house arrest, etc.). Figure 2 provides data on the percentages each classification assumed based on the survey results. The most numerous program type was partial/intensive outpatient drug and alcohol treatment (14%), followed closely by intensive probation supervision, work release/work camps, and programs classified as "other", each with 13%. The least reported classifications were house arrest without electronic monitoring (2%), halfway residential facilities (3%) and house arrest with electronic monitoring (4%).

TARGET POPULATIONS**

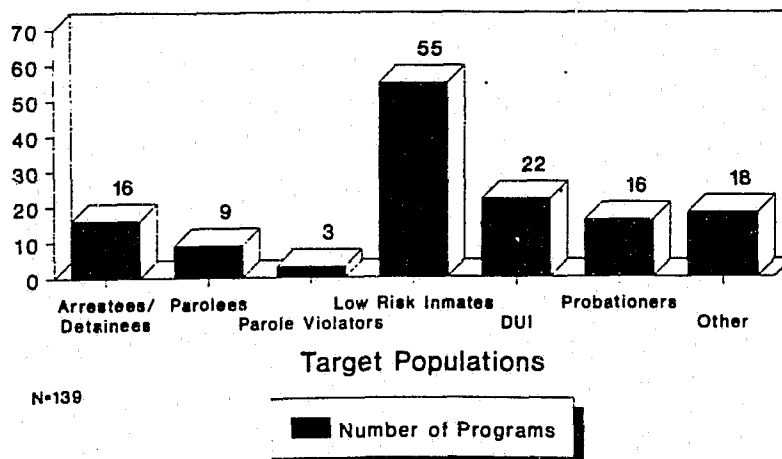


Note: Many single programs target several populations simultaneously

Seventy percent (320) of the 459 reported IPPs targeted several offender types simultaneously. Figure 3 (above) illustrates the number of IPPs serving particular target populations. Offender types most frequently cited as a target by IPPs are probationers (266), parolees (253) and DUI offenders (172). Table 1 (page 6) provides complete figures for each program type for all target population categories.

Of the 459 reported IPPs, 139 (30%) were designed exclusively for one target population. Figure 4 (below) illustrates the number of "focused" programs for each target population. Low risk inmates were targeted most (55) followed by DUI offenders (22) and probationers and arrestees/detainees (16).

Forty-five (26%) IPPs involving DUI offenders were created since 1987, the year DUI offenders peaked at 40.6% as the single largest sentenced offender-type received in county prisons. With capital costs for new jails becoming more prohibitive, many counties have found IPPs relatively low cost alternatives.

According to the Department of Corrections, it costs counties in 1989 an average of \$17,573 to incarcerate one inmate annually. IPPs average an annual cost of \$838 per individual\*\*.

Table 2 on the following page provides a summary of the number of offenders supervised or treated by program type by county. Table 2 illustrates that all responding counties utilize IPPs and there is no demonstrable pattern associating one program type or another with county size or geographical location. What seems to drive the development and implementation of IPPs (especially those involving DUI offenders) is the need for alternatives to incarceration for a particularly prevalent offender type within a given county.

Table 1 below illustrates the number of program types involving the target populations listed in the survey questionnaire. As mentioned earlier, 70% of all IPPs involve more than one target population.

## CONCLUSION

Intermediate punishment type programs are already flourishing in Pennsylvania usually under the auspices of either county adult probation departments or jails. Changes in Pennsylvania's sentencing guidelines will allow judges to sentence offenders to intermediate punishments as an alternative to incarceration while still placing sanctions on the offender. Figures in Table 3 may offer a glimpse of judges' propensity to sentence offenders to IPPs.

IPPs may offer Pennsylvanians immediate cost savings and, perhaps more importantly, begin to address the basic issue of choosing which offenders to incarcerate and which to sentence to an IPP. Of course, the great unknown is the public's perception of IPPs concerning the questions of safety and fairness. This issue, of course, is beyond the scope of this survey but it may serve as a basis for future evaluations.
