Introduction

This factbook provides data on persons detained, jailed, or imprisoned in Delaware during the years 1981 to 1990. Its purpose is to provide a factual basis for understanding past and present trends in the incarcerated population. The need to understand what is happening is increasingly urgent because of the steadily growing costs of building and operating institutions to house and treat the expanding offender population. Consider the fact that between 1981 and 1990 the incarcerated and detained population in Delaware grew from 1,562 to 3,635 inmates, an increase of 133 percent. Dealing with the problems of increased numbers is increasingly difficult in this era of governmental fiscal austerity and in light of the competing needs of education, social services, health services, and transportation. During this difficult time, we need to be especially attentive to the use of the most expensive item—prison beds. In this situation our greatest need is the need to know why our incarcerated populations are growing so rapidly. What kinds of changes are going on and what are the strategic points for intervention to regain control of the rising numbers? In addition we need to know what kind of an information system we must have to assess in advance the probable effects and costs of new legislative enactments and new policy changes in sentencing and correctional management.

This report provides baseline data to build an information system that can answer such questions. It is focused on those detained, jailed, and imprisoned. It does not yet include data on those under supervision as probationers or parolees. It draws on data available in the Department of Correction's (DOC) automated data system and is subject

to that system's current data limitations, as for example the absence of detailed information on the past criminal records of prisoners. But concerted efforts are being made to identify and remedy these deficiencies by the DOC, the Statistical Analysis Center (SAC), and the Delaware Justice Information System (DELJIS). It is the objective of SAC to update the trend data presented in this report on a yearly basis and to integrate new data as they become available.

The factbook has four sections, each containing an introductory note, graphic representations of the data, and detailed tables for each year of the decade. The first section on detention, for example, presents a table which shows admissions to detention for fourteen types of crime. Another table classifies admissions according to the seven broad offense categories used by the Sentencing Accountability Commission (SENTAC). On the facing page for each year is a table showing the average time detained in days for each type of crime and a second table presenting average time detained using the SENTAC categories.

Admissions and time served are the key determinants of change in the size of the incarcerated population in Delaware. Accordingly, in the second sec-

tion a similar pattern is followed in presenting tabular data on offenders sentenced to jail or prison. The third section provides a snapshot profile of the incarcerated population on June 30th of each year from 1981 to 1990. Again, the population is classified by type of crime and by SENTAC category. Finally, the fourth section presents snapshot data on the demographic characteristics of the incarcerated population as of June 30th of each year. One table shows sex and race distributions by type of crime and a second table shows the average age classified by gender, race, and crime type.

Several features of the Delaware system of criminal justice should be noted in examining the trend data.

Unified Correctional System. In Delaware, both jail and prison populations are under the control of the state Department of Correction. In all but six states in the country, by contrast, persons detained or sentenced to jail are under the jurisdiction of county or city governments, while those sentenced to prison are the responsibility of the state. One advantage of Delaware's arrangement is that comparable information is available on both jail and prison populations in the DOC statistical office.

SENTAC. A second distinctive feature of Delaware is the Sentencing Accountability Commission. SENTAC was created in October 1987 to develop sentencing standards that would make the most effective use of incarceration facilities. This has meant giving highest priority in use of incarceration to sentencing of offenders who employed violence in committing their offenses. Nonviolent felons and misdemeanants are likely to receive shorter sentences or direct commitment to community-based custody or supervision. SENTAC has established five different sentencing levels in terms of the intensity of supervision and surveillance. Level V involves incarceration in a jail or prison. Level IV uses halfway houses, residential drug treatment, and house arrest with electronic monitoring, often coupled with full days of work, education, or treatment. Level III provides 25-offender caseloads for probation officers and requires frequent supervision contacts and participation by the offender in work, education, and treatment. Level II involves traditional probationary supervision and Level I is passive surveillance that incorporates routine computer checks on police contacts and special conditions the judge may order to provide restitution for the victim and public protection. It is increasingly common for judges to

split the sentence between a period of incarceration at Level V and subsequent amounts of time to be served at other levels in the community. Successful performance under sentence may result in an acceleration toward freedom by transfer to a less restrictive sentencing level. Failure to meet required conditions may result in increased surveillance and punishment.


Truth in Sentencing. A third distinctive feature of Delaware's criminal justice system is the adoption of a determinate sentencing law known as Truth in Sentencing. This legislation, which took effect in July 1990, sought to correct a long-standing problem of disproportionate awards of good or merit time credits by the DOC and also eliminated parole release. Before Truth in Sentencing, serious offenders with long sentences had access to programs that grant extensive time served credits to which nonviolent offenders did not have access. Truth in Sentencing adopted a maximum of 90 days good time credit per year served. It required more time to be served by offenders who had committed crimes against persons and shorter time for non-person-crime offenders. This change created a more equitable and still budget-neutral sentencing system. In time, the early updates for

this factbook should document the effects of these changes on time served and on the size and composition of the incarcerated population.


The databases for the incarceration factbook, which took over two years to develop, with the assistance of the De-

partment of Correction and the Delaware Justice Information System, are already having an important impact on the types of analyses being produced by the Statistical Analysis Center. Detention and inmate population forecasts, analyses of the detention population, and assessments

Admissions by Incarceration Status 1981-1990




Snapshot Population by Type of Incarceration on June 30 1981-1990

of the effects of Truth in Sentencing are outgrowths of the development work. An indication of the usefulness of the data base can be gained from the accompanying graphs. The graph on admissions by incarceration status during 1981-1990 shows the increasingly heavy demands being placed on the detention and jail system for pre-sentenced and sentenced offenders. The graph of the June 30 snapshot population during 1981-1990 by type of incarceration shows the heavy demand for bed space in the prison system as a reflection of longer sentences, compared to the faster turnover in the jail and detention populations. It is also possible to determine

the contribution of different types of criminal offenders to population growth. For example, the graph on trends in the detained and incarcerated drug offenders populations shows the special burden on the prison system resulting from changes in the drug laws and increased drug law enforcement. Reductions in the amount of drugs required for mandatory commitment to prison and increases in police manpower have had a significant impact on the prison population, especially since 1985. Similar analyses can be carried out with the trend data presented in this factbook for other offenses and for the SENTAC offense categories.

Detention

Anual admissions to pretrial detention grew from 3,526 in 1981 to 8,260 in 1990, an increase of 134 percent. The state population increased 11 percent during the same time period.


The detention population growth was related to increases in both the number of admissions and the average time detained. The majority of the increase was caused by increased admissions. Increased time detained had a lesser effect.

Detention admissions increased each year of the decade, but the greatest rate of increase occurred between 1987 and 1989. As the graph on detained admissions shows, in 1987 monthly detention admissions ranged from 358 to

516, with a monthly average of 430, and in 1989 they ranged from 469 to 753, with a monthly average of 638. The increase in average monthly admissions between 1987 and 1989 was 48 percent. The increase in just these two years constitutes more than one half the increase during the decade.

In 1990, the rate of increase appears to have slowed and possibly stabilized with the monthly

Note: Crosspiece = annual mean.



range of detention admissions ranging from 583 to 734, and a monthly average of 688.

Detention for drugs contributed significantly to the increase in admissions over the decade. In 1981, there were 216 persons detained for a drug arrest as shown in the graph on detained admissions by crime group. In 1990, there were 1,238 persons detained for a drug arrest. These increases can be seen more clearly by examining the yearly tables in the following pages.

As impressive as the increase for drug detention is, it is outranked by the increase in admissions for capias/contempt violations as can be seen more clearly in the following tables. In 1981, there were 337 persons detained for a capias or contempt violation. In 1990, there were 2,303 persons detained for those reasons. Another category that helps explain the rapid increase for detention admissions is "miscellaneous crimes." In 1981, for these offenses, 692 persons were detained. Detention in 1990 climbed to 1,224. Miscellaneous crimes include disorderly conduct, obstruction of an arrest, fugitives from other states, federal government holds, and attempted crimes of an unknown type.

Crime on the streets and the war on drugs have had a major impact on increasing detention admissions. These increases are relatively understandable because they can be cross-checked with reported crime and arrest patterns and specific public policies. The more administrative-type changes like the rapid increase for capias/contempt admissions is more difficult to understand. The causes of this type of change are more subtle and involve changing processes in law enforcement and the courts and require intensive study to be fully understood. The very rapid recent increase in probationers should not be overlooked. Between January 1989 and January 1990, the number of probationers increased by 42 percent. Violations of probation conditions often lead to a capias being issued.

The changing time served patterns for detention are shown in the table on average time detained. Overall the average time detained increased by 17 percent between 1981 and 1990. Considering the 134 percent increase in detention admissions, it is almost surprising that the time served increased only by 17 percent. There has not been a 134 percent increase in detention, prosecutorial, public defense, or court manpower, yet time served in detention has increased by a relatively small degree. This must be attributed to the participating agencies' innovativeness and dedication to keeping suspects

moving through the criminal justice system.

Between 1981 and 1990, average time detained increased from 24.66 days to 28.84 days. The most significant increases relate to drugs (+117 percent), weapon possession (+89 percent), miscellaneous crimes (+59 percent), and probation violation (+47 percent).

Average detention times decreased for violent felonies (-13 percent), non-SENTAC crimes (-57 percent), and specific crimes like fraud (-21 percent) and traffic (-20 percent).

The data tables in this section on detention are organized with admissions information on the left-hand side and average time detained on the right-hand side. The top half of the facing pages shows admissions and time served for 14 types of crime listed in the lexicon in the introduction of the report. The bottom half of the facing pages shows admissions and time detained by the SENTAC categories. The use of SENTAC categories prior to 1987 is heuristic in that it provides a "what if" scenario showing what time detained would have been, for example, for violent offenders had SENTAC existed prior to 1987 and been applied to detainees.



Sentenced Admissions

Sentenced admissions and time served are examined from three perspectives. These components of change are first split into jail admissions (sentences equal to or less than one year) and prison admissions (sentences greater than one year). This division makes it possible to compare Delaware's prison admissions to the prison admissions of other states. It also makes it possible to examine how changes in short term admissions to jail compare to changes in long term admissions to prison.

The third perspective describes sentenced admissions by SENTAC groups. This provides data on violent felonies and misdemeanors, nonviolent felonies and misdemeanors, parole and probation violators, traffic/DUI, and non-SENTAC offenders.

As noted in the graph on sentenced admissions to the Department of Correction, average monthly admissions have increased since 1981 from 149 per month with a range of 122 to 172, to 314 per month with a range of 262 to 357 per month in 1990. During the 1980s, sentenced admissions increased 111 percent (recall that detention admissions increased 134 percent during the same time period).

By examining the graph on sentenced admissions by SENTAC



group and also the yearly tables that follow, it can be seen that violent felony admissions have increased each year since 1984, from 280 to 837 in 1990, a 198 percent increase. Much of this growth is due to increases in admissions of drug offenses (37 in 1984 and 248 in 1990), sex offenders (49 in 1984 and 84 in 1990), robbery (46 in 1984 and 71 in 1990), and assault (52 in 1984 and 83 in 1990).

However, when prison admissions are compared to jail admissions over the decade as noted in the bar chart on sentenced admissions, the increases in prison, as significant as they are, appear relatively small. Over the decade, jail admissions increased steadily from 1,087 in 1981 to 2,921 in 1990 (168 percent). The following yearly tables indicate that the major contributors to increased jail admissions between 1981 and 1990 are DUI (37 to 925), capias/contempt (194 to 437), probation violators (79 to 272), drugs (49 to 193), and assault (96 to 170).

Although jail admissions have increased at an almost constant rate over the decade, the pattern for prison admissions has been more complex. Prison admissions declined from 696

in 1981 to a low of 527 in 1984. From that point prison admissions increased to 968 in 1989 and then decreased to 850 in 1990. The decrease in prison admissions in the early 1980s may be related to the parallel decrease in reported Part I crimes and arrests during the same period. It would however appear that the decrease in 1990 is related to the implementation of Truth in Sentencing which was designed to shift some property offenders from prison to jail, in exchange for



longer time served for offenders committing crimes against persons. Most notable are the reduction of prison admissions for burglary (155 in 1989 to 106 in 1990) and theft (81 in 1989 to 47 in 1990). The Statistical Analysis Center will continue to monitor these changes.

Time served as a second major component of change in incarcerated populations has also been on the increase. The time served increases, however, as was true for detention patterns, have had less effect on population increases than have increased admissions. From 1981 to 1990 average prison time served increased from 24.57 months to 30.28 months, and

jail time served increased from 72.07 days to 80.26 days.

In prison, the types of crime with the largest increases for time served over the decade are fraud (9.9 to 22.5 months, +126 percent); probation violations (9.5 to 20.7 months, +117 percent); capias/contempt (9.9 to 15.8 months, +60 percent); and burglary (20 to 30 months, +51 percent).

In jail the crime types with the largest increases for time served over the decade are weapons (64 to 118 days; +85 percent), theft (65 to 95 days; +46 percent), burglary (111 to 159 days; +43 percent), and sex crimes (129 to 177 days; +38 percent).


Persons incarcerated in Delaware are included in one of three categories: detention includes those persons awaiting a bail hearing or a trial prior to sentencing; jail includes those persons sentenced to one year or less; and prison includes those persons sentenced to more than one year. Although Delaware is one of six states that operate a unified detention and corrections system, the categories "jail" and "prison" allow population comparisons to be made with non-unified corrections states. Most states maintain locally controlled detention and jail systems and state-operated prison systems.

Between 1981 and 1990, the overall incarcerated popula-

tion as of June 30 each year increased 133 percent (from 1,562 to 3,635). Proportionately over the decade, the jail population shows the largest increase—233 percent (177 to 590). The detention population increased nearly as rapidly as the jail population—200 percent (from 237 to 711). Numerically, the prison population increased more than either the jail or detention populations (+1,186). Proportionately, however, it increased the least—103 percent.

The preceding sections of this report show the relationships between admissions and time served

for detention, jail, and prison. It is the combination of admissions patterns and length of stay patterns that produce the incarcerated populations that are described in this section. As described in those earlier sections, the reasons for differential growth for the different incarcerated populations vary.

For instance, the detention populations, although increasing over the decade for all types of crime except "traffic," increased most rapidly between 1987 and 1989. The rapid increase of the detention population was caused by increased admissions for capias/contempt violations (from 1,007 to 1,883), drug offenses (417 to 1,072), and "miscellaneous crimes" (954 to 1,241).

In contrast to the growth spike in the last years of the 1980s for the detention population, the jail population steadily increased throughout the decade. The jail population increased in every crime category over the decade. The largest increases were for DUI, from a population of 7 in 1981 to a population of 149 in 1990; and drug offenses, from 11 in 1981 to 65 in 1990. It is interesting to note that DUI represents the crime type with the largest population growth for jail,

while it was not a major factor in the detention population. This means that very few DUI defendants are detained prior to sentencing.

Prison admissions decreased between 1981 and 1984. This decrease appears to be related to the decreasing crime rates during the same period. From that point, prison admissions increased until 1989. In 1990, for the first time since 1984, prison admissions decreased, even as the number of reported violent crimes increased. The decrease in 1990 appears to be related to implementation of Truth in Sentencing, because many property offenders will be serving shorter terms than previously while violent offenders will be serving longer terms. In the short run, it is anticipated that Truth in Sentencing will stabilize the prison population through shorter time served for property offenders. In the long run, this stabilization will be offset with longer time served for some of the violent offenses.

Even though prison admissions decreased between 1981 and 1984, the decrease was not large enough, nor did it last for long enough, to offset longer lengths of stay. As admissions to prison decreased, the population actually increased from 1,148 in 1981

to 1,578 in 1983. The population grew only slightly in 1984.


As prison admissions increased between 1984 and 1989, so did the population, from 1,583 in 1984 to 2,304 in 1989. In 1990, most likely due to Truth in Sentencing, the population stabilized at 2,334.

As the graph "Sentenced Population by SENTAC (Level V)" shows, most of the growth in the prison population over the decade has been for violent felonies and non-SENTAC crimes. However, because of SENTAC and the

addition of nonprison punishment options, the numbers of persons imprisoned for nonviolent felonies have decreased since 1987.


Often in prison population analysis, the focus is limited to the number of offenders in prison. Funding for beds and prison operations requires the bottom line of the number. Perhaps as important, however, is the mixture of the offenders. The pie charts for the population profiles show the comparative size and mixture of the total Delaware incarcerated population for six groups—person crimes, DUI/traffic crimes, property crimes, violator crimes, other crimes, and drug crimes. The chronological series of the four pie graphs depicts not only a rapidly growing incarcerated population; it also shows the undercurrents of changing types of offenders.

Sentenced Population By SENTAC (Level V) 1981-1990





Population Profiles







Demographic Profiles

After the numbers and types of offenders are known, the most frequently asked questions relating to the incarcerated population are questions of gender, age, and race. This section provides, for the first time for Delaware, answers to many of these questions.

Comparative graphics and tables provide a decade long comparison for gender and race. These displays provide numerical and proportional comparisons. For instance, 135 black males were detained in 1981; this was 57 percent of the 237 total detainees. In 1990, there were 429 black males detained or 60 percent of the 711 total detainees. Similar displays are provided separately for jails and prisons.

In addition to the displays relating to gender and race, another table compares the average (mean) age of prisoners by gender and race. Separate summaries are provided for detention, jail, and prison. Almost across the board, there has been a two- to three-year increase in the average age of the detainees and sentenced offenders. In 1981, the average male detainee was about 27 years old. In 1990, the average male detainee was about 29.5 years old. In prison, the average male age increased from 29.8 years old to about 32.2 years old.

The increase of two to three years for the average age of incarcerated persons is important because it represents a significant increase in the number of persons arrested, convicted, and incarcerated for ages 30 to 40 and even 40.

and over. This single finding may mean that the belief that involvement in crime decreases very rapidly after age 30 is not nearly as valid as it was 10 to 15 years ago.

The propensity for older persons to be involved in criminal activity takes on even more importance when broader demographic trends for Delaware are examined. In Delaware, as elsewhere in the nation, it was hoped that the passing of the baby boom cohort into their middle ages in

the 1980s would produce a reduction in prison admissions. The increased propensity of persons over the age of 30 (the baby boom) to commit crimes in the 1980s may have erased this anticipated source of reduced prison admissions.

For each year in the decade, two de-

tailed tables are provided. The first table shows the distribution of gender and race by type of crime separately for detained, jail, and prison populations. The second table shows the average (mean) age by gender and race groups for each type of crime separately for detained, jail, and prison populations.
