

Offenders Released from
Wisconsin Adult Correctional Institutions
Calendar Year 1990

H I G H L I G H T S

- Wisconsin's correctional institutions for adult offenders reported the release of 3,034 offenders, 2,804 males and 194 females, during calendar year 1990. First releases made up almost three-fourths (72.5 percent) of the group, while one-fourth (22.6 percent) were classified as rereleases, and the remainder (4.9 percent) were released after alternative to revocation hearings, or for other reasons.

(See Table 1.)
- Nine out of 10 (89.2 percent) of the persons released left the institutions for supervision in the community on parole (47.0 percent), mandatory release (41.6 percent), or special action early release (0.6 percent) status. The remainder of the releases were discharged at completion of sentence (4.7 percent), discharged by court order (0.9 percent), released after completion of revocation hearings (0.6 percent), released after alternative to revocation placement (4.3 percent) or died while institutionalized (0.3 percent).

- Unarmed burglary (22.9 percent), other drug offenses (10.6 percent), and theft (7.9 percent) were the offenses for which males first and rereleased during 1990 had most often been sentenced. Females first and rereleased during 1990 had most often been sentenced for other drug violations (22.5 percent), forgery (14.1 percent), and theft (8.4 percent).

- The average (mean) sentence for all offenders released during the year was 60.6 months. Males released during 1990 were serving average (mean) sentences of 61.8 months; females, 43.5 months.

- Milwaukee was the county of commitment for over one-third (36.5 percent) of the males and three-tenths (30.4 percent) of the females released during 1990. Over one-fourth (27.1 percent) of the males and about two-fifths (37.7 percent) of the females had been committed from Dane, Kenosha, Racine and Rock Counties.

- Males had an average (mean) length of stay of 22.8 months; females, 15.8 months. The average (mean) length of stay since most recent admission for all offenders was 22.4 months.

- Offenders rereleased during 1990 had spent an average (mean) of 56.0 months in the institution since last new admission. Males spent an average (mean) of 57.2 months; females, 30.3 months.

- One-half (52.4 percent) of the males and almost one-half (46.1 percent) of the females were from White racial and ethnic backgrounds.

- One-fourth (26.4 percent) of the males released during 1990 were categorized as assaultive offenders, over one-tenth (14.3 percent) as drug offenders, and slightly less than one-half (45.9 percent) as property offenders.
(See Table 9.)
- More than two-fifths (43.5 percent) of the females released during 1990 were classified as property offenders, while over one-half were drug (27.7 percent) and assaultive (24.6 percent) offenders.

- Less than one-tenth of the males (3.2 percent) and females (2.6 percent) were released on outstanding detainers to authorities from other states.

- One-fourth of the males (24.2 percent) and females (25.2 percent) had either completed some type of academic program while incarcerated or were enrolled in such a program at the time of release:
(See Table 11.)
- Almost one-fifth (17.7 percent) of the males and about one-tenth (8.9 percent) of the females completed a vocational or apprenticeship program while incarcerated.
(See Table 12.)
- Over one-tenth of the males (13.9 percent) and females (14.1 percent) released in 1990 completed some type of substance abuse treatment program prior to leaving the institution. One out of 10 males (14.2 percent) and 4 out of 10 females (41.4 percent) were enrolled in a program of this type at the time of release.
(See Table 13.)
- Less than one-tenth (8.2 percent) of the males as contrasted with one-third (33.5 percent) of the females were enrolled in some type of clinical or other therapy program at the time of release. Completion of a program of this type during institutionalization was noted for about one-tenth of the males (14.8 percent) and females (9.4 percent).

- First-released males, who were most often sentenced for unarmed burglary, other drug offenses, and theft, spent an average (mean) of 23.9, 14.6 and 18.9 months respectively in the institution.
(See Table 15.)
- Rereleased males, who were most often sentenced for unarmed burglary, unarmed robbery, and theft, served an average (mean) of 27.7, 9.9, and 9.3 months between the time of return to the rerelease in 1990.
(See Table 16.)
- Females serving sentences for the most common offenses among those rereleased during 1990 (other drug violations, forgery, theft, and armed robbery) spent an average (mean) of 27.6, 17.2, and 6.9 months in the institution prior to rerelease.
(See Table 16.)
- First-released males and females with five year sentences spent an average (mean) of 28.2 and 21.7 months respectively in the institution prior to being released.
(See Table 17.)
- Males and females with five-year sentences who were previously released and returned to the institution following revocation of field supervision spent an average (mean) of 12.6 and 11.3 months in the institution prior to rerelease in 1990.
(See Table 18.)
- Wisconsin was the intended residence for the majority of the males (75.9 percent) and females (69.6 percent) released during 1990. One-fourth (23.8 percent) of the males and three-tenths (30.4 percent) of the females intended to live elsewhere in the United States.
