on June 30, 1990

- * Eight-tenths (81.2 percent) of the men and nine-tenths (90.3 percent) of the women in residence were serving new sentences. This category includes offenders with new sentences as well as probation violators received with or without new sentences. Men and women reinstated with or without new sentences following the revocation of parole or mandatory release supervision made up 17.2 and 9.2 percent of the resident population respectively

- * Over one-half (53.1 percent) of the men were from White racial and ethnic backgrounds, while about two-fifths (38.7 percent) were Black. Whites made up over one-half (52.9 percent) of the population of women with Blacks making up over two-fifths (42.8 percent of the population.

- * Men were most frequently sentenced for unarmed burglary (17.7 percent), armed robbery (8.9 percent), other drug violations (8.6 percent), and first degree sexual assault (8.5 percent). Forgery (18.6 percent), other drug violations (14.4 percent), and theft (10.5 percent) were the offenses for which women were most often institutionalized.

- * Men classified as assaultive offenders made up about three-fifths (57.4 percent) of the population. Over one-tenth (14.1 percent) were drug offenders, and one-fifth (21.0 percent) were classified as sex offenders. These three classifications are not mutually exclusive. Those classified only as property offenders made up three-tenths (30.4 percent) of the population.

- * Over two-fifths (43.1 percent) of the women in residence were property offenders, just under two-fifths (38.9 percent) were categorized as assaultive offenders, almost one-fifth (18.0 percent) as drug offenders, and less than one-tenth (3.6 percent) as sex offenders. The latter three categories are not mutually exclusive.

- * Men were serving an average (mean) sentence of 11.0 years; women, 6.6 years. Offenders serving life sentences, 402 men and 20 women, were excluded from these computations.

- * Men committed from Milwaukee County accounted for almost two-fifths (37.0 percent) of the population while commitments from Racine, Dane, Kenosha, and Rock counties made up an additional one-fourth (26.1 percent) of the group. One-third (32.7 percent) of the women had been committed from Milwaukee County with commitments from Kenosha, Dane, Racine, and Rock counties accounting for an additional one-third (32.7 percent) of the population.

- * Men, with an average (mean) age of 30.9 years, were over one year younger than women who had an average (mean) age of 32.1 years.

- * Wisconsin was the birthplace of over one-half of the men (54.9 percent) and women (52.9 percent) in residence.

- * Three-fourths (73.6 percent) of the men and three-fifths (59.2 percent) of the women were found to be without physical, developmental, or emotional disabilities.

- * Men with a record of military service made up approximately one-fifth fifth (17.1 percent) of the population. Two women had also served in the military.

- * One-third (33.7 percent) of the men and women had some high school level education but had not earned diplomas. High school diplomas or GED certificates were held by two- fifths (43.1 percent) of the men and one-fourth (27.1 percent) of the women.

- * One-third (34.1 percent) of the men and one-fourth (25.2 percent) of the women were found to test at or below the sixth grade level. Three out of 10 men (27.3 percent) and women (29.7 percent) tested at or above the twelfth grade level.

- * Men in residence had been institutionalized for an average (mean) of 26.4 months; women, for 17.7 months.

- * Following the completion of assessment and evaluation procedures about two-fifths (43.7 percent) of the men were assigned a maximum security classification, almost one-half (45.5 percent) a medium or medium out classification, and the remainder (10.8 percent) a minimum security rating. Three-tenths (30.7 percent) of the women in residence were classified as maximum, two-fifths (39.9 percent) as medium or medium out. and the remainder (29.4 percent) as minimum security.

- * Men were more likely (61.5 percent) than women (38.6 percent) to have at least a moderate need for help in dealing with problems relating to the use of alcohol.

- * Two-thirds of the men (65.2 percent) and three-fifths (59.1 percent) of the women had at least a moderate need for involvement in some type of drug abuse treatment program.
(See Table 16, p.35, p.66)
- * Eight out of 10 men (82.2 percent) and 7 out of 10 women (69.9 percent) were found to have alcohol and/or drug problems.
(See Table 17, p.36, p.67)
- * About one-fifth of the men (17.4 percent) and women (18.6 percent) were found to be in need of assistance with problems relating to mental health.

- * Assessment and evaluation results show that over one-half (52.6 percent) of the men and about two-thirds (63.7 percent) of the women required involvement in some type of educational programming.
(See Table 19, p.38, p.69)
- * Moderate or serious need for involvement in some type of programming designed to assist the offender in the development of vocational skills was noted for three-fourths of the men (76.3 percent) and women (77.1 percent).
