Abstract

This report is the first of two reports on recidivism rates of offenders released from Department of Correction facilities during 1987. Some highlights from this report are:

- The recidivism rate in 1987 was 28%. This is slightly higher than the rate for 1986 (27%).
- The number of releases increased from 2,767 in 1986 to 2,859 in 1987, an increase of 3%.
- The recidivism rate varied by security level of the institution from which the offender was released: 50% for maximum, 35% for medium, 25% for minimum, 19% for minimum/pre-release, 21% for state pre-release and 22% for contract pre-release.
- From 1986 to 1987 the recidivism rate for releases from maximum or medium security institutions increased from 34% to 36%, and the recidivism rate for releases from lower security facilities stayed the same (20%).
- The recidivism rate for males was 29% an increase from the 1986 figure of 28%; and the rate for females was 23% an increase from last year's figure of 22%.
- Among males, the recidivism rate was 32% for those serving a Cedar Junction/State Prison sentence (compared to 30% for 1986), 34% for those serving a Concord/Reformatory sentence (compared to 33% for 1986), and 9% for those committed to other jurisdictions (e.g. county).
- Recidivists were returned for a variety of reasons: 22% for technical parole violations, 54% for a parole violation involving a new arrest, 24% for re-incarceration on a new offense, and less than one percent to await trial for a new offense.
- Offenders released by parole had a higher recidivism rate (36%) than those who were discharged (15%).
- Offenders who previously had been paroled and parole violated on their present sentence had higher rates of recidivism than those who were first releases (51% vs. 19%).
- For males, those committed for property offenses had the highest recidivism rate (44%); for females, those committed for drug offenses had the highest recidivism rate (26%).
- The recidivism rate for those released with no prior adult incarcerations was lower (20%) than for those released with a history of one (32%) or more than one (37%) prior adult incarcerations.
- The recidivism rate was higher for offenders with no furloughs prior to release (31%) than the recidivism rate for individuals with one or more furloughs prior to release (16%).

I. Introduction

This report presents a statistical description of offenders released to the street from Massachusetts correctional facilities during 1987 with corresponding recidivism rates. This report presents statistics for the maximum security facility (Cedar Junction), medium security facilities (MCI-Concord, OCCC, MCI-Framingham, MCI-Norfolk, SECC and NCCI), minimum security facilities (Bay State C.C. and N.C.C.), and three facilities which combine minimum and pre-release populations (MCI-Plymouth, MCI-Warwick and Longwood T.C.). For purposes of this report, institutions with a pre-release component are collapsed into the "other" category. Statistics for three facilities which combine minimum and pre-release (MCI-Shirley, MCI-Lancaster and Hodder House), state pre-release facilities (Boston State PRC, South Middlesex PRC, Park Drive PRC, and Norfolk PRC), one drug rehab program (Spectrum House), and seven contract pre-release facilities (Brooke House, Coolidge House, Coolidge II, THP, McGrath House, Charlotte House and Hillside PRC) are presented in another report (Number 349). In order to be consistent with past recidivism reports, MCI-Plymouth, MCI-Warwick and Longwood T.C. are reported as minimum, and MCI-Shirley, MCI-Lancaster and Hodder House are reported as pre-release.

Information contained in this report includes recidivism rates with regard to release variables, nature of present offense, personal background, criminal history, furlough participation, and release follow-up variables. Each table contains two types of information: (1) statistical data describing characteristics of offenders released from each institution during 1987; and (2) the rates of recidivism cross-tabulated with each of the categories of the statistical data for these offenders.

There are two main sections in this report. Section One discusses selected variables in relation to recidivism rates. Where appropriate, comparisons are made between 1986 and 1987 rates. Section Two consists solely of statistical tables. In reading the tables, the reader should note the following: (1) the release population is divided according to the institution of release; (2) N represents the number of offenders who fall into the corresponding category in the table; (3) P represents the percentage of the number of offenders in a particular category to the number of offenders released from that institution (column percents); (4) R represents the number of offenders who are recidivists; and (5) RR (Recidivism Rate) represents the percentage of offenders in that category who have recidivated. For example, upon referring to the first table on pages 23 and 24, the variable "Type of Release" is presented and the following kinds of information may be obtained: (1) the total number of releases broken down by specific institution is labeled and presented horizontally across the head of the table; (2) the type of release (parole or discharge) is labeled and presented vertically; (3) of the 2,859 offenders released during 1987, 1,729 (60%) were released on parole and 1,130 (40%) were released on a discharge; and (4) those offenders released from Norfolk who were released on parole had a recidivism rate of 54% while those offenders released from Norfolk on a discharge had a recidivism rate of 19%.

II. Methods

During 1987, a total of 2,859 offenders (2,278 males and 581 females) were released from DOC facilities listed above after having been incarcerated in the DOC for at least 30 days. Any offender who was incarcerated for less than 30 days or who was not released to the community (i.e., released to a new sentence at a State, Federal or county facility, or released to and held on a warrant) was excluded from the study. In the case of inmates transferred from houses of correction to Longwood T.C., the time spent in county facilities was counted towards the 30 days. An analysis of the cases excluded from the sample appears in Section VI Technical Notes. The follow-up period is one year from the date of the offender's release to the community. A recidivist is defined as any offender who returns to a state or federal correctional institution, or to a house of correction or jail during the follow-up period for 30 days or more. This includes parole violators as well as those offenders sentenced for new crimes.

There were three individuals released from Lemuel Shattuck hospital, four individuals released from OCCC, and one released from Spectrum house. In order to protect the identity of these individuals, in the statistical tables in Section Two of this report the Shattuck releases are combined with the facility where they were prior to their last move; the four Old Colony Correctional Center releases are included in the total columns but not in specific institution category, and the one Spectrum House release is included in the "other" institution category (which combines all pre-release facilities).

The material for this report was derived from the DOC computerized inmate data base. Additional court record information was collected from the Office of the Commissioner of Probation's records and computerized data base. Recidivism data on female releases were collected from six-part folders located at MCI-Framingham.

Recidivism data were collected and coded for this study by students from the Northeastern Cooperative Education Program. Special thanks for their efforts.

III. Section One: 1987 Recidivism Rates

There were 2,859 releases to the street from the DOC during 1987. Of these, 792 offenders recidivated during one year of their release.

Type of Return

Table 1 presents the distribution of types of return for recidivists. Recidivists were returned for a variety of reasons: 22% for a technical parole violation, 54% for a parole violation involving a new arrest, 24% for re-incarceration to a county house of correction or a Department of Correction facility on a new offense, and less than one percent were held in jail to await trial on a new offense.

The proportions within these categories are very different for male and female offenders. For males, 24% were technical parole violators, 61% were parole violators with new arrests, 14% were re-committed for new offenses, and three individuals were in jail to await trial on a new offense.

For females, 10% were technical parole violators, 18% were parole violators with a new arrest, and 71% were re-incarcerated for a new offense.

Time Until Return

Table 2 presents time until return by sex of the recidivist. Of the 792 recidivists in 1987, 53% recidivated within 6 months of their release, 27% between 6 and 9 months, and 20% between 9 months and 1 year.

For males, 6% recidivated within one month of their release, 19% between 1 and 3 months, 29% between 3 and 6 months, 27% between 6 and 9 months, and 20% between 9 months and a year of their release. This was similar for females, where 5% recidivated within one month of release, 16% between 1 and 3 months, 33% between 3 and 6 months, 26% between 6 and 9 months, and 20% between 9 months and a year of their release.

Institution Released From

Table 3 shows the recidivism rate by institution and security level of the institution from which the inmate was released. Releases from maximum security had the highest recidivism rate (50%). Releases from medium security had a lower recidivism rate of 35%. The recidivism rate was the lowest for releases from lower security facilities: minimum (25%), minimum/pre-release (19%), state pre-release (21%), and contract pre-release (22%).

When compared to last year's figures, one finds that the recidivism rate increased in some security level categories and decreased in other categories. An increase in recidivism rates from last year occurred for releases from medium security institutions from 32% to 35%, minimum/pre-release security institutions from 18% to 19%, and state pre-release institutions from 17% to 21%. A decrease in recidivism rates from last year occurred for releases from maximum security from 51% to 50%, minimum security institutions from 37% to 25%, and for releases from contract pre-release facilities from 23% to 22%.

Furlough Program Participation

Table 4 shows that the recidivism rate was substantially lower for those who had received at least one furlough prior to release (16%) than it was for those who had not been furloughed (31%). Of all releases, 672 (24%) released during 1987 received a furlough prior to their release during 1987. The remaining seventy-six percent had not participated in the furlough program prior to release. Compared to last year, the proportion of individuals released from prison who had not received a furlough prior to release increased from 71% in 1986 to 76% in 1987.

The recidivism rate also varied by security level of the releasing institution. Offenders released from a maximum or medium security institution who had never been on a furlough, had the highest recidivism rate (36%), while offenders who were released from a lower security facility (minimum or pre-release) and who had been on at least one furlough had the lowest recidivism rate (13%).

Similar trends are apparent when the data are grouped by sex. The recidivism rate was highest for males and females who had not participated in the furlough program, 34% for males and 24% for females. Once again, the recidivism rate decreased as the security level of the releasing institution decreased. For males, the rate was lowest if the offender was released from lower security and had participated in the furlough program. The recidivism rate was 41% for males released from maximum or medium security institutions with no prior furlough participation, while for males released from lower security facilities with prior furlough participation the recidivism rate dropped to 13%. The same pattern held true for females, although the numbers of females who had been on a furlough were very low.

Type of Release

Table 5 shows recidivism rates by type of release and security level of releasing institution. Overall, the recidivism rate was higher for those released on parole (36%) than for those who were discharged (15%).

It is important to look at whether the offender had been paroled and subsequently returned as a parole violator on his/her present sentence prior to the 1987 release, or if the offender's 1987 release was for the first time on his/her present sentence. The data in Table 5 show first releases to have consistently lower rates of recidivism than parole violators. For parolees, those who were first releases had a lower recidivism rate (23%) than those who were parole violators (61%). For offenders discharged from their sentence, the recidivism rate was lower for those who were first releases (13%) than for those who were parole violators (24%).

When the data were compared by security level of the releasing institution, the recidivism rate was 32% for first releases paroled from maximum or medium security institutions and 19% for first releases paroled from lower security institutions. For those paroled from maximum or medium security who were parole violators, the recidivism rate was 61%, compared to 60% for those paroled from lower security who were parole violators.

The recidivism rate for offenders discharged by expiration of sentence or good conduct discharge was 20% for first releases from maximum or medium security and 6% for first releases from lower security. For those who were discharged, but were parole violators, the recidivism rate was 27% for those released from maximum or medium security and 14% for those released from lower security.

Table 6 shows recidivism rates by type of release for males and females. The overall recidivism rates are the

same as the overall recidivism rates for Table 5, i.e., offenders released by parole have a higher recidivism rate than those released by expiration of sentence or good conduct discharge; and parole violators have a higher recidivism rate than first releases.

Males released by parole had a recidivism rate of 38% and males released by discharge had a recidivism rate of 12%. For both types of release, the recidivism rates were lower for first releases than for parole violators. For females, those released by parole had a higher recidivism rate than those released by discharge 24% vs. 22%. The recidivism rate for females was also higher for parole violators who were released than first releases.

Offender Characteristics

Table 7 shows recidivism rates for male and female offenders by their race, age at release, present offense and prior adult incarcerations. There is an overall pattern found when the data are broken down by sex, that females have a lower rate of recidivism (23%) than males (29%).

The section of the table on recidivism by race and sex shows that whites had a recidivism rate of 25%, followed by 31% for blacks, and 36% for hispanic inmates. This pattern was similar when the data was broken down by males and females.

The section on age at release and sex of offender shows that younger offenders generally have a higher rate of recidivism than older offenders. For males, the recidivism rate is lowest in the forty year and older age group (13%) and highest in the 21 year and younger age group (39%). For females, the recidivism rate is lowest in the forty year and older age category (14%) and highest in the 26 to 29 year age category (35%).

In terms of present offense, the recidivism rate was highest in the property offense category (37%), followed by person offenses (33%), drug offenses (26%), sex offenses (20%), and "other" offenses (13%). Males committed for property offenses had the highest rate of recidivism (44%) and those committed for "other" offenses had the lowest recidivism rate (8%). Excluding the sex offense category, where the number of cases is too small to make any comparisons, the highest rate of recidivism for females was in the drug offense category (26%), and the lowest was in the person offense category (18%).

The final section of Table 7 on recidivism by prior adult incarcerations and sex of offender reveals a higher recidivism rate for those with a history of one or more prior adult incarcerations than for those with no prior adult incarcerations. Overall, the recidivism rate was 20% for offenders with no prior adult incarcerations versus a 32% recidivism rate for those with one prior adult incarceration and a 37% recidivism rate for those with two or more prior adult incarcerations. This pattern holds true for males and females. For males, those with no prior adult incarcerations had a 21% recidivism rate, while those with one prior adult incarceration or those with more than one prior adult incarceration had higher rates (32% and 38%, respectively). Females with no prior adult incarcerations had a 16% rate, those with one prior adult incarceration had a 32% rate, and those with more than one prior adult incarceration had a 30% rate of recidivism.

VI. Technical Notes

This study draws its cases from a cohort of offenders released to the community from the Department of Correction during 1987 by parole, good conduct discharge, or expiration of sentence. Data are collected on each case which may result in a case being dropped from the study. There were 255 cases dropped from the release cohort for purposes of the recidivism study. There are five reasons why cases may be dropped: 1) the release file in error, i.e., person not released or release was not a parole, expiration, or discharge; 2) offender not released to community but released to a from and after sentence or warrant; 3) offender served less than 30 days in custody prior to release; 4) offender died within 1 year of release; and 5) offender deported.

It should be noted that in calculating time served, the day the person started serving their sentence and the day of release were both credited toward time served. For all releases serving their first period of incarceration in a DOC facility, time served starts on the day committed to the DOC and does not credit any time served in a jail, house of correction, or other correctional facility prior to commitment.

Table 8 gives a breakdown of the cases dropped from the study by the reason for the drop: 75% were cases where time served was less than 30 days; 17% were because the release was not to the community; 7% were due to data errors in the release file; less than 1% to death of the releasee; and no cases were dropped due to the releasee getting deported.

Due to the large proportion of females that were dropped from the study because their time served was less than 30 days, an analysis was done to determine what effect the inclusion of these cases might have had on recidivism rates.

Follow-up information was collected on the 173 females by a check of the computerized inmate data base. Twenty-seven of the cases were found to be recidivists. Table 9 which follows, shows that if these cases had been included in the study, the overall recidivism rate would decrease from 28% to 27% and the recidivism rate for females would decrease from 23% to 21%.
