




This report provides statistical information on criminal offences which occurred in NSW in the years 1989, 1990 and 1991. The offences included are all those which were reported to police and which had been recorded on the NSW Police Service computer system by April 1992.

DEFINITIONS AND EXPLANATORY NOTES

The statistics in this report were prepared from data supplied by the NSW Police Service. The data were extracted from the NSW Police Service Crime Information and Intelligence System (CIIS) in April 1992.

COUNTING UNITS

Number of offences recorded

The number of offences recorded **as having occurred in the counting period** is the primary counting unit. Where more than one offence was recorded from a single criminal incident, each offence is counted separately. For example, if in the course of robbing a bank a person also assaults a bank customer, two separate offences will be counted, one of robbery and one of assault.

In this report a recorded offence is defined as an offence which is:

- (1) detected by or reported to the police, and
- (2) recorded on the CIIS.

The recorded offence statistics in this report include breaches against the following Acts:

- Bail Act
- Crimes Act
- Firearms Act
- Gaming and Betting Act
- Liquor Act
- Summary Offences Act
- Drug Misuse and Trafficking Act

Note, however, that the classification of offences used by the police does not correspond exactly with offences defined in legislation. It is the police classification which is followed in this report.

Number of offences cleared

A cleared offence is one which has, in the view of police, been satisfactorily cleared by charge or otherwise.

An offence is cleared by charge when police have laid a charge or an information against at least one person. The information may have been laid with a view to the issuing of a warrant, summons or other process for the purpose of bringing an offender before the court.

An offence is cleared other than by charge when, under normal circumstances, a charge or information would have been laid against at least one person, but, for a variety of reasons, police have been unable to make an arrest, despite knowing the identity of the offender and having sufficient evidence to support a charge. Examples of situations in which an offence may be cleared other than by charge include the following:

- (1) the offender is a juvenile and is cautioned;

- (2) the offender has died before a charge is made or information laid;
- (3) the offender has been committed to a psychiatric institution and is unlikely to be released;
- (4) there is an obstacle to charging e.g. diplomatic immunity;
- (5) the complainant or essential witness is dead and proceedings would be aborted;
- (6) the offender is serving a sentence and no useful purpose would be served by prosecution.

Cleared offences are counted in the report if the offence was cleared within the counting period. An offence which has been cleared within the counting period may not have been recorded as an offence within the same counting period. Because it may take some time for the police to identify and charge an individual for an offence, it is possible for an offence which was cleared in the counting period to have occurred prior to the counting period. For this reason, cleared offences have been separated into two categories as follows:

- (1) Number of offences cleared in the counting period that occurred in the counting period.
- (2) Number of offences cleared in the counting period that occurred prior to the counting period.

The separation of these measures allows comparison of the speed with which police are able to clear different types of offence.

Single year clear-up percentage

The single year clear-up percentage relates to a particular counting period. It indicates the number of offences which both occurred and were cleared in the counting period as a percentage of the total number of offences which occurred in the counting period. This provides a measure of police response for different types of offence.

In previous reports published by the NSW Police Service, clear-up rates were calculated by taking the number of offences cleared in the counting period (regardless of when they occurred) as a percentage of the number of offences that occurred in the counting period.

COUNTING PERIOD

A counting period is a full calendar year. This report includes information for three counting periods: 1989, 1990 and 1991. To be counted, an offence must have occurred within the counting period, i.e. the date of commencement of the offence must be on or prior to the last day of the counting period. All offences include both a date of commencement and a date of completion. This is because some offences, such as incest, may occur over an extended period of time. The date of commencement of the offence is used to determine the relevant counting period for an offence. Note, however, that in a large number of cases, the date of commencement of the offence is missing in the data provided from the CIIS. In these cases, the following dates are used to determine whether the offence will be counted in a particular counting period:

- (1) the date of the end of the offence;
- (2) the date on which the offence was reported;

- (3) the date on which the offence was cleared;
- (4) the date on which the offence was entered as a computer record to the CIIS;
- (5) the date on which the computer record was updated on the CIIS.

The first date which exists for the offence according to the priority order shown above is used to determine the counting period in which the offence is counted.

This procedure ensures that all offences are counted. However, using this procedure, it is possible that a small number of offences may be assigned to an incorrect counting period (i.e. an offence may be assigned to a period other than the one in which the offence occurred).

REGIONAL STATISTICS

Statistics are provided on the number of offences recorded in each of the Statistical Divisions of NSW as defined by the Australian Bureau of Statistics. Within the Sydney Statistical Division, statistics are provided for Statistical Subdivisions. Appendix 1 provides maps indicating the location of each Statistical Division and Sydney Statistical Subdivision. Appendix 2 lists the Local Government Areas within each of the Statistical Divisions and Statistical Subdivisions. An offence is counted within a particular region when the location of the offence falls within that region.

Rates of recorded offences per 100,000 population are provided for each of the regions, and for NSW. For the rate calculations, population data were obtained from the Australian Bureau of Statistics publication, *Regional Statistics New South Wales 1991* (Catalogue No. 1304.1) for 1989, and from the publication, *Estimated Resident Population of Statistical Local Areas New South Wales, At 30 June, 1990 Final and 1991 Preliminary* (Catalogue No. 3210.1) for 1990 and 1991. For last year's report, *New South Wales Recorded Crime Statistics 1990*, the estimated resident population as at 30 June 1989 was used for the calculation of rates per 100,000 population, for both 1989 and 1990 recorded offences. (Regional population data for 1990 were not available.)

OFFENCE CLASSIFICATIONS

Appendix 3 provides a list of offences which appear within each major offence category. Comparison with a similar list contained in previous reports allows the changes in classification to be identified.

Sexual assault

Note that a change has been made to the categorisation of sexual assault in this report, to reflect legislative changes to the *Crimes Act 1900 No. 40*. The effect of the legislative changes is to replace the four categories of offence seriousness which were shown in previous reports with three new categories. In this report, some attempt has been made to provide comparability across the three years of data by retaining the previous numbered category labels. Note, however, that some of the offences

recorded in 1991 in the second category (aggravated sexual assault) would previously have been classified as Category 1 offences. For this reason, data within the first two categories of sexual assault for 1991 are not comparable with the data for 1989 and 1990. Data for Categories 1 and 2 should be summed in order to make year to year comparisons. In future reports the Category 1 offences shown here will be merged into the general category of aggravated sexual assault.

UPDATED STATISTICS

Offences are recorded on the CIIS according to the date on which they occurred. They are counted in this report within the counting period in which the offence occurred (except as noted above in 'COUNTING PERIOD'). Offences which occurred within the counting period but which are reported to police in a subsequent period, must therefore be added to the period in which the offence occurred. Thus, for a particular period, early published recorded crime figures will underestimate the level of recorded crime. The level of recorded crime for a specified period will vary over time as more offences are added to the totals. Offence clear-ups are even more subject to this effect as the police may take some time to find and charge an offender.

It was noted in last year's report that due to the updating problem it was not possible to publish data earlier than six months after the end of the relevant counting period. Since the publication of the last report it has been possible to analyse the updating effects for different types of offence. As a result of this analysis it is apparent that, for the majority of the major offence groups, over 98% of all recorded offences relevant to the counting period have been entered to the CIIS by the end of the following quarter. For the remainder, with the exception of fraud as noted below, over 90% of offences have been entered at the end of this time.

It was concluded from this analysis that, with the exception of fraud, data extracted from the CIIS three months after the end of the relevant counting period would be minimally affected by delays in reporting and recording. Hence data for this report were extracted in April 1992, three months after the end of the 1991 counting period.

Fraud

There are long delays in the recording of fraud offences. Only 68% of the recorded fraud offences which occur in a counting period have been entered on the CIIS three months after the end of the counting period. Six months after the end of the counting period this percentage has risen to almost 85%. However, this means that even after six months, there are still over 15% of offences relevant to the counting period which have not been recorded on the CIIS.

Data for fraud offences in 1991, as extracted from the NSW Police Service computer in April 1992, have been included in this report. However, it should be noted that the recorded fraud offences for 1991, reported here, are underestimates of the total number of recorded offences for 1991.

For this reason, fraud data for 1991 are not directly comparable with the data for 1989 and 1990. In particular, data for July 1991 to December 1991 are not reliable and were excluded from the statistical test for trend in fraud. A note has been included on every table to warn the reader that the final year's data for fraud are not reliable.

ORGANISATION OF THE REPORT

The report is organised into five main sections as follows. First there is an overview of major trends in recorded offences over the three year period from January 1989 to December 1991. Figures showing trends in selected offences are provided as well as an analysis indicating which trends are statistically significant.

The second section presents the monthly trends in recorded offences for 1989, 1990 and 1991, for selected major offence categories. The tables in this section provide the data on which the figures in the first section are based.

The next section provides the numbers of cleared offences in each offence classification for 1989, 1990 and 1991, for the State as a whole. Cleared offences are split into two groups: those that occurred in the same year and those that occurred earlier. The tables also present a single year clear-up percentage. This percentage is the number of offences cleared in the specified year, that occurred in that year, as a percentage of the total number of offences that occurred in that year.

In the fourth section there are 17 tables, one for each major offence category. Each table gives the numbers of recorded offences in 1989, 1990 and 1991 for each of the NSW Statistical Divisions and for each Statistical Subdivision in Sydney. Rates per 100,000 population for each region and for the State as a whole are also shown.

The last section of the report has 27 tables, each table being for a specific region of New South Wales. The tables provide numbers and rates of recorded offences for 1989, 1990 and for 1991, for all offence classifications.

OVERVIEW OF MAJOR TRENDS

OVERVIEW OF MAJOR TRENDS

INTRODUCTION

However they are presented, the interpretation of trends in recorded crime is a difficult task. For example, the results from crime victim surveys conducted in NSW in 1983 and 1990 clearly illustrate the extent to which trends in recorded rates of various offences are affected by public willingness to report crime to police.¹ The surveys revealed that the true level of assault remained essentially unchanged between 1983 and 1990, despite the fact that the number of assaults recorded by police over this period rose from a little over 8,000 to nearly 30,000.² We now know that this increase was in a large measure due to increased public willingness to report assault to the police.³ Public willingness to report crime, however, is just one of the extraneous factors which can affect trends in recorded offences. Shifts in policing policy, to take another example, can have a very marked effect on the number of recorded drug offences or the number of cases of offensive behaviour.

The interpretation of trends in official reports of crime can be considerably more difficult than the interpretation of trends in unemployment or inflation statistics. The ease with which recorded crime statistics can be misunderstood creates a temptation to offer an authoritative explanation for each and every major crime trend. Unfortunately in many instances it is simply impossible to state with any assurance why a particular trend has appeared. This report therefore confines itself to identifying trends in recorded offences rather than explaining them. Where the relationship between the actual occurrence of some offence and the recorded occurrence of the offence is unproblematic this is indicated. Where previous research indicates that a trend in recorded offences is probably influenced by factors other than the crime rate this is also highlighted.

Two changes have been made in the examination of trends this year. First, the trends examined in this report cover a three year period (not a two year period). Second, for some offences, the trends have been examined in more detail. This second change is in response to the enquiries generated by last year's report. Information is provided on the targets of a number of property offences and trends have been examined for subcategories of three offences: robbery, breaking and entering, and stealing.

Trends in robbery offences have been separately examined for robbery with a firearm, robbery with a weapon other than a firearm, and robbery without a weapon. Trends in breaking and entering offences have been separately examined for dwellings and non-dwellings. Similarly, trends have been separately examined for two subcategories of stealing offences: stealing from the person and stealing from a shop or business.

It should be emphasised that these detailed trends are only examined in this overview. For reasons of continuity the offence categories in the body of the report have been kept the same as last year.

For all offences except fraud⁴ a statistical test for trend was applied to the monthly numbers of recorded offences in each major offence category, over the 36 month period from January 1989 to December 1991.⁵ For those offences where a statistically significant trend was found, the percentage change between 1989 and 1991, in the annual total of recorded offences, is used as an indicator of the extent of the trend.

SIGNIFICANT DOWNWARD TRENDS

In the following discussion the bracketed figures denote the percentage change in the annual number of recorded offences between 1989 and 1991.

There were statistically significant downward trends across the State for the following offence categories:

- breaking and entering (-9.3%)
- possession and/or use of narcotics (-27.0%)

Breaking and entering

Breaking and entering is one of the most common serious offences, affecting between 8% and 9% of NSW households in a given year.⁶ It is also an offence whose recorded rate provides a reasonably good guide to trends in the underlying rate of the offence.

Figure 1 shows the overall downward trend in recorded numbers of breaking and entering offences. Figure 2 shows separate trends for breaking and entering - dwelling, and breaking and entering - non-dwelling. Statistical testing of the trends in Figure 2 suggests that the downward trend in Figure 1 is mainly due to a downward trend in breaking and entering offences involving dwellings. The trend for non-dwellings is not statistically significant.

Figure 1: Breaking and entering





Table 3.5 of the report shows that the recorded rate of this offence in 1991 was more than one and a half times as high in the Inner Sydney Statistical Subdivision as it was in the region with the next highest rate (Central Western Sydney Subdivision), although recorded offence rates were also high in the Statistical Subdivisions of Eastern Suburbs and Fairfield - Liverpool. The table also shows that, despite the overall downward trend, there was considerable variation between Subdivisions and Divisions in both the size and the direction of the trend. Between 1989 and 1991




there were reductions in recorded breaking and entering offences in most areas of the State. The largest reductions were in the Statistical Subdivisions of Sydney, especially Inner Western Sydney (-29%), Inner Sydney (-26%), Central Western Sydney (-23%), Eastern Suburbs (-22%) and Canterbury – Bankstown (-22%). There were, however, some regions with increases in recorded offences, notably the Outer South Western Sydney (+38%) and Gosford – Wyong (+23%) Subdivisions, and the Illawarra (+23%), the Murrumbidgee (+21%) and the Murray (+18%) Statistical Divisions.

Possession and/or use of narcotics

Figure 3 shows the trend for the possession and/or use of narcotics. Whereas trends in recorded offences for breaking and entering provide a good guide to the underlying trends in that offence, trends in recorded drug offences are much more difficult to interpret. Drug offences are usually only recorded when an arrest is made. For this reason a downward trend in drug offences may signify either lowered rates of offending, a shift in policing policy (for example, targeting more serious offenders), fewer resources being devoted to drug law enforcement, reduced police effectiveness in detecting drug offences and/or apprehending offenders, or some combination of these things. There is no way of telling from the data which of these factors accounts for the trend shown in Figure 3.

Regional variations in recorded rates of this offence, though marked, must be treated with caution, due to the very small number of cases sometimes involved. Moreover, as with the temporal trends for drug offences, variations in recorded rates of drug offences across different regions may reflect variations in law enforcement emphasis as well as variations in the rate of occurrence of the offence itself. Inspection of Table 3.12 nonetheless reveals that the highest recorded rate of possession and/or use of narcotics is to be found in the Inner Sydney Subdivision, where the recorded rate of the offence in 1991 was almost eight times the State rate. It also shows that the downward trend in recorded cases of possession and/or use of narcotics was far from uniform across the State. While most regions recorded a reduction in recorded offences over the time period, there were increases in some regions. The increases in

the Northern (+150%) and the Mid-North Coast (+88%) Divisions were substantial, although the numbers of offences were small in both these regions, particularly in the Northern Division.

OFFENCES WHERE THERE WAS NO UPWARD OR DOWNWARD TREND


There was no statistically significant generally upward or downward trend in any of the following offence categories:

- murder
- sexual assault
- fraud
- receiving, goods in custody
- motor vehicle theft, illegal use of a vehicle
- possession and/or use of cannabis
- dealing, trafficking in narcotics
- dealing, trafficking in cannabis
- cultivating cannabis
- offensive behaviour

The numbers of offences recorded for each month from January 1989 to December 1991 are shown in Figures 4 to 13. There are several observations, however, which are pertinent to an understanding of these offences.

Murder

Figure 4 shows recorded murder offences for each month from January 1989 to December 1991. It is clear that with such small numbers of offences, the month to month variation is extremely marked. For this reason it is difficult to detect trends over a period as small as three years. Past research by the Bureau, however,




suggests that the incidence of this offence in NSW has been stable for at least two decades.

Table 3.1 shows the regional distribution of the offences. Because of the small numbers, it is not sensible to make regional comparisons. A recently published Bureau report examined the regional distribution of domestic and other types of homicide using data aggregated over a number of years.⁷

Sexual assault

It can be seen from Figure 5 that recorded sexual assault offences appear to be




somewhat higher in the summer months than in the winter months.

Inspection of Table 3.3 reveals that, in 1991, Murrumbidgee had the highest rate of recorded sexual assault offences per 100,000 population. Both the Inner Sydney Subdivision and the Far West Division also had high rates, almost double the rate for the State as a whole in 1991. The Far West and North Western Divisions had high recorded offence rates in each of the three years, 1989, 1990, and 1991.

Fraud


Fraud is an offence whose recorded rate is strongly influenced by variations in both police ability to detect and public willingness to report fraud offences. There is in fact often a considerable lag between the commission of a fraud and its discovery by police, a fact which accounts for the downward trend in recorded cases of fraud, evident in Figure 6 over the period from July to December 1991. When offences recorded over this period are disregarded there is no overall trend in fraud offences.

Credit card fraud accounts for about 61% of all recorded fraud offences in NSW.



Inspection of Table 3.6 reveals that in 1991 the recorded rate of fraud offences was more than six times higher in the Inner Sydney Subdivision than it was for the State as a whole. Other areas with high recorded offence rates include the Eastern Suburbs and Lower Northern Sydney Subdivisions. In each of the three years of the time period examined, recorded fraud offences in Sydney (that is, in the Sydney Statistical Division) accounted for more than 80% of all recorded fraud offences in NSW.

Figure 7: Receiving, goods in custody




Receiving, goods in custody

Receiving and goods in custody are offences typically discovered by police rather than reported to them. The absence of a trend in the recorded numbers of offences may therefore reflect either stability in policing policy or stability in the level of offending or both. Figure 7 shows the monthly numbers of recorded offences over the three year period.

Regional variations may also be indicative of variations either in offending or in policing policy or both. Table 3.7 shows that the Inner Sydney Subdivision consistently had the highest offence rate for receiving, goods in custody offences, nearly four times the State rate in each of the three years. Other areas with high recorded offence rates in 1991 included the Far West and the Richmond - Tweed Statistical Divisions.

Motor vehicle theft, illegal use of a vehicle


Recorded rates of motor vehicle theft and illegal use of a vehicle are generally good indices of the underlying rates of these offences. Although Figure 8 suggests a decline in the rate of motor vehicle theft over the six month period ending in December 1991, the trend over the full three year period is not statistically significant.

Notwithstanding the stability in the Statewide trend for this category of offence, it can be seen from Table 3.8 that there is marked regional variation in the rates of its occurrence. The Inner Sydney Subdivision continued to experience a rate of motor vehicle theft almost three times the State rate. The Fairfield - Liverpool, Central Western Sydney and Inner Western Sydney Subdivisions also continued to experience rates of car theft well above the State rate.

Possession and/or use of cannabis

The cautionary remarks made above about trends in recorded cases of possession and/or use of narcotics apply with equal force to possession and/or use of cannabis and the other drug offences discussed below.


As can be seen in Figure 9, the trend in recorded offences for possession and/or use of cannabis would appear to have a seasonal component to it. Table 3.13 shows that the recorded offence rates for this offence tend to be much higher in rural areas than in urban areas. Four regions have consistently had high offence rates per 100,000 population over the three year period examined. They are the South Eastern, Richmond - Tweed, Mid-North Coast and Far West Statistical Divisions. In 1991, the lowest recorded rate of the offence in 1991 was in the Canterbury - Bankstown Subdivision.



Dealing, trafficking in narcotics

Figure 10 shows recorded offences for dealing, trafficking in narcotics for each month over the three year period.

Figure 10: Dealing, trafficking in narcotics




Inspection of Table 3.14 indicates that the highest recorded rate of dealing, trafficking in narcotics was in the Inner Sydney Subdivision, which alone accounts for more than one third of the 1991 Statewide total of recorded offences of this type. Note, however, that the total of 515 recorded offences for the whole State is very small.

Dealing, trafficking in cannabis

Although there is no statistically significant upward or downward trend over the three year period, Figure 11 shows a strong seasonal pattern in the recorded offences for dealing, trafficking in cannabis. Clearly, there are higher numbers of recorded offences in the summer months than in the winter months. The seasonality probably reflects the growing and harvesting cycle of the cannabis plant.

Figure 11: Dealing, trafficking in cannabis




Examination of Table 3.15 shows that there is considerable variation in offence rates both between regions and from one year to the next. For example, in 1991, the highest recorded offence rates were in the Far West Division (58.7 per 100,000 population) and the Inner Sydney Subdivision (51.7 per 100,000 population). In 1990, Richmond - Tweed Division was the region with the highest rate (84.7 per 100,000 population).

Cultivating cannabis

As with other drug offences, the numbers of recorded offences for cultivating cannabis are strongly influenced by law enforcement policy. Hence trends in the extent of offending for this offence cannot reliably be inferred from recorded rates of offending. As was the case for dealing, trafficking in cannabis, there is a strong seasonal effect influencing recorded numbers of offences for cultivating cannabis. The seasonal pattern can be seen in Figure 12.

Table 3.16 shows that there are marked regional variations in the recorded offence rates for cultivating cannabis, although once again this fact is not necessarily indicative of the true variation in rates of offending. In each of the three years, 1989, 1990, and 1991, the highest recorded offence rates per 100,000 population have been in the Richmond - Tweed and Mid-North Coast Statistical Divisions.




Offensive behaviour

Figure 13 shows the monthly numbers of recorded offences for offensive behaviour. Although there is no overall trend over the period it is evident from Figure 13 that the rising trend between 1989 and 1990 noted in last year's report gave way to a decline in 1991. This is probably due at least in part to changes in the exercise of police discretion under the Summary Offences Act.⁸

As can be seen in Table 3.17, the regional variation in the recorded rate of this offence

is quite marked, ranging from a recorded rate of 78.5 offences per 100,000 population in the Canterbury - Bankstown Subdivision to 1,021.5 offences per 100,000 population in the Far West Division. The North Western Division also continued to have a very high recorded rate of this offence. How much of this variation is attributable to regional variations in numbers of police or policing policy and how much to patterns of public behaviour is impossible to say.



SIGNIFICANT UPWARD TRENDS


Over the period from January 1989 to December 1991, there were statistically significant upward trends in the monthly numbers of recorded offences in the following categories:

- assault (+13%)
- robbery (+29%)
- stealing (+5%)
- arson (+92%)
- malicious damage to property (+22%)

The trends are shown in Figures 14 to 20. Note once again that the bracketed figures denote the percentage change in the annual recorded numbers of offences between 1989 and 1991.

Assault

Figure 14 shows the trend in recorded assault offences over the three year period from January 1989 to December 1991. Assault is an offence the recorded rate of which can be strongly influenced by both the exercise of police discretion and public willingness to report assaults to police. However, the results of the 1991 Australian



Bureau of Statistics Crime and Safety Survey suggest that some if not all of the increase reflects a real increase in the rate of assault in the community between 1990 and 1991.⁹ It is nevertheless worth remembering that the ABS estimates the proportion of the NSW population assaulted or threatened with assault over a twelve month period to be less than 3%.

Table 3.2 indicates that the 13% Statewide increase in recorded offences between 1989 and 1991 is greatly exceeded in some areas. These include the Outer South Western Sydney (+47%), Inner Western Sydney (+36%), Outer Western Sydney (+29%) and Inner Sydney (+27%) Subdivisions. On the other hand, only two regions recorded a decrease in recorded assault offences, the change in one region (the Hunter Division) being less than 1% and in the other region (the Illawarra Division) being less than 6%. Despite the fact that a number of western Subdivisions of Sydney exhibited the largest increases in recorded assault offences, Table 3.2 also indicates that the highest offence rates continue to be found in the Far West Division (1863.0 per 100,000 population), the Inner Sydney Subdivision (1524.0 per 100,000 population) and the North Western Division (1171.4 per 100,000 population). By way of comparison, the recorded rate of assault for the State as a whole was 516.7 per 100,000 population.


Robbery

The Statewide robbery trend depicted in Figure 15 reflects a continuation of the trend observed in last year's report. Recorded robbery offences for 1991 increased by 29% compared with 1989.

Figure 16 shows the trends for each of three types of robbery offence: robbery without a weapon; robbery with a firearm; robbery with a weapon not a firearm. There is a statistically significant upward trend over the three year period for each type of robbery offence.

The ABS estimated that 1.5% of the NSW population aged 15 and over were victims of robbery or attempted robbery in the twelve month period ending April 1991.¹⁰

Inspection of Table 3.4 reveals that the largest increase in recorded robbery offences between 1989 and 1991 occurred in the Manly - Warringah Subdivision (+91%). Marked increases also occurred, however, in the Central West Division (+80%) and the Inner Western Sydney (+80%), Outer South Western Sydney (+70%), Hornsby - Ku-ring-gai (+64%) and Outer Western Sydney (+52%) Subdivisions. The Far West Division shows a substantial percentage decrease (-22%) in recorded numbers of robberies but the number involved is very small. The Eastern Suburbs Subdivision experienced a decrease (-12%) in recorded robbery offences involving somewhat larger numbers of offences.

Figure 16: Robbery with and without a weapon





Table 3.4 also reveals, that recorded rates of robbery offences in 1991 remained highest in the Inner Sydney Subdivision (694.4 per 100,000 population), more than six times higher than the State rate (101.2 per 100,000 population), and more than three times higher than rates in any other Statistical Division or Subdivision. Other areas of the State with high recorded robbery rates include the Inner Western Sydney (207.4 per 100,000 population), Central Western Sydney (161.5 per 100,000 population) and Fairfield - Liverpool (154.9 per 100,000 population) Subdivisions. The South Eastern Division had the lowest recorded rate of robbery offences (17.7 per 100,000 of population in 1991).

Stealing


Figure 17: Stealing

Stealing (not including breaking and entering or motor vehicle theft) is easily the most frequently recorded kind of offence in NSW. The upward Statewide trend in general stealing offences, depicted in Figure 17, while statistically significant and probably reflective of a real increase in stealing offences, is only relatively small. The 1991 total was 5% greater than the total for 1989.

The two major subcategories of stealing offences which generate most public concern are stealing from the person and stealing from shops/businesses. Trends for these subcategories of stealing are shown in Figure 18. There is a statistically significant upward trend for stealing from shops/businesses but no significant upward or downward trend for stealing from the person.

The 5% Statewide increase in recorded stealing offences, between 1989 and 1991, is not uniformly reflected at a regional level. Examination of Table 3.9 reveals that there are marked increases in recorded rates of stealing offences, for example, in the Outer South Western Sydney (+26%) and Gosford - Wyong (+20%) Subdivisions, and the Richmond - Tweed Division (+21%). A number of other regions also had increases in recorded stealing offences that were two or three times as large as the Statewide

increase. These large increases are offset to some degree by small decreases in recorded stealing offences in regions such as the Inner Sydney Subdivision (-9%), the Northern Division (-5%), the North Western Division (-4%), the Eastern Suburbs Subdivision (-3%) and the Canterbury - Bankstown Subdivision (-3%).


Table 3.9 also reveals that recorded stealing rates in the Inner Sydney Subdivision in 1991 (7,881.6 per 100,000 population) exceeded three times the State rate (2244.6 per 100,000 population). Unlike robbery, recorded stealing rates in country areas not infrequently exceed those in urban areas. Thus, per head of population, the Far West (3029.4 per 100,000 population) ranks third in the State in recorded rates of stealing, while the Murray Division ranks fourth (2825.1 per 100,000 population).

Arson

Although arson is among the least frequently recorded types of offence covered in this overview, over the period between January 1989 to December 1991 it has shown by far the largest increase. Figure 19 shows a very marked upward trend in recorded arson offences, most of which appears to have occurred in the period from April 1990 onwards. The upward trend is likely to signify a real increase in arson offences. Most notable among the categories of arson which have increased is motor vehicle arson. Recorded numbers of offences in this category increased from 392 in 1989 to 1112 in 1991, an increase of 184%.

The Statewide increase in arson of 92% between 1989 and 1991, moreover, is greatly exceeded in some regions. Table 3.10 shows that these regions included the Mid-North Coast (+281%), Richmond - Tweed (+225%), Illawarra (+134%) and Hunter (+130%) Divisions as well as the Outer Western Sydney (+219%), Fairfield - Liverpool (+219%), Blacktown - Baulkham Hills (+158%) and Manly - Warringah (+150%) Subdivisions. Most of the increase in recorded numbers of arson offences in these

areas was caused by an increase in cases of motor vehicle arson. The increases between 1989 and 1991 in the frequency of motor vehicle arsons for these areas were as follows:



The regional variations in recorded arson offence rates are not as pronounced as for other offences. Table 3.10 indicates that in 1991 the highest recorded rate of this offence was in the Outer Western Sydney Subdivision (126.8 per 100,000 population) where the rate was nearly two and a half times the State rate (50.5 per 100,000 of population). High recorded rates of arson also occurred in the Fairfield - Liverpool (83.7 per 100,000 population), Blacktown - Baulkham Hills (73.7 per 100,000 population) and Inner Sydney (65.1 per 100,000 of population) Subdivisions, and the Illawarra Division (78.5 per 100,000 population).

Malicious damage to property

Figure 20 suggests that there has been a steady increase in instances of malicious damage to property (other than arson).

Inspection of Table 3.11 indicates that there were increases in recorded offences, between 1989 and 1991, in all regions except the Eastern Suburbs Statistical Subdivision and the North Western Statistical Division. The largest increase in recorded offences between 1989 and 1991 occurred in the Fairfield - Liverpool Statistical Subdivision (+49%). There were also notable increases in the Hornsby - Ku-ring-gai Statistical Subdivision (+45%) and the Outer South Western Sydney Statistical Subdivision (+44%).

TRENDS IN CLEAR-UP RATES

Clear-up rates are not necessarily a good measure of police performance. While for some offences (for example, homicide) the ability to solve a crime is undoubtedly a distinctive police skill, for other offences (for example, offensive behaviour, selling illegal drugs, soliciting for prostitution) detection of the offence and the offender generally occur simultaneously. In such circumstances the clear-up rate (that is, the percentage of reported offences cleared) may be 100% but this provides no reliable indication of police effectiveness in 'solving' the offence in question.

Even in circumstances where 'solving' crime is a meaningful possibility, the clear-up rate may not provide the most satisfactory overall measure of police performance. For example, a high profile police initiative may at the same time reduce crime (due to greater perceived risk of apprehension among offenders) and reduce the clear-up rate (by encouraging reporting of offences to police with the result that recorded offences increase to a greater extent than do the number of offences cleared).

The influence of public willingness to report crime on crime clear-up rates makes the interpretation of differences in clear-up rate across different categories of offence

quite hazardous. Some offences (for example, car theft) are much more likely to be reported to the police than others (for example, assault). For this reason from the standpoint of police effectiveness it is often more productive to examine trends over time in clear-up rates **within** particular categories of offence than between them. Unfortunately, since it takes some time to 'solve' offences, trends in the raw percentage of reported offences cleared always tend to trend downwards the more recent the crime figures being examined.

Tables 2.1, 2.2 and 2.3 give the numbers of offences cleared in each of the years, 1989, 1990 and 1991, respectively. The cleared offences are split into two groups: those which occurred in the same year and those which occurred in an earlier year. The clear-up measure used is the single year clear-up percentage. For a specified calendar year, this percentage is the number of offences which both occurred and were cleared during the year, as a percentage of the total number of offences recorded for the year. Comparisons across the tables show that, generally, within a specific offence category, the single year clear-up percentage is fairly similar from year to year.


MOTOR VEHICLE THEFT, ILLEGAL USE OF A VEHICLE

All data printed in the report for this offence should be disregarded. The data are incorrect because the information originally provided by the NSW Police Service mistakenly included offences where motor vehicle engines or licence plates were stolen.

The corrected monthly trend data are shown in Figure 8 below. This figure and the text below it replace Figure 8 on page 8 and the paragraph at the top of page 9 of the report.

The table on the reverse of this sheet replaces Table 3.8 on page 41. The data in this table also replace the data for motor vehicle theft, illegal use of a vehicle in each of Tables 4.1 to 4.27.

Unfortunately no data could be obtained on cleared offences. There are therefore no replacement data for the data presented in Tables 2.1, 2.2 and 2.3.



Motor vehicle theft, illegal use of a vehicle

Recorded rates of motor vehicle theft and illegal use of a vehicle are generally good indices of the underlying rates of these offences. There is a significant downward trend in recorded offences over the 36 months from January 1989 to December 1991. Recorded offences in 1991 decreased by 7.8% compared with 1989.

There were decreases in recorded offences between 1989 and 1991 in most areas of Sydney, the biggest decreases occurring in the Inner Western Sydney Subdivision (-28%) and the Eastern Suburbs Subdivision (-21%). However, there were increases in recorded offences in 6 of the 11 other Statistical Divisions. In the Far West Statistical Division recorded offences increased by 91% (although it should be noted that there are relatively few recorded offences in this region). The other areas with large increases were the Illawarra (+25%) and the Mid-North Coast (+16%) Statistical Divisions. By contrast, there was a 23% decrease in the Murrumbidgee Statistical Division.


