

UNIFORM CRIME REPORTING PROGRAM

PURPOSE OF UCR

The fundamental objective of the Uniform Crime Reporting program is to produce reliable crime statistics for law enforcement administration, operation, and management. This compiled data is also available for the use of scholars and the public as a measure of the fluctuations in the amount of crime in our society. The means utilized to attain these objectives are: (1) To measure the extent, fluctuation, distribution, and nature of crime through the collection of data on the eight serious Crime Index Offenses; (2) to measure the total volume of serious crime known to police; (3) to show the activity and coverage of law enforcement agencies through arrest counts and police employee strength data.

HISTORY OF UNIFORM CRIME REPORTING

THE NATIONAL PROGRAM

The Uniform Crime Reporting program of the Federal Bureau of Investigation is an outgrowth of the need for a uniform national view of law enforcement statistics. Recognizing this need, in the 1920's, the International Association of Chiefs of Police (IACP) formed the Committee on Uniform Crime Records to develop a system of uniform police statistics. In January 1930, the IACP's voluntary national crime collection program began with the participation of 400 city police agencies

representing some 20 million citizens in 43 states. In that same year, the United States Congress authorized the Federal Bureau of Investigation (FBI) to serve as the national clearinghouse for the crime statistical information collected by the program.

In UCR, crime reports are obtained from law enforcement agencies throughout the nation based on uniform classifications and procedures of reporting. In an effort to provide as complete a picture of crime in the United States as possible, the Committee on Uniform Crime Records of the IACP chose to obtain data only on offenses that became known to police. A meaningful overview of crime was made available through examination of the seven offenses selected for their seriousness, frequency of occurrence and likelihood of being reported. These Crime Index Offenses are Murder, Forcible Rape, Robbery, Aggravated Assault, Burglary, Larceny-Theft and Motor Vehicle Theft. By mandate of the U.S. Congress, Arson became the eighth Index offense in 1979.

In the early planning stages of UCR, it was recognized that the differences among state and local criminal codes precluded the possibility of creating a national crime total based upon an aggregate of local statistics. To provide for national uniformity, the IACP chose to adopt standardized definitions of crimes. This standardization overcame the problems posed by the variations in state and local definitions of crimes. Reporting agencies participating in the program were required to interpret local criminal acts in the context of the standard national definitions before submitting their crime totals to the national program. Because of the differences among the state codes, there is no possibility in a program, such as UCR, to distinguish between crimes by designations such as "felony" or "misdemeanor".

THE TEXAS UCR PROGRAM

On January 1, 1976, Texas joined a growing number of states to adopt the Uniform Crime Report as the official statewide crime report. The Department of Public Safety accepted the responsibility to collect, validate and tabulate UCR reports from all reporting jurisdictions in Texas. To handle this task, the Uniform Crime Reporting Section was established within the Identification and Criminal Records Division (now Crime Records Division) to coordinate the collection, processing and publication of information regarding the extent of major crime in Texas.

METHOD OF DATA COLLECTION

REPORTING PROCEDURES

Monthly, law enforcement agencies report the number of known offenses in the following crime categories: Murder, Forcible Rape, Robbery, Aggravated Assault, Burglary, Larceny-Theft, Motor Vehicle Theft, and Arson. The offense count is taken from law enforcement agency records of complaints from victims and witnesses, and from crimes discovered by the agency during their operations. Complaints that are later determined to be unfounded are eliminated from the total count. The resulting number of "offenses known to law enforcement officials" is reported without regard to whether arrests were made, stolen property recovered, or prosecution took place. Agencies also report additional information on the value of property stolen and recovered, the circumstances surrounding homicides, family violence information, and reports of persons arrested. The arrest reports are categorized to provide information on the age, sex, race and ethnic origin of all persons arrested.

Each contributing agency is responsible for compiling its own crime reports and submitting them to the Uniform Crime Reporting program on a monthly basis. In an effort to maintain quality and uniformity in the data received, the DPS' UCR field representatives provide training in Uniform Crime Reporting procedures. All contributors are furnished the Uniform Crime Reporting Handbook which outlines detailed procedures for scoring and classifying offenses.

VERIFICATION PROCEDURES

A major concern in the collection of crime statistics is the validity and uniformity of the data received. With the receipt of voluntary monthly reports from 855 jurisdictions, the problem of attaining uniformity is readily apparent. Each incoming report is examined for arithmetical accuracy and reasonableness as a possible indication of errors. Numerous cross-checks are then employed to insure the accuracy of the reports. While minor errors are corrected by the UCR report verifiers, unusual variations are brought to the attention of the submitting agency by direct contact of a UCR field representative. After resubmission of a corrected return from a UCR field representative, the form is again verified. Only after the completion of all individual form verification processes are summary statistics derived.

FIELD REPRESENTATION

In compliance with national guidelines for field representation and in an effort to ensure the accurate reporting of crime information, the Texas Uniform Crime Reporting Program has assigned five persons to assist local agencies in crime reporting procedures. Based in Austin, each field representative is assigned a specific area (see map in Appendix A), and is responsible for assisting local police agencies in the resolution of reporting problems and for contacting non-reporting agencies to enlist their participation in the program.

A great deal of the success of Texas' UCR Program to this point has been due to the full time field staff assigned to assist local agencies in crime reporting procedures. Personal contact is invaluable to the accuracy and uniformity of UCR data received. To further this goal, the DPS UCR Section also employs a full time trainer who conducts on site training programs for local agencies.

OFFENSE ESTIMATION

The Texas UCR program enjoys a high rate of participation among Texas' Law Enforcement jurisdictions. In 1991, 855 Texas Law Enforcement agencies submitted reports to the DPS' UCR Section. The population covered by these agencies represented 99.9% of Texas' total population. Because UCR relies upon the voluntary participation of these agencies and to give a true picture of the total crime scene in Texas, it is necessary to estimate the crime totals for the non-reporting agen-

cies. Using the known crime experiences of similar areas within the state, the estimates are computed by assigning the same proportional crime volumes to non-reporting agencies. Through the application of standardized estimating procedures, Index Crime totals are directly comparable between specific years.

ADVISORY GROUPS

The Committee on Uniform Crime Records, IACP, continues to serve in an advisory capacity to the FBI in the operation of UCR. The National Sheriff's Association (NSA) in 1966 established a Committee on Uniform Crime Records to serve in an advisory capacity to the Uniform Crime Reporting Program. This Committee actively encourages full participation in UCR.

Committees on Uniform Crime Reporting within state law enforcement associations are active in promoting interest in UCR, fostering widespread use of uniform crime statistics, and lending assistance to contributors when the need exists. The FBI actively assists in the development of statewide police statistical programs that are compatible with the national system. State statistical programs provide the advantage of increased coverage of law enforcement agencies thereby assuring the completeness and quality of crime information.

The Texas Uniform Crime Reporting Program is directly made possible by a Grant Award from the State of Texas through the Criminal Justice Division of the Governor's Office.

RECENT DEVELOPMENTS

FAMILY VIOLENCE

The 71st Texas Legislature directed the Department of Public Safety to collect information on Family Violence incidents. This data collection commenced with calendar year 1991 and the compiled information will be released shortly after the release of this publication.

HATE CRIME DATA COLLECTION

Beginning in the calendar year 1992, under mandate of state and federal law, Hate Crime informa-

tion will be collected by the Texas UCR program. The "Hate Crime Statistics Act of 1990" directs the U.S. Attorney General to collect data, "about crimes that manifest evidence of prejudice based on race, religion, sexual orientation, or ethnicity." Shortly after passage of the National Law, the Texas Legislature amended its Government Code to require the Department of Public Safety to, "Establish and maintain a central repository for the collection and analysis of information relating to crimes that are motivated by prejudice, hatred, or advocacy of violence." The passage of this law impacted every law enforcement agency in Texas through the requirement that, "Local law enforcement agencies shall report offenses described by Subsection (a) in the form and manner and at regular intervals as prescribed by rules adopted by the department." The first set of Hate Crime Statistics is expected to be published in the calendar year 1992 edition of *Crime In Texas*.

CAMPUS CRIME

In 1990, the federal Crime Awareness and Campus Security Act was enacted into law. The Act requires eligible educational institutions to maintain certain crime and arrest data in accordance with UCR definitions. Index Crime reports from Texas campus police departments are available in Chapter Seven of this report.

INCIDENT BASED REPORTING

Since its inception, the UCR program has provided a steady, reliable stream of information about crime in this nation. The reliability of this system is evidenced by the fact that no major revision of UCR has taken place since its design in the 1920's. However, because UCR is a summary based reporting system, information about individual crime incidents is not available. The summary based methodology, despite its reliability, is limited in many aspects that become illuminated in the current age of information processing speed. Limitations of the summary system include a lack of information on offenses, arrests, and victim/offender relationships.

To take advantage of the current computer based processing environment, the FBI, in conjunction with the National UCR Conference, undertook a major enhancement of the UCR program. The resulting "Blueprint for the Future of the Uniform Crime Reporting Program: Final Report of the UCR Study" was released in 1985 and outlined the

emerging Incident Based Reporting (IBR) system. In its final implementation, IBR will collect data on the circumstances of each crime incident in electronic form. The full detail allowed by computerized data base searches of IBR data will greatly enhance the speed, availability, accuracy, and utility of crime statistics. Although still many years from full implementation, the Texas Incident Based Reporting System (TIBRS) is beginning to collect some information that will become available in the future.

CRIME FACTORS

Statistics gathered under the Uniform Crime Reporting Program are submitted by the law enforcement agencies of Texas and project a statewide picture of crime. Awareness of factors which influence the resulting crime statistics is necessary in order to draw fair conclusions. These crime factors influence the crime experience of each community. Therefore, comparisons of crime statistics between communities should not be made without consideration of the individual factors present in each community.

Crime is a social problem of grave concern in which the police are limited in their role of suppression and detection. As stated by the President's Commission on Law Enforcement and Administration of Criminal Justice:

"The fact that the police deal daily with crime does not mean that they have unlimited power to prevent it, or reduce it, or deter it. The police did not create and cannot resolve the social conditions that stimulate crime. They did not start and cannot stop the convulsive social changes that are taking place in America. They do not enact the laws that they are required to enforce, nor do they dispose of the criminals they arrest. The police are only one part of the government; and the government is only one part of society. The criminal process is limited to case by case operations, one criminal or one crime at a time."

Set forth below are some of the conditions which affect the crime types and volume that occurs in differing jurisdictions:

- The metropolitan area's population size and density.
- Demographic composition of the population with reference to age, sex and race.
- Economic status of the population and area unemployment rates.
- Population stability including the number of commuters, transients, and seasonal population variations.
- Climate.
- Cultural conditions, such as educational, recreational, and religious characteristics.
- Family values.
- Law enforcement employment standards and relative strength.
- Policies of the prosecuting officials and the courts.
- Public attitudes towards law enforcement and crime.
- The administrative and investigative efficiency of the local law enforcement agency, including the degree of adherence to crime reporting standards.
- Crime reporting practices of the citizenry.

TYPE OF CRIME IN TEXAS


CRIME INDEX OFFENSES

OFFENSE ESTIMATION

Because a few Texas law enforcement agencies experienced difficulty in finalizing their 1991 crime reports prior to state and national release deadlines, it has been necessary to estimate the number of offenses for 0.1% of the state's population.

VOLUME

During the calendar year of 1991, there was an estimated total of 1,356,451 Index Offenses in Texas. The crimes in this group are all serious, either by their very nature or because of the frequency with which they occur, and present a common enforcement problem to all police. Crimes within this index can be further categorized as Violent Crimes, which include Murder, Forcible Rape, Robbery and Aggravated Assault, or as Property Crimes, which consist of Burglary, Larceny-Theft, and Motor Vehicle Theft. In addition to the above offenses, there were 10,046 cases of arson reported.



VIOLENT CRIMES

Violent Crimes involve the element of personal confrontation between the perpetrator and the victim. Because of their nature, Violent Crimes are considered more serious than Property Crimes. These Offenses for 1991 made up 10.7% of the Crime Index Total.


An estimated 145,718 Violent Crimes occurred during 1991. This figure represents a 12.7% increase over 1990. A review of the distribution of the Violent Crimes discloses that Murder accounted for 0.2%, Rape 0.7%, Robbery 3.6%, and Aggravated Assault 6.2% of the total Crime Index.

PROPERTY CRIMES

The number of Property Crimes occurring during 1991 was estimated at 1,210,733. As a group, Property Crimes made up 89.3% of the total Crime Index.

Property Crimes increased .9% over 1990 UCR figures. Burglary accounted for 25.8% of all property offenses and 23.1% of the Total Crime Index. Larceny Theft accounted for 60.6% of all property offenses and 54.1% of the Total Crime Index. Motor Vehicle Theft made up 13.5% of all property offenses and 12.1% of the Crime Index Total.


CRIME IN TEXAS 1976 - 1991



CLEARANCES

For Uniform Crime Reporting purposes, an offense is cleared when a law enforcement agency has identified the offender, there is enough evidence to charge him, and he is actually taken into custody. The arrest of one person can clear several crimes or several persons may be arrested in the process of clearing one offense. Clearances are also recorded in exceptional circumstances when some element beyond law enforcement control precludes formal charges against the offender.

CLEARANCE RATES



Law enforcement officers cleared 20% of all Index Offenses reported to them in 1991 by arrest or exceptional means. Of the Violent Crimes reported, 47% were cleared while 17% of all Property Crimes were cleared.

Reports submitted by the law enforcement agencies of the State during 1991 disclosed that, in the area of Violent Crime, they were successful in solving 69% of the Murder offenses, 59% of the Forcible Rapes, 27% of all Robberies, and 57% of all Aggravated Assaults. Texas' law agencies showed Property Crimes clearances of 14% in Burglary, 19% in Theft, and 14% in Motor Vehicle Theft. Arson had a 18% clearance rate statewide.

The relatively high clearance rate for Violent Crimes compared to the Non-Violent Property Crimes is, in part, attributable to the element of confrontation between the victim and the perpetrator which contributes to identification of the offender.


In 1991, persons under the age of 18 represented 15% of all cases solved. They accounted for 9% of all Violent Crime Clearances, while being respon-

sible for 17% in the Non-Violent Crime categories. The involvement rate of persons under 18 years of age was 10% for Murders, 10% for Forcible Rape, 10% for Robbery, and 8% for Aggravated Assault. In the Non-Violent Crime categories, this age group accounted for 13% of the Burglaries, 17% of the Thefts, and 19% of the Motor Vehicle Thefts.

STOLEN PROPERTY VALUE

The total value of property stolen during 1991 in Texas was estimated at \$1,616,300,185.



PROPERTY VALUE LOST IN CRIME (In Millions)

As the most aggregate representation of UCR data, the Crime Clock should be viewed with care. The Crime Clock conveys the relative frequency of Index Crimes. This display does not imply any regularity in the commission of crimes, but rather, the Clock represents the annual ratio of crimes to fixed time intervals.

ESTIMATED CRIME IN TEXAS

The number of offenses shown in this report were compiled from reports submitted to the Uniform Crime Reporting Program by Texas law enforcement agencies. Because the degree of reporting compliance has varied throughout the years covered in this publication, it has been necessary to estimate the number of crime offenses for non-reporting jurisdictions. The rate of compliance for the year 1976 represented 94.5% of the state's population, while the rate of compliance for 1991 covered 99.9% of Texas' inhabitants. Traditionally, previous editions of *CRIME IN TEXAS* have estimated crime in non-reporting jurisdictions based on an average of the reporting agencies in the same population group or by projecting annual totals from agency reports that cover less than twelve months. This same philosophy is followed here. The term rate refers to the number of crimes per 100,000 population.

MURDER

DEFINITION

Murder and nonnegligent manslaughter, as defined in the Uniform Crime Reporting Program, is the willful killing of one human being by another.

This offense category includes any death due to a fight, argument, quarrel, assault or commission of a crime. Attempted murder and assaults with the intent to kill are not counted as murder, but are included in UCR as aggravated assaults. Suicides, accidental deaths, and justifiable homicides are also excluded from the murder classification.


The classification of this offense, as well as for all Index Crimes, is based solely on police investigation and not upon determinations by courts, medical examiners, coroners, juries, or other judicial bodies.

ANALYSIS

VOLUME

The estimated number of murders committed in Texas in 1991 was 2,651. This represented an 11% increase in the number of murders when compared with 1990. More persons were murdered in Texas

in August than in any other month, while the fewest were killed during January and March (187 murders for each month).

RATE

The murder rate for Texas in 1991 was 15.3 murders for every 100,000 persons. The change in the murder rate from 1990 was an increase of 8.5%.


CLEARANCE RATE

Texas law enforcement agencies continue to be successful in clearing or solving by arrest a greater percentage of murders than any other Index Crime. In 1991, 69% of all murders were cleared.

NATURE

Of the murders committed in 1991, 69.9% were committed with the use of firearms. Knives or cutting instruments were the means of murder in 14.6% of the reported cases. Personal weapons, which are hands, feet and fists, accounted for 6.6% of the murders. Blunt objects were employed in the 4.9% of the murders and the remaining 3.9% were classified as unknown weapons.

Of the murders in which firearms were the instrument of murder, handguns accounted for at least 72% (or 50% of all murders). Shotguns were the murder means in more than 9% of the cases, rifles were used in more than 4% and firearms whose type was not stated accounted for the remaining 14%.


PERSONS ARRESTED

When compared to 1990 statistics, the number of persons arrested for the crime of murder in Texas rose 13% to 2,013. Of the persons arrested for murder, 210 or 10.4% were aged 16 and under (in 1976 Juveniles accounted for 5.2% of Murder arrestees); 1181, or 59%, were White; 831, or 41% were Black; 1371, or 68%, were Not Hispanic; and 642, or 32%, were Hispanic.



MURDER ARRESTEES BY AGE AND SEX





When Firearm was Murder Weapon





MURDER VICTIMS


Law enforcement agencies participating in the UCR program cooperate in providing additional homicide information so that in-depth analysis of this crime is possible. Through the Supplemental Homicide Reporting system information is provided identifying the age, sex, race and ethnic origin of victims and offenders; weapons used in the commission of murder; the relationship of the victim to the offender; and the circumstances surrounding the offense.

Based on this information about murder victims it can be determined that 79% of murder victims were male and 21% were female. Of the victims whose race was known, 58% were white, 40% were black, and the remainder were of other races. Of the murder victims whose ethnicity was known, 1,862, or 71%, were Not Hispanic and 757, or 29%, were Hispanic.

RAPE

DEFINITION


Rape, as defined in the Uniform Crime Reporting program, is the carnal knowledge of a female forcibly and against her will. Statistics reported in this crime category include assaults to commit forcible rape, however, statutory rape (without force) and sexual assaults on males are excluded.

ANALYSIS

VOLUME

The estimated number of rapes committed in Texas in 1991 was 9,265. This represented an increase of 5.9% in the number of rapes when compared with 1990. More rapes were committed in Texas in August than in any other month, while the fewest rapes were committed during January. Property loss during the commission of the crime of rape in 1991 amounted to \$562,468.


RAPE OFFENSES 1976 -- 1991






RAPE BY MONTH




NATURE OF FORCIBLE RAPE

CLEARANCE RATE

Statewide, Texas law enforcement agencies continue to be successful in clearing or solving by arrest 59% of all rapes that were reported. Of the attempts to commit forcible rape, 48% were cleared, and of the rapes by force 60% were cleared.

NATURE

Forcible rape differs from other violent crimes because, in many cases, the victim is hesitant to report the offense to police. The rigors of court procedures, embarrassment, and fear of any accompanying stigma exert a deterrent effect upon the victim's willingness to contact the police. The presence of prior relationship between the victim and offender may make the determination of force difficult to establish, while the usual clandestine

nature of this crime presents a problem in verification.

Of all reported forcible rapes during 1991, 13% were attempts to commit forcible rape while 87% were rapes by force.

PERSONS ARRESTED

When compared with 1990, the number of persons arrested for forcible rape rose 4.6% to 2,709. Of the forcible rape arrestees in 1991, 331 or 12.2% were Juveniles (16 and under) with the remainder being Adults; 2,671, or 98.6%, were Male; 1,788, or 66%, were White; 913, or 33.7%, were Black and the remainder were other races; 72% were not Hispanic and 28% were Hispanic.

ROBBERY

DEFINITION

Robbery, in the Uniform Crime Reporting program, is defined as the taking or attempting to take anything of value from the care, custody, or control of a person or persons by force, threat of force or violence, or by putting the victim in fear.


Robbery is a violent crime that frequently results in injury to the victim. Included in this category are assaults to commit robbery and attempted robberies.


VOLUME

The estimated number of robberies committed in Texas in 1991 was 49,698. This represented a 12.1% increase in the number of robberies when compared with 1990. More robberies were committed in Texas in August than in any other month, while the fewest robberies were committed during February.

ROBBERY BY MONTH




ROBBERY OFFENSES 1976 ---- 1991





MONETARY LOSS TO ROBBERY 1976 ---- 1991






ROBBERY LOCATIONS



NATURE

In 1991, Property loss during the commission of robberies amounted to \$56,553,949. The state total was a 28% increase over the property loss experienced in 1990. The value of property stolen during

robberies averaged \$1,138 per incident. Average dollar losses ranged from \$301 taken during robberies of convenience stores to \$6,809 per bank robbery. The impact of this violent crime cannot be measured in terms of monetary loss alone. While the object of robbery is money or property, the crime involves force or threat of force and many victims suffer serious personal injury.

Robberies on streets or highways accounted for more than one third (38%) of the offenses in this category. Robberies of commercial and financial establishments accounted for 32% and those occurring at residences, 12%. The remainder were miscellaneous types.

Of all reported robberies in 1991, 44% were committed with the use of firearms. Strong-arm tactics accounted for 34%, knives or cutting instruments were used in 12% and other weapons made up the remainder.

PERSONS ARRESTED

Statewide arrests for robbery in 1991 amounted to 9,670 persons. When compared with 1990, the number of persons arrested for robbery rose 8.7%. Of the robbery arrestees in 1991, 1,845 or 19% were Juveniles (16 and under) with the remainder being Adults; 8,712, or 90% were Male; 4,372 or 45%, were White; 5,277, or 55%, were Black; 75% were not Hispanic and 25% were Hispanic.

AGGRAVATED ASSAULT

DEFINITION

Aggravated Assault is defined in the Uniform Crime Reporting program as an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault is usually accompanied by the use of a weapon or by means likely to produce death or great bodily harm. Statistics for aggravated assault include attempts to commit aggravated assault.



The estimated number of aggravated assaults committed in Texas in 1991 was 84,104. This represented a 13.8% increase in the number of aggravated assaults when compared with 1990. More aggravated assaults were committed in Texas in August than in any other month, while the fewest aggravated assaults were committed during January.





The use or attempted use of a dangerous weapon in an assault or the serious injury inflicted by hands, fists or feet separates this index offense from assaults categorized as "Simple Assaults". Texans reported 221,034 simple assaults in 1991.


AGGRAVATED ASSAULT BY MONTH

AGGRAVATED ASSAULT ARRESTEES BY AGE AND SEX




CLEARANCE RATE

Statewide, Texas law enforcement agencies were successful in clearing or solving by arrest 57% of all aggravated assaults that were reported. Of the aggravated assaults by type of weapon used, Personal weapon (hands, fists, feet, etc.) assaults experienced the highest rate of clearance (63.6%), while aggravated assault by firearm showed the lowest rate of clearance (47.1%).

PERSONS ARRESTED

Texas law enforcement agencies arrested 24,338 persons for aggravated assault in 1991. When compared with 1990, the number of aggravated assault arrests rose 6.4%. Of the aggravated assault arrestees in 1991, 3,001 or 12% were Juveniles (16 and under) with the remainder being Adults; 87% were Male; 16,168 or 66%, were White; 8,095, or 33%, were Black and the remainder were other races; 67% were not Hispanic and 33% were Hispanic.

DEFINITION


Burglary, for Uniform Crime Reporting purposes, is the unlawful entry of a structure with the intent to commit a felony or a theft. While the use of force to gain entry is not required to classify an offense as burglary, attempted forcible entries to commit burglary are also counted in this crime's statistics.

ANALYSIS

VOLUME

The estimated number of burglaries committed in Texas in 1991 was 312,719 and this number represents a 0.6% decrease when compared with 1990. Burglary was the only Index Crime to experience a decrease in the number of offenses this year. More burglaries were committed in Texas in July than in any other month, while the fewest burglaries were committed during February.


BURGLARY OFFENSES 1976 --- 1991






BURGLARY BY MONTH




Of all reported burglaries in 1991, more than two of every three were residential in nature. Forcible entry accounted for 73% of all Texas burglaries, while 23% were unlawful entries without force, and the remainder were forcible entry attempts. Offenses for which time of occurrence was known were nearly evenly divided between day and night.

In 1991, burglary victims suffered losses totaling \$382,635,455. This total represents a decrease of 12.6% when compared with 1990 total burglary losses. The average dollar loss per burglary was \$1,224. The average loss for residential offenses was \$1,263, while for nonresidential property, it was \$1,144.

BURGLARY ARRESTEES BY AGE AND SEX





Statewide, Texas law enforcement agencies were successful in clearing or solving by arrest 14% of all burglaries that were reported.

PERSONS ARRESTED

In 1991, 32,130 arrests for burglary were made by Texas law enforcement agencies. When compared with 1990, the number of persons arrested for burglary decreased 0.2%. DEFINITION

Larceny-Theft, in the Uniform Crime Reporting program, is the unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. Larceny-Theft includes crimes such as shoplifting, pocket-picking, purse-snatching, thefts from motor vehicles, thefts of motor vehicle parts and accessories, bicycle thefts, and the like in which no use of force, violence or fraud occurs.


In the UCR program, this crime classification does not include embezzlement, "con" games, forgery, and the passing of worthless checks. Motor Vehicle Theft is excluded from this category inasmuch as it is a separate Crime Index offense.

ANALYSIS

VOLUME

The estimated number of thefts committed in Texas in 1991 was 734,177 making this the largest crime category of the Index Crimes. The volume of theft in 1991 increased 0.4% compared with

THEFT OFFENSES 1976 ---- 1991




1990. More thefts were committed in Texas in August than in any other month, while the fewest thefts were committed during February.


RATE

The 1991 theft rate for Texas was 4,231.5 thefts for every 100,000 persons. The change in the theft rate from 1990 was a decrease of 1.7%.


In 1991, theft victims suffered losses totaling \$326,820,141. This total represents an increase of 3.1% when compared with 1990 total theft losses. The average dollar loss per theft was \$445, up from \$434 in 1990. Thefts in the 'under \$50' category accounted 47% of all reported thefts, while 32% were \$200 and over and the remainder were between \$50 and \$200.

The highest average theft category was theft from buildings which yielded an average \$790.56 per reported occurrence. Thefts from motor vehicles averaged \$467.50 per report, the average Purse-snatching resulted in a \$320 loss, and the average loss to victims of Pocket-picking was \$275.50. It is expected that many of the offenses in this category, particularly where the value of goods stolen is small, are never reported to police agencies.

CLEARANCE RATE

Statewide, Texas law enforcement agencies were successful in clearing or solving by arrest 19% of all thefts that were reported. As with other non-violent property crimes, theft is primarily a crime of opportunity. The combination of the factors of opportunity and stealth work in the favor of perpetrators and against police detection, and, thereby, reduce available solutions for this offense.


THEFT ARRESTEES BY AGE AND SEX



PERSONS ARRESTED

Texas law enforcement agencies made 122,572 larceny—theft arrests in 1991. When compared with 1990, the number of persons arrested for theft increased 2.2%. Of the theft arrestees in 1991, 29,719 or 24% were Juveniles (16 and under) with the remainder being Adults; 68% were Male; 87,286 or 71%, were White; 34,602, or 28%, were Black and the remainder were other races; 68% were not Hispanic and 32% were Hispanic.

MOTOR VEHICLE THEFT

DEFINITION


Motor Vehicle Theft, for UCR purposes, is the theft or attempted theft of a motor vehicle. A motor vehicle is defined as a self-propelled vehicle that travels on the surface but not on rails. Specifically excluded from this category are motor boats, construction equipment, airplanes, and farming equipment.

ANALYSIS

VOLUME

The estimated number of motor vehicle thefts committed in Texas in 1991 was 163,837. The volume of motor vehicle theft increased faster than any other property crime in 1991 totaling a 6.1% increase when compared with 1990. More motor vehicle thefts were committed in Texas in July than in any other month, while the fewest motor vehicle thefts were committed during February.


MOTOR VEHICLE THEFT OFFENSES 1976 — 1991




RATE

The 1991 motor vehicle theft rate for Texas was 944.3 motor vehicle thefts for every 100,000 persons. The change in the motor vehicle theft rate from 1990 was an increase of 3.9%.


MOTOR VEHICLE THEFT BY MONTH

MOTOR VEHICLE TYPES STOLEN




NATURE

In 1991, motor vehicle theft victims suffered losses totaling \$849,392,441. This total value loss represents a decrease of 0.8% when compared with 1990 total motor vehicle theft losses. The average dollar loss per motor vehicle theft was \$5,186 down from \$5,549 in 1990. Of the types of motor vehicles that are reported to be stolen, 68% are Automobiles, 26% are Trucks and Buses, and the remainder are classed as "Other Vehicles". Other vehicles includes all other motor vehicles limited by the UCR definition, such as snowmobiles, motorcycles, motor scooters, trail bikes, mopeds, golf carts and the like.

CLEARANCE RATE

Statewide, Texas law enforcement agencies were successful in clearing or solving by arrest 14% of all motor vehicle thefts that were reported. Persons

MVT ARRESTEES BY AGE AND SEX




in the under-18 age group accounted for 19% of the motor vehicle thefts that were cleared.


In 1991, Texas law enforcement agencies arrested 17,055 persons for motor vehicle theft. When compared with 1990, the number of motor vehicle theft arrests increased 7.9%. Of the motor vehicle theft arrestees in 1991, 5,870 or 34% were Juveniles (16 and under); 90% were Male; 11,105 or 65%, were White; 5,880, or 35%, were Black and the remainder were other races; 66% were not Hispanic and 34% were Hispanic.

Of the three vehicle types for which information is collected, Automobiles show the highest clearance rate of 15%. 21% of the automobile clearances involved persons under eighteen. Thefts of trucks and buses were cleared at a 12% rate, of which only 14% involved persons under eighteen. The other vehicle classification shows a 12.5% clearance rate, 24% of these clearances involved persons under the age of eighteen.

ARSON

DEFINITION

For Uniform Crime Reporting purposes, arson is defined as any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.


Only fires determined through investigation to have been willfully or maliciously set are classified as arsons. Fires of suspicious or unknown origins are excluded.


VOLUME

The reported number of arsons committed in Texas in 1991 was 10,046. The volume of arson increased 1.8% in comparison with 1990. Because the U.S. Congress did not mandate Arson to be an Index Crime until 1979, information on offenses before that year is incomplete. The charts in this section reflect this fact.

ARSON ARRESTS 1979 --- 1991




ARSON OFFENSES 1979 --- 1991

The 1991 arson rate for Texas was 57.9 arsons for every 100,000 persons. The change in the arson rate from 1990 was a decrease of 0.3%.


Structures were the most frequent targets of arsonists in 1991 and comprised 58% of the reported incidents. Mobile property constituted 32% of reported arsons, while other (crops, timber, fences, signs, etc.) formed the remaining 10%. Residential property was involved in 67% of the structural arsons in 1991, with 50% of such arsons directed at single occupancy dwellings. Seventeen percent of all targeted structural property was uninhabited at the time the arson occurred. Motor vehicles composed 95% of all mobile property at which arsons were directed.

In 1991, arson victims suffered losses totaling \$104,560,969. This total value loss represents a 4.7% increase when compared with 1990 total arson losses. The average dollar loss per arson was \$10,409 up from \$10,120 in 1990. Industrial/manufacturing property was the classification with the highest average loss per offense, \$130,395. Single occupancy residences showed an average loss of \$12,922, motor vehicle arsons averaged a loss of \$4,200, and the 'other' group (crops, timber, fences, signs, etc.) had the lowest average loss of \$455.

CLEARANCE RATE

Statewide, Texas law enforcement agencies were successful in clearing or solving by arrest 18% of all arsons that were reported. Of the community structures struck by arson, 42% were cleared, a greater percentage than any other group. Motor

ARSON ARRESTEES BY AGE AND SEX




vehicles showed the lowest clearance rate (7%) of any property class. Of all arson clearances, 51% involved persons under the age of eighteen years old. Persons in this age group accounted for 68% of the Community structure arson clearances and 79% of the 'other' category.





Of the persons arrested for arson in 1991, 365 or 34% were Juveniles (16 and under); 88% were Male; 875 or 82%, were White; 190, or 18%, were Black and the remainder were other races; 71% were not Hispanic and 29% were Hispanic.

For UCR purposes, Driving Under The Influence is the crime of driving or operating any motor vehicle or common carrier while drunk or under the influence of liquor or narcotics.




As with all Part II, non—index crimes, no information on the number of reported crimes is collected by the Texas UCR program for this offense. However, information on the number of persons arrested for this crime is collected and is reported here in this special section.

The reported number of arrests for DUI in Texas in 1991 was 112,022. The volume of DUI arrests decreased 0.7% in comparison with 1990.

RATE

The 1991 DUI arrest Rate for Texas was 645.7 arrests for every 100,000 persons. The change in the DUI arrest rate from 1990 was a decrease of 2.8%.

NATURE

Any consideration of the number and rate of DUI arrests must be reconciled with the fact that many factors control the ability of law enforcement personnel to detect and arrest drunken drivers. Among the significant factors which drive the DUI arrest rate are these: media coverage of the DWI problem, public awareness, availability of funds for patrol officer overtime, and the skill and training in DUI detection of law officers.

PERSONS ARRESTED

Of the 112,022 persons arrested for Driving Under the Influence in 1991, only 199 or 0.2% were Juveniles (16 and under); 100,577, or 90% were Male; 103,163 or 92%, were White; 8,662, or 8%, were Black and the remainder were other races; 63% were not Hispanic and 37% were Hispanic.


DEFINITION

For UCR purposes, drug abuse encompasses all violations of the Narcotic drug laws. These are offenses relating to narcotic drugs, such as unlawful possession, sale, use, growing and manufacturing of narcotic drugs.

In this report these violations are summarized to include all drug abuse arrests (Grand Total Drug Abuse), Sale and Manufacturing arrests, and Drug Possession arrests.

As with all Part II, non-index crimes, no information on the number of reported crimes is collected by the Texas UCR program for these offenses. However, information on the number of persons arrested for these crimes is collected and is reported here in this special section.


The reported total number of arrests for drug abuse in Texas in 1991 was 61,742. This grand total of all drug abuse violations decreased 1% in comparison with 1990.

The 1991 grand total drug abuse arrest rate for Texas was 355.9 arrests for every 100,000 persons. The change in the grand total drug abuse arrest rate from 1990 was a decrease of 2.8%.

PERSONS ARRESTED

Of the 61,742 persons arrested for drug abuse violations in 1991, only 3,176 or 5.1% were Juveniles (16 and under); 51,660, or 84% were Male; 36,549 or 59%, were White; 25,101, or 41%, were Black and the remainder were other races; 73% were not Hispanic and 27% were Hispanic.

The number of arrests for illegal drug sale and manufacturing totaled 10,191, which was a 6.5% increase over 1990.





DRUG POSSESSION ARRESTS BY DRUG







DRUG SEIZURES

PURPOSE

Drug seizure information is presented in compliance with Article 4476-15 §5.14 V.A.C.S. and its requirement that, "All law enforcement agencies in this state shall file monthly with the (DPS) Director a report of all arrests for drug offenses made and quantities of controlled substances seized by them during the preceding month."

QUANTITIES

The following chart displays the quantity of illegal drugs seized in Texas. Quantities are rounded. Dose Units refer to one pill, tablet, capsule or other single user quantity. The information presented here is based upon reports of drugs seized by Texas Law Enforcement agencies and does not include drugs seized in Texas by any Federal law enforcement agencies.

MARIJUANA PLANTS, FIELDS AND GARDENS

In addition to the drug seizure quantities displayed in the chart, Texas Law Officers seized 114 Marijuana Gardens, 101 Wild Marijuana Fields, 156 Marijuana Cultivated Fields, and 26 Marijuana Greenhouses. The total number of all marijuana plants that were reportedly seized in 1991 was 628,487.

CLANDESTINE LABS

During 1991, 71 Clandestine Labs were seized in Texas. Of these seized labs, 42 were used to produce Methamphetamine, 22 were manufacturing Amphetamines, and 7 were engaged in production of Phenylacetone (P2P).


Weapons: carrying, possessing includes all violations and attempted violations of regulations or statutes controlling the carrying, using, possessing, furnishing, and manufacturing of deadly weapons or silencers.

As with all Part II, non—index crimes, no information on reported crimes is collected by the Texas UCR program for this offense. However, information on the number of persons arrested for this crime is collected and is reported here in this special section.


ANALYSIS

Because of media attention to weapons violations by juveniles, this section focuses on trends in weapon possession. As indicated in the Murder section, the percentage of juvenile arrests for murder has increased from 5.2% of all murder arrestees in 1976 to 10.4% in 1991. In light of the knowledge

that firearms are the murder weapon of choice in almost 70% of all Texas murders, a close inspection of weapons violations becomes justified.

VOLUME AND RATE


The reported number of arrests for Weapons Violations in Texas in 1991 was 22,245. The volume of Weapons arrests increased 9.5% when compared with 1990.

The 1991 Weapons arrest Rate for Texas was 128.2 arrests for every 100,000 persons. The change in the arrest rate from 1990 was an increase of 7.2%.

PERSONS ARRESTED

Of the 22,245 persons arrested for Weapons Violations in 1991, 3,014 or 13.5% were Juveniles (16 and under); 20,673, or 93% were Male; 13,934, or 63%, were White; 8,251, or 37%, were Black and the remainder were other races; 69% were not Hispanic and 31% were Hispanic.

In this report's base year of 1976 there were 11,159 Weapons arrests. Of this total, 6.4% were Juveniles, 90% were Male, 64% were White, and 36% were Black. 1976 ethnicity data is unavailable.


LAW ENFORCEMENT EMPLOYEE DATA

The Texas Uniform Crime Reporting program collects pertinent data relating to the police agencies of the state. Information regarding law enforcement employee strength, employment trends, Law Officers assaulted in the line of duty, and Law Officers killed in the line of duty is discussed in this section.

COMMISSIONED PERSONNEL

Texas' law enforcement community employed 39,171 full time sworn officers as of October 31, 1991. The average number of officers for every 1,000 inhabitants of Texas was 2.26. The law officer rate has increased over the 1990 Texas rate of 2.06 officers per 1,000 inhabitants and now compares favorably with the National average (2.2 in 1990).


TEXAS LAW OFFICERS PER 1,000 POPULATION



CIVILIAN EMPLOYEES

The 861 Texas agencies reporting law enforcement employee data employed 23,465 civilian workers. Civilian employment has increased 17.6% over 1990 and now makes up 37% of the Texas law enforcement work force. The trend towards civilians performing non-enforcement police activities such as communications is largely responsible for this dramatic rise in law enforcement agency employment of civilians.

LAW ENFORCEMENT OFFICERS ASSAULTED


The killing or assaulting of a law officer creates a serious detrimental effect on the security of our society. The real possibility of being assaulted by members of the community that they are sworn to protect may weigh heavily on the minds of persons contemplating law enforcement careers. As attacks on police officers reduce their ability to combat crime, violence towards the police equals violence towards society.

In 1991, 4,905 Texas Law Officers were assaulted in the line of duty. The number assaulted represented 12.5% of all Texas Officers or one out of every eight full time sworn officers. The number of assaults declined 3% from 1990. Assaults resulted in injury to the officer in 38% of the cases, while 92% of the assaults were cleared.




TEXAS LAW OFFICERS ASSAULTED 1976 - 1991




LAW OFFICER ASSAULTS BY TIME OF DAY







OFFENSES IN UNIFORM CRIME REPORTING

Offenses in Uniform Crime Reporting are divided into two groupings designated as Part I and Part II offenses. Offense and arrest information is reported for the Part I offenses, while only arrest information is reported for Part II offenses.

Part I Offenses

1. **Criminal Homicide.** (a) Murder and nonnegligent manslaughter: All willful felonious homicides as distinguished from deaths caused by negligence. Excluded are attempts to kill, assaults to kill, suicides, accidental deaths, and justifiable homicides. Justifiable homicides are limited to: The killing of a person by a law enforcement officer in the line of duty; and the killing of a person in the act of committing a felony by a private citizen. (b) Manslaughter by negligence: Any death which the police investigation established was primarily attributable to gross negligence of some individual other than the victim.

2. **Forcible Rape.** The carnal knowledge of a female, forcibly and against her will. Included in this category are rapes by force, assaults to rape, and attempted rapes. Excludes statutory offenses (no force used victim under age of consent).

3. **Robbery.** Stealing or taking anything of value from the care, custody, or control of a person by force or by violence or by putting in fear, such as strong-arm robbery, stickups, armed robbery, assaults to rob, and attempts to rob.

4. **Aggravated Assault.** Assault with intent to kill or for the purpose of inflicting severe bodily injury by shooting, cutting, stabbing, maiming,

poisoning, scalding, or by the use of acids, explosives, or other means. Excludes simple assaults.

5. **Burglary breaking or entering.** Burglary, house-breaking, safecracking, or any breaking or unlawful entry of a structure with the intent to commit a felony or a theft. Includes attempted forcible entry.

6. **Larceny—Theft (except motor vehicle theft).** The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. Thefts of bicycles, automobile accessories, shoplifting, pocket-picking, or any stealing of property or article which is not taken by force and violence or by fraud. Excludes embezzlement, "con" games, forgery, worthless checks, etc.

7. **Motor vehicle theft.** Unlawful taking or stealing or attempted theft of a motor vehicle. A motor vehicle is a self-propelled vehicle that travels on the surface but not on rails. Specifically excluded from this category are motor boats, construction equipment, airplanes, and farming equipment.

8. **Arson.** Willful or malicious burning with or without intent to defraud. Includes attempts.

Part II Offenses

9. **Other assaults (simple).** Assaults which are not of an aggravated nature.

10. **Forgery and counterfeiting.** Making, altering, uttering or possessing, with intent to defraud, anything false which is made to appear true. Includes attempts.

11. **Fraud.** Fraudulent conversion and obtaining money or property by false pretenses. Includes bad checks except forgeries and counterfeiting. Also includes larceny by bailee.

12. **Embezzlement.** Misappropriation or misapplication of money or property entrusted to one's care, custody or control.

13. **Stolen property; buying, receiving, possessing.** Buying, receiving, and possessing stolen property and attempts.

14. **Vandalism.** Willful or malicious destruction, injury, disfigurement, or defacement of property without consent of the owner or person having custody or control.

15. **Weapons; carrying, possessing, etc.** All violations of regulations or statutes controlling the carrying, using, possessing, furnishing, and manufacturing of deadly weapons or silencers. Includes attempts.

16. **Prostitution and commercialized vice.** Sex offenses of a commercialized nature and attempts, such as prostitution, keeping a bawdy house, procuring, transporting women for immoral purposes, etc.

17. **Sex offenses (except forcible rape, prostitution, and commercialized vice).** Statutory rape, offenses against chastity, common decency, morals, and the like. Includes attempts.

18. **Narcotic drug laws.** Offenses relating to narcotic drugs, such as unlawful possession, sale, use, growing and manufacturing of narcotic drugs.

19. **Gambling.** Promoting, permitting, or engaging in illegal gambling.

20. **Offenses against the family and children.** Nonsupport, neglect, desertion, or abuse of family and children.

21. **Driving under the influence.** Driving or operating any motor vehicle or common carrier while drunk or under the influence of liquor or narcotics.

22. **Liquor laws.** State or local liquor law violations, except "drunkenness" (class 23, below) and "driving under the influence" (class 21, above). Excludes Federal violations.

23. **Drunkenness.** Drunkenness or intoxication.

24. **Disorderly conduct.** Breach of the peace.

25. **Vagrancy.** Vagabondage, begging, loitering, etc.


26. **All other offenses.** All violations of state or local laws, except classes 1 - 25, above, and traffic violations.

27. **Suspicion.** Arrests for no specific offenses and released without formal charges being placed.

28. **Curfew and loitering laws (juveniles).** Offenses relating to violation of local curfew or loitering ordinances where such laws exist.

29. **Runaway (juveniles).** Limited to juveniles taken into protective custody under provisions of local statutes as runaways.

GLOSSARY OF TERMS

Adult — In Texas an adult is defined as a person 17 years of age or over. In this publication we have followed this definition.

Cleared by arrest or exceptional means — For Uniform Crime Reporting purposes, an offense is cleared by arrest or solved when at least one person is (1) arrested, (2) charged with the commission of an offense and (3) turned over to court for prosecution. In certain situations police are not able to follow these three steps. In many instances police have exhausted all leads and have done everything else possible to clear a case. If the following four conditions can be met, the offense can be cleared exceptionally: (1) the investigation has definitely established the identity of the offender, (2) there is enough information to support an arrest, charge, and turning over to the court for prosecution, (3) the exact location of the offender is known so that he could be taken into custody and (4) there is some reason outside the police control that prevents the arresting, charging, and prosecuting of the offender.

Crime factors — Conditions which affect the amount and type of crime that occurs in a geographical area.

Crime Index — The sum total of seven major offenses used to measure the extent, fluctuation and distribution of crime in a given geographical area. Crime classifications used in the index are: (1) murder, (2) rape, (3) robbery, (4) aggravated assault, (5) burglary, (6) larceny-theft and (7) motor vehicle theft. Each of these offenses is referred to as an "Index Offense." While arson is also an Index Offense, it is not included as part of the Crime Index.

Crime Rate — The number of offenses per 100,000 inhabitants. This rate can be calculated

regardless of the number of inhabitants in your city or county. To compute rates, divide the population by 100,000 and divide the number of offenses in each class by that answer. The answer is the number of offenses in that class per 100,000 and is your crime rate for that offense. Example: (a) Population for your jurisdiction, 75,000. (b) Number of burglaries for your jurisdiction for a year, 215. Divide 75,000 by 100,000 - 0.75. Divide 215 by 0.75 - 286.7. Your burglary rate: 286.7 per 100,000 inhabitants. The number 0.75 can now be divided into your totals in any offense class to produce a crime rate for that offense.

Juvenile — In Texas a juvenile is defined as a person 16 years of age or under. In this publication we have followed this definition.

Non-violent crime — Consists of the Index Offenses of Burglary, Larceny-Theft and Motor Vehicle Theft.

Part I Offenses — The first of two main categories of crime classes composing a universal crime classification system established for crime reporting purposes. Part I Offenses are by their nature more serious and/or occur most frequently. The monthly tabulation of Part I Offenses provides a count of "offenses known."

Part II Offenses — The second of two main categories of crime classes composing a universal crime classification system established for crime reporting purposes. Part II Offenses are generally less serious in nature and/or occur less frequently. Monthly tabulations of Part II Offenses are limited to arrest information only.

Violent crime — Consists of the Index Offenses of Murder, Forcible Rape, Robbery, and Aggravated Assault.
