Compensation is available for out-of-pocket expenses incurred as a direct result of the criminal acts of another person. Examples of economic losses covered under the law are: medical care, rehabilitation, funeral expense, work loss, home maintenance, child care cost or mental health care. Property loss and pain and suffering are not compensable. The crime must have occurred on or after July 1, 1992, and must be reported to law enforcement within five days. Federal crime victims are eligible to apply for compensation whether or not the crime falls under tribal, state, or federal jurisdiction. Emergency payments up to \$1,000 may be accessed if the victim/family would suffer undue hardship if payment were not forthcoming. Maximum payment for any one claim is \$10,000.
