### Residents in Wisconsin Adult Correctional Facilities on December 31, 1991

Eight out of 10 men (81.7 percent) of the men and 9 out of 10 women (90.6 percent) were serving new sentences. This category includes offenders who were not under any type of sentence prior to being committed as well as those who were admitted as probation violators either with or without new sentences. Men and women returned to the institution with or without new sentences following revocation of parole or mandatory release supervision made up 17.0 and 7.9 percent of the resident population respectively. Ninety-one men (1.3 percent) and 5 women (1.5 percent) of the residents institutionalized pending revocation of field supervision, on alternative to revocation contracts, or for other reasons have been excluded from Tables 2 through 13.

White men made up one-half (49.5 percent) of the resident population while two-fifths (41.6 percent) were Black. The reverse was true among the women where one-half (51.2 percent) were Black and over two-fifths (44.6 percent) were White.

Men in residence had most frequently been sentenced for unarmed burglary (15.6 percent), first degree sexual assault/first degree sexual assault of a child (9.5 percent), armed robbery (8.9 percent), and other drug violations (8.6 percent). Forgery (14.4 percent), other drug violations (13.5 percent), theft (12.0 percent), and first degree murder/first degree intentional homicide (7.2 percent) were the crimes for which women had most often been sentenced.

\* Three-tenths (29.2 percent) of the men were classified solely as property offenders. Three-fifths (59.2 percent) were classified as assaultive offenders, one-fifth (21.2 percent) as sex offenders, and over one-tenth (13.4 percent) as drug offenders. The latter three categories are not mutually exclusive.

Two-fifths (40.7 percent) of the women were classified only as property offenders. An additional two-fifths (39.8 percent) were classified as assaultive offenders, about one-fifth (18.9 percent) as drug offenders, and less than one-tenth (7.8 percent) as sex offenders. These three categories are not mutually exclusive.

\* Men in residence were serving an average sentence of 11.3 years; women, an average sentence of 7.0 years. Residents serving life sentences, 462 men and 23 women, were excluded from these computations.

\* About two-fifths of the men (38.5 percent) and women (38.6 percent) in residence were committed from Milwaukee County. An additional one-fourth (26.3 percent) of the men and one-third (32.1 percent) of the women were committed from Dane, Kenosha, Racine, and Rock Counties.

\* Men, with an average age of 30.9 years, were over one year younger than women who had an average age of 32.3 years.

\* Wisconsin was noted as the place of birth for more than one-half of the men (52.2 percent) and women (54.2 percent) in residence.

\* Seven out of 10 men (69.1 percent) and women (67.4 percent) were free from any type of physical, developmental or emotional disability. One-tenth of the men (10.7 percent) and women (11.7 percent) had some type of physical disability.

\* Less than one-fifth (15.3 percent) of the men and 6 women had a record of previous military service.

(See Table 10.)

\* Over one-third of the men (36.3 percent) and women (36.2 percent) had some high school education but had not earned diplomas. High school diplomas or GED certificates had been earned by about two-fifths (38.4 percent) of the men and over one-fourth (27.3 percent) of the women.

\* Men had been institutionalized for an average of 26.6 months; women, for an average of 16.4 months.

\* After the completion of the assessment and evaluation process, one-third (33.6 percent) of the men were assigned a maximum security classification. Just under two-fifths (37.0 percent) were classified as medium or medium out, one-fifth (19.1 percent) as minimum, and less than one-tenth (4.0 percent) as suitable for special programs. The remainder, (6.3 percent), had not as yet been classified. One-fourth (24.6 percent) of the women were classified as maximum, less than one-fifth (16.8 percent) as medium or medium out, two-fifths (40.1 percent) as minimum, and less than one-tenth (6.5 percent) as eligible for special programs. Classification assignments had not yet been made for 40 (12.0 percent) of the women.

\* One-fifth (20.1 percent) of the men and over one-fourth (28.4 percent) of the women in residence had completed or were currently enrolled in some type of substance abuse treatment program. An additional three-tenths (30.8 percent) of the men and about one-sixth (15.6 percent) of the women were scheduled to take part in substance abuse programs as space became available or the time for participation was deemed more appropriate.

\* Over 14 percent of the men and 16.5 percent of the women were currently enrolled in or had completed some type of clinical or social work oriented treatment program designed to provide assistance with psychological or personal problems.

\* Nine out of 10 men (96.7 percent) and women (94.6 percent) had not as yet taken part in any type of educational program.

(See Table 16.)

\* About one-fifth (17.1 percent) of the men and one-tenth (11.1 percent) of the women had completed or were enrolled in vocational/apprenticeship programs. An additional one-fourth (24.9 percent) of the men and three-tenths (29.1 percent) of the women were slated for participation in such programs at a future time.
