INTRODUCTION

This report summarizes statistical information about the Maricopa County Juvenile Court Center in 1992. This report compares the court activity in 1992 with the activity of the prior four years (1988-1991).

The bulk of this report deals with juvenile delinquency and incorrigibility (status) referrals. Information is obtained from police reports, other referring entities, and from probation officers who interviewed the children and their families. It describes the number and characteristics of delinquency and incorrigible offense cases in 1992 handled by the Maricopa County Juvenile Court.

A child becomes known to the court by a "referral" which alleges that the child has violated the law in some way. It should be noted that many children whose actions or social conditions might warrant action by the Juvenile Court are not referred to the court and are therefore not included in these data. Some children are not referred simply because their illegal actions are not observed or reported, or the child is not apprehended. Furthermore, not all activities of juveniles once reported to the police are subsequently referred to the Juvenile Court. Some police agencies within the county use community counseling programs for children apprehended for minor offenses, followed by release to their parents. Consequently, the data presented in this report cannot be taken as a complete measure of the extent of delinquent behavior in Maricopa County.

When it has been decided by a referring agency that a child's action or social condition warrants intervention by the court, that child is referred, and when a child is referred, the intake division of the Juvenile Court begins the process of diagnosis and recommendation. There are numerous ways in which a referral may be dealt with by the court. However, the best interest of the child, balanced with what is in the best interest of the community, must always be considered.

Children also become known to the court when they are being adopted, when one or both parent's rights are being severed (usually prior to adoption), or when the child may have been neglected, abandoned or abused.



STATE AND COUNTY STATISTICS


Arizona is geographically the sixth largest state in the nation with 113,909 square miles and a population estimate in 1992 of 3,858,825 in 15 counties. Maricopa County is the seventh most populated county in the nation with 9,226 square miles and a population of 2,285,199. (Department of Economic Security Population Estimates for 1992.)

Approximately 59.2% of the state's population resides in Maricopa County. There are 248 residents per square mile. Nationwide, Maricopa County has the seventh largest population. Phoenix is the county seat.





In any given year, about 6% of the juvenile population of Maricopa County is referred at least once to the Court Center. That's about one juvenile in every 17 at risk.


In 1992, there were 27,624 referrals generated by 18,183 juveniles.

This is an increase of 4.7% from 1988 in the number of juveniles referred to the court, and a 10.4% increase in the number of referrals.

Delinquent & Incorrigible**







Based on 27,624 Total Referrals for 1992**


Referrals are categorized as to their severity. This order was established by the Maricopa County Juvenile Court Center and is unique to this Court Center. Property crimes (Felony/Grand Theft and Misdemeanor/Theft) account for 41.9% of all referrals.

Incorrigible (status) offenses were 20.7%, Public Order (Peace and Obstructing) 16.9%, Person crimes (Felony/Violent and Misdemeanor/Fight) 15.6%, Drug law violations (Felony and Misdemeanor) were 4.5%, and Administrative (Hold) were .5% of 27,624 total referrals for 1992.



SEVERITY OF REFERRAL 1988-1992


Violent Referrals




Fight Referrals




Grand Theft Referrals




Drug Referrals



Obstruction Referrals




Public Peace Referrals




Theft Referrals




Violent Referrals


Auto Theft Referrals

Drug Offense Referrals




Drug Referrals

Violations for drug offenses have increased 25% since 1988. In 1992, drug referrals account for 4.5% of the total referrals received. Specifically, Marijuana offenses increased 44%, Narcotic offenses increased 15%, and Paint sniffing increased dramatically by 168% over 1991.

Delinquent and incorrigible (status) cases are referred to the court by law enforcement agencies, social service agencies, schools, parents, and probation officers. Law enforcement officers are the primary source of referral.

Overall, 90% of all cases in 1992 were referred by law enforcement agencies.

The law enforcement agency that contributes the most referrals to the Juvenile Court is the Phoenix Police Department. In 1992, Phoenix sent 12,524 referrals, which accounts for 45% of all referrals received. Phoenix, Mesa, Tempe, Glendale, and Chandler Police Departments comprise the top five sources of referrals received, accounting for 75% of all referrals to the Juvenile Court Center in 1992.





(at which time the Juvenile Court loses jurisdiction), the chances of becoming known to the Juvenile Court Center increases. These data are consistent over many years.



Ethnicity of Referred





Number of Juveniles


■ Screened ■ Detailed

During 1992, there were 7,938 requests for detention. This resulted in detention 6,822 times, or 85.9% of the requests. A request for detention may occur when a Police Officer believes, for the safety of the community or the juvenile, that physical detention may be required. The juvenile is taken to either of the two Maricopa County Juvenile Detention Centers and interviewed by an Intake

Screening Officer. Based upon Supreme Court Rules and the Court Center's administrative criteria, the Intake Screening Officer has the option to release the juvenile to the parents or physically detain the juvenile pending court action. Intake Screeners are available 24 hours a day, seven days a week. If the juvenile is detained, a petition must be filed and a detention hearing held within 24 hours.

In 1992, 6,822 juveniles were detained. Of those, 3,231 were detained for delinquent or incorrigible acts, and the remainder of 3,591 juveniles were detained for such reasons as: court holds, courtesy holds, family counseling, family crisis, FOJ (from other jurisdiction), warrants, and home detention.

The average daily population in detention (including both facilities) was 225 juveniles. The average (mean) length of stay was 11.8 days. Length of stay does not have a normal distribution. Most juveniles stay less than 13 days while those who stay longer remain

much longer than the 1992 average might suggest. The cost of a juvenile per day in detention was \$93.32 in 1992.



During 1992, 2,807 juveniles were placed on probation. Probation Officer caseload has increased to a five year high of 58 cases under supervision. The average number of months a juvenile is on probation was 13 months in 1991 and 1992, down from 14 months in 1989 and 1990.




Assessments are imposed by the judiciary in cases allowed for probation service fees and placement service fees among others.

Placement Assessments and Collections








**Intake Caseload

The Intake cite-in is the interview of the referred juvenile and parent(s) at the Juvenile Court by an Intake Officer. Generally, these juveniles are first and second referral misdemeanors or status offenders. The Intake Officer has the discretion to handle the referral without initiating a formal court process.


The above graph shows the average number of days to first cite-in (excluding time assigned to County Attorney), measuring how quickly the Intake Division is able to get to the caseload assigned. Of those complaints NOT sent to the County Attorney, the number of days decreases to 52. A second measure is the number of pending (unfinished) cases is shown in the graph to the right. There were 2,953 pending cases in 1992, a 2.6% decrease from 3,032 pending cases in 1991.

New Complaints Received




Referrals (complaints) where no formal petition is filed may be adjusted by the Intake Officer after the initial interview with the juvenile and parent(s). If the juvenile has acknowledged involvement in the alleged offense, the matter will not be adjusted until specific conditions established by the Probation Officer are met. Conditions of adjust may include referral to community agencies for family counseling,

individual counseling, specialized education, and awareness programs such as alcohol and drug abuse, restitution to victims, voluntary work hours in the community, and other similar options.

The number of New Complaints Received has shown a slight decrease from 16,452 in 1991 to 16,073 New Complaints in 1992, from a high in 1990 of 17,925.

PIC-ACT Assessments and Collections



The Progressively Increasing Consequences Act (PIC-ACT) became effective through legislative action on July 1, 1984. If after conducting an intake interview with the alleged juvenile offender and parent(s), and the juvenile acknowledges responsibility for the delinquent act or alcohol offense, the Juvenile Probation Officer may adjust the delinquency complaint once the juvenile has complied with specific conditions.


Assessments made for Intake Services in 1992 have increased 114% over 1991 to \$112,100, and

collections have increased 70% over 1991 to \$88,170 for 1992.

This legislation concentrates on first and second time offenders in hopes of eliminating future delinquent behavior patterns before they become firmly established. The development of PIC-ACT centers on the debate of whether holding youthful offenders more accountable for their delinquent behavior will result in a lower incidence of recidivism. Programs sponsored under PIC-ACT are currently in operation in all fifteen counties in Arizona.


Home Detention is an alternative between structured institutional detention and unconditional release back into the community. Juveniles originally held in the juvenile detention facility, but being allowed to return home pending Court, may be assigned to Home Detention. In this program, the juvenile's freedom is greatly restricted and the Home Detention staff maintain frequent and close contact with

the juvenile on an unannounced basis to assure compliance with the conditions of release.

As compared to 1991, juveniles placed on Home Detention decreased slightly from 1,667 to 1,640 in 1992. Juveniles released, also decreased from 1,700 in 1991 to 1,618 in 1992. The average daily population on Home Detention is 180 juveniles with an average length of stay of 36.2 days in 1992.


Placement



The number of juveniles in Placement has increased dramatically since 1988, but in 1992, Day & Evening Care are showing a decrease from 1991 in the number of juveniles from 348 to 314. Residential Care increased by 7 juveniles from 423 in 1991 to 430 in 1992.

Residential placement has increased by 113% from 1988 to 1992. Day & Evening Care has increased 136% in the same 5 years. The cost involved per day per juvenile was \$45.67 for Day & Evening Care, and \$137.02 for Residential care in 1992.

Diversion Programs



Diversion programs are established and supervised by various municipalities for the needs of some first time offenders in their communities. These programs are developed by agreement with the Court Center as provided by statute.


Several municipalities within Maricopa County have designed First Offender Programs to work with juveniles.

Cities such as Phoenix, Mesa, Tempe, Glendale, Peoria, Scottsdale, Williams Air Force Base, Chandler, and Gilbert have various types of diversion programs for the first time offender.

The number of juveniles assigned to diversion programs have decreased by 23% from 1,261 in 1988, for a total of 969 juveniles in 1992.

Violation, and Invalid Complaints.**


In this table, recidivism is defined as the probability of a subsequent referral within one year of the initial referral, i.e., the probability of a subsequent arrest (guilt may not have been determined). Administrative offenses (Holds), and technical probation violations (i.e., no law violation charged) are not counted as initial referrals or subsequent referrals. If the juvenile is 17 years or older at the initial referral, they are not considered. As soon as a juvenile reaches the age of 18, the Juvenile Court loses all jurisdiction over that person.

Two samples are used above. The sample called "First Timers" utilized only the first referral to Juvenile Court as the initial referral, while "All Juveniles" utilize any referral except an administrative offense or probation violation.

Juveniles recidivating has been gradually increasing over the past five years. In 1992, approximately 28% of all First Time Offenders recidivate, and approximately 40% of All Juveniles recidivate.



1992 Court Hearings Summary



A Scheduled hearing is set before a particular judicial officer on a particular day and time, though for many hearings (advisories for instance) several may be "stacked" at the same time. A hearing categorized as Held, is one with a recorded start and end time. A Completed hearing is one showing a result of

completed, under advisement, or conditional (applying to dispositions).

In 1992, 46,037 hearings were scheduled, 33,793 hearings were held, and 28,524 hearings were completed. Approximately 74% of these hearings were for delinquency matters.

Total scheduled court hearings have increased 42% since 1988, from 32,345 to 46,037 scheduled hearings in 1992, but decreased by 10% from 1991 to 1992.

There has been major increase in Delinquency hearings which increased by 50% in the last 5 years.

Hearing types were re-adjusted in 1993 to re-classify the Miscellaneous category. Hearings for the years 1988 to 1992 were re-calculated as a result of this adjustment. Actual Total Hearings Scheduled did not vary significantly from the numbers previously published, but Miscellaneous and Delinquency Hearings were re-defined which did effect their total.
