



ADMINISTRATOR'S MESSAGE

One of the most important objectives of drug law enforcement is reducing the availability of illegal drugs. Because they are indicators of availability, two yardsticks for measuring effectiveness are: drug costs and drug purity. The *Illegal Drug Price/Purity Report*, by charting these variables on a drug-specific basis, provides these yardsticks.

This report outlines current trends in the availability of drugs in the United States. It also shows recent fluctuations in the price and purity of illegal drugs. Depressed prices and elevated purity levels often signal an increased availability of a certain drug.

Cocaine prices at the kilogram level remained relatively stable in most major U.S. cities during January - March 1993, but are still above their all-time low levels recorded in 1988-89. Moreover, during the first quarter of 1993, the national purity of cocaine decreased at all levels of the traffic, suggesting a slight reduction in availability. The price and purity levels of heroin are more difficult to pinpoint, but heroin prices have declined at the low end of the price range since the early- to mid-1980s, and a wide variety of sources and an abundance of supply have led to all-time high purity levels. Marijuana prices have increased during the past several years at virtually all levels of the traffic, and these price increases generally track with a decline in marijuana use. On the other hand, overall prices for LSD remain low, and other indicators point to increasing use.

EXECUTIVE ASSESSMENT

This edition of the *Illegal Drug Price/Purity Report* provides illegal heroin, cocaine, marijuana, hallucinogen, depressant, and stimulant prices in the United States from January 1990 through March 1993. In addition, purity levels are included for cocaine and heroin as is the delta-9-tetrahydrocannabinol (THC) potency for marijuana. The prices reported from all areas are used to determine the "national range." The data used in this report were compiled from DEA quarterly *Trends in the Traffic* reports.

Cocaine prices at the kilogram level remained relatively low and stable in the primary importation/distribution centers of Houston, Los Angeles, and New York City as well as in most other major U.S. cities during January - March 1993. Several exceptions to this included Miami, where the kilogram price rose from a range of \$15,000 to \$20,000 during October - December 1992 to a range of \$17,000 to \$24,000 during January - March 1993, and Chicago, where prices increased from a range of \$17,500 to \$25,000 to a range of \$21,000 to \$26,000 during the same time frame. Nevertheless, cocaine remained readily available in virtually all major U.S. metropolitan areas throughout the January - March 1993 period. (Price information for Chicago, Los Angeles, Miami, and New York appears on pages 1 and 2 of this report; price information for the major cities not listed in this report is available upon request.)

Cocaine purity at the kilogram, ounce, and gram levels decreased from October - December 1992 to January - March 1993. Kilogram purity, which averaged 83 percent during October - December 1992, decreased to 81 percent during January - March 1993. At the ounce level, the purity, which averaged 76 percent during October - December 1992, declined to 71 percent during January - March 1993. Gram purity decreased from 72 percent to 60 percent during the same time frame.

Trends based upon heroin prices and purities are less clearly defined than for other drugs of abuse in this report. Numerous and diverse foreign sources of supply and extremes in purity levels evident at both the wholesale and retail levels account for the wide variances. The most discernible trend indicates that the lower-end prices for gram, ounce, and kilogram quantities of heroin have declined since the mid-1980s. In

addition, the purity for gram and ounce heroin purchases has risen steadily since 1990.

During the first three months of 1993, the price for a pound of commercial grade marijuana ranged from \$350 to \$5,000. By contrast, a decade ago, the price ranged from \$350 to \$600 per pound. Sinsemilla, with an inherently higher THC content, ranged from \$1,100 to \$9,000 per pound during January - March 1993. A decade ago, the price ranged from \$1,000 to \$2,000 per pound.

Although there was some fluctuation in the price of LSD nationally over the past several years, overall prices for this hallucinogen remained relatively low.

CRACK PRICE DATA

Crack cocaine, also referred to as "rock," is packaged in vials, glassine baggies, film canisters, etc. Sizes of the "rocks" are imprecise, but generally range from 1/10 to 1/2 gram. These "rocks" can sell for as low as \$2 to as high as \$75, but prices generally range from \$10 to \$50. Crack is generally converted locally from cocaine hydrochloride for sale at the retail level. When available in kilogram quantities, prices for crack cocaine are comparable to those for kilogram quantities of cocaine hydrochloride. The national range for ounce quantities of crack is from \$475 to \$2,500. A gram ranges in cost from \$45 to \$150.

Hashish Prices

Because of U.S. consumer preference for marijuana, hashish prices are unavailable in many regions. When encountered, however, retail prices average \$6 to \$20 per gram, \$100 to \$600 per ounce, \$1,000 to \$6,000 per pound, and \$3,000 per kilogram. (The Boston Field Division reported that hashish was selling for as high as \$6,000 per pound in New Hampshire due to extremely limited availability.) The THC content of hashish seized in the United States during Calendar Year 1992 was 7.55 percent. (THC content of hashish is not yet available for January - March 1993.) Hashish oil sells for \$35 to \$55 per gram and \$2,500 to \$4,000 per pound.
