Detention of Juveniles In Local Correctional Facilities North Dakota, 1990

In 1990, 758 detentions of juveniles in local correctional facilities were reported to the North Dakota Jail Information System (NDJIS). This is an increase of 4.1 percent from the total of 728 detentions reported in 1989.

Local correctional facilities in the state maintain records of all persons incarcerated and report this information to the Department of Corrections and Rehabilitation through the Bureau of Criminal Investigation, Office of the Attorney General. Reports are not received from jails on the state's reservations. NDJIS data does not include information from the State Industrial School, the State Farm, the State Penitentiary, or any other state institution.

The number of detentions of juveniles, persons under the age of 18, should not be interpreted as the number of individuals detained. The numbers produced by the NDJIS indicate the number of times that the detention process is initiated. It is possible that some individuals were detained numerous times in one or a number of facilities.

Of the 758 detentions, approximately 66 percent, or 502, were male. The average length of detention for juvenile males was 156 hours, compared to 78 hours for juvenile females. On an average day in North Dakota in 1990, there were 9 male and 2 female juveniles in detention. In 1989, the average length of detention was 94 hours for juvenile males and 83 hours for juvenile females.

Detentions for status offenses or custody were approximately 45 percent of the detention total. Status offenses are those which would not be considered offenses if committed by an adult, e.g., curfew violations and running away. In 1990, 188 detentions for running away were recorded. See Table I on page 5 for information on juvenile detentions by offense and age. In analyzing detentions by offense, running away has consistently been the offense for which the largest number of juveniles have been detained. See Table II on page 6 for information on juvenile detentions by offense and year.

In 1990, alcohol-related offenses comprised 9.2 percent of juvenile detentions. Detentions relating to alcohol included: 17 detentions for DUI offenses; 4 for liquor law violations other than DUI; 44 for possession of alcohol and 5 for detoxification. The number of detentions for alcohol-related offenses has been dropping each year since 1985.

Detentions for drug offenses have consistently been a very small portion of the total number of juvenile detentions. (See Summary on page 3.) In 1990, the 6 drug-related detentions accounted for less than 1 percent of total detentions. The largest yearly total for juvenile drug-related crimes occurred in 1977 with 62 detentions. Comparing that total with the 1990 total, we find that there has been a decrease of approximately 90 percent since 1977.

Figure I on page 7 illustrates the juvenile detention totals during the period 1977-1990.

Table III is a breakdown of juvenile detentions by age and facility. Cass County Juvenile Detention Center reported 406, or 53 percent, of the total juvenile detentions in 1990. Grand Forks County Juvenile Quarters was second with 141 detentions.
