INTRODUCTION

In 1979, Title 2C replaced Title 2A as New Jersey's Criminal Code. Since then, adult arrest volume and DOC admission volume have increased steadily. Length of stay has increased at the same time, primarily as a result of 2C's mandatory minimum term provision. Two factors - admission volume and length of stay - dictate the size of a prison population.

Since 2C was implemented, other statutory changes have been enacted and have exacerbated the impact that would have derived directly from 2C, alone. These revisions and additions to 2C have further impacted on length of stay and/or admission volume. They include:

- Parole Act (1980)
- Graves Firearms Act (1982)
- Capital Sentence Law (1985)
- Parole Violator Enhancements (1986)
- Comprehensive Drug Reform Act - CDRA - (1987)

The charts and tables on the following pages highlight the growth in adult inmate and parolee populations experienced over the past seventeen years. In addition, the charts reflect changes in the composition of these populations over the same span. Changes in composition include: the recent growth in those committed for drug offenses and a corresponding reduction in the percentage committed for violent or property offenses; the increased incidence of mandatory minimum terms; and the shift in the percentage of mandatory min residents committed for drug offenses.

NOTE CONCERNING LOG FUNCTION DISPLAY:


The graphs on pages 5 and 8 utilize log functions to depict relationships between the displayed data.

The log function is a mathematical computation that is used to equalize widely disparate numbers by creating a standard basis for comparison when computations of both large and small numbers are required. As a result, the log function provides the capability to display both large and small numbers on the same graph. For example, numbers in the hundreds can be depicted on a graph with numbers in the hundred thousands.

NEW JERSEY DEPARTMENT OF CORRECTIONS


AS OF APRIL 1, 1994


COUNTY JAIL POPULATION

NEW JERSEY DEPARTMENT OF CORRECTIONS





- UNTIL TITLE 2C WAS ENACTED, THE ADULT STATE INMATE POPULATION REMAINED STABLE AT SOMEWHAT LESS THAN 6,000 INMATES.
- SINCE 1980, THE ADULT JURISDICTIONAL POPULATION HAS INCREASED STEADILY. THE CURRENT LEVEL OF 24,068 IS THE HIGHEST IN THE HISTORY OF THE DEPARTMENT.


**N.J. CRIMES & ARRESTS

- FROM 1975 THROUGH 1992, CRIMES PER 100,000 POPULATION HAVE BEEN RELATIVELY STABLE - 5,191 IN 1975 COMPARED TO 5,257 IN 1992 - AN INCREASE OF 1%.
- ARRESTS DURING THE SAME PERIOD HAVE INCREASED MODERATELY - 1,059 IN 1975 COMPARED TO 1,231 IN 1992 - AN INCREASE OF 16%.
- THESE INCREASES COMPARE WITH A 7% INCREASE IN TOTAL STATE POPULATION DURING THE SAME PERIOD.

NOTE: THE NEW JERSEY STATE POLICE UNIFORM CRIME REPORTS LISTS THE FOLLOWING AS "INDEX CRIMES": MURDER, RAPE, ROBBERY, AGGRAVATED ASSAULT, BURGLARY, LARCENY, THEFT AND MOTOR VEHICLE THEFT. WE HAVE ADDED MAJOR DRUG CRIMES TO THIS LIST. IN ALL, THESE ARE CRIMES WHICH COULD MOST LIKELY RESULT IN ADMISSION TO DOC FACILITIES.

- FROM 1975 THROUGH 1980, NEW JERSEY'S INCARCERATION RATE REMAINED STABLE AT A TIME WHEN THE RATE FOR THE U.S. SHOWED AN INCREASE FROM 110 PER 100,000 TO 140 PER 100,000.
- BEGINNING IN 1980, FOLLOWING ENACTMENT OF 2C IN 1979, NEW JERSEY'S RATE OF INCARCERATION JUMPED FROM 80 PER 100,000 TO 300 PER 100,000 IN 1991, AN INCREASE OF 275%. SINCE 1991, THE RATE HAS DROPPED BY 4% TO 289 PER 100,000.
- FROM 1980 TO 1992, THE U.S. RATE INCREASED BY 138%. A MODEST INCREASE IN COMPARISON WITH NEW JERSEY'S INCREASE.
- IN 1980, NEW JERSEY WAS RANKED 32 IN RATE OF INCARCERATION (31 STATES SENTENCED MORE PEOPLE TO STATE PRISON). IN 1991, NEW JERSEY WAS RANKED 22ND (ONLY 21 STATES HAVE A HIGHER RATE OF INCARCERATION THAN NEW JERSEY).



NJ CRIMES, ARRESTS & INCARCERATION RATES Per 100,000 Population




INMATE POPULATION vs. STATE POPULATION COMPARATIVE GROWTH (1840-1992)

- IN THIS CHART WE SEE HOW GROWTH IN NEW JERSEY'S ADULT INMATE POPULATION HAS ROUGHLY PARALLELED GROWTH IN NEW JERSEY'S AT LARGE POPULATION. THE PERIOD FROM 1980 TO PRESENT HOWEVER, HAS SEEN GROWTH IN THE INMATE POPULATION FAR OUTPACE GROWTH IN THE AT LARGE FIGURE.


**ADULT RESIDENTS BY OFFENSE TYPE


**ADULT RESIDENTS BY TOTAL TERM





- **THE NUMBER OF ADULT INMATES IN OUR DATABASE SERVING MANDATORY MINIMUM TERMS HAS INCREASED BY 107% SINCE 1/1/87 - FROM 5,900 TO 12,200.**
- **FIFTY-FIVE PERCENT OF ALL ADULT INMATES IN OUR DATABASE ARE SERVING SENTENCES WHICH INCLUDE MANDATORY MINIMUM TERMS. THIS IS A THIRTY-SEVEN PERCENT INCREASE SINCE 1/1/87.**
- **MANDATORY MINIMUM TERMS MUST BE SERVED IN FULL PRIOR TO ACHIEVING PAROLE ELIGIBILITY. NO CREDITS FOR GOOD TIME, WORK TIME OR MINIMUM CUSTODY CAN BE APPLIED TO REDUCE TIME TO PAROLE ELIGIBILITY.**

(AS OF JANUARY 1, 1994)**





(5,600 INMATES)**








- THE ADULT INMATE POPULATION QUADRUPLED DURING THIS PERIOD, FROM 5,600 IN 1975 TO 23,393 IN 1994. IN 1994, THE NUMBER OF INMATES HOUSED FOR DRUG OFFENSES ALONE, EXCEEDED THE TOTAL INMATE POPULATION HOUSED IN 1975.
- OVER THE 17 YEAR PERIOD, THERE HAS BEEN A DECIDED SHIFT IN THE BASE OFFENSE PROFILE OF THE INMATE POPULATION WITH A REDUCTION IN THE PROPORTION OF THOSE COMMITTED FOR VIOLENT AND NON-VIOLENT OFFENSES AND A COMMENSURATE INCREASE IN THE PROPORTION OF THOSE COMMITTED FOR DRUG OFFENSES.

(5,600 INMATES)**




**ADULT INMATE POPULATION

(5,900 INMATES)**





- BY 1982, THE IMPACT OF TITLE 2C HAD BEGUN TO ACCRUE IN TERMS OF INMATE POPULATION GROWTH. BY 1994, POPULATION HAD INCREASED TO A LEVEL OF 23,393, ALMOST FOUR TIMES THE 5,900 INMATES HOUSED ON JANUARY 1, 1980.
- IN SPITE OF TREMENDOUS GROWTH IN THE INMATE POPULATION, THE OFFENDERS PROFILE BY BASE OFFENSE EXPERIENCED LITTLE CHANGE FROM 1975 THROUGH 1987.
- SINCE 1987, IMPLEMENTATION OF THE COMPREHENSIVE DRUG REFORM ACT (CDRA) HAS CAUSED A DRAMATIC CHANGE IN THE OFFENDER PROFILE. INMATES CONVICTED OF DRUG OFFENSES IN 1994 ACCOUNTED FOR 35% OF THE ADULT INMATE POPULATION AND ONLY 46% WERE CONVICTED OF VIOLENT OFFENSES. THIS COMPARES TO PREVIOUS NUMBERS OF 11% AND 64%, RESPECTIVELY, IN 1987.
- WHILE THE PERCENTAGE OF VIOLENT AND NON-VIOLENT OFFENDERS WENT DOWN FROM 1987 THROUGH 1994, THEIR ACTUAL NUMBERS INCREASED - FROM 9,150 TO 10,200 FOR VIOLENT OFFENDERS, AN 11% INCREASE AND FROM 3,675 TO 4,250 FOR NON-VIOLENT OFFENDERS, A 19% INCREASE. THESE COMPARE TO AN INCREASE OF 1.9% IN AT-LARGE N.J. STATE POPULATION DURING THE SAME PERIOD.



- IN 1982, TWO YEARS AFTER ENACTMENT OF TITLE 2C, ONLY ONE OUT OF TEN (11%) OFFENDERS RESIDENT IN STATE FACILITIES WERE COMMITTED WITH MANDATORY MINIMUM (PAROLE INELIGIBILITY) TERMS. BY 1987 AND 1994, THAT PORTION OF THE INMATE POPULATION INCREASED TO 41% AND 55%, RESPECTIVELY.
- THOSE SERVING MANDATORY MINIMUM TERMS USUALLY SERVE MORE THAN TWICE AS MUCH TIME TO RELEASE THAN NON-MINS.
- IT IS EXPECTED THAT AT SOME POINT IN THE FUTURE, INMATES WITH MANDATORY MINS WILL APPROXIMATE 70% OF OUR ADULT RESIDENT POPULATION.


ADULT INMATES WITH MAND MINS

(900 INMATES)**




ADULT INMATES WITH MAND MINS


- **IN 1983, THE OVERWHELMING MAJORITY (83%) OF OFFENDERS RESIDENT WITH MANDATORY MINIMUM TERMS WERE SENTENCED FOR VIOLENT CRIMES (MURDER, RAPE, ROBBERY, ASSAULT).**
- **PRIOR TO ENACTMENT OF THE CDRA IN 1987, SEVEN OUT OF TEN OFFENDERS WITH MINS WERE COMMITTED FOR VIOLENT CRIMES.**
- **SINCE ENACTMENT OF THE CDRA, INMATES WITH MINS FOR VIOLENT OFFENSES PLUMMETED TO 53%, WITH A CORRESPONDING TRIPLING OF MINS FOR DRUG OFFENDERS, FROM 12% IN 1987 TO 37% IN 1994. APPROXIMATELY 4,500 ADULT INMATES ARE NOW SERVING MINS FOR DRUG OFFENSES.**


- FROM 1975 THROUGH 1987 WE SAW A GENERAL DECLINE IN THE PERCENTAGE OF BLACK INMATES WITHIN OUR ADULT POPULATION. DURING THE SAME PERIOD, THERE WAS AN INCREASE IN THE PERCENTAGE OF HISPANIC INMATES, PROBABLY ATTRIBUTABLE TO INCREASES IN THEIR PROPORTION OF THE STATE'S AT-LARGE HISPANIC POPULATION, ESPECIALLY IN URBAN CENTERS. THE PERCENTAGE OF WHITE INMATES WITHIN OUR POPULATION FLUCTUATED SLIGHTLY, BUT REMAINED RELATIVELY STABLE.
- FROM 1987 THROUGH 1994, A DISCERNIBLE SHIFT IN PERCENTAGES IS NOTED. BLACK AND HISPANIC INMATE PERCENTAGES INCREASED WHILE THE PERCENTAGE OF WHITE INMATES DROPPED BY EIGHT PERCENTAGE POINTS OR 30%. WHILE WE HAVE NOT HAD AN OPPORTUNITY TO REVIEW RELATED DATA, IT IS LIKELY THAT THIS REDISTRIBUTION IS A FACTOR OF CDRA AND ITS HEAVY IMPACT IN URBAN CENTERS WITH LARGE MINORITY POPULATIONS.
- AS NOTED WITH SOME OF OUR OTHER DATA, WHILE THE PERCENTAGE OF WHITE INMATES DECREASED FROM 1987 TO 1994, THEIR NUMBER ACTUALLY INCREASED BY 9%, FROM APPROXIMATELY 3,860 TO 4,190.

JAN. 1 PAROLEE POPULATION**




- PAROLEE DATA DISPLAYED HERE INCLUDE ALL PERSONS UNDER JURISDICTION OF THE BUREAU OF PAROLE. DATA AS OF JANUARY 1994 INCLUDE 1,169 COUNTY JAIL CASES RELEASED TO PAROLE SUPERVISION AND 18,493 PERSONS WITH EXPIRED MAXIMUM SENTENCES WHO HAVE CONTINUING REVENUE PAYMENT OBLIGATIONS.


**PAROLEE POPULATION

(14,367 PAROLEES)**






AS DISPLAYED HERE, WE SEE THAT FROM 1982 TO 1986, THE COMPOSITION OF THE PAROLEE POPULATION IN TERMS OF OFFENSE TYPE, DID NOT CHANGE DRAMATICALLY IN SPITE OF A POPULATION INCREASE IN EXCESS OF 40%. BY 1994, THE POPULATION HAD MORE THAN DOUBLED FROM 1986 LEVELS AND A DRAMATIC REDISTRIBUTION IN OFFENSE TYPE OCCURRED WITH SHIFTS FROM VIOLENT AND NON-VIOLENT OFFENDERS INTO THE DRUG OFFENDER CATEGORY. THIS IS SIMILAR TO AND CONSISTENT WITH THE REDISTRIBUTION OBSERVED WITH THE INMATE POPULATION AND IS DEFINITELY A FACTOR OF THE COMPREHENSIVE DRUG REFORM ACT.

NOTE: PAROLEE DATA DO NOT INCLUDE COUNTY JAIL INMATES RELEASED TO PAROLE SUPERVISION. AS OF JANUARY 1994, SUCH PAROLEES TOTALLED 1,169 CASES.


**PAROLEE POPULATION

OVER THE PAST 10 OR SO YEARS THERE HAS BEEN A DISCERNIBLE SHIFT IN THE RACE/ETHNICITY DISTRIBUTION WITHIN THE PAROLEE POPULATION, ESPECIALLY FROM 1986 THROUGH PRESENT. THE MOST RECENT INCREASE IN THE PROPORTION OF BLACK AND HISPANIC PAROLEES AND THE REDUCED PERCENTAGE OF WHITE PAROLEES YIELDS A CURRENT PAROLEE POPULATION CONSISTENT WITH RACE/ETHNICITY FOR OUR CURRENT INMATE POPULATION.
