

This <u>GUIDE</u> contains primarily public record information that can be used in criminal investigations of Maryland businesses. Emphasis is placed on resources that will help in the investigation of small, unknown businesses that may be trying to escape detection.

The <u>GUIDE</u> includes suggestions about where you will find specific investigative information. If you contact a resource and they don't have the information you are looking for, ASK THEM where you can get it. They will likely know of other resources in their field.

The Maryland State Police, Criminal Intelligence Division Library (410-290-0780 X139) maintains a <u>forms file</u> of government forms for the agencies included in this <u>Guide</u>. Copies are available to law enforcement agencies.

Government agencies usually do not charge law enforcement officers for copies of documents.

No resource guide can be totally comprehensive. Your ideas for additions or updates are welcome.

THE FIRST STEP

The <u>CENTRAL REGISTRATION SECTION</u> in Baltimore (Section 1.1) is the ******HUB***** of the State of Maryland business files. This Section is comparable to the "Central Files" of a business.

Whether the business you are investigating is incorporated or not incorporated, you can go to the Central Registration Section and ask for the <u>Combined Registration Application</u>. The Combined Registration Application is used by 97% of businesses currently operating in Maryland. They use this form to apply for a Sales and Use Tax license. They can also use it to open Income Tax Withholding Accounts and Unemployment Insurance Accounts for their employees. Unless the business has <u>no</u> employees and is <u>not</u> collecting sales tax, they should have a Combined Registration Application on file in the Central Registration Section or they are in violation of Maryland law!

PENALTY FOR FAILURE TO FILE

Question: What is the CIVIL penalty for willfully failing to collect and forward retail sales tax?

The fraud penalty for retail sales tax is a 100% penalty. For example, if the business owes \$5,000 in back taxes they will be held liable for a penalty payment of \$10,000. It is possible to seize the property to satisfy this penalty. (See Section 13-701 to 13-714 of the Tax-General Article of the Annotated Code of Maryland)

<u>Ouestion</u>: What is the CRIMINAL penalty for willfully failing to collect and forward retail sales tax?

Willfully failing to pay retail sales tax is a misdemeanor carrying a penalty fine of up to \$5,000 and imprisonment of up to 5 years or both. (See Section 13-1001 to 13-1024 of the Tax-General Article of the Annotated Code of Maryland)

QUICK LOOK: Retail Sales Tax / Withholding Tax Unemployment Insurance

Ask for: Combined Registration Application (CRA)

******THE HUB****** of State of Maryland business files

The <u>same</u> application is used for: Sales & Use Tax License, Sales & Use Tax Exemption Certificate for non-profit organizations, Alcohol Tax License, Tobacco Tax License, Admissions & Amusement Tax, Unemployment Insurance, Motor Fuel Tax, and Income Tax Withholding.

Most (97%) businesses operating in Maryland <u>must</u> file a Combined Registration Application (exceptions: if they have no employees or are not paying retail sales tax - for example a home business or a self-employed consultant). If a business is collecting sales tax or has employees and has not completed a Combined Registration Application, it is <u>in violation of Maryland law !!!</u>

The Central Registration Section is located in the Comptroller's Office. The Comptroller's Office handles payment of many different types of taxes (income, motor vehicle, alcohol, retail sales, etc.) ASK the Assistant Manager about taxes for the business you are interested in and they will refer you to the correct office for tax records on your target business.

The CRA is available to <u>law enforcement personnel only</u>. All requests will be handled by the Assistant Manager. The target business is <u>not</u> informed when a law enforcement agency makes an inquiry on their record. There is no charge to view the CRA, but a subpoena is needed to get a certified copy.

Certified copies:

- (1) You can visit this office with your request on letterhead paper. You may want to develop a simple <u>form letter</u> so that officers can easily just enter the name of the business.
- (2) You can request certified copies by mail. Use letterhead paper and address the letter to the attention of Ms. Nancy Grueninger. Your request will be kept confidential and you will receive a certified copy within one week at no charge.

These files cannot be purged by law.

CONTAINS: Name of business, address of registered office, resident agent's name, date of incorporation, purpose of the corporation, number of shares, initial board of directors, incorporator's name and address

QUICK LOOK: Annual Report

Ask for: Annual Report (Personal Property Return-Form 1)

Incorporated businesses are required to file an Annual Report with the State. Businesses that are not incorporated must file an Annual Report with the County.

If a business has employees, the owner has responsibility for:

unemployment insurance - Maryland Division of Employment and Training (1.5)

workers' compensation - Maryland Worker's Compensation Commission (1.6)

withholding tax - Maryland Income Tax Division-Withholding Department (1.7)

Federal withholding taxes,
unemployment insurance,
social security - Internal Revenue Service
Disclosure Office (1.8)

NOTE: Unemployment and withholding taxes are paid to <u>both</u> federal and state governments. Failure to pay any of these taxes is a violation of Maryland law. (see THE FIRST STEP)

QUICK LOOK: Unemployment Insurance (Payroll)

Ask for: Wage File

Unemployment Insurance File (provide SSN or business name)

There is a wage file on everybody who works in Maryland. Unemployment taxes are withheld from each employee's paycheck. The employee's contribution is recorded in the Wage File. The business also pays unemployment taxes for each employee. The business' contribution is recorded in the Unemployment Insurance File.

The Field Audits & Investigations section operates on tips and tries to discover businesses who may <u>not</u> be paying their unemployment taxes. You may call (410) 333-5270 and check to see if your target business is being investigated.

past several years, how much money they earned

If the employee has filed a claim, additional information will be on file: address, telephone, when and where the claim as filed, how much they were paid weekly, DOB, sex, ethnic identification, citizenship, migrant permit n u m b e r, dependents, union membership, child/spousal support payments and the name/address of where to send these payments

Business Unemployment Taxes File (employer): business address, alternate address (home, accountant, etc.), telephone, date business started, type of business, active or inactive (closed), Federal Employer ID number

Copy Fee: No charge (with letter)

QUICK LOOK: On-the Job Injury (Workers' Compensation)

Ask for: Claim File

This office keeps files of employees who make a workers' compensation claim because they have been injured on the job. Claim files are filed by the employee's Social Security number.

CONTAINS: employee's name, address, telephone, DOB, single/married, date of injury, description of injury, business name and address, insurance carrier, doctor/hospital names

Copy fee: 25 cents per page

QUICK LOOK: Withholding Taxes (State)

Ask for: Withholding Account

Records payments from businesses for withholding tax.

CONTAINS: business name, address, telephone, Federal Employer ID number, owner's social security number (sometimes), status of the account

PENALTIES FOR FAILURE TO PAY TAX

a) Who is liable for failure to pay withholding taxes?

If the business is a corporation, liability extends to any officer who had fiscal responsibility to collect the withholding taxes. If the business is a sole proprietorship or partnership, the individuals are liable. (See Section 10-906 of the Tax-General Article of the Annotated Code of Maryland)

- b) What is the CIVIL penalty? (failure to file monthly or quarterly Form 506 for withholding taxes for employees)
 - Up to 25% penalty on the tax they should have remitted (See Section 13-701 of the Tax-General Article of the Annotated Code of Maryland) and 13% interest charged on any remaining delinquent tax (See Section 13-601 of the Tax-General Article of the Annotated Code of Maryland)
- c) What is the CRIMINAL penalty? (failure to file monthly or quarterly Form 506 for withholding taxes for employees)

Failure to pay withholding taxes is a misdemeanor carrying a fine of up to \$5,000 and imprisonment of up to 5 years, or <u>both</u>. (See Section 13-1007 of the Tax-General Article of the Annotated Code of Maryland)

Copy Fee: A court order is needed to release information on the Withholding Account

QUICK LOOK: Delinguent Federal Withholding Taxes

Ask for: Taxpayer information by submitting a Freedom of Information request on letterhead

Usually this office needs the written consent of the taxpayer to release any information. On rare occasions they can provide <u>direction</u> (not facts) about a tax return.

If you suspect the business didn't pay Federal Withholding Taxes for their employees, go to the Records Department - County Clerk's Office and ask to see the Tax Liens (Federal/State).

New businesses must get a Federal Employer ID Number (issued from Philadelphia) and begin withholding taxes from their employees paychecks. If they fail to pay their withholding taxes, IRS puts a lien on the business through the County Clerk's Office. This lien information is public record. There is no central repository for liens from all the counties.

CONTAINS: name of business, trade name, address, file date, Federal Employer ID number, amount of lien

QUICK LOOK: Workers' Compensation Insurance

Ask for: Application Form

Maryland law (Article 101) requires businesses to carry Workers' Compensation Insurance to cover workers who are injured on the job. (See Section 1.6)

Insurance may be: (1) Pri

- (1) Private carrier
- (2) Self insured
- (3) Injured Workers' Insurance Fund

The Injured Workers' Insurance Fund is a State of Maryland agency. They offer workers' compensation insurance to both businesses and individuals. Monthly or quarterly premiums are collected. When a business or individual fails to pay the premium, the account is referred to the Central Collection Unit (See entry 1.15).

CONTAINS: business name, address, type business, trade names, total payroll amount by job class, owner's name-address-SSN, telephone, bank name, Federal Employer ID number signature of applicant

Copy Fee: Free Certified Copy

QUICK LOCK: Occupation Licenses

Ask for: License Application

The Department of Licensing and Regulation licenses a number of different occupations and professions. However, this office is not the only government agency that licenses various occupations and professions. Almost any specialized job skill requires a license. Try to guess which agency might license your target profession. For example, dieticians are licensed by the Department of Health & Mental Hygiene, fur dealers are licensed by the Department of Natural Resources, and driver training instructors are licensed by the Department of Transportation.

The State Board of Barber/Cosmetologist (Section 1.11) is an example of the occupation licenses offered by the state of Maryland. The license application contains valuable information you can use in your investigation such as DOB, current employer, SSN, home address and references.

- (2) Pre-trial advice and assistance concerning evidencerelated testimony and tactics to prosecutors.
- (3) Investigative support in major cases involving the seizure of large volumes of evidence too bulky to submit to the FBI Laboratory. Field examinations of such evidence can be used to develop immediate probable cause for additional search warrants arising from the initial seizure.

COUNTY RESOURCES

3.0 COUNTIES - GENERAL INFORMATION

The 23 county governments in Maryland perform almost identical functions, but these functions are sometimes located in different county offices. Law enforcement investigators are most interested in those offices that keep records regarding:

- 1) the power to investigate (for safety, in response to complaints, etc.)
- 2) the power to license (trades, professions, businesses)
- 3) the power to tax (make assessments, record delinquency)
- 4) the power to control pollution (regulation, complaints)
- 5) the power to insure health (food quality)
- 6) the power to control the transfer of land
- 7) the power to enforce zoning

Howard County will serve as an example of county government functions. There is no copy fee for law enforcement.

If you are investigating a local business and don't find information in this County Resources section, call the county switchboard and ask for the office that handles that kind of function. Be flexible and creative. Sometimes if you don't ask for the information by the correct word (example: ask for a license instead of a permit) the Operator will tell you they don't perform that function.

The adoption process for a dog or cat includes a home visit if the new owner for the pet is a Howard County resident. The warden makes the visit as soon as possible after the application has been filed - the animal cannot be taken the same day it is filed on. In addition, Animal Control has the right to enter upon the applicant's property after the adoption to ensure the well being of the animal. A subpoena is needed to enter the home without the owner's consent, but in most cases owners do not object to the warden's request to come into the house to check on the animal.

Occasionally you will see a dog tatooed on the ear, inside hip or stomach. Often the owner uses his SSN or driver license number. Numbers are registered with local or national organizations such as the National Dog Registry, P. O. Box 116, Woodstock, NY 12498.

Certain individuals come in looking for a large, aggressive dog (pitbulls, wolf-husky hybrids, and rottweilers are most popular). When asked, "Why do you want a dog?" they claim they just want "a family pet". If you know a suspect has a dog, you may be able to get some personal information about the owner from the files of the local Animal Control office.

They also maintain the <u>Annual Personal Property Return</u> files. If your target business is <u>not</u> incorporated, you can look up their annual report on their return. It will include such things as the company's <u>assets</u> and <u>inventory</u>.

When license is not displayed, it can be reported to: Comptroller of the Treasury, Retail Sales Tax Division, State License Bureau at (410) 225-1550 and they will send out an investigator. The fine is \$100 a day (usually only charged for one day). Authority to levy the fine is given in Article 56, Sections 9 and 11A of the Annotated Code of Maryland. No complaint file records are kept by the State License Bureau.

Failure to have a license is a violation of Section 21-305, Health General Article of the Annotated Code of Maryland as well as Section 12 of the Howard County Code 09-A-1 (not all counties have a food license code). A Complaint Log is kept of citizen complaints about food establishments.

CONTAINS: owner's name, mailing address, owner/operator and signature, name of certified manager, food establishment telephone, non-profit?, type of establishment (restaurant, market, carry-out, caterer, mobile, processing plant, warehouse, other), hours of operation, former name, types of food to be served, seating capacity, number of employees, size of establishment in square feet, water/sewage public or private?

Temporary food establishments (14 days) include booths at a festival or fair, flea market, or fireworks display.

CONTAINS: owner's name, mailing address, contact person or coordinator, telephone for food establishment, name of event, owner signature, non-profit?, type of establishment, hours of operation, types of food, diagram of set-up, water/sewage public or private?

BCommunity Environmental Health (rats, insects, trash, odors)

Ask for: Community Hygiene Reports (313-2642)

These reports cover such things as:
Rodent Control (rats)
Insect Control (mosquitoes, etc.)
accumulated trash
appliances in a yard
manure odor
exotic birds
nursing homes
trailer parks
camps

Pet shop exotic birds can develop a disease called psitocene which can be transmitted to humans. Pet shops need a permit to sell these birds. Health Department personnel can do a pet shop inspection if they suspect infected birds are being offered for sale. They can also inspect private property but not inside a dwelling for rats, insects, trash, and offensive odors.

CSwimming Pools (Public) (313-2642)

Ask for: Application (for permit to operate the pool)
Annual Renewal Form
Complaint File (example: inadequate chlorine level)

A permit to <u>construct</u> a swimming pool is issued by the County Clerk's office, and a permit to <u>operate</u> the pool requires an annual permit from Environmental Health.

DRabies Control (313-2642)

Ask for: Community Hygiene Report (filed by owner name)

All animal bite cases are handled by Environmental Health Services as they pose a threat to public health. They check the animal on the last day of quarantine whether it is at home or at an Animal Control facility.

EWater & Sewer (313-2640)

Ask for: Record of Investigation

This office responds to complaints about septic and well water problems such as open wells, overflow sewage (from a septic system), or chemicals in the soil. They also respond to burning complaints and noise complaints. Violators are fined \$100-\$1000 and can get up to 30 days in jail.

CONTAINS: owner/occupant name, address, telephone, reason for investigation, date of investigation, time, weather, report, date submitted, sanitarian's name

FCommunity Environmental Health (313-2644)

Ask for: Inspection Reports

This office handles air quality, odor, smoke, and dust complaints. They also handle noise pollution and DISCARDED SYRINGES. In addition they investigate fuel oil spills during office hours. Investigations are for either a business or private residence.

Community Hygiene Report

An annual report is done on each mobile home park to renew their license to operate. Complaints about individual trailers are investigated and filed on a Community Hygiene Report

Landfill: Dump trucks must have a permit to use the landfill. They are weighed when they go in and when they come out. When they come out, the driver must sign the Way Ticket. By searching the Application for Permit (can put up to ten vehicles on one application), you can tell how many vehicles are owned by a particular company. Also, the Division of Solid Waste tries to keep useful information that would help them deal with a company that is writing a bad check for landfill services.

Consumer complaints against businesses include complaints about new homes, home improvements, asphalt pavers, roofers, auto repairs, and massage parlors. This agency tries to get money back for the consumer. They settle complaints by telephone or make an on-site visit. They have a public right access to the business premises and if asked to leave, they do; however, they do have subpoena power.

BDoor-to-door salesmen

Peddlers who sell door-to door include snack wagons, magazine salesmen, and salesmen for such items as fresh crabs and cleaning supplies. All of these sellers must have a Peddler's Identification Card.

Fundraisers (profit or non-profit) are considered Solicitors and must have a Solicitor's Identification Card.

CTow Trucks

Vehicles are prohibited from trespassing on public lots and condo lots. Tow truck operators can fill out an application form to register with Citizen Services and then get calls to remove these vehicles. Certain rules apply such as the tow cannot be farther than 12 miles and must remain in Howard County. Owners who challenge the tow charge can be heard at an administrative hearing or appeal to the Circuit Court. Ask to see the <u>Application Form</u> for registered tow truck operators.

4.1 COMMERCIAL PROPERTY - BUSINESS INSPECTIONS

The Supreme Court has recognized that the Fourth Amendment's prohibition on unreasonable searches and seizures is applicable to commercial premises, as well as private residences. "This expectation exists not only with respect to traditional police searches conducted for the gathering of criminal evidence but also with respect to administrative inspections designed to enforce regulatory statutes." (Marshall v. Barlow's, Inc., 436 U.S. 307, 312-313 (1978).

"An expectation of privacy in commercial premises, however, is different from, and indeed less than, a similar expectation in an individual's home." (Donovan v. Dewey, 452 U.S. 594, 598-599 (1981). The Supreme Court declared in Marshall v. Barlow's, Inc: "Certain industries have such a history of government oversight that no reasonable expectation of privacy, see Katz v. United States, 389, U.S. 347, 351-352 (1967), could exist for a proprietor over the stock of such an enterprise." 436 U.S., at 313.

If your investigation requires that you <u>GAIN ACCESS TO A COMMERCIAL PROPERTY/BUSINESS</u>, it MAY be possible for you to:

- (1) accompany a County, State or Federal Inspector who has a legal right to enter the premises in order to carry out the purposes of the agency
- (2) <u>share information</u> with a government agency that has the legal right to make inspections.

There are several government agencies that have the power to inspect commercial property/businesses. These agencies may be able to assist a law enforcement investigation in several ways:

- (1) Meet with the Inspector prior to a planned inspection. Ask him to watch for specific things while he is making the inspection.
- (2) Accompany the Inspector on the inspection.

4.12 TEMPORARY SERVICES

Some temporary services will answer law enforcement inquires. Ask about business name, address, telephone number, hours of operation, number of temporary employees.

4.13 SAFE DEPOSIT BOXES

An business or individual can rent a safe deposit box in any bank. In some areas, safe deposit boxes are limited, so they are reserved for bank customers. A good first step is to check the suspect's bank to see if he has a safe deposit box there. You will need the <u>name of his bank</u>. Here are some suggestions for getting the bank name:

- (1) <u>Business Guide</u> Section 1.9 If the individual or business happens to be insured for workers' compensation through the Injured Workers Insurance Fund, the application will list the name of their bank.
- (2) <u>Business Guide</u> Section 2.5 You could try doing a postal mail cover to see which bank is sending statements to the suspect. Also watch for mail from an insurance company that may be insuring the contents of the box.
- (3) <u>Business Guide</u> Section 3.5 If the business happens to be a small hauling/dumping operation, the County Department of Public Works may have the bank name on their credit application.
- (4) <u>Business Guide</u> Section 3.8 The County Finance Office can trace back the bank name if the suspect has ever paid a County bill by check.
- (5) Search warrant Look for a safe deposit box receipt.
- (6) Suspect's key ring (safe deposit box keys are a distinctive shape)
- (7) Surveillance (of the suspect or local banks near his home or office)

There is no central listing of safe deposit box renters. A subpoena is needed to allow the bank to tell you whether someone has a safe deposit box and to open the box.

The Maryland State Police - Asset Seizure Unit maintains a Maryland Association of Bank Security (MABS) contact list for large banks and banks primarily in the Baltimore area. These bank security people may be able to assist you in your search for a safe deposit box. Call the supervisor of the Asset Seizure Unit to access the MABS contact list:

The Columbia Library can help you if you need reference information from <u>another state</u> (example: a criss cross directory). They will tell you the name and phone number for the nearest main library in that city or state. Some out-of-state libraries will FAX to you or to the Columbia Library.

A big city or large college library will have a more extensive collection of business reference materials. Their Reference collections are usually open to the public.

The Standard Industrial Classification Code**SIC code**refers to the type of business (food service, novelty items, lumber, etc.).

DO NOT be intimidated by the Library's Reference Section. Your tax dollars built and support it. It's yours to use. Some Librarians are more knowledgeable or helpful than others. You'll soon discover which ones they are. However, all Reference Librarians will show you where to look and how to use the reference materials. You are not bothering them. It's their job to help people find what they came in for. Ask to speak with the Head Reference Librarian if you don't find what you need.
