Introduction

This is the first comprehensive directory of the criminal justice system in West Virginia. During the fall and spring of 1992-93, the WVSAC requested recent names, addresses, telephone and fax numbers from criminal justice agencies in the state of West Virginia .

The directory was compiled by West Virginia Statistical Analysis Center (WVSAC) which is funded by a grant from the U. S. Department of Justice, Bureau of Justice Statistics (BJS-Grant No. 91-BJ-CX-K030). Individuals or organizations seeking a specific address often do not know where to turn and may require several referrals before the current office is found. It is hoped the West Virginia Criminal Justice Directory will serve as a road map to those who need assistance.

While great care was taken in compiling and proofreading the agency listings, the WVSAC relied on different sources that may contain errors or may be outdated. Users are urged to report any corrections to the WVSAC office so that the errors can be corrected in the subsequent editions.
