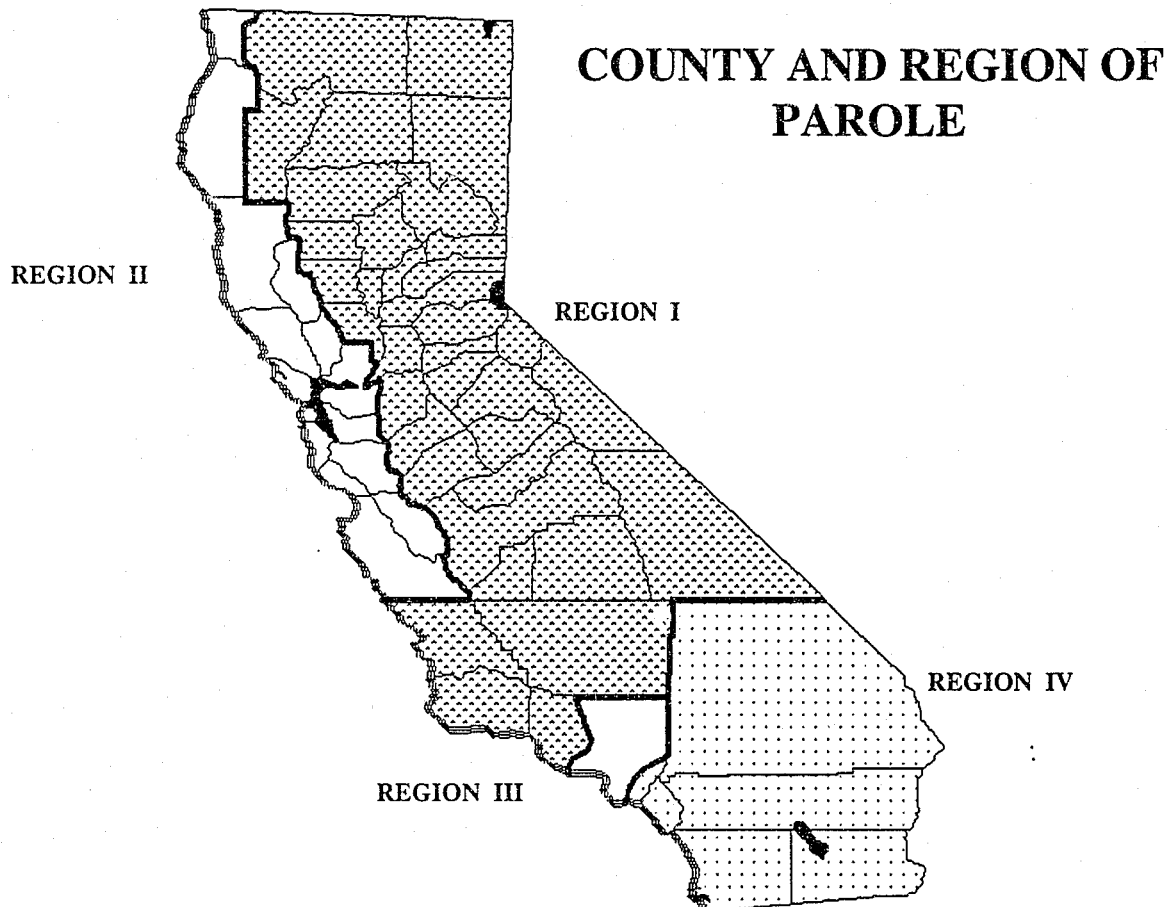

Region I: Covers Alpine, Amador, Butte, Calaveras, Colusa, El Dorado, Fresno, Glenn, Inyo, Kern, Kings, Lassen, Madera, Mariposa, Merced, Modoc, Mono, Nevada, Placer, Plumas, Sacramento, San Joaquin, San Luis Obispo, Santa Barbara, Shasta, Sierra, Siskiyou, Stanislaus, Sutter, Tehama, Trinity, Tulare, Tuolumne, Ventura, Yolo, and Yuba counties.

Region II: Covers Alameda, Contra Costa, Del Norte, Humboldt, Lake, Marin, Mendocino, Monterey, Napa, San Benito, San Francisco, San Mateo, Santa Clara, Santa Cruz, Solano and Sonoma counties.

Region III: Covers Los Angeles County excluding the southeastern area (Long Beach through Pomona).

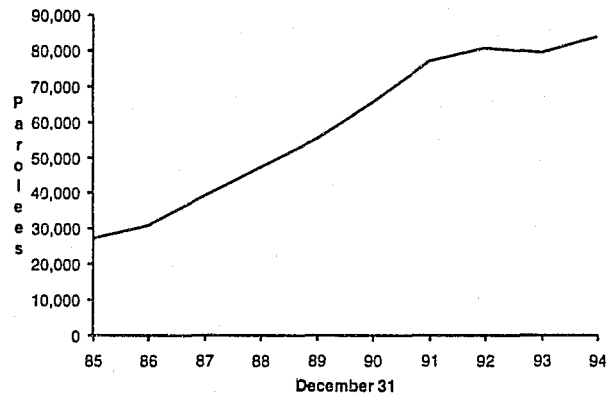
Region IV: Covers southeastern areas of Los Angeles County, and Imperial, Orange, Riverside, San Bernardino and San Diego Counties.

CALIFORNIA FELON PAROLEES SUPERVISED BY THE CALIFORNIA DEPARTMENT OF CORRECTIONS

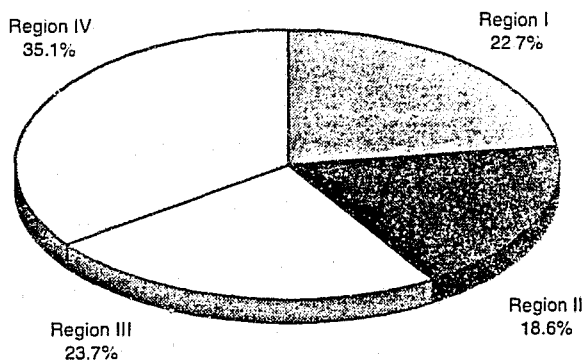
As of December 31, 1994, there were 83,778 California felons receiving parole supervision by the California Department of Corrections (CDC).

- This population increased by 4,274 (5.4%) since December 31, 1993.
- There were 76,610 (91.4%) males and 7,168 (8.6%) females in this population on December 31, 1994.

December 31, 1985 Through 1994



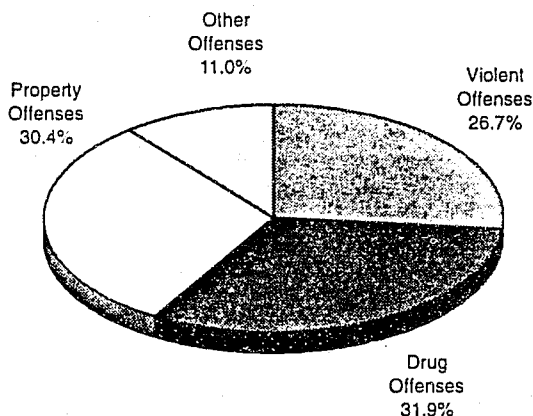
Region of Parole

- Region I accounted for 22.7% (18,980) of the felon parole population supervised by the Department.
- Region II accounted for 18.6% (15,545).
- Region III accounted for 23.7% (19,816) of the felon parolees supervised by CDC.
- Region IV accounted for 35.1% (29,437).

December 31, 1994

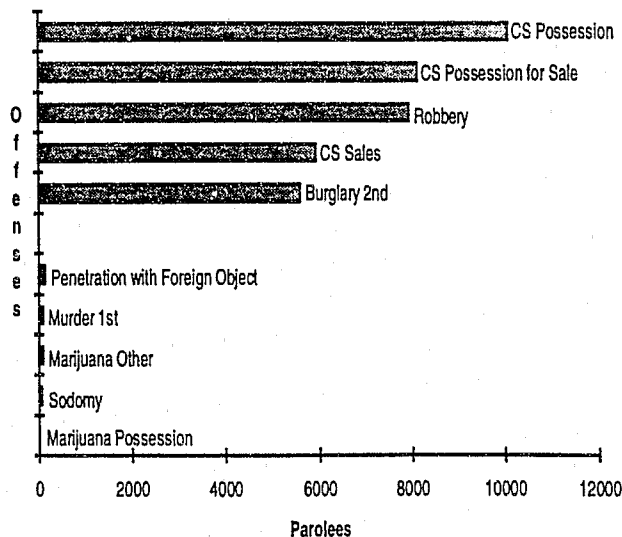


On December 31, 1994:

- Violent offenders accounted for 26.7% (22,409) of the California felon parolees supervised by CDC.
- Property offenders accounted for 30.4% (25,486).
- Drug offenders accounted for 31.9% (26,695) of this population.
- The remaining offenses accounted for 11.0% (9,188).

**Five Largest and Five Smallest Groups of
Parolees by Offense**
December 31, 1994

- The largest group of felons on parole were originally committed for Controlled Substance Possession and accounted for 12.0% (10,064).
- The next largest group was committed for Controlled Substance Possession for Sale at 9.7% (8,121).
- The smallest group for this population was those that were originally committed for Marijuana Possession (22).

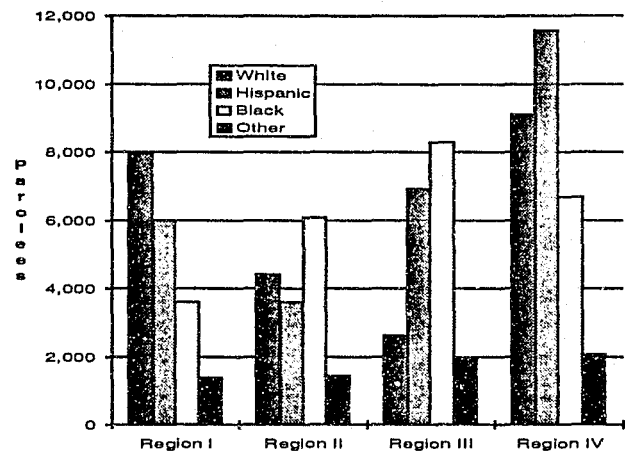


CALIFORNIA FELON PAROLEES SUPERVISED BY THE CALIFORNIA DEPARTMENT OF CORRECTIONS

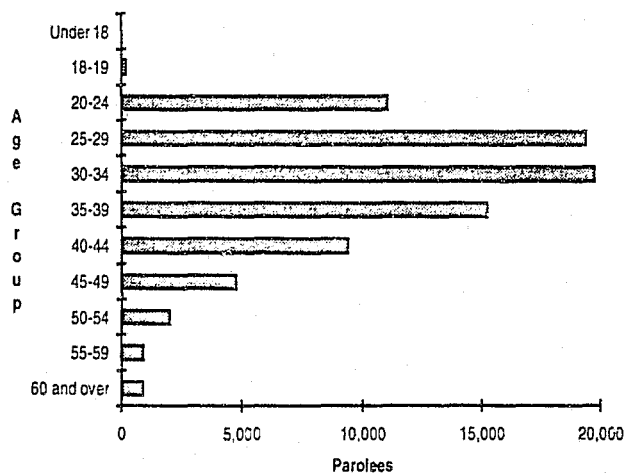
The Hispanic (Mexican) racial/ethnic group represents the highest percentage of the California felon parolees supervised by CDC on December 31, 1994.

- In Region I, the White racial/ethnic group represented the largest percentage of the population, accounting for 42.0% (7,970).
- The Black racial/ethnic group represented the largest percentage of the population in Region II and Region III, accounting for 39.1% (6,078) and 41.8% (8,291), respectively.
- The largest percentage of the parole population for Region IV was represented by the Hispanic (Mexican) racial/ethnic group, accounting for 39.3% (11,573).

Almost half of the felon parolees (46.7%) fall into the 25-34 year old age groups.

- There were no male or female parolees in the under 18 age group.
- The largest age group of felons on parole was 30 through 34 years old and accounted for 23.6% (19,761) of the population.
- The next largest age group was the 25 through 29 years old, accounting for 23.2% (19,407) of the population.
- The 60 and over age group represented 1.1% (912) of the population.
