Note from the Director

This projection considers that impact of C.S.S.B. 15. The baseline assumptions are those stated in the projection report of April 17, 1995. Assumptions related to changes made to SB 15 are stated below.

- ✓ Direct sentencing to state jails
 - Repeat state jail felons can be sentenced directly to state jails
 - The distribution of sentences for state jail felons receiving direct sentences is as follows:
 - 6 months 40%
 - 1 year 40%
 - 1.5 years 15%
 - 2 years 5%
- ✓ State jail felons with two prior convictions for <u>state jail felonies</u> can be enhanced as third degree felons and can be sentenced to prison
 - Sentencing dynamics assumptions are the following:
 - 25% of state jail felons with two prior convictions for state jail felonies are enhanced to a third degree felony
 - 93% of state jail felons enhanced to third degree felonies will be sentenced to prison (1991 Sentencing Dynamics Study)
 - Sentence distribution of enhanced state jail felons is 2 to 10 years with the greatest number of cases receiving sentences in the 6 to 8 years range
- ✓ The law will become effective January 1, 1996

The projected paper ready county jail backlog on August 1998 under C.S.S.B. 15 is 19,553 compared to the impact of the original bill in which the backlog for the same date was projected to be 35,699. The projected backlog under status quo for August 1998 is 15,363.
