Crime in Arkansas, 1994, is a report on crime, based on summary information submitted by law enforcement agencies as a part of the Arkansas Uniform Crime Reporting (UCR) program.

While this document is a comprehensive report on crime, it must be understood that it includes only the number of arrests and incidents known and reported by law enforcement agencies. It does not include any data relating to prosecution, adjudication or correction. Likewise, it does not attempt to draw any conclusions about the cause of crime.

UCR data pertains to the number of criminal events in specific geographic areas, rather than the effectiveness of agencies. It should not be used to evaluate or directly compare one agency to another.

In 1994, index crime in Arkansas increased 1.1% compared to 1993. With the exception of a decrease in 1992, index crime in Arkansas has increased each year since 1984. In 1994, the number of arrests decreased slightly (-0.7%) from 1993.

If the statistics in this report tell us anything, it is that we must continue to enhance our efforts. To effectively fight crime, the entire criminal justice community needs more funding and assistance. A high priority must be placed on dealing with crime, beginning with an overall awareness of the problem. This report is presented as an aid in the process.

Section 1

The Uniform Crime Reporting Program In Arkansas

Background

Development of a national Uniform Crime Reporting (UCR) program began more than 60 years ago. In 1930, Congress authorized the FBI to collect crime statistics from local police departments. All information came from reports that law enforcement agencies routinely compile for their own efficient administration. The underlying philosophy of UCR is oriented toward law enforcement statistics for use by law enforcement agencies.

In an effort to obtain a complete picture of crime on a national level, data is collected on certain offenses that become known to police. Originally, this overview was obtained by examining seven offenses that were selected because of their seriousness, frequency of occurrence, and likelihood of being reported to police. These offenses, which make up the Crime Index, are murder and non-negligent manslaughter, forcible rape, robbery, aggravated assault, burglary, theft, and motor vehicle theft. By congressional mandate, arson was added as the eighth index offense in late 1978.

To provide nationwide uniformity in the reporting of data, a set of standard definitions were written for specific criminal acts. This standardization was necessary to overcome the variation in definitions from state to state. Reporting agencies are required to submit their data in accordance with the UCR definition of offenses. Because of the variance in punishment for the same offenses in different states, it is not possible to distinguish between felony or misdemeanor crimes in the UCR program.

In the 1970's, the FBI actively assisted individual states in the development of state-operated UCR programs compatible with the national system. With a state UCR program, data is more readily available for use by the state, and the FBI ceases collection of data directly from individual law enforcement agencies within the state. Instead, compiled information from all reporting agencies is forwarded to the national program by the state program. State programs also provide more direct and frequent contact with local agencies, assuring more completeness and quality of information provided by them.

On January 1, 1974, the Arkansas Crime Information Center began collecting monthly UCR data in our state. The following year, Act 742 of 1975 was approved, which included a section making the reporting of UCR data to ACIC mandatory for law enforcement agencies in Arkansas.

Purposes of the Arkansas UCR Program

Information from the UCR program provides a picture of reported crime in Arkansas. It should be an important tool in making effective management studies and decisions.

While there are many purposes and objectives of the Arkansas UCR program, the primary goals are:

1. To collect, verify, and analyze information on crime reported by law enforcement agencies in Arkansas.
2. To provide data back to law enforcement administrators for use in operational planning and assessments.
3. To give an overview of crime, its magnitude and trends, and to provide this information to the Governor, the Legislature, and to the general public.
4. To develop base data and statistics for use in improving the efficiency, effectiveness, and performance of the Arkansas criminal justice system.
5. To provide the FBI with complete UCR data to be included in the national crime reports.

Reporting Procedures

The Arkansas UCR program utilizes a "summary" reporting procedure. Law enforcement agencies are responsible for compiling their own crime figures and submitting them once a month to ACIC.

A good record-keeping system is necessary for the effective operation of any law enforcement agency. This record system is the source of statistics on crime. Agencies are furnished training in scoring and classifying offenses, in use of tally books, and in procedures for completing the reporting forms. ACIC will also make basic records, forms and technical assistance available to any agency.

On a monthly basis, law enforcement agencies report the number of offenses that become known to them during the month. This count is taken from the complaints received by the agency from victims, other sources or as discovered by officers. Whenever complaints of a crime are determined through investigation to be unfounded or false, they are eliminated from the count. The number of "actual offenses known" are reported to ACIC without regard to whether anyone is arrested for the crime, any stolen property is recovered, or any other restrictive consideration. Law enforcement agencies also report the total number of these crimes which they clear by either arrest or exceptional means. To supplement the offense information, data is reported on the value of property stolen and recovered, circumstances surrounding homicides, additional information concerning assaults on police officers and other pertinent information.

In addition to offense information, reports on the number of persons arrested on all criminal offenses are collected. These reports provide age, sex and race information, with the adult and juvenile arrests separate. Names of the individuals arrested are not included in the UCR program.

Arkansas Crime Index

The Crime Index is used as a basic measurement of crime. It is the figure which is often publicized by the news media and which is widely used to assess the level of crime in a given location. Many of the figures presented in this report indicate the volume, fluctuations and distribution of crime in Arkansas on the basis of this Crime Index. The eight offenses making up the Crime Index are:

1. Murder
2. Forcible Rape
3. Robbery
4. Aggravated Assault
5. Burglary
6. Theft
7. Motor Vehicle Theft
8. Arson

These crimes were selected for use as an "index" due to their serious nature, their frequency of occurrence and the reliability of reporting from citizens to law enforcement agencies. The Crime Index is the total number of index crimes that come to the attention of law enforcement.

In reviewing crime index figures, the reader should keep in mind that there is currently no way of determining the total number of actual crimes committed. The Crime Index has been established to measure only the instances of crime which come to the attention of law enforcement agencies.

Violent crime refers to events such as murder, rape, and assault that may result in injury to a person. Robbery is also considered a violent crime because it involves the use or threat of force against a person.

Property crimes are unlawful acts with the intent of gaining property, but do not involve the use or threat of force against an individual. Theft, burglary, motor vehicle theft, and arson are examples of property crimes.

In UCR, an offense is considered to be *cleared* (solved) when at least one offender is arrested. The arrest of one person can clear several crimes, or several persons may be arrested in the process of clearing one crime. Offenses may also be cleared by exceptional means when the offender commits suicide; makes a dying declaration; confesses while in custody or serving time for another crime; is prosecuted in another jurisdiction for the same offense; when the victim refuses to prosecute or another jurisdiction refuses to extradite. When examining clearance data, keep in mind that not all crimes are cleared within the calendar year in which the offense occurs. Also note that the recovery of property stolen with regard to a specific offense does not, by itself, constitute a clearance for UCR purposes.

The *Crime Rate* is one of the most quoted crime statistics and is based on the number of Index Crime per 100,000 population.

Data Comparisons and Limitations of UCR

While UCR is the best source of crime statistics available at the present time, it has been subject to much criticism during its history. Some of these criticisms may be valid. However, the criticism is softened when it is remembered that the program was developed to furnish information for use primarily by law enforcement agencies.

The obvious tendency with a publication of this kind is to make comparisons of data between jurisdictions, whether they be between agencies, or counties, or regions. Caution should be exercised for the many reasons which should be apparent as the reader continues through this publication. Comparisons may not be appropriate because of the great variety of factors which affect the extent and fluctuation of crime. Such factors are not taken into consideration in either raw data or crime rates. All crimes are considered "equal" in computing crime rates. One theft affects a crime rate the same as one murder.

The Uniform Crime Reporting program is designated to measure offenses reported and persons arrested. Difficulty will arise if this distinction is not kept uppermost in mind. Crime relates to events, but arrest relates to persons, and this is not a one-to-one correspondence. While UCR is the best information available, no claim is made that they represent "all crime".

Summary

The information in this report portrays the most accurate and realistic assessment available on the crime situation in Arkansas. ACIC is grateful for the participation of the law enforcement agencies that contributed data each month, without which this publication would not be possible.

Individuals using these tabulations are again cautioned against drawing conclusions by making direct comparisons between agencies. Numerous factors affect the amount and type of crime from place to place. More valid use can be made of these figures by determining deviations from state averages or through comparisons with averages for similar population groups.

It is important to remember that crime is a social problem, and therefore, a concern of the entire community. The efforts of law enforcement are limited to factors within its control.

Section 2

Crime Summary

Facts At A Glance

- There were 117,997 serious crimes reported, with a 27% clearance rate (page 75).
- The crime rate for the State of Arkansas was established at 4,872 serious crimes for every 100,000 inhabitants (pages 10 and 75).
- 176,271 arrests were made in the state. Eleven percent of these involved persons under 18 (pages 88 and 89).
- The value of property stolen amounted to \$94,233,368, a small increase (+0.3%) compared to 1993. Ten years ago the value of this property was estimated to be \$57 million; fifteen years ago, \$35 million. Recovered property was estimated to be \$38,959,139 with a recovery rate of 41% (page 78).
- The theft of jewelry and precious metals account for a property loss amounting to almost \$8 million, a decrease from 1993 and even a slight decrease from five years ago. Theft of TVs/radios and cameras amounted to \$9.1 million, an increase of 8% compared to 1993 (page 78). The value of stolen motor vehicles, \$41.4 million, decreased from 1993. This is the first yearly decrease on record. In 1978, the value of stolen vehicles was \$11 million.
- Firearms were used in 73% of all murder/non-negligent manslaughter reported (page 24), 52% of all robberies (page 34), and 30% of the aggravated assaults (page 40).
- 1,026 reported rapes occurred during 1994, no change from 1993, but an increase of 11% compared to 5 years ago; 51% compared to 10 years ago (page 28).
- 10,098 aggravated assaults were reported. Of these 3,323 (33%) were committed by the use of hands, fists, or feet and 3,068 (30%) using firearms (pages 38 and 40).
- Residential burglaries accounted for 73% of all burglaries reported. The estimated value of property stolen in all burglaries is almost \$23 million, with almost one-third of this taken in daytime residential burglaries (page 45).
- 7,702 motor vehicle thefts were reported, amounting to an approximate value loss of over \$41.4 million. Compared to 1993, the number of these thefts decreased (-1%) and the value loss of the vehicles decreased 5% (pages 52 and 78).
- For the year of 1994, there were no Arkansas law enforcement officers killed by felonious means while on duty (page 62).
- There were 371 assaults on officers reported, and 43% of these resulted in personal injury to the officer (page 65). In 1993, only 38% of the assaults resulted in personal injury.






Yearly Violent Crime Trend




Yearly Property Crime Trend




Murder Trend




Rape Trend




Robbery Trend




Aggravated Assault Trend




Burglary Trend




Theft Trend

Contributing Agencies and Population Coverage

For the year of 1994, 187 law enforcement agencies throughout the state contributed Uniform Crime Reports monthly and directly to the Arkansas Crime Information Center. Each month all of the 75 county Sheriff's Departments and 103 Police Departments participated. In addition, Public Safety Departments at eight universities and the state university medical center submitted data to the program. Uniform Crime Reports received from these agencies represent statistical data covering approximately 99% of the estimated Arkansas population.

An Index Crime

Murder

Murder is defined in Uniform Crime Reporting as the willful killing of another. The classification, as in all of the other Crime Index offenses, is based solely on police investigation as opposed to the determination of a court, medical examiner, coroner, jury, or other judicial body.

Deaths caused by negligence, suicide, accident, or justifiable homicide are not included in the count for this offense classification. Attempts to kill or assaults to kill are counted as aggravated assaults and not as murder.

Murder in 1994

There were 293 murders in Arkansas in 1994, an increase of 19% from 1993, and a 45% increase from five years ago. There were 12 murders for every 100,000 population, with a clearance rate of 81%.

There were also five incidents of manslaughter and six justifiable homicides in the state.

Murder accounted for less than 1% of the total Crime Index and only 2% of the violent Crime Index.

The state's five largest law enforcement jurisdictions (representing more than 55,000 people each) accounted for 42% of the murders.

The victims of murder were more likely to be black (59%) than white, male (72%) than female and the most frequent age range was age 24 through 30 (23%). The most frequent suspect was also black (62%), male (79%) and the most frequent age range was 17 through 19 (21% where age was known). Over half (54%) of the known offenders were age 15 through 25. Only 33 offenders were women. There were 57 murders committed by unknown perpetrators.





Murder Circumstances



A felony murder is defined as a killing which occurs in conjunction with the commission of another crime. During 1994, of the 59 felony murders, two occurred in conjunction with rape, 37 with robbery, two with burglary, one with a motor vehicle theft, three with arson, one with a sex offense other than rape, and 13 with drug offenses.

Murder

The oldest victim was a 86 year old black female. The ages of murder victims ranged from age 86 to a newborn infant less than a week old, with almost one-fourth of the victims being age 24 through 30. There was an increase of 38% in the number of victims from age 25 to age 35 compared to 1993 and an increase of 33% in victims aged 30 to 45.

An Index Crime

Rape

Forcible rape, as defined under this program, is the carnal knowledge of a female through the use of force or the threat of force. Assaults to commit forcible rape are also included; however, statutory rape (without force) is not counted in this category.

Rape in 1994

There were 1,026 rapes in Arkansas during 1994. There was no change in total number of rapes compared to 1993, but figures increased 11% compared to five years ago, 51% compared to ten years ago. Approximately one-third of the victims were age 12 through 17.

Rape accounted for 0.9% of the total Crime Index and 7% of the Violent Crime Index. The five largest law enforcement jurisdictions in the state (representing populations of more than 55,000 each) accounted for 41% of all rapes.



Robbery

Robbery is the taking of property or things of value from a person by use of force or threat of force. Assault to commit robbery and attempts are included. This is a violent crime and frequently results in injury to the victim.

Robbery in 1994

There were 3,150 robberies in Arkansas in 1994. Robberies represented 3% of the total Crime Index and 22% of the Violent Crime Index. The five largest law enforcement jurisdictions (representing populations of more than 55,000 each) accounted for almost two-thirds of all robberies (59%).

Firearms were used in 52% of the robberies and 34% were strong arm robberies with no weapon involved. The number of robberies increased 4% compared to 1993, 19% compared to five years ago and 95% compared to ten years ago.

Street robberies accounted for 43% of all robberies, an increase of 30% compared to 1993. The average value of property stolen in street robberies remained almost equal to 1993 (\$485 vs. \$487).

Overall, the total number of robberies increased due to increases in street and residential robberies. All other types of robbery decreased. The total value of stolen property decreased 37% from an average value per robbery of \$843 in 1993 to \$506 in 1994.





Aggravated Assault

Aggravated assault is an unlawful attack by one person upon another for the purpose of inflicting severe bodily injury usually accompanied by the use of a weapon or other means likely to produce death or serious bodily harm. Attempts are included.

Aggravated Assault in 1994

There were 10,098 aggravated assaults in Arkansas during 1994. Aggravated assaults accounted for 9% of the Crime Index and for 69% of the Violent Crimes, with an increase of 33% since 1989. The five largest law enforcement jurisdictions (representing populations of more than 55,000 each) accounted for 58% of all aggravated assaults in the state.

Almost one-third (28%) of all those arrested for aggravated assault were age 16 through age 21.

There were 20,197 additional non-aggravated assaults reported during 1994, an increase of 10% since 1993, and 70% more than five years ago.





Burglary

Burglary is the unlawful entry of a structure to commit a felony or theft. The use of force to gain entry is not required to classify the crime as burglary. The subclassifications of burglary are: forcible entry, unlawful entry without force, and attempted forcible entry.

Burglary in 1994

There were 26,833 burglaries in Arkansas in 1994. Burglaries accounted for 23% of the state's Crime Index Offenses and 26% of the Property Crimes. The five largest law enforcement jurisdictions (representing populations of more than 55,000 each) accounted for 39% of the burglaries in the state. Burglary increased only 1% over 1993 and has actually decreased 6% compared to five years ago.

In 1994, there were more 16 year olds arrested for burglary than any other age, and 43% of those arrested were 18 years or younger.





Theft

Theft is the unlawful taking or stealing of property or articles without the use of force, violence, or fraud.

Theft in 1994

There were 68,270 thefts reported in Arkansas in 1994, with a value of \$29.3 million stolen. Thefts accounted for 58% of the Crime Index, and 66% of the Property Crime. The five largest law enforcement jurisdictions (representing populations of more than 55,000 each) accounted for 37% of all thefts.

The number of thefts has increased only 1% since 1993, but there were 8% more thefts than in 1989. The average property value per theft was \$429 in 1994, a slight increase from 1993 (4%), and 13% higher than five years ago. The total value of property stolen in theft was \$29.3 million. This is 5% higher than 1993 and 16% higher than five years ago.



The incidence of purse snatching in Arkansas is 42% lower than five years ago, and shoplifting has decreased 5%. The theft of parts from motor vehicles has decreased 30% in five years.

Motor Vehicle Theft

Motor vehicle theft is defined as the unlawful taking or stealing of a motor vehicle, including attempts. This excludes the taking for temporary use by those persons having unlawful access to the vehicle.

Motor Vehicle Theft in 1994

There were 7,702 motor vehicles stolen in Arkansas in 1994. The value of stolen motor vehicles was \$41.4 million. Motor vehicle thefts accounted for 6% of the Crime Index Offenses, and 7% of the Property Crime Offenses. The five largest law enforcement jurisdictions (representing populations of more than 55,000 each) accounted for 44% of all motor vehicle thefts. There has been a slight decrease in motor vehicle theft for the past three years, but the increase over a five year period is still 21%; over ten years, 81%.

Almost half of those arrested for motor vehicle theft were age eighteen or younger (46%). Only 9% of those arrested were female, and over half of those were age 18 or younger.





Arson

Arson is defined as any willful or malicious burning or attempts to burn, with or without attempt to defraud.

Arson in 1994

There were 625 arsons reported in Arkansas in 1994. The value of the property damage was \$24.7 million. Although arson decreased slightly (2%), the value of the property damage increased in every type of structural property. The largest increases were in storage buildings and in industrial buildings. The average damage per arson amounted to \$39,489 in 1994, \$10,887 in 1993 and \$15,646 in 1992. Arson accounted for less than 1% of the Property Crime Offenses and the total Crime Index Offenses. The five largest law enforcement jurisdictions (representing populations of more than 55,000 each) accounted for 45% of the arson in the state.







Section 9

Glossary

Glossary of Terms

Actual Offense - A violation of the law which has been confirmed to have happened by law enforcement personnel.

Adult - For Uniform Crime Reporting (UCR) purposes, a person 18 years of age or more (Arkansas Statutes define an adult the same as UCR).

Aggravated Assault - An unlawful attack by one person upon another for the purpose of inflicting severe bodily injury.

All Other Offenses - All violations of state or local laws not specifically covered in the Part II offenses, except traffic.

Arrest Rate - The number of arrests reported for each unit of population (per 100,000 in this publication). The arrest rate is computed by dividing the number of arrests in a particular category by the population and multiplying that answer by 100,000.

Arson - Any willful or malicious burning or attempting to burn, with or without attempt to defraud.

Burglary - The unlawful entry of a structure to commit a felony or theft.

Classifying - Determining the proper crime categories in which to report offenses for UCR based on the facts contained in the police investigation report.

Clearance by Arrest - An offense is considered cleared when at least one person involved in the commission of the offense has been (1) arrested, (2) charged, and (3) turned over for prosecution.

Clearance by Exceptional Means - An offense in which some element beyond law enforcement control prevents placing of formal charges against the offender, but the police have: (1) definitely established the identity of the offender, (2) enough information to support arrest, charge, and turn over to the court for prosecution, and (3) knowledge of the location of the offender so that he could be taken into custody.

Clearance Rate - The percentage of offenses cleared by arrest. This is computed by dividing the number of clearances in a particular offense category by the number of offenses reported in that category.

Crime Factor - Conditions which affect the amount and type of crime that occurs in a geographical location.

Crime Index - The total of eight major offenses chosen because of their seriousness and frequency with which they occur (Murder, Rape, Robbery, Aggravated Assault, Burglary, Theft, Motor Vehicle Theft, and Arson).

Crime Rate - The number of index offenses reported for each unit of population (per 100,000 in this publication). Crime rate is computed by dividing the number of index offenses by the population and multiplying that answer by 100,000.

Crime Trend - A percent change of an offense over a comparable previous period. A negative indicates a decrease and a positive an increase.

Curfew and Loitering - Violation of local curfew or loitering ordinances (persons under 18).

Disorderly Conduct - A breach of the peace.

Driving Under the Influence - Driving or operating any vehicle or common carrier while drunk or under the influence of liquor or narcotics.

Drunkenness - Drunkenness or intoxication.

Embezzlement - Misappropriation or misapplication of money or property entrusted to one's care, custody or control.

Forgery and Counterfeiting - Making, altering, uttering, or possessing with intent-to-defraud anything false which is made to appear true or the attempt to do any of the above.

Fraud - Fraudulent conversion and obtaining of money or property by false pretenses. Includes bad checks except forgeries and counterfeiting.

Gambling - Promoting, permitting, or engaging in illegal gambling.

Hierarchy Rule - A standard UCR scoring practice in which only the most serious offense is counted in multiple offense situations. This is determined by crime index offense order (The exception to this is arson. It is always counted, even in multiple situations).

Hotel Rule - A standard UCR scoring practice which limits to one the number of burglaries which can be counted when more than one room is entered for the purpose of committing a felony or theft within a structure generally intended to house transients.

Jurisdiction - The area for which a city, county, or state law enforcement agency is responsible. In UCR: (1) police report offenses which occur within their city, (2) county and state report offenses which take place in the county, (3) agencies report only those arrests made for offenses committed within their jurisdiction, and (4) the recovery of property is reported only by the jurisdiction from which it was stolen.

Juvenile - For UCR purposes a juvenile is defined as a person under 18 years of age (Arkansas Statutes define a juvenile the same as UCR).

Justifiable Homicide - The killing of a felon by a peace officer in the line of duty or the killing (during the commission of a felony) of a felon by a private citizen.

Liquor Laws - State or local liquor law violations, except driving under the influence.

Manslaughter by Negligence - The killing of another through gross negligence.

Motor Vehicle Theft - The theft or attempted theft of a motor vehicle.

Murder - The willful (non-negligent) killing of one human being by another.

Narcotic Drug Laws - Offenses relating to narcotic drugs, such as unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs.

Non-Aggravated Assault - All assaults and attempted assaults which are not of an aggravated nature and do not result in serious injury to the victim.

Offense - A violation of the law.

Offenses Against Family & Children - Non-Support, neglect, desertion, or abuse of family and children.

Part I Offenses - The first of two main groupings of UCR crime classifications consisting of eight index offenses.

Part II Offenses - The second of two main UCR groupings of crime classifications not already designated in Part I. Part II offenses are limited to arrest information only with the exception of simple assault.

Property Crimes - Unlawful acts with the intent of gaining property, but do not involve force against a person (Theft, Burglary, Motor Vehicle Theft, Arson).

Prostitution & Commercialized Vice - Sex offenses of a commercialized nature, such as prostitution, procuring or the transportation of women for immoral purposes.

Rape - The carnal knowledge of a female forcibly and against her will.

Robbery - The taking of property or things of value from a person by use of force or threat of force.

Runaway - Limited to juveniles taken into custody under the provisions of local statutes.

Scoring - Counting the number of offenses after they have been classified.

Sex Offenses - Statutory rape; offenses against chastity, common decency, morals, and the like.

Stolen Property; Buying, Receiving, Possessing - Buying, receiving or possessing of stolen property as well as all attempts of the above.

Suspicion - Arrested for no specific offense and released without formal charges being placed.

Theft - Unlawful taking or stealing of property or articles without the use of force, violence, or fraud.

Unfounded Offenses - Offenses which are determined through investigation to be false or baseless.

Vagrancy - Vagabondage, begging, loitering, etc.

Vandalism - Willful and malicious destruction, injury, disfigurement, or defacement of property without consent of the owner or persons having custody or control.

Violent Crime - Unlawful acts that involve the use or threat of force against a person (Murder, Rape, Robbery, and Aggravated Assault).

Weapons; Carrying, Possessing, etc. - All violations of regulations or statutes controlling the carrying, using, possessing, furnishing, and manufacturing of deadly weapons.
