## Delaware Juvenile Secure Detention, 1992-1994

From 1992 to 1994, secure detention patterns have shown increases in admissions, populations and length of stay. From 1992 to 1994, secure detention admissions increased from 695 to 1,250, or 80 percent; populations increased from an end of the month snapshot average of 35 to 69, or 97 percent; and length of stay increased from an average of 18 days to 20 days, or 11 percent.

### **1992-1994 Secure Detention**

Juvenile detained admissions increased 35 percent in 1994. The detained snapshot population increased 57 percent in 1994. The length of stay increased 18 percent in 1994. The table below details secure detention figures for 1992 through 1994.

Stevenson House admissions increased 46 percent over 1993. The snapshot population increased 73 percent and the length of stay (LOS) increased 17 percent.

New Castle County Detention Center (NCCDC) admissions increased by 29 percent over 1993. The snapshot population increased by 54 percent and the LOS increased 18 percent. Driving the increases at the Detention Center were Superior Court admissions, which increased by 107 percent in 1994, from 14 in 1993 to 29 in 1994. The average monthly Superior Court population increased from 2 per month to 7 Superior Court detainees per month. The LOS for Superior Court detainees

increased 66 percent, from 54 days in 1993 to 90 days in 1994. On average, 1994 Superior Court detainees stayed at the Detention Center 73 days longer than Standard (non-Superior Court) detainees.

During 1994, juveniles detained for violent offenses accounted for 42 percent of NCCDC admissions. Detainees whose leading charge was assault accounted for 9 percent of 1994 admissions. Burglary detainees accounted for 7 percent of 1994 admissions. Drug offense detainees accounted for 11 percent of admissions during the period. Robbery detainees accounted for 7 percent of NCCDC admissions during 1994.

Juveniles detained for violent offenses stayed an average of 26 days at NCCDC during 1994 and represented 55 percent of the Detention Center's population. Detainees facing homicide/manslaughter charges spent, on average, 96 days at NCCDC during 1994. Felony sex offenders spent an average of 89 days detained in 1994. Detainees facing felony weapons charges spent an average of 32 days at NCCDC during 1994. Violent felony detainees spent an average of 27 days at NCCDC during 1994. Violent misdemeanor detainees spent an average of 19 days at NCCDC.

During 1994, 456 detainees facing nonviolent felony/misdemeanor, traffic, and other miscellaneous charges were admitted to NCCDC. These detainees accounted for 58 percent of all admissions to NCCDC and spent an average of 15 days at NCCDC during 1994.
