## BACKGROUND

In conjunction with the six hotlines that form the Maryland Youth Crisis Hotline, the Center for Substance Abuse Research (CESAR) developed the Maryland Automated Hotline Reporting System (MAHRS). Data collected through MAHRS provide a new indicator of substance use and the need for treatment across the state.

Working with hotline staff, CESAR developed a scannable telephone log form that met the data collection needs of each hotline and CESAR. In return, the hotlines agreed to ask several drug-related ("drug box") questions of all callers for whom drugs or alcohol was an issue. Completed forms are sent to CESAR each month for optical scanning and analysis, and CESAR returns an updated file to each hotline. MAHRS can generate descriptive reports tailored to each hotline's needs as well as county-level and statewide data on alcohol and drug use, frequency of specific drug mentions, patterns of injection drug use, callers' assessment of the need for alcohol or drug treatment, and many other aspects of the data.

A report on the first five months of MAHRS operation (March 1-July 31, 1993) was released by CESAR in March 1994.<sup>1</sup> The tables included in this packet provide hotline data for March through December 1993 and, separately, January through December 1994. An annotated List of Tables describes the data presented in each table.

The activities of the Maryland Youth Crisis Hotline are coordinated by Henry Westray of the Maryland Mental Hygiene Administration. The participating hotlines are operated by the Frederick County Mental Health Association, Grassroots Crisis Intervention, Hotline & Suicide Prevention Center Inc., the Life Crisis Center, the Mental Health Association of Montgomery County, and Walden/Sierra Inc. To safeguard the anonymity of callers to the hotlines, the hotlines are not identified by name in the tables that follow.

## LIST OF TABLES

### 1. Monthly Number of Calls to Hotlines

The total number of calls in this table (48,829 for 1993; 63,157 for 1994) provides the basis for all subsequent tables. Note that the table excludes calls from "frequent callers," people who call many times a month for companionship rather than crisis help. Frequent callers are excluded from the analyses so they do not distort the results.

### 2. Characteristics of Hotline Callers

Hotline callers are identified by age, sex, and whether they were calling about themselves, a third party (someone other than themselves), themselves and a third party, or from an agency. Over 80 percent of callers in 1993 and 1994 called to discuss their own problems.

### 3. Monthly AOD-Related Calls to Hotlines

Of the 39 issues listed on the data collection form as possible reasons for the call, up to 4 issues are recorded by hotline counselors for each call. Included among the issues are alcohol, drugs, social and personal relationships, mental health concerns, daily stressors, housing and homelessness, and general family issues. (Table C lists the 39 issues.)

Alcohol use and/or other drug use were mentioned as issues in 4,725 calls in 1993 and in 5,861 calls in 1994. These alcohol and other drug (AOD) calls are the focus of the remaining tables.

### 4. AOD and Non-AOD Calls, by County

Calls with no AOD mentions, calls with AOD mentions, and total calls are broken down by the county from which the calls came. Note that the counties in which the hotlines are located (identified in the table) might be expected to have a higher call volume than other counties.

### 5. Percentage of Population and Call Volume of MAHRS Regions

Because the number of calls to some counties was small, the counties were aggregated into six regions for analysis. This table compares each region's share of the state population and share of total calls to all hotlines. The counties in each region are identified in the table.

### 6. Percentage of Calls per Month with AOD Mentions, Self-reported History of Injecting Illegal Drugs, and Self-reported Need for Treatment

Hotline calls with AOD mentions are broken down by month, type of drug mentioned, whether the call involved a

report of injection drug use, and whether the caller reported a need for drug treatment. Calls from agencies are excluded from the drug injection and treatment statistics because agency calls frequently do not provide information on the history of a specific client.

**7. AOD Mentions per 100 AOD-related Calls and Total Drug Mentions, by Region and Month**

Some of the data presented in Tables 1-6 could be misleading because of changes in the number of calls to hotlines from month to month. To control for this potential bias, this table focuses on the rate at which specific drugs were mentioned in each region. The table is a useful tool for examining changes in AOD calls over time. The "total" column in this table is the only column not based on rates; it is included so readers can see the *absolute* number of AOD mentions per region per month for each drug.

**8. Characteristics of AOD-related and Non-AOD related Calls**

AOD- and non-AOD calls are broken down by the age and gender of the caller, the hotline called, and the region in which the call was made.

**9. Demographics, Ever Injected, and Need for Treatment of Callers with Drug Mentions, by Drugs Mentioned**

Calls with AOD mentions are broken down by type of drug used and the age and gender of the caller, region in which the call was made, and whether the caller reported injection drug use and/or need for treatment.

**10. Characteristics of AOD-related Calls and Callers, by Need for Treatment**

AOD-related calls are broken down by characteristics of the calls and callers and whether the caller reported a need for treatment and, if so, the type of treatment needed (alcohol only, drug only, alcohol and drug).

**11. Drug Mentioned, Ever Injected, and Need for Treatment for Those Referred to Addiction Services**

This table reports the percentage of AOD-related calls that resulted in the caller being referred to addiction services. The data are broken down by type of drug mentioned, injection drug use, and reported need for treatment. Note that some calls may not have resulted in a treatment referral because the caller or third party involved was already participating in a drug or alcohol treatment program.

**12. Comparison of SAMIS and MAHRS AOD Mentions, by Drug**

The principal purpose of MAHRS is to examine hotline calls as indicators of need for substance abuse treatment among the caller population. One way to determine whether

hotline calls are valid indicators of treatment need is to compare the MAHRS data with an indicator of treatment utilization, such as the Substance Abuse Management Information System (SAMIS) of Maryland's Alcohol and Drug Abuse Administration (ADAA). For each person admitted to alcohol or drug treatment in Maryland, SAMIS records up to three substances mentioned by the client as most problematic in his or her life.

This table compares the regional distribution of AOD mentions, by drug, in the SAMIS and MAHRS data bases. Total correspondence is not expected between the two data bases because unlike MAHRS callers, SAMIS clients are currently entering treatment. Thus, the two populations presumably represent populations that differ to some degree with regard to life-style, severity of drug problem, motivation to seek treatment, and other important dimensions.

**13. Comparison of SAMIS and MAHRS AOD Mentions, by Region**

This table compares SAMIS and MAHRS data on the relative number of mentions of each drug in a given region.

**Appendix Tables:**

**A. Completion Rates for Three "Drug Box" Questions**

A crucial aspect of MAHRS data collection is that the hotline counselors ask the "drug box" questions each time a caller identifies alcohol or drugs as an issue. If the drug box completion rates is low, trends might be missed or differences might exist between calls for which the drug box is and is not completed.

This table reports completion rates for each of the three drug box questions, broken down by hotline.

**B. Number of Drug Mentions by Region and Month**

This table supplements the data presented in Table 7. It provides the absolute number of drug mentions per month in each region, broken down by type of drug. The rates reported in Table 7 were calculated using the data in this table.

**C. Calls to Hotlines by Issue Mentioned**

This table identifies the number and percentage of hotline calls that involved each of the 32 issues listed on the data collection form as reasons for the call.
