**FELONY PROCESSING REPORT**

Attached is the fourth of a series of quarterly reports, required by Chapter 603 of the Laws of 1973, on the processing of felony cases in New York State.

The report covers the period July through September 1974 and shows statistics on the number of defendants who were arrested, who were indicted, whose cases were disposed of, and who were sentenced.

The report shows useful information on patterns of felony arrests and subsequent handling of felony defendants.

The information in the report, however, should not be used at this stage to assess the deterrent value of penalty provisions or to measure the precise workloads and resource needs of the courts and related criminal justice agencies.

#### BACKGROUND

Basic focus. The information in this report is organized and summarized to show on a geographic basis:

- How many felony arrests occurred; and of that total, how many arrests involved drug charges.
- How many defendants were indicted for specific types of felonies (e.g. assaults, burglaries, drug crimes, homicides, rapes, robberies, etc.); and
- What happened to defendants indicted for felonies at different stages of criminal justice process.

Limitations. With respect to the above, it should be stressed that:

- While the number of felony arrests reported during the quarter represents over 95 percent of the total felony arrests that actually occurred during the quarter;
- The number of reported felony indictments, dispositions, and sentences represent smaller and varying percentages of the total felony processing activity which actually occurred in each category.

The reported information on indictments, dispositions and sentences is adequate to identify certain basic trends, such as the following, which relate more to the way in which defendants are being handled within geographic areas than to the overall workload of the courts and related criminal justice agencies:

- What proportion of reported indictments were for each specific type of felony?
- What proportion of defendants whose cases were reported as disposed of were convicted, acquitted, or dismissed?
- For each type of felony, what proportion of the defendants convicted were sentenced to incarceration, placed on probation, or given some other type of sentence?
- For the defendants indicted, what were the median number of calendar days required to dispose of their cases through sentences, acquittals or dismissals?

Comments on limitations. The information on indictments, dispositions, and sentences is being provided on a voluntary basis by 60 of the 62 district attorney offices across the State, and it is the only such information currently available for publication within the deadlines prescribed by Chapter 603.

Fortunately, because of the high degree of cooperation afforded by the district attorney offices, the volume of occurrences being reported is sizeable enough to provide meaningful indications of the overall trends mentioned above.

The Division of Criminal Justice Services, in cooperation with the courts and other criminal justice agencies, currently is in the process of developing an Offender Based Tracking System which, when it becomes operational will replace the current method of collecting indictment, disposition and sentencing data.

In addition to the current information on arrests, this new system, and another system now being developed, will produce complete, up-to-date information on reported incidents and on indictments, trials, dispositions and sentences.

Thus, the information provided under these new systems will make it possible to continue evaluating basic trends and at the same time to measure workloads.

#### QUARTERLY HIGHLIGHTS

Given the above background, some of the highlights shown in the felony processing report for the July through September quarter for the State as a whole are the following:

Arrests. Arrests for all felonies totaled 32,042; up 4,023 or 14 percent over the corresponding period in 1973.

Arrests for drug felonies totaled 4,629; up 520 or 13 percent over the corresponding period in 1973.

Drug charges. The 4,629 individuals arrested for drug felonies were arrested on 5,080 drug felony charges.

Of the total reported drug charges, 1,349 or 23 percent were for Class A felonies; up 1,107 or 82 percent over the corresponding period in 1973.

Indictments. Reported indictments totaled 7,335; with robbery (22 percent), burglary (18 percent), and drug felonies (17 percent) accounting for 57 percent of the total number of reported indictments.

Dispositions. Reported dispositions for all felonies covered 4,887 indicted defendants; of whom 3,984 or 82 percent were convicted. (During the previous quarter, the percentage figure was 80 percent).

Reported dispositions for all drug felonies covered 724 indicted defendants; of whom 560 or 77 percent were convicted. (During the previous quarter, the percentage figure was also 77 percent).

The 724 drug dispositions included 466 defendants indicted under the terms of the new drug law, and 376 or 81 percent of these dispositions were convictions.

Convictions. Of the reported 3,984 defendants convicted, 1,013 or 25 percent were convicted of the same offense for which they were indicted.

Another 1,208 defendants or 30 percent were convicted of felonies in the same or next lower class as the one for which they were indicted.

Sentencing patterns. Of the reported 3,984 defendants convicted, 1,844 or 46 percent were sentenced to State or local correctional institutions or committed to drug facilities. (During the previous quarter, the percentage figure was also 46 percent).

Of the reported 553 defendants convicted of drug charges, 190 or 34 percent were sentenced to State or local correctional institutions or committed to drug facilities. (During the previous quarter the percentage figure was 32 percent).

Processing times. With respect to dispositions, the median time for processing all 4,887 defendants indicted on felony charges, from indictment to disposition (e.g. dismissal, acquittal, or conviction) was 127 days and for those who were convicted, the median time from conviction to sentencing was 51 days. (During the previous quarter, the median processing times were 147 days and 46 days respectively).

By contrast the median time for processing the 724 defendants indicted on drug charges through disposition was 147 days, and for those who were convicted, the median time from conviction to sentencing was 41 days. (During the previous quarter, the median processing times were 167 days and 44 days respectively).

#### CONCLUSION

The regional variations in the above Statewide trends are described in the attached quarterly report.

It is important to stress again that, with the exception of arrest statistics, these trends are based on partial samples and that there has not been sufficient time at this point to analyze the reasons for or significance of seasonal and regional trends.

PREFACE

The following report presents statistics concerning New York State indictments and felony prosecutions for the third quarter of 1974. This report is the fourth in a series of regular quarterly reports required under Chapter 603 of the Laws of 1973.

The report contains data supplied voluntarily by the State District Attorneys' Offices. Because of the high degree of interest in and cooperation with the reporting process, activity in 60 of the State's 62 counties is reflected. DCJS appreciates the efforts of the District Attorneys' Offices and the District Attorneys' Association in making this report possible.

The primary objective of this data collection and reporting system is to supply useful and timely information to members of the criminal justice community. There may be instances where the total number of defendants reported is less than the actual number of indicted defendants processed through the felony courts. This may result from several factors. First, the Division is entirely dependent on the voluntary cooperation of the source agencies for the data. Second, the requirement to produce the report as soon as the quarter is completed implies that information relating to activity during the last days of the quarter may not be received and processed in time for publication. However, it is important to emphasize that the focus of these reports is on those patterns of felony processing that can be portrayed adequately on the basis of the data received, not on the total number of defendants processed.

The data presented in this report include both defendants indicted and defendants whose cases were disposed of during the third quarter of 1974. Because convictions are not reported until time of sentencing, the category "defendants disposed of" refers to any of the following types of cases:

1. Defendants convicted and sentenced during the quarter,

2. Defendants convicted during a previous quarter but not sentenced until the current quarter, and
3. Dispositions other than convictions during the quarter.

The exhibits included in the body of the report focus on three major geographical areas of the State--New York City, Suburban New York and Upstate. Suburban New York includes the counties of Nassau, Rockland, Suffolk and Westchester, areas characteristically different from either New York City or Upstate New York. In addition, similar information is presented by Judicial Department in the Appendices.

These reports and the information presented therein may suggest certain additional data or exhibits of interest to specific readers. Such information, if available, will be provided upon request by DCJS.

## Section 1

### QUARTERLY SUMMARY

This section presents a summary of the information received by the Division of Criminal Justice Services regarding felony processing for the months of July, August, and September.

The summary indicates changes in arrest pattern by comparing data for the current quarter with data received for the same quarter last year. Similar comparisons for indictments and dispositions cannot be made since the Division did not institute the present system of collecting indictment and disposition data from the District Attorneys until the fall of 1973.

#### FELONY ARRESTS

- New York State Law Enforcement Agencies reported a total of 32,042 felony arrests to the Division. 6
- In New York State, reported felony arrests for the period July 1, through September 30, 1974 were up 14.4% from the corresponding period in 1973. Arrests for drug felonies increased by 12.7% and non-drug felony arrests increased by 14.7%. 6
- In New York City, reported felony arrests for the period were up 16.6% over the corresponding period in 1973. Arrests for drug felonies increased by 23.9% and non-drug felony arrests increased by 15.8%. 6
- In Upstate New York, which includes all counties except Nassau, Rockland, Suffolk, Westchester and those in New York City, reported felony arrests were up by 15.8%. Arrests for drug felonies increased by 12.2% and non-drug felony arrests increased by 17.2%. 6
- Suburban New York was the only area to show a decrease in overall felony arrests. The decrease was 1.5%. Non-drug felony arrests increased by 1.6% whereas drug felony arrests dropped by 9.9%. 6

- New York City reported 47.6% of the total drug felony arrests for the State. Though less than 50% the drug felony arrests were from New York City, 74.9% of all Class A drug arrest charges and 80.5% of all Class B drug arrest charges were reported by New York City. 6, 7, 8
- Drug felony arrests accounted for 14.4% of all reported felony arrests for the State. In New York City 9.8% of the reported felony arrests were drug felonies. In Suburban New York and Upstate New York drug felonies accounted for 24.5% and 25.6% respectively of all felony arrests. 6

#### INDICTMENTS

- District Attorneys throughout the State reported 7,335 indicted defendants for the third quarter of 1974. 12
- For New York State, 57% of all reported indicted defendants were for Robbery, Burglary or Drug Offense. 12
- As in previous quarters, the highest incidence of indictments in New York City was for Robbery (32%), Burglary indictments (33%) continued to predominate in Upstate and indictments for Drug charges (20%) remained the highest in Suburban New York. 12
- Indictments for sale of controlled substances continued to account for about two-thirds of the drug indictments statewide. 13
- In both New York City, and Suburban New York over three-fourths of the drug indictments were for Sale of Controlled Substances. In Upstate New York only one-third of the drug indictments were for the Sale of a Controlled Substance. 13
- Over one-half the drug indictments reported throughout the State were for Class A drug charges. In New York City over three-fourths of drug indictments were for Class A drug charges. 13

#### DISPOSITIONS

- A total of 4,887 felony defendants were reported disposed of during the third quarter of 1974. 15

- Convictions accounted for 81.5% of the reported dispositions statewide. For New York City 77.8% of the dispositions reported were convictions. Suburban New York reported 87.9% conviction rate and Upstate reported 85.3% of the dispositions as convictions. All the geographical areas reported an increase in their conviction rate over the last quarter with the Upstate area showing the largest increase. 15, 16, 17, 18
- The category "other court action", referring generally to consolidation of indictments or a plea to another indictment, varies according to county practices. This disposition applied to 9.6% of indicted defendants in New York City, 4.4% in Suburban New York and 6.3% Upstate. 16, 17, 18
- Subtracting "other court action" from total dispositions yields a net conviction rate of 86.1% in New York City, 91.9% in Suburban New York and 91.0% Upstate. 19, 20, 21
- Guilty Pleas accounted for 92% of all reported convictions. This is the same percentage reported last quarter. 15
- The conviction rate of defendants indicted on new drug law charges was 80.7%, of which 90.9% plead guilty. The rate of conviction for defendants indicted for Class A drug charges was 64.5%, of which 75.8% plead guilty. 27, 31
- Of the 3,984 defendants convicted, 25% were convicted of the most serious charge in the indictment. An additional 30% were convicted of felonies in the same or next lower class as the one for which they were indicted. 36
- Of the 377 convicted defendants who were indicted under the new drug law for Sales, 29% were convicted of the most serious charge in the indictment whereas the comparable figure for those indicted for Possession was only 14%. 41, 42
- For defendants indicted on Class A Drug charges and convicted, 57% were convicted of the most serious offense in the indictments and a total of 82% were convicted of a Class A offense. 41, 42

- Of the convicted defendants sentenced, 45% were sentenced to State or Local correctional institutions and 46% sentenced to probation. 43
- For those convicted defendants indicted under the new drug law, 32% were sentenced to State or Local correctional institutions and 58% received a sentence of probation. 27

PROCESSING TIMES

- For New York State, the median time required to process felony cases resulting in dismissal or acquittal continued to take more than twice as long as the median time to process convictions. 50
- The median time for processing the 4,887 reported dispositions was 127 days from indictment to disposition. The corresponding time for the last quarter was 147 days. 50
- Since the last quarterly report, all three major areas of the state showed a decrease in the median processing time, with the N.Y.C. decrease of 26 days being the most significant. --
- The median delay between conviction and sentencing was about 10 weeks for New York City, 9 weeks in Suburban counties and 3 weeks Upstate. 51, 52,

Section 2

FELONY ARRESTS

The felony arrest statistics presented in this section have been generated from the fingerprint file maintained by the Division of Criminal Justice Services. Since New York State Law requires that a fingerprint card be submitted to DCJS as a result of each felony arrest, the file is an excellent source of data concerning statewide felony arrest activity.

The data describe felony arrests only, and, therefore, do not necessarily reflect crime incidence for the same time period. In addition, felony arrests may not survive to become indictments, for many are disposed of in lower criminal courts or are weeded out by grand juries. And, because it is not yet possible to link felony arrests to indictments in a continuous data collection process, the relationship between arrest activity and subsequent criminal justice processing cannot be established.

Exhibit 2-1 presents third quarter arrest figures for the years 1973 and 1974. Exhibits 2-2, 2-3, 2-4 and 2-5 present the breakdown of drug charges for these same periods.

It should be noted that the figures in Exhibit 2-1 are for arrests and that the figures in Exhibits 2-2, 2-3, 2-4 and 2-5 are for arrest charges. Arrests may consist of more than one charge, therefore, total drug charges may exceed total drug arrests.

Any comparisons must be viewed with caution. Since fingerprint cards reach DCJS by mail for most Upstate counties, there is a lag of perhaps several weeks before the fingerprint data base is complete for the prior month. Consequently, the data for the present quarter may be lower than actual count because some of the September arrests may not have been posted to the data base.

Section 3

INDICTMENTS

The statistical gathering and reporting system which was developed in response to the Dangerous Drug Control Law has established a source of data which can be used in describing and analyzing New York State's felony processing from time of indictment through final disposition. This section will present information concerning felony indictments occurring during the period of July 1 through September 30, 1974.

Below is a summary of the classifications of felonies used in these exhibits and in the exhibits of subsequent sections of this report.

Section 4

FELONY DEFENDANT PROCESSING FLOW


Between July 1 and September 30, 1974, the disposition of 4,887 indicted defendants was reported to DCJS. These dispositions, although somewhat fewer than the actual number of dispositions throughout the State, represent a sufficient sample to describe felony processing patterns for the adjudication process that begins with indictment and ends with final disposition.

To examine the disposition patterns of these indictments, felony defendant processing flow diagrams were created. The flow diagrams depict the various disposition "paths" that a defendant may follow. Exhibits 4-1 through 4-4 are for New York State, New York City, Suburban New York and Upstate New York. Appendix A provides similar flow diagrams by Judicial Department.

For each chart, the unit of count is the indicted defendant: an individual who is indicted in two separate indictments is counted as two indicted defendants. The number entries indicate how many indicted defendants were processed through each disposition path. Except where noted, the percent figures measure the proportion of total indicted defendants that remain at each point on the diagram.

NET DISPOSITIONS

The differences in the regional use of "other court action" as a disposition may complicate the picture of felony processing. The disposition flows, referred to above, traced indicted defendants as a function of total indicted defendants whose cases were disposed of. By subtracting the "other court action" category from the total, net dispositions result. Net dispositions are defined as indicted defendants disposed of on the merits of the indictment (not by plea to another indictment or consolidation, etc.) Felony defendant processing flows showing net dispositions are presented for New York City, Suburban New York and Upstate New York in Exhibits 4-5 through 4-7.

### DRUG CHARGES

To highlight Felony Drug Case processing, flow diagrams were generated to depict the disposition pattern of defendants indicted on drug charges.

Exhibits 4-8 through 4-11 present the flow for indictment on drug charges under the old law that was repealed as of August 31, 1973.

To focus on the impact of the new Dangerous Drug Control Law, Exhibits 4-12 through 4-15 present similar flow diagrams that trace the processing patterns for defendants indicted for new law drug offenses. These indictments include:

- All new sections of PL 220.
- Sections of PL 220 not repealed by the Dangerous Drug Control Law.
- Public Health Code and other drug violations.

Exhibits 4-16 through 4-19 show the pattern for defendants indicted on new Class A drug charges.

INDICTMENT vs. CONVICTION CHARGES

For all convicted defendants, a comparison has been made between indictment charges and conviction charges in order to examine charge reduction during felony prosecutions. These comparisons are presented for convictions in New York State, New York City, Suburban New York and Upstate New York in Exhibits 4-20 through 4-23. The tables divide convicted offenses into three categories: (1) same offense as indictment offense; (2) same Penal Law article as indictment offense but different charge (subdivided to show the class of the convicted offense) and (3) different article than indictment offense (broken down by class). For example, Exhibit 4-20 indicates that for all New York State Class A felony indictments, 24.8% were convicted of the same offense, 64.3% of the same article but different offense (24.5% being Class B felony convictions) and 10.9% were convicted of an offense in another Penal Law article. Each column illustrates, similarly, the conviction charges for a particular class of felony indictments.

For felony cases involving multiple indictment/conviction charges per defendant, the data collection reports only the most serious indictment/conviction charge. Thus, for example, the New York State totals in Exhibit 4-20 indicate that 25.4% of the defendants were convicted for the most serious indictment charge.

Exhibit 4-24 illustrates, for New York State reported convictions, the relationship between indictment charge and conviction charge for major Penal Law articles. The percentages represent the proportion of persons indicted in one category who were convicted in another. For example 70.0% of persons indicted for homicide were convicted of homicide, while 10.4% were convicted of felonious assault.

Finally, Exhibits 4-25 and 4-26 show a similar statewide analysis of charge reduction for convictions of defendants indicted on drug sale or drug possession offenses within the new drug law.

Below is a summary of the geographical distribution of sentences for felony indictments resulting in conviction.

This summary examines geographical differences in the types of sentences imposed: for example, New York City shows contrasting sentencing patterns when compared with either Suburban or Upstate counties. These variations in sentencing can be additionally explained by examining the conviction charges receiving specific sentences.

Exhibits 4-27 through 4-30 analyze the conviction charges which comprise the types of sentences imposed in New York State, New York City, Suburban New York and Upstate counties, respectively. For example, in Exhibit 4-26, for New York City 40.8% of cases sentenced to state prison were for convictions on charges of robbery and 9.6% on drug charges.

Since the distributions of indictment and conviction charges are distinct for each area, the resultant sentencing of convicted defendants also tends to be distinct. Thus, combining all areas into a statewide description may mask certain geographic characteristics.

## Section 5

### FELONY DEFENDANT PROCESSING TIMES

The use of offender-based statistics and the tracking of each case for each defendant from time of indictment until final disposition makes possible the measuring of elapsed times between various stages in processing.

Exhibits 5-1 through 5-4 are flow diagrams which summarize processing time for New York State, New York City, Suburban New York and Upstate New York, respectively. Processing times for defendants indicted on felony drug charges which were repealed as of August 31, 1973 are presented in Exhibits 5-5 through 5-8. Exhibits 5-9 through 5-12 present the processing times for defendants indicted under the new Dangerous Drug Control Law. Processing times for defendants indicted on Class A Drug Charges under the new Law are presented in Exhibits 5-13 through 5-16.

Processing times for these same categories by Judicial Department are found in the Appendices.

The times used in the flow diagrams are median days. The median is obtained by ranking all the values in a specific category (e.g., time from indictment to disposition) and choosing the middle number--that is, the value with an equal amount of numbers above and below it. As a result, median values are not influenced by very large or very small numbers the way "average" values are.

At the top of each exhibit the value associated with the term "disposition" is median days from indictment to disposition, regardless of type. The diagrams then branch to show median days from indictment to specific type of disposition. Similarly, the numbers associated with "convicted" and "total sentence" represent times from indictment to conviction and sentencing for all convictions, regardless of type of processing. The branches for "guilty plea", "jury trial" and "non-jury trial" differentiate between processing times associated

with the types of proceeding by which a conviction was obtained.

Some of the processing times contained in the diagrams appear quite large especially in the area of "maximum" times. This may be caused by several characteristics of felony processing: some of the cases were not covered by the rules governing speedy trials, and may result in high processing times; the nature of homicide and rackets cases tends to slow processing; interim commitments to mental facilities result in prosecution continuing over long time periods.
