## <u>VICTIM SERVICES TO NATIVE AMERICANS</u> ENHANCED WITH DEPARTMENT OF JUSTICE GRANTS

WASHINGTON, D.C. -- Victim assistance services in Native American communities will be significantly enhanced as a result of grants totaling \$729,745 to 18 states awarded by the Department of Justice's Office for Victims of Crime (OVC). These grants, awarded under the Victim Assistance in Indian Country (VAIC) Discretionary Grant Program, will expand existing victim assistance programs and firmly establish victim assistance in areas where Native Americans have limited access to victim services.

The grants will help tribal communities provide direct services to victims, including crisis intervention, emergency shelters, mental health counseling for victims and their families, court advocacy in federal court proceedings, and salaries of victim service providers.

"Cooperation and coordination among the federal, state, and local levels are essential if we are to address the needs of Native American crime victims," said OVC Director Aileen Adams. "We are very proud of our work with tribal leaders and state

governments. Together, we have worked effectively to ensure that Native American crime victims receive the much needed services and assistance that they are entitled to receive."

Since 1988, OVC has awarded more than \$5.9 million to 19 states under this grant program. As a result, 52 Native American victim assistance programs have been established in the states of Arizona, Colorado, Idaho, Iowa, Kansas, Michigan, Minnesota, Mississippi, Montana, Nevada, New Mexico, North Dakota, Oklahoma, Oregon, South Dakota, Utah, Washington, Wisconsin, and Wyoming. Many of these states now fund tribal victim assistance programs entirely with state revenues.

The VAIC Discretionary Grant Program funds are allocated from the Crime Victims Fund, which was created by the Victims of Crime Act (VOCA) of 1984, as amended. The Crime Victims Fund receives money entirely through fines, penalty assessments, and bond forfeitures from federal criminal offenders, not from taxpayers.
