

DEPARTMENT OF EVALUATION AND PROGRAM AUDIT

YOUTH SERVICES REPORT

Purpose

The purpose of the Youth Services evaluation report is to determine the progress of the Youth Services Team in McNary and Sprague High Schools in meeting the objectives set forth by the Team at the beginning of the 1973-74 school year.

The report will cover each of the two high schools separately and their respective junior highs and then a summation of progress towards the objective across high schools.

Format of the Report

The report will present supported data on the accomplishment of the objectives specified by the Team at the beginning of the 1973-74 school year. It must be pointed out at the beginning of this report that when the Teams identified the objectives to be monitored for evaluation purposes there was no attempt to identify in performance terms all of the work performed by the Team. In discussing with the Team leaders and the respective members of each of the Teams, it was determined that the objectives covered about 10 to 15 percent of the total services provided by the Youth Services Team at each of the high schools.

The Teams themselves are located at Sprague High School and at McNary High School. The junior highs of Judson and Whiteaker also received some

services from the Teams. The McNary Team is involved more with providing services to youth at Whiteaker Junior High School than the Sprague Team is involved in providing services directly to students at Judson. This is a result of the program designed by the Teams for their respective areas. The objectives for each of the Teams are the same. However, the criteria of success varies from Team to Team. The full objectives, along with the criteria for success, can be found in Appendix A.

The Results

Since the evaluation is being undertaken to verify accomplishment of the specified performance objectives, it is necessary to collect data only on those youths involved in the objectives. Table 1 details the number of youths served by the Youth Services Team for matters relating to the project objectives. In Table 1 for Sprague High School, the Youth Services Team was involved with 34 male students from grades 10 through 12. Twenty-nine (29) female students from grades 10 through 12 were seen by the Sprague Team. This was a total of 63 students. In Judson Junior High, the Sprague Youth Services Team was involved with one male and one female, for a total of two students.

The McNary Team at the high-school level was involved with 29 male and 33 female students. At Whiteaker Junior High School, the Team worked with 23 male and 6 female students. Totally, the two Teams have had contact with 156 students.

Table 2 details the percent of students at each level for each school that is involved in more than one objective. It is not uncommon for students who have problems to have more than one. For example, it is not uncommon for a student to be a runaway and also to be served by the Team for burglary.

Nor would it be uncommon for a Team member to be seeing a student for burglary and for drugs at the same time, even though at this point drug prevention or reduction is not one of the specified objectives that is being monitored.

At Sprague High School, out of the 63 students that are being serviced by the Youth Services Team, 17.5 percent are being dealt with for more than one objective. At McNary High School, 16.1 percent of the students being served are involved with the Team for more than one of the objectives.

Table 3 contains summary of accomplishment on the project objectives for all schools. This table combines both the junior and senior high schools. For the objective preventing runaway, the Youth Services Teams were able to accomplish it for both male and females 90 percent of the time. A total of 50 students were involved with that objective. For the objective reducing the number of petitions filed for beyond parental control, 92.9 percent of the students did not have a petition filed. This objective was successfully accomplished. A total of 15 students were involved with that objective. In preventing larceny or burglary, a total of 71.4 percent of the time the Youth Services Team was successful in meeting this objective. A total of 17 students were also involved here.

For the objective of preventing children being removed from their natural home to a foster home, the Team was able to meet this objective 92.9 percent of the time. Twelve (12) children were involved in this objective.

In reducing the number of second runaways, the Youth Services Team was able to meet that objective 66.7 percent of the time, involving a total of 18 children for that objective. It should be pointed out here at this point that the majority of those that run away are females, and that if a boy runs away once, it appears from the data that he is not likely to run away again.

The Youth Services Teams were able to prevent boys from running away a second time 100 percent of the time. However, when it came to the girls, who make up the larger majority of the runaways, the Youth Services Team was able to meet this objective 52.9 percent of the time.

For the objective of reducing the second referral for beyond parental control, the Youth Services Team was able to meet this every time that it was dealt with. A total of 6 children were involved with the Youth Services Team for this objective.

For the objective of reducing the second occurrence of burglary and larceny, the Youth Services Team was able to meet this objective 97.4 percent of the time. A different pattern here appears than with the reducing of runaways. For burglary and larceny, most of the offenders are boys, 34 to 5. For the female students who were involved with the Youth Services Team in this objective, the Team was able to prevent this from reoccurring with girls 100 percent of the time. Of the 34 boys involved in this objective, they were able to meet the objective 33 times and missed accomplishing the objective only once. This resulted in a total of 53 students being involved with the Youth Services Team for this objective.

The final objective for the Youth Services Team was to reduce the number of children in foster home placement. This was accomplished 50 percent of the time. A total of only 3 students were involved with this objective. It should be pointed out that there was very low referral of students to the Youth Services Team for the objective of reducing the second referral of beyond parental control and for reducing the number of children in foster homes. Many of the children involved with the Youth Services Team on the other

objectives were excluded from the objective of reducing the number of children in foster homes because the Youth Services Team members felt that for some of these children the objective was to get the child out of the natural home and into a foster home.

Table 4 details the data on the objectives for Sprague High School. As can be seen from the table, Sprague Youth Services Team was able to meet each of the performance objectives 100 percent of the time. No table was built for the Sprague Team's work at Judson Junior High. This was because only two students were worked with at Judson Junior High School, one boy and one girl. Each objective was met for the boy and the girl.

Table 5 details the accomplishment of the objectives for the McNary Youth Services Team at McNary High School. On the objective of preventing runaway of children, the McNary Team set its accomplishment level at 20 percent. As can be readily seen from the data, the Team met this objective 25 out of 30 times. For the objective of reducing the number of petitions filed for beyond parental control, the McNary Team set its accomplishment at 50 percent. They met this objective 3 out of the 4 times.

For preventing of larceny and burglary, the McNary Team met this objective 100 percent of the time. For preventing the removal of children from parental homes, the McNary Team met this objective 9 out of 10 times. The success accomplishment level established in the objective was 30 percent. The objective of reducing the number of runaways was met 50 percent of the time. There were no students involved in the objective dealing with preventing or reducing the number of second referrals for beyond parental control. For the objectives dealing with reducing the second occurrence of larceny and burglary, the Youth Services Team at McNary High School set the objective

accomplishment at 50 percent. They met this objective 14 out of 14 times.

For the objective of reducing the number of children in foster care, the Team was able to meet this objective 2 out of 5 times, for a total of 40 percent. This objective was not met by the Youth Services Team. In the original objectives, the McNary Team set the accomplishment level at 50 percent. The McNary Team when working with students at Whiteaker Junior High successfully accomplished all of the performance objectives established at the beginning of the year. The details of these objectives and the number of times that the objective was met and not met are detailed in Table 6.

The data also show that the McNary Team, when taking the junior and senior high schools together, dealt with more students than the Sprague-Judson Team. A total of 65 students were dealt with on the objectives by the Sprague Team, while the McNary Team dealt with a total of 91 students. The McNary Team was also more inclined to service the junior high school connected to it than was the Sprague Team.

There is a noticeable difference between the Sprague Team and the McNary Team in the type of services that they are required to perform. At Sprague High School, the major problems that appear to face the Team are:

1. Prevention of runaways,
2. Reduction of the number of petitions filed for beyond parental control,
3. Reduction of the number of second runaways, and
4. Reduction of the second occurrence of larceny and burglary.

Very little work was done by the Sprague Team in preventing larceny, preventing the removal from parent homes, and the reducing of the number of students in foster home care.

At McNary, the heaviest objectives worked on are:

1. Prevention of runaways,
2. Prevention of larceny and burglary of children who have been identified as potential offenders,
3. Reduction of a number of removals from a foster home, and
4. Reduction of the second occurrence of larceny and burglary.

As can be seen, Sprague and McNary Teams overlap in work on the objective for prevention of runaways of children, and reduction of number of second occurrences of larceny and burglary. For both cases, however, McNary had more incidences in dealing with both of these objectives.

While both Teams are very successful in meeting the objectives that are defined, there appears to be some problems with the functioning of the Team. The major problem facing any team of this nature is one of role identification. The roles of the Team and how it should function as a team must be specified. Currently, the way the Teams appear to be operating is as individual members from different agencies housed at a common location. Once in a while, there is sharing of caseloads; however, the majority of the problems are handled by the representative from the agency that referred the child. In discussion with the Team members, one gets the impression that the team idea or concept is the side thought that is used only once in a while, and that each member of the Team continues to function in his or her normal duties as they were performed before coming together in the Team situation. If the Team is truly to operate as a team, some clarification in this area is necessary. It might be necessary for the heads of the various agencies to come up with modifications of their respective agency's procedures to permit the Team to redefine its role in more of a team concept.

Another area that seems to be lacking is in the area of team planning. It is essential that the Team members get together as a team at least every other week to plan their strategy and review their functioning as a team and to share information about students. This will aid in permitting the Teams to function as a team and will improve the kinds of services given the children. Therefore, it will be necessary for the Team leaders and steering committee to exert leadership to see that this is done.

As mentioned earlier, the data reported covers only about 10 to 15 percent of the work performed by the Youth Services Team. If the Team could begin to define its role, it would more than likely be able to define a greater portion of its tasks in performance terms. This is essential if a more detailed evaluation of the Youth Services Team approach is desirable.

Summary

It is evident from the data supplied by the Youth Services Teams that they are meeting the objectives that they have set down for themselves at the beginning of the 1973-74 school year. Since only 10 percent of the work performed by the Youth Services Team is defined in performance terms, a true or complete evaluation of the success or failure of the Youth Services Team concept is not possible. A more detailed evaluation of the project can be given as the Teams begin to define more and more of their functions in performance terms. This movement of defining a greater proportion of their tasks in performance terms will be easier to carry out as the Team begins to clarify its role. Currently the Team appears to be functioning more as individuals housed in a common location than as a team dealing with students

on a team approach. Part of the problem for this lies, no doubt, in the requirements of the respective agencies. The steering committee should examine its policies and decide whether or not any of its respective agencies' policies or regulations can be modified to enable the Team to function more smoothly.

YOUTH SERVICES TEAM OBJECTIVES

The McNary High School Youth Services Team objectives are as follows:

The Youth Services Team will reduce the second referral of runaway of those children who have been previously referred for runaway as measured by the fact that fifty percent do not run away the second time.

The Youth Services Team will prevent runaway of children who have been identified as potential runaway measured by the fact that twenty percent do not run away.

The Youth Services Team will reduce the second referral of Beyond Parental Control of those children who have been previously referred for Beyond Parental Control as measured by the fact that fifty percent do not become Beyond Parental Control.

The Youth Services Team will reduce petitions filed on Beyond Parental Control children as measured by the fact that fifty percent of those referred do not file Beyond Parental Control petition.

The Youth Services Team will reduce the second referral of Larceny or Burglary of those children previously referred for Larceny or Burglary as measured by the fact that fifty percent are not referred for the second offense of Larceny or Burglary.

The Youth Services Team will prevent Larceny or Burglary of those children identified as potentially committing Larceny or Burglary as measured by the fact that thirty percent will not be referred for Burglary or Larceny.

The Youth Services Team will prevent removal from parental home of those children identified as potential Foster Home placement as measured by the fact that thirty percent are not referred for Foster Home placement.

The Youth Services Team will reduce the number of children in foster home placement as measured by the fact that fifteen percent are returned to their parental home or relatives if resources are available.

The Sprague High School Youth Services Team objectives are as follows:

The Youth Services Team will reduce the second referral of runaway of those referred for runaway as measured by the fact that fifty percent will not run away the second time.

The Youth Services Team will prevent runaway of those children who have been identified as potential runaway as measured by the fact that fifty percent do not run away.

The Youth Services Team will reduce the second referral of Beyond Parental Control of those children who have previously been referred for Beyond Parental Control as measured by the fact that forty percent do not become Beyond Parental Control again.

The Youth Services Team will reduce petitions filed on potential Beyond Parental Control children as measured by the fact that fifty percent do not become under official jurisdiction of the court.

The Youth Services Team will reduce the second offense of Larceny and Burglary of those children previously referred for Larceny and Burglary as measured by the fact that ten percent will not be referred again.

The Youth Services Team will prevent Larceny and Burglary of those children identified as potentially Larceny or Burglary as measured by the fact that fifty percent will not commit Burglary or Larceny.

The Youth Services Team will prevent removal from home of the children identified as potential foster home placements as measured by fifty percent reduction of foster home referrals.

The Youth Services Team will reduce the number of children in foster home placements as measured by a fifteen percent of return of child to parental home or relatives if resources are available.
