About this Directory

This is the fourth revision and update of the directory of community drug abuse services in California. This edition was produced through the Drug Abuse Prevention Resource Units (DAPRU) system, newly developed by the National Institute on Drug Abuse. It is planned to use the DAPRU system to create future editions, and on a more frequent basis. Because this was the first effort to produce the directory through the DAPRU system, some time has elapsed between the time the survey was conducted and the time the system was capable of producing the final copy. We hope contributors will pardon us if changes occurring in the interim are not reflected here.

The orientation of this directory is toward information, treatment and rehabilitation services especially targeted for drugs other than alcohol. At some units listed, drug abusers represent only a portion of the total clients served. At other units, drug abusers comprise virtually all the clients served.

In order to hold this volume to a reasonable size, with but few exceptions we have not surveyed military installations, school districts, hospitals and police departments. The reader should keep these in mind as additional sources of information, referral, and help within his community.

Many armed forces bases have special offices for drug abuse to serve military personnel, their dependents, retirees and civilian employees. Many school districts have drug information, education and referral services available to students and parents. Most hospitals can carry out emergency detoxification. Police Departments may provide information services, especially concerning diversion of drug offenders from the criminal justice system into drug abuse rehabilitation programs.

Further assistance may be obtained from the Office of the County Drug Abuse Coordinator, listed at the end of this directory, your County Health Department; or the State of California Department of Health.

GLOSSARY OF TERMS

The types of services appearing on the following pages are defined as follows:

- Referral, Legal, Education** Referral: Includes such services as information referral, referral with follow-up and hotline services.
- Legal: Legal counseling and/or representation is provided for clients.
- Public Education: Includes such services as a speakers bureau, library services, information services, workshops, seminars, drug abuse education and public relations.
- Crisis Intervention** Hotline: This is a telephone line staffed to handle emergency calls.
- Counseling: Includes unscheduled drop-in-counseling and/or crisis intervention counseling. See also Individual Counseling and Group/Family Counseling below.
- Medical Services: Emergency medical help including overdose care.
- Shelter: Temporary shelter on an emergency basis only.
- Runaway Services: Facilities and/or treatment available to runaways.
- Outreach Services: Services not provided at the clinic site.
- Treatment and Rehabilitation** Drug Free: The treatment modality that does not include any chemical agent or medication as the primary part of drug treatment.
- Detoxification: The treatment modality that detoxifies clients with the aid of a medication.
- Maintenance: The treatment modality assigned to a client which exceeds 21 days and during which only methadone, L-Alpha Acetyl Methadol (LAAM) or Darvon-N (Propoxyphene Napsalate) is prescribed to achieve stabilization.
- Medical/Psychiatric: Includes such services as physical examinations, psychological testing, medical care, dental care, and aversive therapy (chemo or shock).

Treatment and Rehabilitation (Continued)

Individual Counseling: Counseling is provided between client and counselor, normally on a scheduled, one-to-one basis.

Group/Family Counseling: Counseling provided to multiple members of the same family as well as counseling given or facilitated in groups.

Therapeutic Community: The client resides in a drug abuse treatment clinic other than a prison or a hospital.

Social, Remedial, Continuing Education: Includes social retraining classes, remedial education, and classes compatible with the regular educational system.

Vocational/Employment: This service includes skill training, job counseling, job placement, and vocational workshop.
