



POPULATION HIGHLIGHTS

As of December 31, 1975, the California Youth Authority had 12,797 wards under commitment. This was a decrease of 3.5 percent from the 13,267 wards under commitment as of December 31, 1974. This decrease was primarily the result of the decrease in the parole caseload which dropped from 8,586 at the beginning of the year to 7,963 as of the end of the year, a decrease of 7.3 percent.

Institution population actually increased from 4,431 to 4,587, up 3.5 percent.

First commitments to the Youth Authority increased 13.3 percent, from 3,002 to 3,402. The increase was primarily in juvenile court commitments which were up nearly 20 percent. The number of first commitments to the Youth Authority reached a low point in 1972 when only 2,728 wards were admitted to institutions. This total has been increasing each year to where there were almost 700 more commitments in 1975 than in 1972. The commitment rate per 100,000 youth population has increased from a low of 65 commitments per 100,000 in 1972 to 80 commitments per 100,000 in 1975.

In contrast to the increase in first commitments, there was a decrease in parole violator returns. The decrease was from 1,615 in 1974 to 1,415 in 1975, down 12 percent. The number of releases to parole remained somewhat constant — approximately 4,300 in 1975 as compared to 4,200 in 1974.

Institutional length of stay in calendar year 1975 rose to 12.7 months — approximately one-half month more than the length of stay in 1974. Length of stay on parole decreased by approximately one month from a high of 25.8 months in 1974 to 24.9 months in 1975. This length of stay was composed of an average of 31 months for non-violators and 19 months for violators.

CALENDAR YEAR 1975


