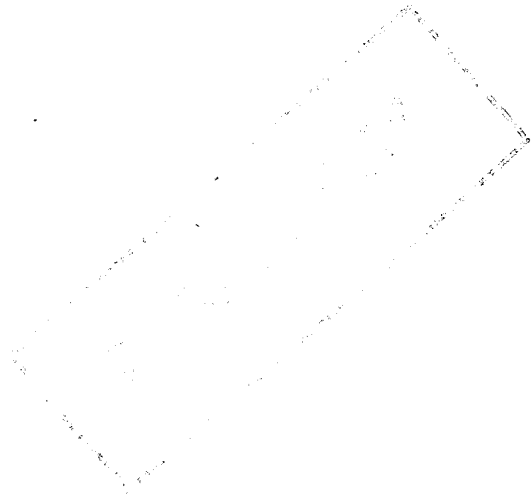

INTRODUCTION

The following Directory of Directories in Criminal Justice was compiled by the Information Center of the National Council on Crime and Delinquency. It is intended to provide in a readily accessible form a selective listing of criminal justice directories. Directories compiled are national or international in scope and have been published by private groups, governmental agencies, and professional associations with an interest in criminal justice. Additionally, a representative group of the best city-wide and statewide directories with comprehensive coverage of any special interest in criminal justice were included.

Directories acquired by the N.C.C.D. library were evaluated for inclusion in this directory. Not included were directories which have not been received recently or regularly, and those whose scope is substantively limited.

Entries have been divided into the following categories:

- (1) U.S. National Criminal Justice Agencies
- (2) Legal Directories
- (3) Law Enforcement Directories
- (4) Probation, Parole and Correctional Directories
- (5) Directories of Correctional Reform Groups
- (6) Directories of Prison Aid Societies and Services to Ex-offenders
- (7) Selected State and Local Directories
- (8) Directories of Professional, Volunteer and Citizen Groups
- (9) Directories of Information and Research Centers
- (10) Directories of Juvenile Justice and Related Services
- (11) Miscellaneous Directories: alcohol treatment and gun control organizations

Each entry provides author, title of the directory, place of publication, publisher, publication date, price (where available) and a brief annotation highlighting the directory's most salient features.

Dissemination of this Directory to the criminal justice planning and operating agencies in Virginia is one phase of a comprehensive range of technical assistance services being developed and instituted by the Division of Justice and Crime Prevention. Companion bibliographies in this series of three annotated listings will include selected Criminal Justice Journals and Criminal Justice Newsletters.

U.S. NATIONAL CRIMINAL JUSTICE AGENCIES

U.S. National Criminal Justice Information and Statistics Service. Criminal Justice Agencies. Washington, D.C., U.S. Government Printing Office, 1975. 10 Vols. U.S. Government Printing Office, Washington, D.C. 20402

A nation-wide criminal justice directory listing 57,575 criminal justice agencies administered by state and local governments in the United States. Of these, 20,158 are law enforcement agencies; 17,583, courts; 8,739, prosecution and legal services agencies; 5,468, correction agencies; 3,285, probation and parole agencies; 1,818 other agencies. Numbers are based on the Criminal Justice Directory Survey conducted by the Bureau of the Census in 1970 as updated and corrected. Separate reports on the states comprising LEAA Regions 1-10 have been prepared and consist of names and addresses of criminal justice agencies arranged by state, type of agency, and level of government. The agencies in each state are arranged in the following sequence: enforcement agencies, courts, prosecution and legal services agencies, defender agencies, adult correctional institutions, juvenile correctional institutions, other correctional institutions, probation and parole agencies, and other criminal justice agencies.

A directory listing American, Canadian, and foreign law firms. The arrangement of law firms is alphabetical by state (or province) and by city within state for the United States and Canadian firms, and alphabetical by country and by city for foreign law firms. Each entry gives the address, telephone number, and staff of the law firm.

American Bar Association. Directory 1975-76. Chicago, Ill.
Annual. 1155 East 60th St. Chicago, Ill. 60637

A nation-wide directory of individuals holding leadership positions in the ABA and other law related organizations in the United States. Lists office holders on the ABA Board of Governors, House of Delegates, Standing Committees, and Special Committees, Commissions, Sections, and Divisions. A separate section lists individuals holding office in other law related organizations (i.e., American Bar Foundation, American Law Institute, National College of District Attorneys). For easy reference an alphabetical index of individuals as well as a geographic index of individuals has been prepared. Each entry gives the name, address, and telephone number of the office holder. A final section provides a directory of bar associations represented in the ABA House of Delegates, and organizations represented in the ABA House of Delegates.

American Bar Association. National Conference of State Trial Judges. Directory of State Trial Judges Associations. Chicago, Ill., 1975. 14 p. 1155 East 60th St. Chicago, Ill. 60637

A nation-wide listing of associations of judges of courts of general jurisdiction in the United States. The associations are arranged alphabetically by state and by association title within state. Each entry gives the association's address, officers and their term of office, membership criteria, and number of current members.

American Bar Foundation. International Directory of Bar Association. 3rd ed. Chicago, Ill., 1973. 45 p. 1155 East 60th St. Chicago, Ill. 60637

A worldwide directory of international and national bar associations. Generally includes only the national bar association from each country, or, if there is no national group, some local ones. The arrangement of bar associations is alphabetical by country. Each entry gives the name, address, and president of the association as well as a brief description of its purpose, principal activities, and publications.

Institute of Judicial Administration. Juvenile Law Litigation Directory. New York, New York University, 1973. V.p. 33 Washington Square, New York, N.Y. 10011

A nation-wide directory listing United States law firms substantially engaged in juvenile litigation, including such issues as schools (First Amendment rights, disciplinary procedures), rights of minors, noncriminal misbehavior, and records and information (confidentiality of court records). Law firms are listed alphabetically by state and by city within state. Entries give the address of the firm, contact personnel, and indicate issues currently or recently litigated.

National College of the State Judiciary. Directory of State and Local Judges. Reno, Nev., 1975. 229 p. Judicial College Bldg. University of Nevada, Reno, Nev. 89507

A nation-wide directory of state appellate, trial, county, and local judges in the United States. The information in the directory is alphabetized by state. All state listings are in alphabetical order within jurisdiction. The order of jurisdiction is as follows: Court of Last Resort, Intermediate Appellate Court, Court of General Jurisdiction, Court of Special/Limited Jurisdiction. Each entry gives name, address, and title of judge.

National Council of Juvenile Court Judges; National Juvenile Court Foundation. Directory: 1973-74. Reno, Nev., University of Nevada, 1974. 87 p. Judicial College Bldg., University of Nevada, Reno, Nev. 89507

A comprehensive directory listing juvenile court judges in the United States, Canada, Guam, and the Virgin Islands. The directory is arranged in two sections: an alphabetical listing of judges according to their surnames. Each entry gives the name, address, and jurisdiction of judge.

National Legal Aid and Defender Association. Directory of Legal Aid and Defender Services. Chicago, Ill. Annual. 2100 "M" St., N.W., Washington, D.C. 20037

A listing of legal assistance and defender programs in the United States. The directory is alphabetical by state and by program within state. Each entry gives the name, address, and telephone number for the service.

LAW ENFORCEMENT DIRECTORIES

A comprehensive directory listing active, associate, life, and sustaining members of the IACP, corrected to May 15, 1975, including United States, Canadian, and foreign membership. The membership is listed alphabetically by country, state (or province), city or town, and name. Each entry gives the name, address, and title of the member.

International Association of Chiefs of Police. Professional Standards Division. Law Enforcement and Criminal Justice Education Directory, 1975-76. Gaithersburg, Md., 1975. 766p. \$9.75. 11 Firstfield Rd., Gaithersburg, Md. 20760

A comprehensive nation-wide directory listing colleges and universities which offer law enforcement and criminal justice degree programs in the United States. There are 664 institutions offering 729 associate, 376 baccalaureate, 121 masters and 19 doctorate degrees. Current programs are listed alphabetically both by state and by college and university. Each entry gives type of degree offered, names of course, size of faculty and student enrollment, and credit requirements. Separate tables list, by state, the number of law enforcement and criminal justice degree programs available, the associate degree programs, the baccalaureate and graduate degree programs, and police officer enrollment.

International Narcotic Enforcement Officers Association. Official Directory: 1976. Albany, N.Y., 1976. 206 p. 178 Washington Ave., Albany, N.Y. 12210

An international directory listing members of the International Narcotic Enforcement Officers Association. Includes foreign, United States and Canadian officers. The directory is arranged alphabetically by country, state (or province), and member's name. Each entry gives name, address, and office of member.

National Police Chiefs and Sheriffs Information Bureau. National Directory of Law Enforcement Administrators. Milwaukee, Wis. Annual. \$14.50. Association of Commerce Bldg. 828 N. Broadway, Milwaukee, Wis. 53202

A nation-wide directory listing law enforcement administrators, including correctional and federal judicial agencies in the United States. The information in the directory is arranged as follows: county law enforcement, municipal law enforcement, state agencies, and federal agencies. The county law enforcement section lists sheriffs and prosecutors in each state, while the municipal law enforcement sections lists chiefs of police. Agencies listed for each state include state correctional institutions, state criminal investigation units, motor vehicle division authorities of the U.S., and state police and highway patrols. Federal agencies listed are the Bureau of Alcohol, Tobacco, and Firearms; U.S. Customs Service; Drug Enforcement Administration; Correctional Institutions (federal); the F.B.I.; General Services Administration; Intelligence Division-- Internal Revenue Service (IRS); Internal Security Division-- I.R.S.; U.S. Attorneys (offices); U.S. Courts; U.S. Marshalls (offices); and U.S. Secret Service Field Offices. Addresses for state and federal agencies are provided.

PROBATION, PAROLE AND CORRECTIONAL DIRECTORIES

American Correctional Association. Directory, Juvenile and Adult Correctional Departments, Institutions, Agencies and Paroling Authorities, United States and Canada. College Park, Md. Annual. \$8. 4321 Hartwick Rd., Suite L-208, College Park, Md. 20740

A comprehensive, nation-wide directory, listing all correctional institutions except jails in the United States and Canada. The arrangement is by state, territory, federal, and military facilities for the United States, and federal and provincial institutions for Canada. Also listed are U.S. LEAA regional offices, state planning agencies, and correctional service agencies such as prisoner aid societies and aftercare agencies. Provides a brief description of the organization of the correctional system of each state. Within each state, institutions are arranged under four main categories of adult and juvenile services: institutions, parole boards, parole services, and probation services. Each entry gives the address, telephone number, and name of the administrator of the agency or institution (director, commissioner, warden, superintendent). Each correctional institution listed includes information on year opened, normal capacity, average population during the previous year, type of inmate admitted (felon, misdemeanor, male, female, juvenile, adult), age limits, and work-release program. A final section provides summary statistics on state correctional facilities for adults and juveniles, including number of facilities according to type of facility and number of inmates in each type.

A nation-wide directory of juvenile and adult halfway houses in the United States and Canada. Includes halfway houses specializing in parole, probation, alcoholism, mental health, drug addiction, pre-release, and work-release. The arrangement is alphabetical by state for the U.S. and by province for Canada. Each entry gives name, address, telephone number, director, sponsoring agency, year opened, capacity, staff, type of client admitted (male, female, adult, juvenile), length of residence, and specialization.

National Association of Probation Officers. NAPO Probation Directory. London, Owen Welles, 1974. 96 p. Owen Wells. 73 Willifield Way, London, England NW11

A comprehensive listing of all probation offices, probation officers, correctional institutions, and petty sessional divisions in Great Britain and Wales. The directory is alphabetical by county. Within each county the entries are arranged under four sections: probation offices, probation officers, correctional institutions, and petty sessional divisions. Each entry gives address, and telephone number.

National Council on Crime and Delinquency. Directory of Probation, Parole and Correctional Associations. Hackensack, N.J., 1973. 35 p. \$2. Continental Plaza, 411 Hackensack Ave., Hackensack, N.J. 07601

A nation-wide directory of probation, parole, and correctional associations in the United States. The contents are arranged by national, regional, and state associations. Within each category associations appear alphabetically. Each entry gives association mailing address, names and addresses of officers, scheduled conferences and meetings, publications, and dues. Included as an appendix, are the model bylaws for state correctional associations as suggested by the NCCD.

National Council on Crime and Delinquency. NewGate Directory: Post-Secondary Education Programs in Correctional Institutions. Hackensack, N.J., 1973. 49 p. Continental Plaza, 411 Hackensack Ave., Hackensack, N.J. 07601

A nation-wide compilation of NewGate programs in the United States. NewGate programs provide inmates in correctional institutions with the opportunity for post-secondary education and counseling both in and out of the institutions and additional follow-up support services in the post-release period. The directory lists NewGate programs alphabetically by state and by program. Each entry gives address, and telephone number of their key staff. A separate section which provides a state by state listing of individuals known to be working for the establishment of more higher education programs for offenders includes addresses and telephone numbers.

National Council on Crime and Delinquency. Probation and Parole Directory, United States and Canada. 17th ed. Hackensack, N.J., 1976. \$20. Continental Plaza, 411 Hackensack Ave., Hackensack, N.J. 07601

A comprehensive nation-wide directory listing all probation and parole offices in the United States and Canada. The contents of the directory are arranged in the following order: the federal system, the states (including the District of Columbia), Puerto Rico, and Canada. In the federal section, agencies at the national level are listed first, followed by a listing of probation and parole offices serving the U.S. district courts in alphabetical order of the states in which the offices are located. In each state section a brief legal summary is given which describes juvenile court, adult probation, and parole and clemency (adult and juvenile), followed by state and local personnel. The state departments, divisions, bureaus, and boards are listed first, with names of administrators and size of operating staff. Following this is an alphabetical listing of county, district, or city offices. For the local listing, each entry gives name of office, type of service (juvenile, domestic relations, felony, misdemeanor), address, name of department head, and size of staff.

U.S. National Institute of Mental Health. Directory of Institutions for Mentally Disordered Offenders. Rockville, Md., Center for Studies of Crime and Delinquency, 1972. 24 p. \$.25. U.S. Government Printing Office, Washington, D.C. 20402

A nation-wide directory of mental health and correctional institutions providing psychiatric care for adult, mentally-disordered offenders in the United States. Included are federal, state, and municipal facilities. Veterans' Administration Hospitals and correctional facilities connected with the Armed Forces are excluded. The information in the directory is listed alphabetically by state and by institution under mental health and correctional facilities. Each entry gives address, administrative officials, capacity, type of institution, and population classified by sex.

DIRECTORIES OF CORRECTIONAL REFORM GROUPS

American Bar Association. Commission on Correctional Facilities and Services. The People of the ABA Corrections Programs. Washington, D.C., 1975. 27 p. 1705 DeSales St., N.W., Washington, D.C. 20036

A nation-wide directory listing individuals working in ABA programs concerned with the rehabilitation of offenders and the improvement of correctional systems in the United States. It covers members of the ABA's Commission on Correctional Facilities and Services, members of the advisory board of the ABA action projects now funded and in operational status, associated staff of various ABA programs, leadership of ABA committee sections working in penal and correctional reform, and liaison persons in other national organizations and ABA units. Individuals are listed under their respective programs. Each entry gives a brief description of the ABA commission, committee, or advisory board and the name, address, and phone number of members.

American Bar Association. Commission on Correctional Facilities and Services. Preliminary List of Grantee Bar Associations and Contact Persons. Washington, D.C., 1975. V.p. 1705 DeSales St., N.W., Washington, D.C. 20036

A nation-wide listing of state and local grantee bar associations in the United States. Grantee bar associations are recipients of funds to be used for correctional reform activities. The arrangement is alphabetical by state, with state bar associations listed first, followed by local bar associations. Each entry gives name, address, and telephone number of a contact person in the association as well as a brief description of the association's activities in correction.

American Bar Association. Commission on Correctional Facilities and Services. Directory of State and Local Bar Association Correctional Reform Committees, compiled by Bar Activation Program for Correctional Reform. Washington, D.C., 1973. 46 p. 1705 DeSales St., N.W., Washington, D.C. 20036

A nation-wide directory listing state bar committees and city and county bar committees engaging in correctional reform activities in the United States. The directory includes only committees whose responsibility lies primarily within the correctional system and whose focus is broad enough to encompass comprehensive, system-wide improvement. The arrangement is by state bar committee followed by city and county bar committees with entries listed alphabetically. Each entry gives mailing address, name and address of chairman, committee members, date activated, staff service, sub-committee, and a summary of activities.

Urban Information Interpretors, Inc. National Prison Directory:
Organizational Profiles of Prison Reform Groups in the United
States, edited by Mary Lee Bundy, and Kenneth R. Harmon. College

A nation-wide directory of over 490 local and national groups involved in trying to change, improve, reform or abolish prisons in the United States. Includes legal, religious, and prisoner groups; correctional associations; and prison coalitions, among others. The main portion of the directory is arranged geographically: New England States, New York State, Rest of the Northeastern States, Southern States, Midwestern States, Mountain and Plains States, and Far Western States. Within each state, organizations are listed alphabetical. Each entry gives address, telephone number, contact person, and a brief description of goals and objectives, programs and activities, and organizational information. An Activity Index gives access to the groups engaged in particular reform activities, such as lobbying for legislation. The Issue Index is a register of interests and concerns of the organizations. The Listing of Organizations was compiled for the convenience of those wanting quick access to the entry for a particular group. Four other listings were prepared: a Prison Periodicals listing, which gives order information for the publications listed; a Prison Criminal Justice Literature listing, which gives information about books, reports, and pamphlets issued by groups in the directory; a listing of Legal Groups which engage in litigative activity on behalf of inmates; the Other Types of Groups listing is a reference guide to over 30 different types of prison reform related groups.

DIRECTORIES OF PRISONER AID SOCIETIES AND
SERVICES TO EX-OFFENDERS

Canadian Criminology and Corrections Association. Directory of Correctional Services in Canada. Ottawa, Ontario, 1974. 165 p. \$8. 55 Parkdale Ave. Ottawa, Ontario, Canada K1Y 1E5

A comprehensive, nation-wide directory, listing all correctional institutions (adult and juvenile) except jails in Canada. The arrangement is alphabetical by Canadian province. Also listed are Canadian federal government services (Ministry of the Solicitor General, Correctional Planning Branch, Penitentiary Service, National Parole Board), national voluntary correctional service agencies, and professional correction associations (judges and magistrates, police, and probation officer's associations). Within each province institutions are arranged under three main categories of juvenile and adult services: institutions, probation services, and prisoner aid agencies. Each entry gives address, telephone number, name of administrator of the agency or institution (director, commissioner, warden, superintendent), and type of inmate admitted.

Correctional Services Federation, U.S.A. Directory of Correctional Service Agencies. Philadelphia, Pa., 1974. 33 p. 311 S. Juniper St., Rm. 300, Philadelphia, Pa. 19107

A nation-wide listing of voluntary, professional, and private nonprofit correctional service agencies in the United States providing direct care services to prisoners, ex-prisoners, probationers, and parolees as well as to their families, including addiction treatment, legal assistance, counseling, rehabilitation, release assistance, job counseling and training. The directory is alphabetical by state and organization. Each entry gives address, telephone number, and a brief description of the organization, structure, source of income, staff, current activities, and services.

International Prisoners Aid Association. International Directory of Prisoners Aid Agencies. Milwaukee, Wis., 1970. 49 p. \$1. University of Pennsylvania, McNeil Bldg., Rm. 203, Philadelphia, Pa. 19174

A worldwide directory of voluntary (nonofficial) organizations primarily concerned with providing aftercare for prisoners or other aid to offenders and their families. Includes only national societies or federations in each country. The arrangement is alphabetical by country. Each entry briefly describes the organization and administration of the penal system, the thrust of voluntary correctional service agencies in that country, financing and trends, and gives the name and address of a national society.

New York Urban Coalition. Action Council. Directory of Services and Programs for Former Prisoners in New York State. New York, 1974. 116 p. 55 Fifth Ave., New York, N.Y. 10003

A statewide directory listing public and private agencies in New York State assisting ex-prisoners and their families. The directory is organized geographically by county. For each county, the name, address, and telephone number of general governmental agencies and programs (Department of Social Service, referral agencies, Parole Office, Employment Office, poverty programs, legal services) offering help to all who need it (including ex-prisoners) is given first, followed by a section listing cities in the county having agency-operated programs for ex-prisoners. Each entry gives address, telephone number, hours, director, funding, program services (job placement, counseling, vocational training, employment, family counseling, legal assistance, addiction treatment), staff, intake, and number in program. Appended to the directory is a section explaining employment barriers confronting those formerly convicted, how to apply for a social security card and birth certificate, and a map of all Department of Correction facilities in the state.

Service Directory of New Jersey, by Ann Chapman and Robert Giovanetti. Ramsey, N.J., Ramapo College, 1975. V.p. Directory P.O. Box 534, Ramsey, N.J. 07446

A statewide directory designed to refer any person being released from a New Jersey State prison to the essential services he may need. The information in the directory is arranged in three parts. Part I explains the services listed in Part II. The services covered are alcohol, drugs, education, employment, housing, legal, medical, mental health, parole, social service, transportation, veterans, welfare, and women. Every person who is released from a New Jersey State prison is given this part of the directory. Part II lists the agencies which offer these services and is arranged alphabetically by county. Each entry gives address, telephone number, director, service, and application procedure. Services are listed only in the county in which they are located. Also included in Part II is a listing of statewide services available. Part III contains a description of the rights and civil liberties which are lost or restricted because of arrest and conviction. Included is information on how to restore some of those privileges, as well as references for further study and a listing of legal resources.

Urban Information Interpretors, Inc. Prison Group Directory. College Park, Md., 1973. 118 p. \$2.50. P.O. Box AH, College Park, Md. 20740

A region-wide directory listing private groups and agencies in Maryland, northern Virginia and Washington, D.C. which provide services to inmates and ex-offenders or operate prison projects or programs. Includes services such as alcohol and addiction treatment, education and training, employment, halfway house or group home, legal assistance, and pretrial assistance. The directory is alphabetical by organization title. Each entry gives address, telephone number, contact person, and a brief description of goals and objectives, services and programs, publications and organizational information.

SELECTED STATE AND LOCAL DIRECTORIES

Academy for Contemporary Problems. Open Doors: An Inventory of Social Services for Youth in Cuyahoga County. Columbus, Ohio, 1975. 99 p. \$1. 1501 Neil Ave., Columbus, Ohio 43201

A county-wide inventory of nonjudicial services available to troubled youth in metropolitan Cleveland (Cuyahoga County), Ohio. Includes one-to-one volunteer programs, residential institutions, community centers and neighborhood organizations, counseling programs, group-home programs, drug counseling and treatment, services for unwed parents, education and employment training and counseling, alternative schools, overnight crisis or shelter care, and crisis telephone services. The directory is alphabetical by agency title. Each entry gives address, telephone number, director, juvenile client information, area served, number served, race, sex, age, restrictions, referrals, and a brief description of goals, service, funding, and fees.

California. Youth Authority. Drug Abuse: a Directory of Community Services in California. Sacramento, 1973. 57 p. State Office of Narcotics and Drug Abuse, 926 "J" St., Suite 300, Sacramento, Calif. 95814

A comprehensive statewide directory of community resource agencies concerned with drug-abuse treatment in California. Contains all known public and private agencies actively providing prevention, treatment, or rehabilitation services to drug abusers. Agencies are listed alphabetically by county. Each entry gives address, director, telephone number, and type of service, including referral (hotline/switchboard, information service, legal assistance), emergency service (detoxification, withdrawal, shelter, free clinic, other medical), and rehabilitation (methadone maintenance, group counseling, individual/family counseling, medical/psychiatric, vocational/employment, residential center, drop-in center).

Community Council of Greater New York City, Inc. Directory of Social and Health Agencies in New York City: 1975-76. New York, Columbia University Press, 1975. 680 p. 225 Park Ave., South, New York, N.Y. 10003

A comprehensive listing of public and voluntary welfare and health agencies serving New York City. Governmental, educational, and religious organizations are included only if they offer services in the field of social welfare or in closely related fields. Many national agencies with offices in New York City are also included. Agencies are listed in the directory in two ways. All agencies are classified according to the service and function that they perform. For example, addiction service (alcohol and drug), rehabilitation, mental health, legal assistance, courts and correctional agencies, family services, financial assistance, employment training, and vocational guidance. There is a complete alphabetical listing of every agency in the directory in the Agency Index. The classified section consists of three subsections or functional fields. Each functional field alphabetically lists agencies that offer services in a particular social and health field. Each entry gives address, telephone number, executive director, and a description of services. In the Agency Index, the legal title, address, telephone number, date of incorporation, and executives are included in each entry.
