STATISTICAL FACT SHEET ON THE MASSACHUSETTS FURLOUGH PROGRAM

Overall Statistics

Between the inception of the Massachusetts furlough program on November 6, 1972 and April 24, 1976, a total of 28,477 furloughs have been granted to 3,624 individual residents. The average number of furloughs per resident therefore is eight furloughs.

Escape Rate by Furlough

Of the 28,477 furloughs granted, 381 have resulted in escape, for a furlough escape rate of 1.3%.

If furlough statistics are analyzed on a yearly basis, it can be seen that the escape rate by furlough declined during 1975 as compared to the previous year. In 1975 there were only 88 escapes for a rate of 1.0% whereas in 1974 there were 127 escapes for a rate of 1.5%. The 1973 escapes were even more numerous, or 134 and a 1.9% escape rate.

Voluntary Returns

Of the 381 escapes, 109 or 28% of the total escapes returned voluntarily within a period of twenty-four hours. If these residents are excluded from the escape statistics, the adjusted escape rate becomes 1.0%.

Escapees at Large

As of April 24, 1976, 325 or 85% of the total escapes had been returned to the custody of the Department of Correction. The remainder, 56 or 15%, remained at large.

Escape Rate by Individuals Furloughed

Of the 3,624 individuals furloughed, 369 have been declared escape on one of their furloughs. The escape rate by individual furloughed therefore is 10.2%.

107 of these individuals returned from furlough voluntarily within twenty-four hours. If these persons are excluded from the statistics, the individual escape rate declines to 7.2%.

Trends in Number of Individuals Furloughed

Since the inception of the program the number of individuals furloughed yearly has significantly decreased. In 1973 a total of 1,868 residents received furloughs whereas in 1975 only 1,474 residents were furloughed, a reduction of 21%.

The escape rate by individuals furloughed is presently declining also. In 1974 the individual rate was 7.6% but in 1975 it dropped to 5.8%. If voluntary returns are excluded, the 1975 individual escape rate becomes only 3.5%.

In sum, the data indicates that the Department of Correction has effectively tightened up the administration of the furlough program, as evidenced by the fewer numbers of residents currently being furloughed and the corresponding decrease in the number of residents who are failing to return from furlough.

Proportion of Population Participating in Furlough Program

Of the 2,356 residents in the custody of the Department of Correction on January 1, 1976, only 977 or 41% of all residents incarcerated had received one or more furloughs. The remaining 59% of the total population have not been allowed to participate in the furlough program.

Lifer Furlough Statistics

As of December 1975, a total of 2,744 furloughs have been granted to residents serving life sentences. Of these furloughs 23 or 0.8% have resulted in escape.

First Degree Murder - Lifers convicted of murder in the first degree were granted 842 furloughs, 9 escapes resulted for an escape rate of 1.1%.

Second Degree Murder - Lifers convicted of murder in the second degree received a total of 1,808 furloughs, 13 escapes resulted for an escape rate of 0.7%.

Other Lifers - Lifers convicted of crimes other than first or second degree murder received a total of 94 furloughs, one escape resulted for an escape rate of 1.1%.

Proportion of Lifer Population Participating in Furlough Program

On January 1, 1976 there were 378 lifers in the correctional system, representing 16% of the total population. Of these 378 individuals, 171 or 45% had received one or more furloughs, 64 or 17% had received no furloughs, and 143 or 38% were ineligible for furloughs in accordance with Department of Correction regulations.

Effect of Furlough Program on Recidivism

A special recidivism study of MCI-Framingham releasees conducted by Boston University revealed a relationship between the number of furloughs received and recidivism. For example, the individuals who had no furloughs or only one furlough had a recidivism rate of 22%; those who had 2-6 furloughs had a re-incarceration rate of 15%; and, those who had seven or more furloughs had a rate of 13%.

Court Prosecution of Escape Cases

Of the 374 escapes from furlough as of March 27, 1976, 152 or 41% were not prosecuted for the escape offenses.

161 or 43% of the escape offense have been fully adjudicated and 61 individuals received an additional sentence to be served from and after their present sentences. The most frequent length of the additional sentence was three months.




