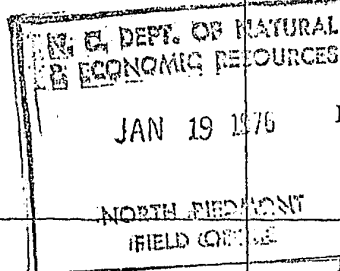



## I. Problem Statement

The Winston-Salem Police Department sought through analyzation of crime index offenses to select the offenses upon which a concentrated law enforcement effort would have the greatest impact. The Department selected one violent crime and two property crimes in which to launch a special enforcement program. The crimes selected were robbery, burglary, and auto theft.

The following comments will provide some indication of the effect the crimes of robbery, burglary and auto theft have on the citizenery of Winston-Salem. Amount the violent crimes, effort was directed at selecting that crime which the Police Department could have the greatest impact on with the least expense. Robbery, therefore, frequently results in injury to the victim. Nationwide, the offense of robbery represents 6% of the total crime index and comprises 45% of violent crimes. In Winston-Salem, robbery represents 3.6% of total crime index and 16.27% of violent crimes, bases on 1973 crime statistics.

Nationwide, burglary makes up 40% of the total offenses and 46% of property crimes; in Winston-Salem the percentages are 25.1% and 32.3% respectively. Burglary, a crime of stealth and opportunity, is difficult to detect and offers even more of a challenge to Police to prevent. Of the index crimes, burglary represents the Department's lowest clearance record with 14.7% as compared with a range of 17% - 21% nationwide. Therefore, when one considers the 1973 clearance percentages, a need for increased effectiveness is readily recognizable. Secondly, from sheer volume alone the crime of burglary demands special attention from the Police.

Auto theft comprised 15% of the nationwide total crime index volume and 5.8% of the total Winston-Salem crime index volume. Auto theft rates reported in the 1972 Uniform Crime Reports reflects nationwide, a 6% decrease in 1972 over 1971,

with a rate of 423 offenses per 100,000 inhabitants. It further shows auto theft in the southern states as lowest in the nation with a rate of 295 thefts per 100,000 inhabitants. In Winston-Salem, the auto theft rate increase in 1972 over 1971, from 408 to 510, an increase of 25%. However, in 1973, the auto theft rate decreased from 510 to 501, a modest decrease of 1.8%. In Winston-Salem, a discernible pattern has developed between the geographic point at which a vehicle is reported stolen and the geographic point at which many vehicles have been recovered. If resources were available, Police management believes the crime of auto theft can be reduced.

Charts are provided the reader to compare Winston-Salem Police Department index crimes clearance rates with nationwide clearance rates reported in 1972 Uniform Crime Reports. In summary, a comparison of these charts will reflect Winston-Salem Police Department's clearance rate performance for robbery and burglary to be less than desirable. While the clearance rate for auto theft would appear to exceed that which one would consider acceptable, a review of offense history reflects in 1967, 460 offenses, a six year low of 399 in 1970; therefore, the crime of auto theft necessitates attention of a special enforcement effort. It must also be noted that the Winston-Salem Police Department's clearance rate in robbery and burglary has continually decreased each year for the past three years, 1971 through 1973.

## II. GOALS AND OBJECTIVES

### A. Goal Statements

To provide the Winston-Salem Police Department with increased investigative resources skilled and oriented to implement a special enforcement program against index crimes of robbery, burglary, and auto theft; to reduce the number of offenses while maintaining current clearance rates or effecting an increased clearance rate; to reduce citizen victimization rate resulting from robbery, burglary, and auto theft.

### B. Implementation Objective

The Police Administrative staff will screen individually and select 10 persons to man the Special Enforcement Unit within 60 days of the date of implementation of the project.

The Winston-Salem Police Department implementated the Special Enforcement Unit on 7 April, 1975. This was the original date set for implementation.

### C. Performance Objectives

1. To provide each officer assigned to the Special Enforcement Unit with a minimum of 80 hours special training within 12 months following implementation of the project.

The officers assigned to the Special Enforcement Unit received the following training:

10 men @ 40	= 400 hours	- Special Enforcement Advanced Training, 4-7-75 to 4-11-75.
10 men @ 2	= 20 hours	- Bank Robbery Investigations (FBI), 4-29-75.
10 men @ 8	= 80 hours	- Firearms Training, 5-8-75.
10 men @ 3	= 30 hours	- Chapter 15-A NC Gen. Statutes 5-26-75.
10 men @ 2	= 20 hours	- Chapter 15-A NC Gen. Statutes 8-3-75.
10 men @ 3	= 30 hours	- New Court Forms, 9-1-75.
10 men @ 2	= 20 hours	- Telephone (By Southern Bell Telephone), 9-8-75.
10 men @ 3	= 30 hours	- Firearms Training, 9-29-75.
10 men @ 8	= 80 hours	- Eastern Armed Robbery Conference, 11-21-75.
10 men @ 71	= 710 hours	- Total training.

The objectives of the grant provided for 80 hours training per man in a 12 month period of time. The department provided 71 hours training per man in the 9 months of operation. Due to the reduction of 3 months in operations the department feels that this objective would have been met if grant had lasted the full grant period.

2. To reduce the number of robberies occurring in Winston-Salem by 20% while increasing the clearance rate from 1973 percentage of 25.1% to 35% during the grant period.

During the year 1973 the Winston-Salem Police Department experienced the sum of 315 robberies with a clearance rate of 25.1%.

The Winston-Salem Police Department implementated the Special Enforcement Unit on 7 April, 1975. The Winston-Salem Police Departments Planning and Research Division supplied the following data for the year 1975.

1. Number of Robberies - 253 - which is a 19.7% decrease over the year 1973. The objective in the robbery catagory was for a 20% reduction which is .3% less than stated goal.

The clearance rate in 1975 is 33.2% which is 1.8% less than the stated goal of 35% over the 25% clearance rate in 1973.

3. To reduce the number of burglaries in Winston-Salem by 20% while increasing the clearance rate from a 1973 percentage of 14.7% to 25% during the grant period.

During the year 1973 the Winston-Salem Police Department experienced a total of 2172 burglary cases. During the year 1974 there was 2763 burglary cases, an increase of 27.2%. On April 7, 1975, the Special Enforcement Unit began operation and the following data was supplied by the Planning and Research Division:

1. Number of Burglaries - 2983 - for the year 1975 which is a 8.2% increase over the year 1974.

During the year 1975, the first 4 months (January, February, March, April) showed an increase of 41.8% over the same months in 1974. In April 1975 the Special Enforcement Unit began operation. During the remaining eight months the burglary rate was reduced to a - 5.3% by the Special Enforcement Unit.

The clearance rate by the department in 1973 was 14.3%, in 1974 it was 11.8%, in 1975 the clearance rate was 16.4%. The year 1975 showed an increased clearance rate of 1.7% over the year 1973 and an increased clearance rate of 4.6% over the year 1974.

4. During the year 1973 the Winston-Salem Police Department experienced a total of 510 auto thefts; in 1974 the department had 502 auto thefts which was a reduction of 2%. In the year 1975 there was an increase in auto thefts by 22 cases which is a 4.4% increase over the year 1974 and an increase of 2.7% over the year 1973.

The clearance rate for the year 1973 was 31.3%, the year 1974 was 32%, and the year 1975 is 33.2%. The year 1975 showed an increased clearance rates of 1.9% over the year 1973 and 1.2% increase over the year 1974. The above facts supplied by the Winston-Salem Police Departments Planning and Research Division.

As can be seen by this data the cases the Special Enforcement Unit received the following objectives of the grant were achieved during the grant period.

1. Increased clearance rate in robbery from 25.1% in 1973 to 43.5% in 1975.
2. Increase clearance rate in burglary from 14.7% in 1973 to 27.5% in 1975.
3. Clearance rate in auto theft from 31.3% in 1973 to 36.3% in 1975.
4. Reduction in armed robberies. Goal set at 20% reduction. During grant period there was a 21.8% decrease in the number of robberies.

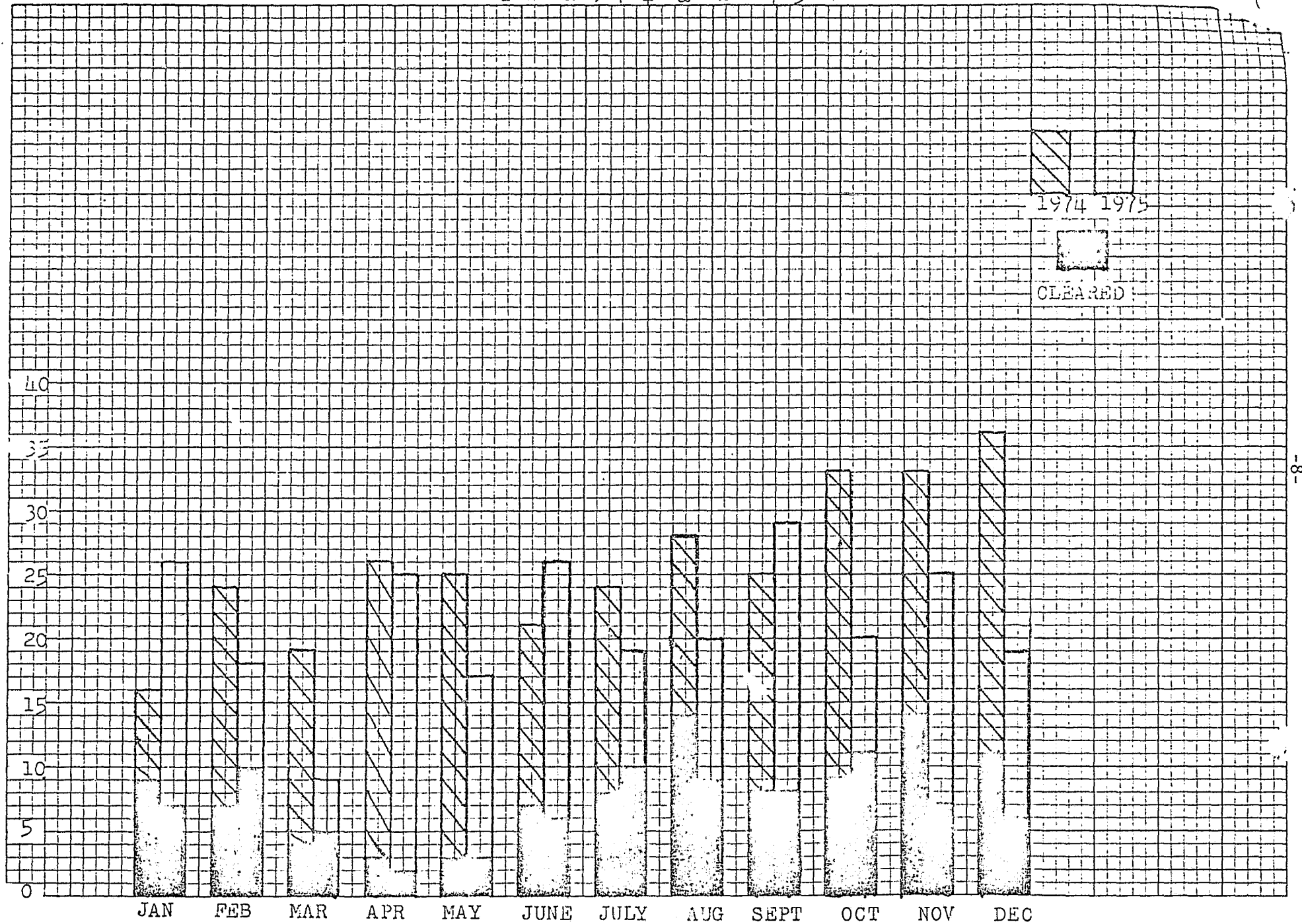


Objectives not achieved by SEU during grant period.

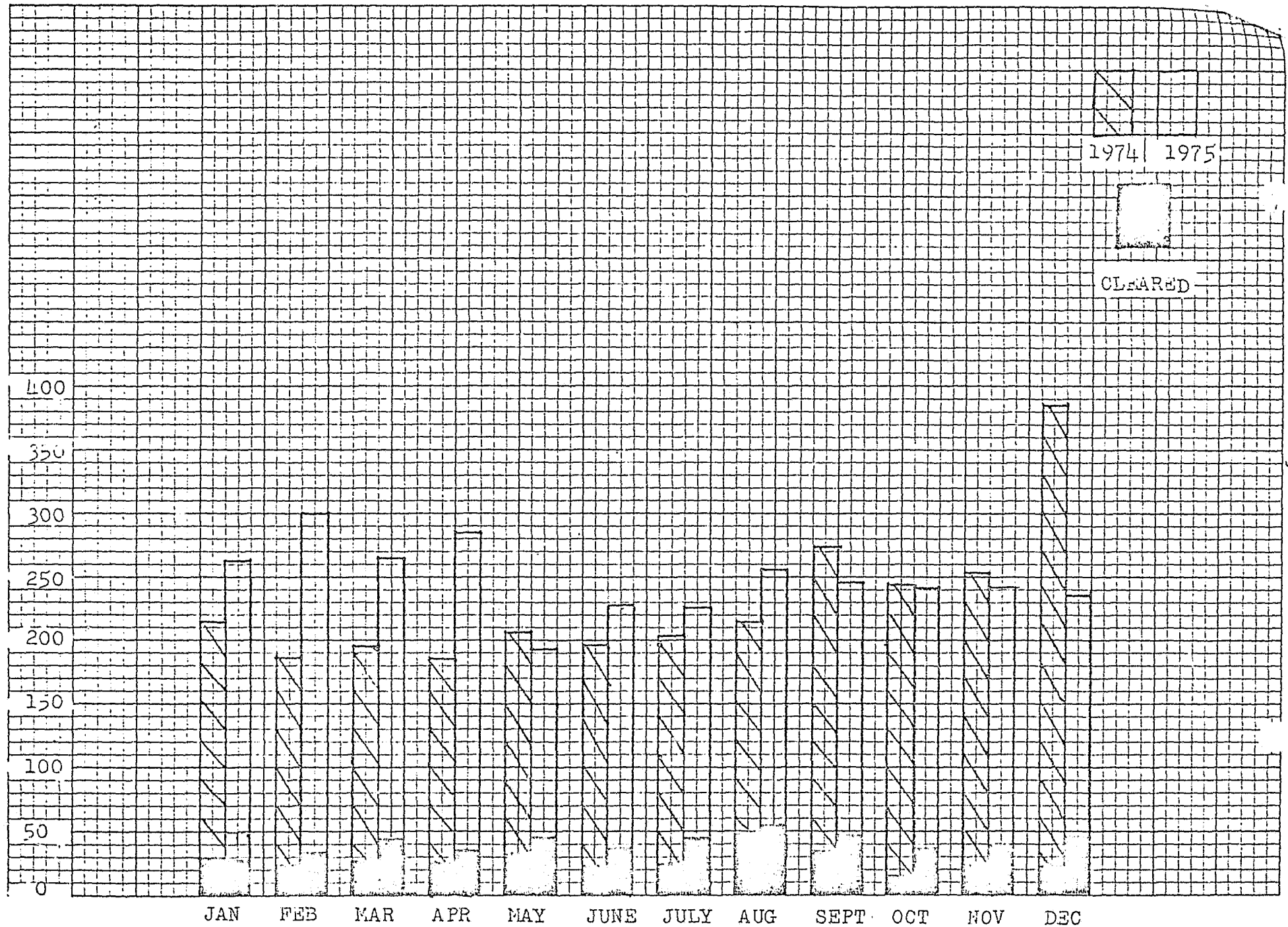
1. Reduction of burglaries by 20%. The unit achieved a 5.2% decrease during the grant period.
2. Reduction of auto thefts by 25%. The unit achieved a 2.1% increase during the grant period.

During the grant period (7 April 1975 to 31 December 1975), the Special Enforcement Unit achieved 5 of the 7 set goals listed in the grant.

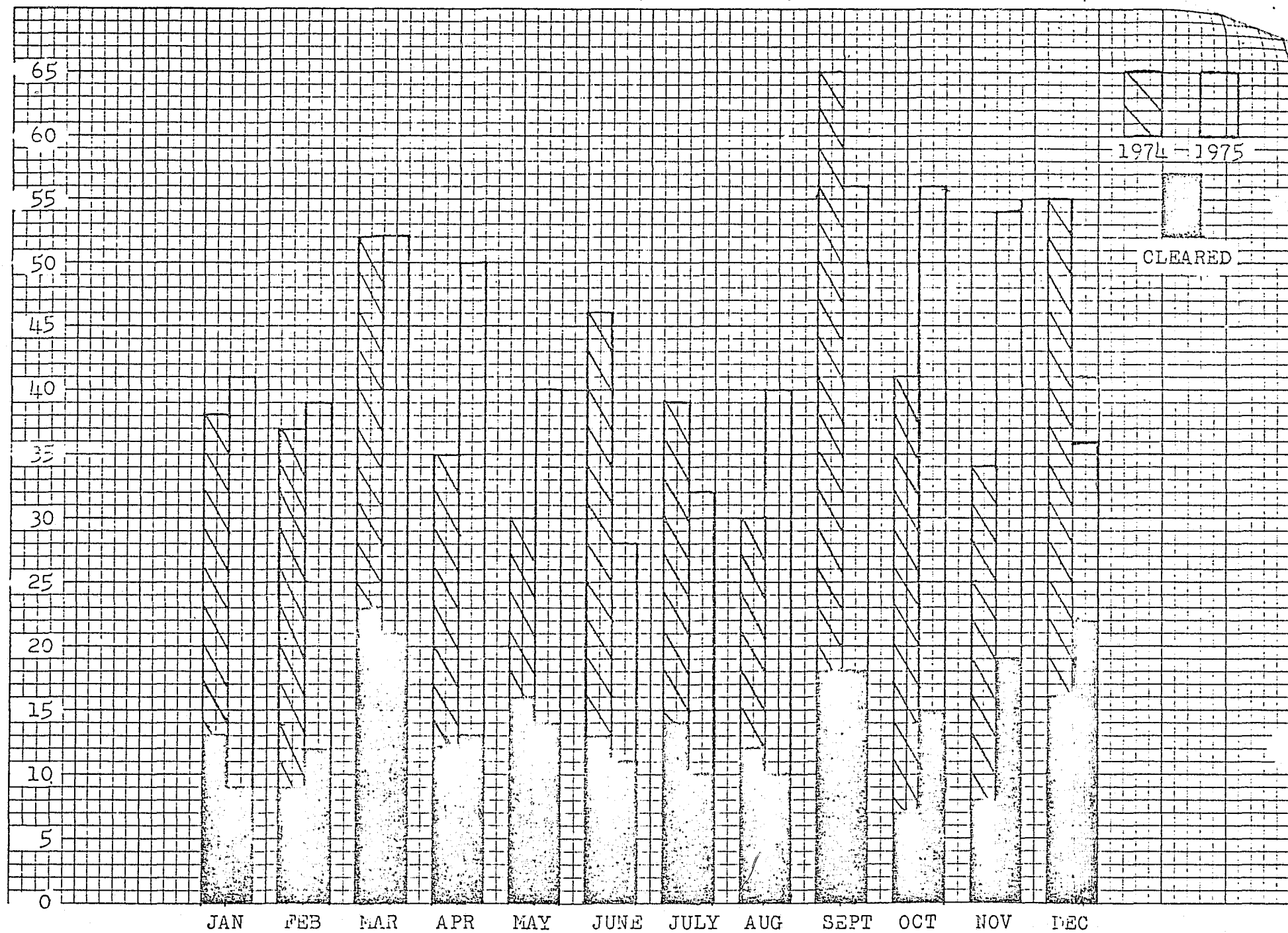
# ROBBERIES IN WINSTON-SALEM IN 1974 & 1975

### III. Method and Procedures

- A. The grant is not on schedule; it is ahead of schedule by 3 months. The advanced completion of the grant is due to the following:
1. More investigators were selected at top salary than was expected at the time of application for the grant.
  2. The grant money ran out 3 months earlier than expected because of two salary increases experienced during the application and implementation of the grant. Dates of salary increases were November 1974 and November 1975.
- B. The only problem encountered in the grant was personnel changes. The only changes encountered were due to two investigators receiving promotions to the rank of Sergeant. At no time was there prior knowledge of these promotions. To send in the proper changes to comply with the grant it was impossible to give advanced notice of personnel changes.

### IV. Evaluation Design

#### A. Records Maintained for Evaluation Purposes

1. Program evaluation forms for robbery, auto theft, and burglary. Evaluation forms attached. Accountability by Planning and Research Division.
2. Time and attendance sheets for each member of the Special Enforcement Unit. Accountability by Sergeant R. L. Haskins, Special Enforcement Unit Supervisor.
3. Monthly activity reports, April to December 1975. Accountability by Sergeant R. L. Haskins.
4. Comparison of SEU index crime rates (robbery, burglary, and auto theft). Accountability by Planning and Research Division. Comparison made involved the 5 months before and 5 months after implementation.
5. Comparison of SEU index crime rates (robbery, burglary, and auto theft) for January through April and May through November 1975. Accountability by Planning and Research Division.
6. Analysis reports on burglary, robbery, and auto theft supplied by Planning and Research Division.

A problem encountered by the Special Enforcement Unit is the delay of 15 to 20 days in receiving printout data from Planning & Research to be analyzed by members of SEU to determine patterns and locations of offenses. To eliminate this problem a daily check of maps maintained by Planning & Research are studied to determine if a pattern may be developing in any area in Winston-Salem.

B. Impact or Effectiveness of Project

1. Robberies - the number of robberies in Winston-Salem during the year 1975 showed a decrease from the year 1974 of 56 robbery cases. The main reason for this decrease was the assigning of investigators to this offense who have become familiar with the individuals involved. With this knowledge there has been better investigations and court cases. The gradual clearing of cases and convictions in court have led to a less number of these individuals walking the streets of Winston-Salem.

During the year 1975 a trend has developed in that very few businesses are being robbed. At the present time the majority (73.8%) of all robbery cases are strongarm robberies of people under the influence of alcohol.

With the increase clearance rate of robbery cases it will serve as a deterrent to potential violators.

2. Burglary - at the time of implementation the Winston-Salem Police Department was experiencing a large increase in this offense. Shortly after the implementation of SEU a burglary ring was uncovered and arrests made. These arrests resulted in a decrease in the number of burglary cases.

During the grant period a concentrated effort was placed on the person buying these stolen goods. Several arrests and convictions resulted in offenders being unable to sell the stolen merchandise as quickly as in the past.

Selected personnel were assigned the task of burglary investigations. Due to the concentrated effort of these men the amount of burglaries in Winston-Salem has shown a decrease for the months of September, October, November, and December 1975. Due to effort there were 150 less burglaries in December 1975 than in December 1974.

Due to these officers being assigned this investigation, they have become very proficient in these investigations and courtroom testimony.

3. Auto Theft - during the year 1975 the Winston-Salem experienced an increase of 22 auto thefts. During the year members of the SEU has established that several auto theft rings were operating in Winston-Salem. In the months of November and December, two of these operations were broken. Due to the arrests of these people, the month of December showed a decrease 20 cases less than the previous 3 months.

Due to the skilled personnel assigned to these investigations a better knowledge of this offense has assisted in better investigations and court testimony.

- C. The Winston-Salem Police Department has submitted to LEAA for funding for a second year of operation. The grant was approved by the City Government and forwarded to the LEAA office for approval.
