
Dear Governor Rockefeller:

The Governor's Committee on Crime,
Delinquency and Correction

The Governor's Committee on Crime, Delinquency and Correction (GCCDC) was formally created by Executive Order in August, 1968. Pursuant to the Omnibus Crime Control and Safe Streets Act of 1968, the GCCDC was designated as the State Planning Agency for West Virginia. The original mandates of the Executive Order and the Congressional action charged the GCCDC with developing a comprehensive criminal justice plan to channel federal funds into improvements for West Virginia's system of criminal justice.

The Law Enforcement Assistance Administration (LEAA), created by Congress in the aforementioned Act, approves the annual comprehensive plan and releases the federal dollars in a block grant so that the GCCDC may proceed to award funds to projects which meet the requirements of the Comprehensive Plan. The law requires all federal funds to be matched by state and local dollars. The West Virginia Legislature appropriates the state matching funds and the County Commissions and City Councils appropriate the local matching funds. The Comprehensive Plan deals with all areas of criminal justice including the following: Adjudication and Law Reform; Community Treatment and Rehabilitative Service; Detection, Investigation, Apprehension; and Manpower and Systems Development. Training of criminal justice personnel has been and will continue to be a number one priority for the GCCDC.

Structure and Membership of The Committee

The Committee, which meets monthly, is representative of the various components of the entire criminal justice system in West Virginia. Operating under the guidelines of the Omnibus Crime Control and Safe Streets Act, this diverse representation gives a multi-disciplined approach to the definition, development and correlation of problems, goals, priorities and programs to improve justice and reduce crime. The members of the Committee are appointed by the Governor, receive no salary and take time from their personal employment to perform their Committee function which consists of reviewing applications, approving projects and awarding funds to State agencies and local units of government under the appropriate program areas as set forth in the State Plan. The most important aspect of Committee work is the annual development of a Comprehensive Criminal Justice Plan which is submitted to the Governor and then to LEAA. STRUCTURE AND FUNCTIONS OF THE STAFF

The Governor's Committee on Crime, Delinquency and Correction's staff has five organizational components which are as follows: the Office of Executive Director; the Office of Program Development; the Office of Program Management; the Office of Audit; and the Office of Support Services. These five organizational components are responsible for developing, administering and awarding all Part B, Part C, Part E and discretionary funds under the Omnibus Crime Control and Safe Street Act of 1968 as amended.

The primary responsibilities for each major component of the GCCDC's staff are as follows:

- (1) OFFICE OF THE EXECUTIVE DIRECTOR -- The Office of the Executive Director is responsible for the overall operation, management and control of the GCCDC;
- (2) OFFICE OF PROGRAM DEVELOPMENT -- The Office of Program Development is responsible for developing the Comprehensive Criminal Justice Plan for the State of West Virginia. This office is also responsible for the evaluation of projects funded, research in the field of criminal justice and general planning and oversight of responsibility for the State's efforts to reduce crime and improve justice;
- (3) OFFICE OF PROGRAM MANAGEMENT -- The Office of Program Management is responsible for project planning, application development, project awards and project management of all subgrants awarded by the GCCDC. Included within this responsibility is fiscal and programmatic project monitoring. This Office is the primary organizational element responsible for effective projects designed to reduce crime and/or improve the system of justice;
- (4) OFFICE OF AUDIT -- The Office of Audit was formed to provide comprehensive and thorough audits of the receipts and disbursements - funds usage, management and administration of Federal and State funds made available to the GCCDC grantees. This Office as established is independent in the performance of audit functions and independent in the coordination of the scheduling of audit activities; and
- (5) OFFICE OF SUPPORT SERVICES -- The Office of Support Services is responsible for providing important administrative and management services to the entire Agency. Examples of these are as follows; automated grants management information system; personnel; accounting; travel; office space and supplies; etc..

HIGHLIGHTS AND ACTIVITIES

FY 1977

The twelve month period from July 1, 1976, to June 30, 1977, proved to be a time of important actions on the part of the Committee and increased workload for the staff. The following outline indicates the highlights and activities of both the Committee and the Staff during this period.

Committee Activities

- The Committee reviewed and approved 206 subgrant applications for federal and state funds.
- The Committee held 11 meetings throughout this 12 month period.
- The Committee held a Workshop in Pipestem, West Virginia and reviewed and approved the Comprehensive Criminal Justice Plan for FY 1977.
- The Committee approved funds for many new and innovative programs for the Criminal Justice System in West Virginia.

Staff Activities

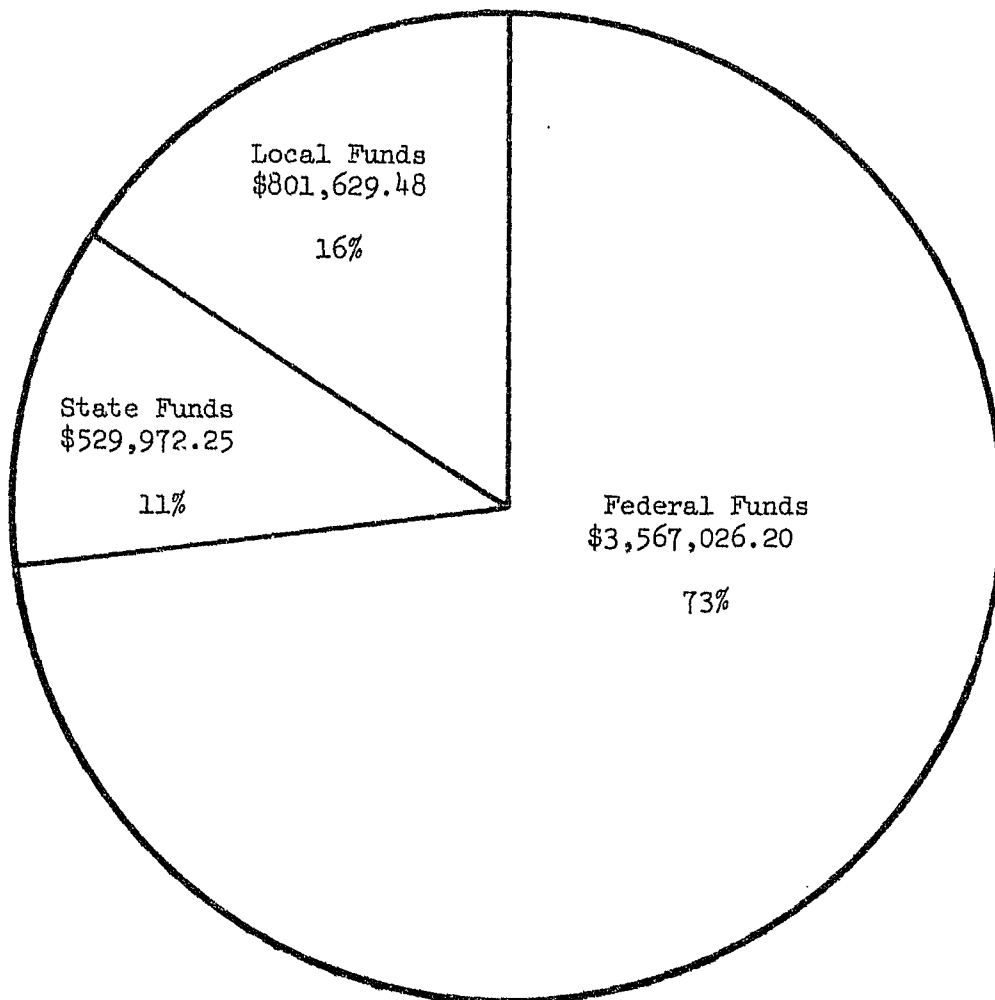
- The staff prepared 164 applications for local units of government.
- The staff maintained fiscal controls over 37.2 million federal dollars received to date.
- The staff developed 42 applications for state agencies.
- The staff developed the FY 1977 Comprehensive Criminal Justice Plan.
- The staff developed the FY 1977 Part B Planning Grant Application.
- The staff reviewed fiscal and program content, civil rights compliance and program compliance of the 206 applications approved by the Committee.
- The staff completed detailed evaluations of ongoing projects within the criminal justice system.

- 2/77 The City of Philippi received a grant which will be used \$1,509.24
by the City Police Department to purchase protective and
communication equipment consisting of one (1) mobile
radio unit, one (1) electronic siren/public address
system, and one (1) safety divider screen. The mobile
radio unit will enable the officers in the cruiser to
maintain continuous communication with the base station
and other officers. The electronic siren/public address
system will enable the officers in the cruiser to provide
an audible warning device to motorist and pedestrians
and will also enable the officers to monitor radio communi-
cations from the base station when the officers are
outside of the cruiser, but in the immediate vicinity
of the cruiser. The safety divider screen will enable
the officers to transport suspects and prisoners in a
safe and more secure manner.
- 3/77 The Barbour County Commission received a grant which \$6,014.63
will be used to purchase legal reference materials for
the Prosecuting Attorney's Office. The legal reference
materials will be housed in the Barbour County Courthouse
and in addition to the Prosecutor, will be made available
for use by members of the Bar and Law Enforcement
personnel. The primary objective of this grant is to
provide the County Prosecuting Attorney with the legal
reference materials necessary to perform the legal
research that is required of him, especially with regard
to criminal cases.
- 6/77 The City of Philippi was awarded a grant which will be used \$22,500.00
to continue the operation of the Sugar Creek Childrens Center,
Inc. The Childrens Center is designed to provide supervision,
guidance and counseling to delinquent youths between the ages
of 12 and 18 years who are referred by the juvenile courts
and the West Virginia Department of Welfare. The purpose of
the Childrens Center is to provide an alternative for the
courts to incarceration of youngsters in state correctional
institutions or to return to an inadequate home environment
at the point of dispositional decision making.

- 2/77 The Berkeley County Commission received a grant which \$2,695.50
will be used to purchase legal reference materials
for the Prosecuting Attorney of Berkeley County.
Currently, Berkeley County does not have a County
Law Library or adequate legal resources for the county
prosecutor and members of the local bar. The reference
materials will be housed in the Prosecutor's Office
or County Court House for use by the Prosecuting
Attorney, members of the local bar and county law
enforcement officials. The objective of this grant
is to provide the Berkeley County Prosecutor with
the legal reference materials necessary to perform
the research that is required of him, especially with
regard to criminal cases.
- 4/77 The City of Martinsburg was awarded a grant which will \$5,746.00
be used by the Martinsburg Police Department to provide
specialized training for three (3) officers who will be
assigned to K-9 dog-man teams. The officers will receive
their training at the Baltimore County Police Department
Training Center in Cantonville, Maryland. It is antici-
pated that this new directive will help control the
increasing crime rate within the City of Martinsburg.
- 4/77 The City of Martinsburg received a grant which will be \$ 700.00
used by the Martinsburg Police Department to purchase
investigative equipment consisting of one (1) fingerprint
and evidence camera and one (1) crime scene investigative
kit. It can be anticipated that the above mentioned
equipment will aid in the overall investigative process
of the Martinsburg Police Department, thus allowing the
department to identify more of the perpetrators responsible
for the crime or crimes committed.
- 6/77 The Berkeley County Commission received a grant which will \$10,667.00
be used to continue the operation of the Berkeley County
Youth Services Center, Inc. serving the youth of Berkeley
County. This project provides three basic services: matching
volunteer adults with girls and boys; serving as a guidance
and referral agency; and an odd job clearinghouse for teens.

The Town of Burnsville received a grant which will be used by the Burnsville Police Department to purchase protective and investigative equipment consisting of one (1) protective screen and one (1) latent fingerprint field kit. The objective of this project is to provide the Burnsville Police Department with the necessary equipment to make their new vehicle fully operational. More specifically, the protective screen will reduce the opportunities for offenders to physically attack police officers while these offenders are being transported in a police cruiser. The fingerprint kit will provide the police department with the resources required for obtaining and utilizing fingerprints at the scenes of crimes or from evidence.

The Braxton County Commission received a grant which will be used by the Braxton County Sheriff's Department to purchase protective, investigative and communication equipment consisting of the following: three (3) electronic siren/public address systems; one (1) identification camera (mugs); one (1) portable radio unit; three (3) mobile radio units; and three (3) protective screens. The electronic siren/public address systems will enable the deputies to provide an audible warning device to motorists and pedestrians and will also enable the deputies to monitor communications from the base station when the deputies are outside of the cruisers, but in the immediate vicinity of the cruisers. The identification camera will provide a permanent record of all persons arrested and booked. The portable radio unit will enable the deputies to maintain continuous communication with the base station when the deputies are away from the cruiser. The mobile radio units will enable the deputies to maintain continuous communication with the base station when the deputies are in the cruisers. And the protective screens will enable the deputies to transport suspects and prisoners in a more safe and secure manner.

warning device to pedestrians and motorists and will
enable the officers when they are outside of their
cruiser to monitor communications from the base station.
The mobile radio unit will enable the officers to
maintain continuous communication with the base
station.
- 5/77 The City of Wellsburg received a grant which will be \$ 8,797.50
used by the Wellsburg Police Department to purchase
communication equipment consisting of the following:
one (1) base station; one (1) antenna; one (1) transmission
line kit; one (1) remote control console; one (1)
emergency generator; and three (3) mobile radio units.
The equipment will be purchased to communicate more
effectively by matching this new system with surrounding
law enforcement radio communication systems. Purchase
and use of this equipment will enable the Wellsburg
Police Department to communicate effectively throughout
the city and with neighboring law enforcement agencies.
- 5/77 The Brooke County Commission was awarded a grant which \$ 3,928.38
will be used by the Brooke County Sheriff's Department to
purchase the following protective and communication equip-
ment: four (4) safety divider screens; two (2) mobile
radio units; one (1) walkie talkie; and two (2) electronic
siren/public address systems. The safety divider screens
will enable the deputies to transport suspects and prisoners
in a more safe and secure manner. The mobile radio units
will enable the deputies in the cruisers to maintain continuous
communication with the base station. The walkie talkie
will enable the deputies on foot to maintain communication
with each other. And the electronic siren/public address
systems will provide an audible warning device to motorists
and pedestrians and will enable the deputies to monitor
communication from the base station when they are outside
of the cruisers, but in the immediate vicinity of the
cruisers.

The City of Huntington received a grant which \$ 13,032.00 will be used by the Huntington Police Department to continue its Specialized Training Program for its police officers. The objectives of this project are as follows: (1) to provide the opportunity for officers of the Huntington Police Department to attend specialized training courses that will increase their ability to effectively perform their work; and (2) to expedite the time and to reduce the expenditures involved in developing individual grant applications for specialized training.

The Cabell County Commission was awarded a grant to 21,984.00 continue to fulfill and meet the state statutes regarding the operation of the Cabell County Youth Center as outlined by the West Virginia Legislature in 1959. The Youth Center generally averages a population of 12-18 boys under commitment. At the present time, only males are committed to the Center, although females are held there in detention for short periods of time. The main goal of the project is to provide psychological counseling, testing and diagnostic services for the residents of the center. In addition, group, individual or family counseling will be incorporated within the structure of the treatment program at the center. This will be accomplished by entering into a contract with the Community Mental Health Center whereby psychological services will be provided at a minimum of twenty hours per week. Furthermore, the youth center will employ a qualified social worker who will assist the staff and provide follow-up with the youths in some form of counseling as well as coordinating other services which may be available from other local agencies. It is anticipated that by incorporating these two new treatment areas within the system the overall goal of the youth center will be reached. That is, to influence the behavior and/or attitudes of the residents of the center so that they may return and remain successfully in the community upon their return.

The City of Huntington received a grant which will \$ 7,686.18 be used by the Huntington Police Department to purchase protective and communication equipment, for their newly purchased cruisers and motorcycles, consisting of sixteen (16) protective screens, three (3) motorcycle radio units and five (5) electronic sirens/public address systems. The protective screens will provide safer conditions for the officers when transporting prisoners or suspects in the police cruisers.

The mobile radio units will enable the deputies to maintain continuous communication with the base station. The electronic siren/public address systems will enable deputies to provide an audible warning device to motorists and pedestrians and will also enable the deputies when they are outside of the cruiser, but in the immediate vicinity of the cruiser, to monitor communications from the base station. \$ 8,603.00
- 5/77 The City of Huntington was awarded a grant which will be used by the Huntington Police Department to continue its Educational Incentive Pay Program. The objectives of this grant are as follows: (1) to provide incentive pay to approximately thirty-two (32) police officers in the Huntington Police Department; (2) to allow participation in and completion of approximately 2,401 undergraduate college hours by participants; (3) to allow participation in and completion of approximately 69 post-graduate college hours by participants; and (4) to allow anticipated completion of at least four (4) undergraduate degrees by Huntington Police Officer. \$ 15,102.00

He will work with interested agencies as conditions warrant and will conduct seminars and workshops as needed. At the request of state, county or municipal law enforcement agencies, he will review and analyze their EEO programs and policies. The West Virginia Human Rights Commission was awarded \$ 19,149.00 a grant to continue the position of an Equal Employment Opportunity Coordinator. The objectives of this grant are as follows: (1) to provide law enforcement agencies with technical assistance and current information needed to update current EEO programs; (2) to assist law enforcement agencies in developing effective EEO guidelines; and (3) to increase the number of minority and female applicants for positions with law enforcement agencies and encourage them to accept positions in law enforcement agencies. The long range objective of this project is to help criminal justice agencies get in compliance and remain in compliance with LEAA and other Affirmative Action guidelines.

8/76 The West Virginia State Fire Commission received a \$ 2,929.00
grant which will be used in acquiring specialized
training for State Fire Marshal's Personnel. The State
Fire Marshal Department, consisting of 14 men and 4
secretaries, has two main responsibilities, one is
inspection in fire prevention and the other is investi-
gation of all fires of a suspicious nature to determine
their cause, point of origin and the subsequent arrest
of the perpetrators of these crimes. There are training
schools and seminars on arson investigation which must
be attended in order to keep abreast of new developments
in the inspection and investigative techniques used in
arson cases. This grant application is designed to
expedite the process of obtaining approval for specialized
arson training for members of the State Fire Marshal's
staff and minimizing the administrative cost by reducing
the numerous small grant requests.

9/76 The State Fire Commission received a grant which will be 10,655.00
used to purchase modern up-to-date investigative equip-
ment to expedite investigations in cases of arson. The
equipment is essential in the cause determination and
evidence accumulation for the purpose of arresting the
person or persons responsible for the crime of arson.
The objectives of this grant are as follows: (1) Provide
capability to photograph fire scenes to establish evidence
for court use; (2) Provide capability to obtain latent
prints at the fire scene; (3) Provide capability to deter-
mine the presence of hydrocarbons and determine if hydro-
carbons accelerant was used to develop rapidity of flame
propagation; and (4) Provide capability to determine types
of solvents used at the fire scene.
