

INTRODUCTION

The Minneapolis Police Department continued to work toward previously established objectives in 1977. And, although there were concerns because of limited resources, many positive achievements were noted.

ACQUISITIONS

The Department continued to plan for its utilization of space allocation. The Investigative Bureau completed its move into new quarters and for the first time in remembered history had what was appropriately labeled as "elbow room." Continued planning for the consolidation of records was in the final stages. The objective was a centralized records complex which would provide better access to the several documents available for both the public and police. An important adjunct to this plan was the development of a departmental records retention program and the initiation of microfilming.

Significant progress was also made towards the installation of a Computer Aided Dispatch System in the Communications Division. A vendor was selected and the project was slated for completion within one year. This new system should greatly assist personnel assigned to communications and provide impetus, once again, for stability in these positions. The system additionally will provide considerable useful data designed to improve management control and facilitate street personnel deployment.

Plans were finalized for the installation of an Automated Latent Fingerprint Identification System (ALFIS) which is a joint venture with the City of St. Paul and available to area suburban departments. Not only will this provide ready access to the volume of fingerprints currently stored by these Departments, but also will provide a sound communication base for the several departments involved. Additional equipment was purchased for the Investigative Bureau to assist field operations which included a "sting type" activity.

A more effective deployment of department vehicles was instituted wherein assignment of this equipment was made to specific division and unit commanders; along with this, appropriate parking areas were developed. The advantage of this project eliminated the need for motor pool personnel and has resulted in the reduction of numbers of squads and total miles driven. These savings obviously will be reflected in our budget.


A significant purchase of equipment was made in an effort to begin an audio-visual studio in the Courthouse Complex, thereby providing in-service training availability to all personnel from a single location.

The Task Force, assigned the responsibility of a new Department Manual, finished its activity and the Manuals were distributed to all personnel prior to the end of the year. This is the first comprehensive manual developed for over thirteen years.

The Department continued to participate in several grant programs including the Organized Crime Intelligence Unit and the Criminal Investigation Analysis.

In conclusion, 1977 was a very productive year and one in which Department Members can be proud of their contributions in making these efforts possible and successful.



Dear Mayor Stenvig:

It is with pride in the men and women of the Minneapolis Police Department that I submit to you the Annual Statistical Report for 1977.

These statistics, compiled in accordance with prescribed criteria of the International Association of Chiefs of Police and the Uniform Crime Report procedures as recommended by the Federal Bureau of Investigation, show a decline in major crime for the second consecutive year. This was accomplished despite a five percent reduction in personnel caused by the city's budgetary problems.

Improved management procedures have also reduced the backlog of accumulated compensatory man-hours and decreased the needed number of vehicles and miles driven.


The department is continuing its efforts to improve performance and provide better service to the community. Consistent with this goal, the center court area of the ground floor of the Court House is being remodeled for a Central Records Division. This will consolidate the various record units and make their services available to the citizen at a single office in close proximity to the main public access to the building and also allow more effective use of personnel.

During 1977 the Administrative Services Unit was established to oversee all budget, payroll, purchasing and supply functions. This unit answers directly to the Deputy Chief of Services and provides for effective management of all fiscal matters.

At the request of the City Council and with the assistance of a citizen and police officer review committee, the rules, regulations, and general orders of the department were rewritten and incorporated into a single duty manual with copies distributed to all officers as a control on actions and discretion. This manual was designed to be readily revised as the department adjusts to the ever-changing needs of modern society.

On behalf of the police department, I extend our gratitude to you, to the City Council, and to all those citizens of Minneapolis whose cooperation and support have enabled us to make this a safer community.





JUVENILE DIVISION

This past year, 1977, marks the third consecutive year in which the number of juveniles processed by the Juvenile Division has declined. The 5,262 youths who had contact with officers of the division were 10 percent fewer than those involved in 1975, which also showed a decline from the previous year. Once again, the 13-14 year olds of both sexes accounted for most of the contacts.

The only serious offense in which an increase was noted was that of robbery in which a 12 percent increase occurred. Most offenses in this category, committed by juveniles, involve purse snatches, which are considered a robbery of person. Offenses of a less serious nature which also showed increases were shoplifting and thefts from business, simple assault, damage to property, theft from auto, and bicycle theft.

A significant decrease in the number of arrests of juvenile prostitutes also occurred with 40 percent fewer arrests being made specifically for this offense than were made in the preceding year. Considering the comparatively few total arrests, however, it is questionable whether this is particularly significant in indicating any lessening of the problem of juvenile prostitution. It might be noted, however, that there were also fewer girls taken into custody for absenting than in the previous year, and although it cannot be assumed that all girls who are on the run become involved in prostitution, it can be stated with a great deal of certainty that most girls who become involved in prostitution are on the run either from home, from a community or correctional home, or from an institution.

The decrease in number of contacts with juvenile offenders might be explained in part by the steadily declining population of the city, particularly of children of school age. What is interesting, however, is the gradual percentage decline of "repeaters" or the rate of recidivism among youthful offenders.

In 1974, 71.4% of juveniles arrested had had at least one prior police contact; in 1975, 70.6%; in 1976, 68.6%; and in 1977, 66.6% had other arrest records.

These juvenile crime statistics are rather cold and nondescript facts. They don't begin to describe or explain the causes of delinquency, the depth of the problem within an individual youth, nor do they depict the price victims and society have paid for the crimes that were committed. Does the trend indicated by these statistics give one reason to hope that either youngsters are changing or that efforts being made to help children with problems is having a positive effect? Or, when we compare these statistics with the general demographic trends, do the lowering crime statistics simply reflect the reduced number of young people in our community?


